5	COMMISSIONERS: Good afternoon.
6	CHAIRPERSON CARTER: Welcome to the weekly
7	Board of Police Commissioner's Meeting. My name is
8	Lisa Carter, the Chair of Commission. I represent
9	District 6. Thank you all for coming to this
10	afternoon's meeting. And for those viewing the meeting
1	at home, thank you for tuning in.
12	The department within the last day, lost another
13	officer, Lieutenant Shawn Wesley. Lieutenant Wesley
4	had a massive heart attack and was unable to recover
15	from his injuries. I would also like to ask for a
L6	period of silence to reflect on his career and life.
L7	Thank you.
8	I would also like to note the death of Linda
L9	Brown. The name sake of the landmark 1954, the Brown
20	versus Board of Education Supreme Court Case that
21	abolished school segregation.
22	Ms. Linda Brown made her transition at the age of
23	75. The Brown decision remains one of the most pivotal
24	opinions ever rendered by the U.S. Supreme Court
25	impacting national education, social policy, and equal

2	I also want to note a critical date in our
3	history, April 4, 1968. The assassination of
4	Dr. Martin Luther King Jr. The 50th anniversary of his
5	assassination will be observed between our regularly
6	scheduled meetings. Therefore, it is appropriate to
7	note and reflect on the tragic event in the nation's
8	history.
9	Fifty years ago, Dr. Martin Luther King was killed
10	in Memphis, Tennessee, fighting for sanitation workers
1	and preparing to lead the poor people's campaign. It
12	is exactly one year since Dr. King delivered his,
13	beyond Vietnam sermon, from the pulpit of the River
4	Side Church in Harlem, New York.
15	Dr. King's death came as a criticism of America's
16	racial divide and incorporated a challenge to
17	inequalities and all facets of American life.
18	Dr. King would also be comfortable today, in
19	criticizing the recent shootings in Sacramento,
20	California, of 22-year-old Stephon Clark who died as a
21	result of twenty-some bullets fired by some police
22	officers.
23	King would also be disappointed with the response
24	by the White House and the Attorney General in the

United States, that indicated the shooting of Mr. King

And it is unlikely that the 1 2 resources of the federal government would be invoked to focus light on another tragic incident, in a string of 3 tragic incidents arising from communities of color. 4 5 Again, I would ask that we pause to remember Dr. King, Linda Brown, and 22-year-old Stephon Clark. 6 Thank you. Pastor Matthew Nichols from the 7 Presbyterian Avenue Church is sick today, and he will 8 9 not join us. Vietnam with the First Aircraft when he was shot and killed in Memphis, Tennessee which is a city that's dear to me. Mississippi born, but Memphis was one of those cities that, we migrate 20 miles from the Delta and Mississippi.

So I recall this incident and some of our other soldiers celebrated his death. And we, as African Americans, some of us wanted to go out there and start participating and create a little havoc. But it was common effect that we realized that would not be the proper thing to honor his legacy.

And after that incident, I had an opportunity to go back home in that area. I went to Lorraine Motel to visit the site. But I dedicated my life to Civil Rights. I will always be on the cutting edge of Civil Rights. Based on that, here serving our country and somehow, a fellow soldier celebrating his death.

So we look back fifty years later, we still have a long way to go, but I'm pleased we are not where we are back then. We have come a long way and still have a long way ahead. I just wanted to share that remark and historical moment because he was a young man that died, as we know, early, at 38 years of age. But he achieved so much. So much that we are enjoying the pit of this now. Thank you, Madam Chair.

As a Board, we receive and investigate 16 non-criminal citizen's complaints, monitor the operations of the department, and working with the 17 18 mayor and the Chief of Police to make and/or modify 19 police policy. 20 Our objective is the same as that of the City, 21 City of Detroit, to provide the best use of your tax 22 dollars to improve on the quality of life within our 23 city. 24 As a Board, we bring a unique perspective to



policing. The eye and viewpoint of civilians. The

principles of civilian oversight is as old and as
important as all of the founding principles in our
democracy. Separation of powers between and within a
government allows for accountability, transparency,
right to appeal and citizen control. These principles
are important nationally, as well as locally.

At the top of our meetings, we also indicate -always indicate on behalf of the Board, our concern and
support for fallen and injured officers and their
families. I would ask that Assistant Chief, during
your remarks, to please provide us with additional
information related to injured and fallen officers,
please.

Today, we have two presentations. We are pleased to have the Detroit Corporation Council, Lawrence Garcia who really -- was recently appointed and will discuss resolutions to our concerns that lawsuits and settlement information be shared with this body.

This information is critical in monitoring the department as well as reviewing and modifying operational policy within the department. We will also receive a report from the office of the Chief Investigator, Dr. Paulene McCalister.

Toward the end of the meeting, we will have oral communications from the audience. So if you would like

For our crime, we are continuing to show reductions. In our homicide rate, we are at an 18 percent reduction. As of today, we're actually at a 25

Page 16 percent reduction in criminal homicides. We have 17 1 2 fewer homicides as of today, than we did the same time 3 last year. Sexual assault seem to be one of the areas -- the 4 5 only area of violent crime where we have an increase. We've been discussing this at length. And what we 6 believe is happening is we had an increase in 7 reporting. And that reporting is through our Lent 8 9 System. It basically means that schools, hospitals, and other entities are doing more reports and referring 10 11 them back to the Police Department than we had before. 12 So even with families that may have inappropriate 13 touching that have occurred between a family member to 14 a minor child, that's being reported now than it has 15 been in the past. 16 And also, just for overall numbers, so this is as of March 25th, we're down 6 percent violent crime and 17 18 14 percent in our -- I'm sorry, 17 percent is in our 19 part-one crime. In our part-one crimes, we're down 14 20 percent year-to-date total. 21 With that, I'll open up any questions to the 2.2 Board. 23 CHAIRPERSON CARTER: Commissioners, do you 24 have questions?

I was impressed with 19 everything that went into that site, and just hands on. 20 And the citizens who came together, the block club, great job with them too, giving their input. I 21 22 heard their input was a large part in helping you to 23 develop that web site. That was a great job with that. I was really impressed with that. And I liked the 24

And in that spirit, I wanted to report out to you, a few data points today. And then, also explain some systems for sharing data that I think will be observed by my office and, perhaps, even by DPD going forward.

First, one of the most important data points to me is payouts by the City. Because I consider it a large part of the Law Department's responsibility to protect the City's finances to the greatest extent possible.

And in 2016, 4.972 million dollars was paid out by the City of Detroit for cases arriving out of the Detroit Police Department.

Last year, 2017, that number was 6.461. The types of cases that generated those payouts really falls largely into just two categories. And I'm sorry, I don't have a slide for you, but you can see it's a pretty even split.

We classified these by type involving violations or alleged violations of constitutional rights, excessive force, wrongful prosecution, illegal imprisonment, that type of thing. That would be 45

Property, and then miscellaneous other absorb what's left in the very small slice of pie that's left in my graph.

The Law Department is happy to share this top
line, sort of, data with the Commission. But in
addition, I think to, sort of, year-end look back, type
of information, you all would probably appreciate
things that are more timely.

So what I'm working on in being able to publish to you monthly, is a spread sheet that captures the basic information that's public on representations sought from the Law Department on behalf of DPD officers. And what I'm talking about in having in that table is the name of the officer, the name of the plaintiff, the date of filing, and some basic description of the claim.

And then, when there's an adjudication or a disposition of the claim, that will show up in the final right-hand column, but later on down the line. So that way, you all can see who are the repeat players in the Law Department's business. And there may be

some ability to detect trend volumes through that view of the information.

As far as reporting out the data regarding officers who are associated payouts, that's a little bit more difficult for my office to distill that information from all of what we see. We're working on that, but it's not as clean a proposition for me. What we have to do is take the proposals that go to council, for approval of settlements and look inside those summaries for each proposal to make sure that we're not missing a case in which the agent at the root of the claim was a DPD officer.

The reason that's difficult is because sometimes it'll say proposing a 15,000-dollar settlement on behalf of the City of Detroit. And the summary may not break out that it was a traffic stop that turned into some claim of a constitutional violation.

So I'm trying to make sure that we're sensitive to finding all of those settlements on the back end when the case comes to its near conclusion. But I hope that providing that information to you will allow you to look for those trend lines.

I just communicated with Mr. Ha, and I don't think there's going to be any problem in also having the situation where officers who have been found

past. And I know the late -- I wouldn't say late -Council Mel Ravitz used to identify how many come
through the council. So it's an area we all should be
concerned about in terms of the quality of police
service.

Also in the impact of the community, not just in financial dollars, but if we can have a convention, a learning lesson from this, then I think we will be a better department.

MR. GARCIA: Commissioner Bell, I can only speak for myself, but I can tell you that I personally met with Chief Craig and discussed this issue, and I think he's open to sharing information and having input. He was very candid in saying that sometimes what appear to be pretty obvious patterns of this behavior are missed in his own systems. So he's -- he's open to having somebody point out where there's patterns where they see them. And I think that's the, kind of, spirit and cooperation that's going to serve everyone best.

I'm aware of, just from the cases where I've worked as a vendor to the city, having defended officers of some names, some repeat players in the game, so to speak, and now that I've been in Corporation Council, I've seen those same officers'



Page 27 names appear in litigation. Most of them have moved on 1 2 to work for the City of Seattle, in their Police 3 Department. But still, your point is very well taken. Some of 4 5 these things are quite plain and quite patent when you look at the data. That's why I'm hopeful. It's not 6 7 going to be hard to see these patterns once we have them in front of us. So I'm eager to provide you that 8 information. 9 10 COMMISSIONER BELL: And Madam Chair, I just 11 want to say thank you. 12 But also on the other side of the coin, I've been 13 one of the officers that have been sued and part of the lawsuit, and not high profile, but basically, you know, 14 15 in that whole process, the Corporation Council do an 16 excellent job. MR. GARCIA: Well, thank you. 17 COMMISSIONER BELL: -- of defending issues 18 that merits that. So it's not a one-sided issue. You 19 20 go and do the research and go to bat. I was impressed with that type of effort. And you still are providing 21 22 that type of service. 23 So we need to know that. Officers need to know that. We're not just totally in opposition of what we 24



need to do. Sometimes it comes with the nature of the

8	shrew of cases were either wiped out or stayed. And
9	when they reactivated, it took some time for the
10	fought-out claims to see to the end.
11	So I'm not sure the 2017 was a bumper year for the
12	City overall, because we weren't just settling cases
13	from 2015 and 2016, but really from earlier than that
14	of cases that had been put on ice. So I don't think
15	you're going to see that repetition in the high number.
16	I think a lot of that is, sort of, an anomaly.
17	But in addition, I'm really struck with the number
18	of cases that come out of motor vehicle accidents. And
19	when I dug into those 86, particular, claims, a lot of

can be associated with DPD.

And I'll give you a point of reference for DDOT.

It's a lot of the same thing. We've got equipment on the road from buses to street sweepers, to asphalt

driving or violations of the motor vehicle code that

the high value settlements were involved in poor

patch trucks and what have you, that are -- that are involved in a lot of motor vehicle accidents which are doubly consequential to the city because of the load rate of auto insurance being held by Detroiters because of the red lining and unnaturally high premiums that Detroiters have to pay for auto insurance. So it's really a constellation of circumstances that puts us at risk for high accountability of motor vehicle accident.

And to address that, this is coming out a little bit early. This isn't ready for prime time yet. My office is working on what we call a Road Show. We're going to go to DDOT and go to DPD and get to some of their time they use for continuing education and put on some of these cases. You know, scared straight or to try to convince people of these accidents when they occur. People are dying. Million-dollar settlements are being made necessary. So careful driving is just so incredibly important. And we can't be nonchalant about the importance of observing the rules, no matter of who we are or what our automobile is marked as when we're driving down the street.

So I'm hoping that we can start a culture of reforming and, you know, see some of those patterns change. Because at least 3 and a half million of the money paid out for 2017 was auto. And that doesn't



Page 31 include the first party of the cases. That's just the 1 2 third-party claims. I'm sorry, I'm talking like an auto negligence 3 If you would like me to break that down, I 4 5 will. But I've talked too long already. VICE CHAIR DEWAELSCHE: No. No. 6 7 information is very interesting and very helpful. 19	harassment, procedure, arrest, property, demeanor,
20	search, entry, and service. Once we look at all the
21	allegations, each allegation is assigned a finding:
22	Sustained which is really important where the
23	preponderance of the evidence shows that the alleged
24	conduct did occur, and the actions of the employee or



employees violated the Detroit Police Department

1	policies, procedures, or training.
2	Not sustained is where there is really
3	insufficient facts to decide whether the alleged
4	misconduct actually occurred.
5	Exonerated is where the preponderance of the
6	evidence shows that the alleged conduct did occur.
7	However, did not violate Detroit Police Department
8	policies, procedures, or training.
9	Unfounded is where the investigation revealed no
10	facts to support that the incident complained of
11	actually occurred.
12	So this slide reflects what we did in 2018 for
13	February and what we did in 2017. We've only had a one
14	percent increase. So what I did, I started checking
15	different police departments such as Cleveland.
16	Cleveland has 1, 573 police officers. For 2016, they
17	had 273 complaints. Their down now, only because of
18	the body cameras. So I'm thinking, as we go in and we
19	continue with the body cameras, this will have a
20	decrease as months go on as well.
21	This is an overview of all the police precincts
22	and divisions that have actually taken in citizens'
23	complaints. Ours being the highest which is the Office
24	of Chief Investigator. Higher was walk-ins. Telephone
25	is the ones that we actually receive. And I think that



Page 35

one was the highest out of them all.

And if you look at the numbers, we're really doing a good job as far as police service because we only had 80 complaints.

This slide talks about the findings. And I agree with the Corporation Council. You know, we look at demeanor. We have 44. We have procedure which was 62 and service, 18. Those were simply allegations. What was proven was only 17. So that says we're still doing something right.

And the ones that -- the allegations, most of that can be handled with retraining. Demeanor can be handled with retraining. Procedure, retraining, as well as service.

These are complaints that we resolved with the DPD scout car video/audio systems. We had 16. Eight were actually captured. Eight were not. The ones that were not captured may have been because maybe the vehicle didn't have equipment installed or maybe the person filed the complaint after the 90 days and we weren't able to capture the video.

The body mark cameras looked pretty good. We had had 36 complaints. Captured were 28. And 8 were not. Same type of scenario. It is possible that maybe the vehicles that they were using or maybe the body cameras



Page 36 1 they had on weren't working. Or maybe the person filed 2 the complaint 90 days later. You know, we don't get the video after 90 days. 3 This one I found rather interesting because this 4 5 gives you a breakdown of all the members on the department. We had 1, 869 male members and only 100 6 got complaints. Out of 621 female members, only 14 got 7 complaints. Out of 932 white members, only 57 received 8 9 complaints. And as it goes down, and you get to the last column, out of 2490, we only had 114 officers 10 11 involved. That's pretty good when you look at the 12 statistics of other police departments 13 COMMISSIONER BROOKS: Right. 14 MS. McCALISTER: I know New York is extremely 15 high. But I think that comes from they don't have a 16 strong board of police Commissioners and they don't work well with their police departments. But I think 17 18 with the combined efforts of our investigators and you 19 guys and DPD, I think we can get that number down. 20 COMMISSIONER BURCH: That's real good. 21 MS. McCALISTER: This one, I took a lot of 2.2 interest in because I looked at the police rank and then the seniority side. The police officers, that 23 could have been you had a lot of new officers on the 24 25 streets that were really unsure of their roles and



Page 37 responsibilities. That can be handled with retraining. 1 2 Maybe they're unsure of policies and procedures. can be handled and reduced with training. 3 Or we've had, an increase in either patrol or 4 5 narcotic enforcements. That always increases complaints. So I think we need to figure out an extra 6 7 category about where they're actually coming from within a certain time frame and we can address those 8 9 issues. What I found interesting were the senior officers. 10 11 Research has proven senior officers don't get 12 complaints. Because at a certain point in time in your 13 career, you're rather relaxed. You know, what you're 14 doing and you know your roles and responsibility. 15 However, for that one, I found out after research, that 16 either comes from low morale or they're just not ready 17 for retirement and they're feeling stress of being 18 forced out and it's causing complaints. 19 What I suggest is we create a phase out program for senior officers. Maybe take them off the street 20 and let them mentor new officers. 21 2.2 COMMISSIONER BROOKS: I like that. 23 MS. McCALISTER: That will reduce the stress of them being forced out and that will change the 24



culture of DPD as well.

1	And we set some goals for 2018. And as we go
2	throughout, I'll add-on more goals. But one is to
3	continue to increase public confidence and trust in law
4	enforcement. We can do that by going out to the
5	community meetings and sharing what we do and how we do

Some of them enjoy working in the precinct. They don't want bureau assignments. But we need to have some form of interaction with them. And like you say,

2	the direction we're going in, but that curriculum is
3	very important. We need to insist on the Academy that

So as far as the curriculum change, that's something we can probably look to. But I think the most immediate thing we can do is actually put something in as a presentation that the Board could do if they want to do something with that and we work that out with A.C. White in his shop and Captain Williams.

Going back to Commissioner Bell's statement about the F-word. Any profanity that's used against any member of the community as a police officer in the day-to-day, I guess the day-to-day execution of their duties is a violation. We have to have courteous manner with all citizens. So I want to make sure that's already part of their policy. When that happens, the officers are acting outside of our policy and we do hold them accountable. And that is actions we do not condone. So we're looking at it and seeing if we do have that large proliferation of that usage of the word and we'll continue to push to our officers to make sure we understand. I think the great majority of our officers, they get it right. But we do have that small minority. Captain Petty, and Captain Petty's staff, we were able to go through a pretty good amount of information that related to the deployment of officers into varying services where there may be an expectation for us to recover the money for that extra outlay of officers.

Typically, that question is related to downtown activity, sports, and entertainment venues, and so forth. But it does include, other than just downtown activity.

But based upon that work that was done, we were able to, in working, I think, again, and cooperatively, we were able to reconstruct that process, I think, over the last couple of years. And we have forwarded one to the board and would also forward to the Chief through D.C. Bettison, a set of recommendations that we think would correct some of the problems that we've had in the past and that.

And for the purposes of the public meeting, I do want to indicate that where we may be under the impression that we had a lot of city funds that was just out there unaccounted for and so forth, well our investigation in an area does not reveal that we have substantial city funds out there just wasting about or anything like that.

In fact, if you take away the exempt services that

had been provided over some period, we had close to an 89 percent recovery for these services in 2017. And in 2018, we had close to 70 percent recovery.

Obviously, we can do better in terms of recovery.

We can do better off in terms of billing. We can do

better in terms of tracking those events and

organizations that may -- that we may select to exempt,

but what we thought our focus should be aside from a

response on the numbers themselves, the accounts, if

you will, we wanted to come up and recommend to the

department and ultimately, the City, a process in which

we can handle this moving forward, so that this would

be cleaner as we move forward, more accurate in terms

of the numbers and so forth. And, that we can get

close to a hundred percent return upon those funds that

are extra funds that are expended when we put extra

police out for these special services.

And that -- a copy of that report is included in your packet. It is the -- well, a copy of the report is included in your packet.

Finally, the only other item that I would like to mention is that roughly, about a year ago, we requested a copy of the curriculum from the Academy and they provided a copy of the curriculum. If that curriculum has changed and I don't know that it has, we would be

4	the types of information that is shared with recruits
