1 COMMISSIONER DEWAELSCHE: Thank you, Chief. 2 Do we have any elected officials or representatives in 3 our audience? Elected officials or representatives? 4 Hearing none. Then I'd like to give a brief report. First, we have our DPOA president, Mr. Mark Diaz. 5 б Thank you for being here. I'll give a brief report and -- but before 7 8 I start I'd like to say that on behalf of the board, 9 as we always do at the beginning of our meetings, we 10 want to express our support and concerns for fallen officers and their families. 11 12 You may want to add some updates, Chief White, if you have any information, but we do have two 13 14 off-duty police officers who were also recently injured in an auto-related accident. One of the 15 officers was hit in connection with a vehicular chase 16 17 involving Hazel Park Police Department, and I would like to ask the chief's office to maybe provide us 18 with an update. 19 20 Also, as chair for today, I would like to remind us that while several recent events have 21 22 disappeared from the news headlines, we are still thinking of the people in Las Vegas and Puerto Rico, 23 24 the Caribbean and southern gulf regions, California,

and other locations devastated by acts of mother

nature or human hands. We pray and hope for speedy
 assistance to reach all the people in need. Thank
 you.

At this time -- oh, I'm sorry. And we also 4 have two short presentations from staff. We have 5 6 several items that will require the board to move into closed session. Under the Open Meetings Act, we are 7 8 allowed to close our meeting to discuss personnel 9 matters. These personnel items will be taken under 10 new business after our committee reports and oral communications from the audience. We have adjusted 11 12 the agenda to allow for those who want to leave before the closed session. Remember that after the closed 13 14 session the board will reconvene to vote on any items from the closed session. 15

16 At this time does the chief have a report, 17 please?

CHIEF WHITE: Yes. I'll start with the 18 crime report. Crime, violent crime, continues to 19 20 trend in the right direction. We're experiencing a 6 21 percent reduction in homicide; 5 percent reduction in 2.2 sexual assault; 14 percent robbery reduction; 13 23 percent carjacking; 5 percent aggravated assault; 11 24 percent nonfatal shooting; and 7 percent overall 25 violent crime reduction.

25 the chief has provided an update on the incident	25	the chief has provided an update on the incident

1 involving Meijer and an officer of the Detroit Police 2 Department. The department has made an internal decision not to seek charges on the subject involved 3 4 in the incident with the officer. We are continuing to look into the matter. There's an open and active 5 6 investigation into the matter that's being conducted by professional standards as well as detectives of the 7 8 12th Precinct, and that's where we are, and that's 9 where we stand currently with that particular issue.

10 The two officers injured -- the officer 11 that was injured in the high-speed chase involving an outside agency off-duty -- my understanding is that he 12 has -- he's at home resting comfortably. That was my 13 14 last update. And with regards to the detective at the 7th Precinct, Detective Sims, he is also home resting 15 16 comfortably, and he's dealing with some serious health 17 issues that he's attempting to resolve, and we ask 18 that you just keep all of our officers in prayer.

19 Reported out to the board -- eleven 20 injuries to officers over the past year, and, you 21 know, certainly because we don't talk about them as 22 often as we should publicly, those officers continue 23 to struggle with getting, you know, some semblance of 24 normalcy back into their lives, not necessarily to 25 come back to work. We just pray that they recover and



1 get a quality of life for them and their families. 2 And then lastly, for the board's benefit, we've finalized on the construction contractor for the 3 Merrill Plaisance facility. You will remember that 4 Merrill Plaisance is going to be the home of the 5 6 office of the chief investigator, and we look forward to working with this construction company, and I 7 8 believe today they did the final paperwork on the 9 construction company. The transition will take place 10 over the next 12 months, and, of course, the board 11 will be part of the programming of the space, and that is my report. I have a report coming on the body-worn 12 13 cameras with planning in a moment. 14 COMMISSIONER DEWAELSCHE: Thank you, Chief. Are there any questions or comments? Commissioner? 15 16 Yes. Go ahead. 17 COMMISSIONER BELL: I have some concern in 18 reference to the Meijer incident and the press conference that was stated initially concerning the 19 20 officer involved. And then after that we had to -well, the chief had to retreat from his position. 21 I 2.2 think that the chief has a right to speak, as we well know, but I'm concerned about the officer involved and 23 24 the public image in terms of making statements and all 25 the facts are not in.

1 And people rush to judgment behind the 2 chief of police statements. And sometimes I don't 3 think it's fair to the officer involved, and all the 4 parties involved, without knowing all the facts and you responding in a short period of time. 5 6 I understand the whole issue about public relations and all that, but it concerns me that we 7 8 rush to make a certain statement. I'm not going to 9 get into detail, but I think you understand what I'm 10 trying to convey at this particular forum here, 'cause 11 people respond to those statements that it's a 12 wrongdoing, and -- and we don't have all the facts at that particular time. So I would caution that -- in 13 14 all fairness -- that we weigh all of that in terms of holding those on-the-spot, quickly -- press conference 15 in reference to the officer involved -- regardless of 16 17 the circumstance. 18 I just -- it seems like it happens quite often that we respond initially, and we don't have all 19 20 the facts. Not to say we have to have all the facts, but it's almost like, okay, this has transpired, and I 21 22 see some wrongdoing here. I just question, is that, being professional, how we should respond. 23 24 CHIEF WHITE: May I?



COMMISSIONER BELL: Yes, sir.

25

1 CHIEF WHITE: Through the chair, I will 2 certainly share your concerns with the chief of police; however, if we recall the initial press 3 4 conference, the chief indicated at that time that we had limited information and that we were going to 5 6 continue an active investigation and update the community and the board accordingly. I think we have 7 8 to look at each circumstance independently and based 9 on the facts that are presented to us at the time, 10 and, quite frankly, the optics of the circumstance. We had a situation -- without getting into 11 12 the weeds of issues, because it's still an active investigation. But certainly we had a -- an incident 13 14 that the community had the right to know what we knew at the time. It was an ugly situation. Every time 15 16 you use force, it's not a pretty sight. But in 17 addition to that, we had to weigh communication with 18 the community based on what we had at the time and just to provide them with the fact that we're going to 19 20 be transparent based upon what we had. Had we said nothing, I think that would have been inappropriate. 21 22 The chief provided information that we had at the time. We had limited information. 23 We had no 24 audio. We had one or two angles of video. I will 25 tell you that more information came to light. A very,



1 very good investigation was done by both internal 2 affairs as well as members of the 12th Precinct. More facts came to light and, again, being transparent and, 3 4 frankly, maintaining credibility in the community, we had to bring that information forward. 5 6 So, you know, if -- if -- had we not, and continued down path that we were with prosecution, 7 8 frankly, it would have been improper. So I support 9 the fact that the chief of police made that decision. 10 I was part of that decision-making metric, and, frankly, we move on from here. The investigation is 11 still active, and we will be providing yet another 12 13 update as we get more information. 14 COMMISSIONER BELL: Madam Chair, I'd just like --15 16 COMMISSIONER DEWAELSCHE: Yes. 17 COMMISSIONER BELL: -- to make one more 18 comment. Well, my observation -- if I was responding initially, I would say with caution what I witnessed 19 20 was improper, but I did not make that statement. But what I heard, that this information -- what he 21 22 witnessed was proper. Do you understand what I'm 23 saying? 24 So it's an opinion there that we could have 25 opposing opinions sometimes, but we -- if we would

1 pause, which, I wanted to pause. Because what I 2 witnessed, I don't want to respond initially. I had some contact and reference to -- what did you see? 3 4 And what I saw, I was not pleased with what I have known just on what this department presented to me 5 6 about the use of baton. He went through it quite thoroughly, including yourself. So what I witnessed, 7 8 I was concerned. But I just pretty much did not make 9 a public statement to that. That's the point I'm 10 trying make. And I understand that. 11 CHIEF WHITE: 12 COMMISSIONER BELL: Okay. I just --If I can make just one last 13 CHIEF WHITE: 14 point: I did, in fact, watch the video 57 times, each frame, and so, certainly, you know, having been a part 15 16 of Use of Force consent judgment, and have studied 17 uses of force across this country, I will tell you 18 that there's never a time that using a baton looks 19 pretty, ever. So if some circumstances were present, 20 then the acts that you witness, as ugly as they are in that video if certain factors were present, would have 21 22 been appropriate if those facts were there. Unfortunately, the facts that we had at the 23

24 time changed. The facts that we had when the initial 25 statements were made supported the subsequent act, and



1 so when that changed, we felt compelled, because we 2 have a good community reputation. Our community supports us, and we felt compelled to communicate 3 4 those changes to the community. 5 But your -- your concerns are duly noted, 6 and I will certainly share them with the chief of police, and I appreciate the opportunity to present. 7 8 COMMISSIONER BELL: Thank you. 9 COMMISSIONER DEWAELSCHE: Thank you. 10 COMMISSIONER VANN: Madam Chair, somewhat in that same vein -- and I understand the -- the 11 12 leadership incumbency of the chief to defend officers. I -- I get that. I'm a CEO. I understand what it 13 14 means to defend people that you have working for you. I also know that we're in a very litigious society, 15 and a lot of times statements that are used at certain 16 17 points, especially in media, are used against us in 18 court or used against us in a lawsuit, and I think that's some of the caution that maybe I hear from 19 20 Commissioner Bell, if I'm interpreting him right. And I hear it from people in the community, 21 2.2 by the way. And I know we have a community responsibility to go back to them with facts. I think 23 24 it's important that when we're not exactly sure 25 investigations are continuing, et cetera, that's

1	normally what's said in most law enforcement circles.
2	Rather than rushing to any judgments and again, I'm
3	taking into account that officers are being supported
4	and protected as much as they possibly can by
5	leadership, and I respect that.
б	But I would I would hope that we'd be
7	careful a little bit about it as well because of the
8	litigious nature of statements and press conferences
9	that are given, just so that we know until we know
10	exactly where things are going. That's just a
11	comment, but I I kind of hear what Commissioner
12	Bell is saying, and I've heard a number of people,
13	significant people in the community, who've had some
14	criticism as to some of those media pieces.
15	COMMISSIONER DEWAELSCHE: Thank you,
16	Commissioner.
17	COMMISSIONER CRAWFORD: Through the chair.
18	COMMISSIONER DEWAELSCHE: Yes,
19	Commissioner.
20	COMMISSIONER CRAWFORD: Yes, ma'am. Also,
21	to I'm not going to belabor this or expound on what
22	Commissioner Bell said; however, I do concur and
23	also Bishop Commissioner Vann. And and like
24	Commissioner Vann, I received a number of phone calls.
25	We had a number of social media posts and stuff in

reference to statements that were made. So I'll just leave that there, but also, too, on the issue of Meijer, where are we in terms of the status of secondary employment? Has that changed since this incident? We still have an officer there, or are there two officers there?

CHIEF WHITE: Well, whatever major 7 8 incident -- through the chair. Whatever major 9 incident happens, you know, we don't miss an 10 opportunity to learn from it and make improvements, so we've made some changes. Number one, the officer in 11 12 question has been suspended from, certainly, the Meijer account, and suspended also from secondary 13 14 employment till the conclusion and findings -- final conclusion of this investigation. 15

16 With regards to one or two officers being 17 at Meijer, I've met with the lieutenant, Lieutenant 18 Franklin Hayes, who runs secondary employment. He's a very conscientious person. He has had several 19 20 meetings. In fact, one of the -- I believe the CEO --I don't want to misspeak, but a high-ranking member of 21 2.2 the Meijer corporation has reached out, and they have a meeting scheduled, and we're going to make some 23 24 improvements with that contract.

COMMISSIONER CRAWFORD: Yes, sir.

17	you know, take actions and do its due diligence as far
18	as findings within an investigation.
19	What is the policy of use of force? How
20	much force does it take to detain a person is what my
21	constituents are reaching out, you know? You know, we
22	congratulate and applaud officers when they doing
23	right, but when you have a situation like the Meijer
24	situation, we cannot stand back and do nothing from a
25	board of police commissioner's standpoint or a police

1 department standpoint or the municipality standpoint. 2 You know, that -- you know, was the officer working, currently working, at that time? 3 Was he on 4 secondary employment? Was he definitely in a uniform? How long is it going to take, you know, before the 5 6 department or the board takes action? But when our officers are -- are doing a tremendous job in the 7 8 community, we support them. We congratulate them. 9 The community supports them, but we cannot stand back 10 and do nothing, you know? We're talking about use of force, and we talk about that across the country. Now 11 12 it happens here at home. What do we do about that? Where do we go from here? 13 14 COMMISSIONER DEWAELSCHE: Okay, Commissioner. Chief? 15 16 CHIEF WHITE: If I may, through the chair. 17 Certainly we are not engaged in the act of doing 18 nothing. The department has taken significant action, direct action, aggressive action, but the officer is 19 20 entitled to due process, and as I indicated earlier, certainly anytime you use force and you use a baton, 21 22 it is not a pretty sight. 23 The department, on average, has 503,000 24 citizen contacts a year. Overwhelmingly, we do a phenomenal job, and we don't have instances as the one 25



1 we just saw. The circumstances, as it relates to 2 that, are still unfolding. As I indicated initially, we had one set of facts. We found more facts, and 3 4 we're going to probably find even more facts as we interview more people and more people come forward. 5 6 With regards to what is force -- this word was present when we established our force policies, 7 8 their best practices. We are tapped by agencies 9 around the country to look at our force policy. We 10 have a very aggressive use of force policy -- category one through category three -- and we follow a force 11 12 continuum that the State of Michigan mandates at the Michigan Law Enforcement Training Council. So we are 13 14 right in lock, step, and line with every effective agency in the United States of America. 15 16 And I will tell you what the officer was 17 dealing with. When you asked what's force, it's 18 everything from officer's presence to, unfortunately, fatal force, and everything in between, based on the 19 20 amount of force that the officer has to deal with. Our officers practice great restraint. When you look 21

22 at the 11 officers that we have right now that are 23 fighting for their lives, fighting for their health. 24 As it relates to the circumstances that they've 25 encountered, of the 11 officer that are fighting for

their lives, there are three citizens that have been
 injured in these contacts.

3 So I think we practice great restraint. Ι 4 think we have a great relationship with our community. I think we have a tremendous group of leaders. 5 We б have a management awareness system that brings officers to our attention, that needs to be managed 7 8 more effectively, and we do a very good job at that, 9 but the problem is force has to be used. Force is a 10 tool in a toolbox for a police officer, and things like this will happen. 11

I think the chief has led from the front on this issue. The officer has been set down, and if it's found after his due-process rights that he was not acting in accordance with our rules and regulations, we will make the necessary corrections in this organization.

18 COMMISSIONER DEWAELSCHE: Thank you, Chief.
19 Moving on to the next item. We have BOPC standing and
20 as -- I'm sorry. I'm sorry -- a presentation to the
21 board by Attorney Wyrick on curfew, first.

MR. WYRICK: Good afternoon, HonorableBoard.

24 BOARD: Good afternoon.

25

MR. WYRICK: Through the chair. My report



1 pertains to the emergency special curfew that has been 2 implemented in the city of Detroit, specifically just for a three-day period, the three-day period being 3 4 between October 29th and 31st of this year, 2017. It has been implemented many times before since the early 5 6 1980s. Our city was scarred with the image of quote, unquote, having "Devil's Night" in which we saw a 7 8 tremendous increase through that three-day period between October 29th and 31st, in the number of arsons 9 10 and vandalism that occurs to properties within the city of Detroit. 11

Very specifically, during that time way 12 back in 1984, the arsons during that three-day period 13 14 alone was 810 arsons in the city of Detroit. Due to the zealous efforts of the citizens of Detroit, the 15 16 public servants of Detroit, over that 30- or 31-year 17 period, a program, a very effective program, has been 18 implemented called Angels' Night, which, due to the tireless efforts and the dedicated efforts of the 19 20 citizens and the public servants, we've seen a tremendous drive during that three-day period of time 21 22 down to, actually, around 26 arsons as of the last 23 time I retrieved a record back in 2015. Very --24 COMMISSIONER MALLETT: Which is -- which is 25 the average arsons -- average fires on any given



1 night. 2 MR. WYRICK: Right. 3 COMMISSIONER MALLETT: Just so that we're 4 clear. So that's -- that -- that is representative of what goes on by accident on a regular basis. 5 б MR. WYRICK: So, consistent with that, Commissioner Mallett, there's a sense of normalcy 7 8 during that three-day period, which 30 or 31 years 9 ago, of course, there was not. That was extremely 10 problematic. This falls under Section 33 of our city code, which actually pertains to minors. 11 12 There's a general curfew that pertains to minors 17 years of age or under, in general, anyway. 13 14 Where this curfew during that three-day period changes, in the essence, their lifestyle, is that 15 16 during the three-day period the curfew for 15- and 17 16-year-olds or under goes down to actually 7:00 p.m. 18 at night during daylight savings time where it's typically -- during the curfew periods -- it is 19 20 actually 10:00 p.m. at night and 11:00 p.m. at night 21 for 17-year-olds. 22 If minors are caught violating the curfew, for those that are still considered juveniles, it can 23 be considered a civil infraction. For those that are 24 25 17 years old, it can be considered a misdemeanor with



1	a fine of up to \$500.
2	COMMISSIONER DEWAELSCHE: Thank you. Are
3	there any questions or comments?
4	COMMISSIONER VANN: Madam Chair
5	COMMISSIONER DEWAELSCHE: Yes,
б	Commissioner.
7	COMMISSIONER VANN: I've been really
8	curious, as Commissioner Mallett has so aptly pointed
9	out, that if we don't have a problem, why are we still
10	talking about Angels' Night? What what is that
11	about? I just don't think it's relevant for us to do
12	that and, you know, to take one day or one weekend or
13	one three-day period and act as if that's such an
14	emergency when there's crimes and other kinds of
15	things happening on all kinds of days and everything.
16	All of our numbers for a number of years
17	now have pointed to a normalcy during that particular
18	period of time. I just don't understand why we're
19	doing it.
20	COMMISSIONER MALLETT: Madam Chair, if I
21	might
22	COMMISSIONER DEWAELSCHE: Yes, sir.
23	COMMISSIONER MALLETT: Bishop Vann, you
24	remember that during the period when Dennis Archer was
25	the mayor

1	COMMISSIONER VANN: I do.
2	COMMISSIONER MALLETT: there was a
3	moment where the mayor's office thought that this
4	particular series of events was behind us. And, in
5	fact, there was not a vigorous presence of as our
б	attorneys indicated of public servants including
7	police and fire and citizens, and things kind of
8	things blossomed in a way that was not positive. So I
9	do think that part of what we are doing, Bishop, is,
10	in fact, proscriptive. We are remaining in front of
11	this. I don't know when you actually could make the
12	administrative decision that you're no longer going to
13	engage in the effort.
14	People would take advantage, I think, of
15	the absence of the 30,000 citizens that are on the
16	streets to be sure that no more further damage is
17	done, and I just don't know when. I don't have any
18	insight. I know that when we have not, then there are
19	people that have responded to the opportunity as
20	opposed to accepting the responsibility.
21	COMMISSIONER VANN: Well, that was over 20
22	years ago. I remember that.
23	COMMISSIONER MALLETT: Yeah.
24	COMMISSIONER VANN: But I just I just
25	wonder sometimes, you know you can raise a red flag



1	when it's not needed, and I don't know. I just I'm
2	just saying if we back down to to some normal
3	numbers for a number of years, at some point or
4	another we can't do this the rest of our lives,
5	have Angels' Night every year for the rest of our
6	lives. That doesn't make sense.
7	I think that we need to just take a hard
8	look at it. I agree. I wouldn't know the exact time
9	to pull the plug on it. I wouldn't make an
10	announcement about it, you know? I would just begin
11	to draw back some of the, you know I mean, if it
12	was me, that's what I'd do, but
13	COMMISSIONER DEWAELSCHE: Commissioner, if
14	I oh, please. Yeah.
15	DEPUTY CHIEF BETTISON: Deputy Chief Todd
16	Bettison, for the record. I just wanted to talk
17	about, you know, this topic in a different approach.
18	The administration's approach this year has been more
19	so celebrating the "angels" piece of it in the overall
20	celebration. For example, last year one of the things
21	that we did differently on Halloween, October the
22	31st we had "Trick or Trunk" at all the precinct
23	stations, and this year we've even relaxed the curfew
24	on Halloween.
25	So if I heard correctly, on actual



Halloween day the curfew will be normal hours, and we're inviting all the families to bring their children to the precinct stations and fire stations and its recreation stations around the city who will have that celebration. We're raising candy. We're going to have a big, big festivity, and that's what we're really celebrating.

8 And then as far as Angels' Night -- it has 9 morphed from Devil's Night to right now. It's just a 10 big family gathering where community members -- it's the largest gathering of citizens coming out --11 volunteer effort -- in the country. So that's really 12 what we're focused on, and by those yellow/amber 13 14 lights, and everybody looking -- actually, the number of fires during this three-day period is lower than on 15 a normal night. And then, also, it's reflected in 16 17 crime as well.

So I would just say that our approach -- I definitely hear what Bishop Vann is saying. You know, we're looking at it. Nobody knows exactly when to say pull the plug, but we are morphing into a celebration, and that's -- that's what I'd like to add to it.

23 COMMISSIONER DEWAELSCHE: Thank you. And I
24 did want to just -- if I could just make a comment.
25 The officers of the board did meet -- have our



bimonthly meeting with the mayor recently, about a
week and a half ago, and this topic did come up, and
really the discussion is how we will transition from
the Angels' Night activity to a community event,
because thousands of people every year look forward to
this event.

I know this. In Southwest Detroit it's a 7 8 huge activity, and they look forward to the 9 celebrating and, really, celebrating the success of having no more, you know, fires and the numbers that 10 we used to. And so it is still a very important 11 12 event. It's a great PR event for our police department. It's wonderful networking with the 13 14 officers, so, you know, I think the mayor wants to continue some kind of an event like that, but 15 16 recognizing that it's not what it used to be, Bishop 17 Vann, as you pointed out. But we're working on a 18 transition.

DEPUTY CHIEF BETTISON: 19 Absolutely. And 20 through the chair, I would just like to add: One of 21 the things that we did as far as morphing and changing 22 regarding the curfew last year -- it was actually 23 starting to commence at 6:00 p.m. This year we scaled 24 back an hour to 7:00 p.m. And just for the community -- letting everyone know that we really 25

utilize tremendous discretion if the kids have a note 1 2 or have somewhere to be. It is not the police department's position to detain you. 3 4 It's a tool in the toolbox, but if I'm not -- each year since 2013, the number of youth that 5 6 we've detained with the curfew has went down, down, I believe last year we only detained, over the 7 down. 8 three-day period, six youth, so I just wanted to add 9 that as well. 10 COMMISSIONER DEWAELSCHE: Thank you very 11 much, DC. Any other comments? I'm sorry. Commissioner Crawford? 12 13 COMMISSIONER CRAWFORD: Yes, ma'am. 14 Through the chair, I just want to state that from a historic perspective it was the Honorable Coleman --15 16 the Honorable Mayor Coleman Alexander Young that wrote 17 the book and wrote the plan, and as -- for commission -- for Angels' Night, in terms of the 18 organization and mobilization of tens of thousands of 19 20 citizens and also with the work of the Detroit police officers and everyone in this great city participating 21 2.2 over the years. 23 And as Commissioner Mallett stated, it was 24 that year that -- as a matter of fact, it was his 25 first year in office, and Mayor Archer -- the first



1 year in office -- I'll never forget that -- where they didn't pull the book off the -- the shelf and open it 2 up and follow that plan, and thus there was a rise in 3 4 fires and in a number of other activities occurring those three nights. 5 6 And, of course, years thereafter, you know, they blew the dust off the book and continued to 7 8 follow that plan of mobilizing the people in this 9 city. And that's why the -- thus, the arrests and the 10 tensions are down of the youth, and the arsons are down, and, of course, there's more community-oriented 11 12 programs to engage the youth and the citizens in the 13 city. Thank you.

14 COMMISSIONER DEWAELSCHE: Thank you,
15 Commissioner. Any other comments? Questions?
16 Hearing none. Then we have -- thank you, Attorney
17 Wyrick.

18 MR. WYRICK: Thank you.

19 COMMISSIONER DEWAELSCHE: We have a second 20 presentation on body-worn cameras final directive by 21 Ms. Melanie White.

22 MS. WHITE: Good afternoon, your Honorable 23 Board. I am Melanie White, executive manager of 24 policy. Last week we provided you with the 25 preliminary status of the BWC policy, which was

pending at that time, regarding additional corrections and edits that needed to be made on the part of the department.

4 Since that time on October 16, 2017, the BOPC has received an updated draft copy of the BWC 5 6 policy, which includes all of the board's proposed recommendations, including those substantive changes 7 8 as well as those minor edits, and so at this time it 9 is before you for a vote. You received a copy of a 10 summary of the BWC corrections this past Tuesday -you may have received that electronically -- and you 11 12 should probably also have it in your packet at this time. 13

14 COMMISSIONER BELL: Madam Chair -15 COMMISSIONER DEWAELSCHE: Any questions?
16 Comments? Commissioner?

COMMISSIONER BELL: As chair of the policy 17 18 committee, we went through this quite thoroughly in terms of Ms. White working with staff, and so they 19 20 have made the necessary departments to entertain all our concerns, and we have a former draft that we are 21 22 pleased with, as far as the policy committee, and that she indicated the full board has been aware of all 23 24 other minor corrections, et cetera.

25

So I move that this board adopt a policy



1 that's been established by DPD with recommendation of 2 the Board of Police Commission. 3 COMMISSIONER CRAWFORD: Seconded. 4 COMMISSIONER DEWAELSCHE: It's been moved 5 and seconded. All those in favor indicate by saying 6 aye. THE BOARD: Aye. 7 8 COMMISSIONER DEWAELSCHE: Opposed? 9 Thank you. The motion carries. Thank you, 10 Commissioner Bell, and thank you, Ms. White. Do we have any standing committees or ad hoc committee 11 12 reports? Hearing none. Then our next item is the 13 report from the board secretary, Mr. Hicks. Thank 14 you. 15 MR. HICKS: Thank you, Madam Chair, and I 16 am mindful that a good part of our agenda involves a 17 closed session. I did want to point out that there 18 were five items that were brought to the attention of the board, and you see them listed on the -- on the 19 20 agenda. Having said that, in the interest of time, 21 that concludes my report. 2.2 COMMISSIONER DEWAELSCHE: Thank you, 23 Secretary Hicks. 24 COMMISSIONER MALLETT: Great report. 25 COMMISSIONER DEWAELSCHE: Thank you,

7	Bettison come back to the mic to report on the
8	Neighborhood Police Officers Conference this past
9	Saturday. In my opinion, myself, Commissioner Brooks,

12	shooters that we all appreciated, because we can all
13	utilize that type of information.
14	So the conference was well attended, but
15	you are the organizer, and I think Chief Craig did an
16	outstanding job in terms of his remarks, in terms of

18	But as you know, the architect who did all
19	the legwork is the man standing in front of us, so I'm
20	going to get now I wanted to say, also, on Friday
21	that 28 officers graduated from the police academy
22	after six months of training. It was outstanding to
23	see these young people. There was international
24	vetting of these officers, coming across the state,
25	received their badge I would say the badge.

1	And acting Investigator Akbar here we
2	had the opportunity to spend Monday with them, a
3	couple hours, and we were very impressed with the
4	caliber of people that we going through the
5	academy. We don't take that very lightly. And that
б	type of interaction, the Q and A, and just to get some
7	background on these officers before they walk off the
8	stage I just couldn't say enough. With Gail
9	Oxendine, Commissioner Brooks, and others who worked
10	towards that recruiting effort to get a finished
11	product to actually walk across this stage, I just
12	want to compliment DPD in terms of the graduation, so
13	
14	COMMISSIONER DEWAELSCHE: Thank you for
15	those comments. And, please, DC Bettison?
16	DEPUTY CHIEF BETTISON: DC Bettison, for
17	the record. I just want to thank the board, and then
18	thank my team, and then thank the members of audience
19	as well, because without you all it wouldn't have been
20	a success because you know, to spend your Saturday,
21	you know it started at eight o'clock in the
22	morning, and you all stayed the whole day, and then we
23	had at least about 225 folks there, and the feedback

12	have to be in a heightened state of alert, not only
13	the police department, but our citizens as well. So
14	thanks, everyone.
15	COMMISSIONER DEWAELSCHE: Thank you, sir.
16	Any other comments?
17	COMMISSIONER VANN: I would just add, Madam
18	Chair, that, yes, we've been actively engaged and
19	involved with the department with regard to evacuation
20	measures, terrorism measures, et cetera, et cetera,
21	with my security team, and it's been a very rewarding
22	experience, and I want to thank Deputy Chief Bettison
23	for his leadership in that area, and he's been able to
24	pull a number of us together and make sure that this
25	would take place. And it is needed because these are

Then we have changed the agenda so that we can have 7 8 oral communications at this time in public comments. 9 We did pass around some cards earlier. 10 churches or at Wayne County Community Colleges. They 11 have plenty of rooms and parking spaces, and would be 12 less costly. You can alternate the summits by having 13 them on the east and west side of Detroit. Please 14 consider this proposal. Thank you.

15 COMMISSIONER DEWAELSCHE: Thank you. 16 Chief?

17 CHIEF WHITE: Thank you for bringing that 18 matter to our attention, ma'am. I will make sure I 19 communicate your concerns to the chief. DC?

20 DEPUTY CHIEF BETTISON: Just one point of 21 correction and clarification -- no tax-payer dollars 22 were spent on the summit. My name is Eric Blount, lifelong resident of the city. 3 4 I'm glad to hear that my concerns over the past year about body-worn cameras is now going to be fulfilled. 5 6 I think it's important that we get that presentation available to us so that we know ahead of time before 7 8 anything happens -- what are the rules and regulations 9 as far as who can see those, the tape, from the 10 body-worn cameras. 11 Bill Proctor was here not that long ago, 12 and he has reached out to me for support and -- just so we all know what -- what the rules are. Thank you. 13 14 COMMISSIONER DEWAELSCHE: Thank you. Chief, would you like to respond? 15 16 CHIEF WHITE: I'd be very happy to provide 17 the community with a presentation on body-worn 18 cameras. I would like to acknowledge the team, if I may, and we'll tell you that we are committed to 19 20 working transparently in providing information. As you know, the board has finally had an opportunity to 21 2.2 go through the policy. We had to make some changes. There was a delay on our end -- the police department, 23 24 not board. I don't want to present that as such. But 25 the people that do the work -- I get to sit here and

tell you about the work, but I wanted to show you the people that do the work.

Can the member -- members of the body-worn 3 4 camera committee please stand, please? Trisha Stein, director of administrative operations; Lieutenant 5 6 Franklin Hayes -- that's the secondary lieutenant, as well. He started the body-worn initiative. 7 The 8 police officers started the body-worn initiative. He 9 took it and ran with it; got the grant secured along 10 with Director Stein.

11 John Watkins, one of the best policy writers, I think, in the country, to be honest with 12 13 you, put together a very good policy, has a great 14 working relationship with your team. We implemented a lot of the rules changes. And William Sims, a 15 16 lieutenant who is in charge of the civil rights 17 division -- civil rights division is not going away 18 because the consent judgment is gone. It does outstanding audits, looks at uses of force -- proper 19 20 uses of force, improper uses of force -- training, and he also heads our body-worn camera division. So thank 21 22 you.

23 COMMISSIONER DEWAELSCHE: Thank you, all.24 Thank you, chief.

MR. BROWN: Ms. Smith -- Madam Chair,



1 Ms. Smith will be your last speaker. 2 COMMISSIONER DEWAELSCHE: Thank you, sir. 3 MS. SMITH: Bernice Smith, political 4 activist also. Also, you are very, very efficient in regards to getting your information with the Meijer. I spoke with people -- 'cause that's the store I go to every weekend, and I spoke with some of the employees there that was close to the incident, and they got a different story altogether, which I will repeat to you.

12 In the meantime, I suggest that you check 13 the two security -- store security people that were 14 standing on the side of the officer, 'cause that's 15 their policy. They're supposed to be there. I said 16 that last week, and, again, I repeat, they are 17 supposed to stand on the side. So they have plenty of 18 information in regards to what happened.

Also, you have a police in the lot that's surveying the lot in a car, so he could have been in the -- in the incident also. He could have been there to help him out, but do a thorough check in regards to that incident, because I think you have more on your side than what the Meijer have on theirs. And I thank you for your time.
