5	A.C. WHITE: Afternoon everyone.
6	VICE-CHAIRPERSON BELL: Thank you, sir, for
7	your attendance. And Assistant Chief White, you want
8	to introduce any staff members or DPD members at this
9	time?
10	A.C. WHITE: Yes. We have our Labor
11	Director. Sir, could you state your name again because
12	I always for get your last name.
13	MR. VALLIE: Rodney Vallie, Manager for
14	Labor.
15	A.C. WHITE: Thank you for being here.
16	Lieutenant Murpheson on my staff runs secretary
17	employment and you also run planning and accreditation
18	And then we have Commander Commander Simms behind him,
19	professional standards, and that's it.
20	CHAIRMAN NELSON: Thank you, sir. At this

5	motion carries. The next item of business would be the
6	approval of the minutes from Thursday, November 12th,
7	2015. And you received the minutes prior to and also
8	in your package. What is your pleasure for approving
9	the minutes?
10	COMMISSIONER: So moved.
11	COMMISSIONER: Support.
12	VICE-CHAIRPERSON BELL: It's been moved and
13	supported. Those in favor aye?
14	COMMISSIONERS: Aye.
15	VICE-CHAIRPERSON BELL: Discussion? I should
16	have said that before. Nays? Motion carries. Thank
17	you.
18	And the Chair is not here to report, but I
19	just want to share this with the Board that on December
20	the 10th at our Community meeting that we had a brief
21	conversation upstairs with the Board Secretary Linda
22	Bernard, and on that date we will be receiving our duly
23	charted power back so that was a community meeting at
24	6:30. So I think we should entertain, have some type
25	of light reception afterwards or whatever's

We had an opportunity to meet with the mayor
a week ago. He indicated after we made a request that
he should be attending one of our meetings, and that
might be one of the meetings that we might want to
invite him to if the schedule's not conflicted. Also
any other council members, especially Council President
Brenda Jones and Councilwoman Mary Sheffield had an
opportunity to interact with them last night Councilman
Cushinberry. So I think we should extend an invitation
to any other past commission, etcetera. In other
words, if the Board of Secretary and Linda Bernard, of
course with the Chair would work that up and come up
with some recommendation, I think that would be
appropriate so I just want to throw those feelers out
now so you can plan your schedule accordingly in terms
of that historic date in terms of December 10 at 6:30
on Linden. And that should be very convenient for
Commisioner Mallett, since he's a west-sider
COMMISSIONER MALLETT: Yes, sir.
VICE-CHAIRPERSON BELL: Thank you. At this
time, I would like to mention one other item that we
didn't mention that we met the mayor that I asked about
the annual report and he had a chance to read it and he

said yes, he hadn't read it thoroughly, but he was

1	highly impressed as to who worked it up, and I gave
2	credit to our Board Secretary, George Anthony. He was
3	very impressed with our annual report and to receive
4	that. So I just want to give a proper acknowledgement
5	at this time. I don't think we mentioned that before
6	that he was pleased and hopefully we can do the same
7	thing in 2015 in terms of annual report in a timely
8	manner.

So on that note, at this time, I would ask your Chief Investigator Pamela Davis-Drake to come forward with with OCI monthly update.

C.I. DAVIS-DRAKE: Thank you, Mr. Vice-Chair and good afternoon, Board.

COMMISSIONERS: Good afternoon.

C.I. DAVIS-DRAKE: All right. Our statistics for today, Thursday, November 19th are as follows: We currently have 184 cases on record. We have 23 cases that have either been submitted to myself or to a supervising investigator for review and we have no cases that have been submitted over 90 days.

The number of complaints for October 2015 are as follows. We had a total of 88 cases during that month that were submitted, 103 last year at this time. So that represents 15% decrease in the number of cases from last years. And just a point of reference, they

1	continue to decrease. The overall cases there is a 15%
2	decrease in the overall number of cases.
3	At the end of October, the Office of the
4	Chief Investigator had 212 open cases, 950 cases were
5	filed, and 930 cases were closed. Those are overall
6	numbers.
7	Of the 88 cases filed in on October 2015, 34%
8	involved unknown officers. The alleged known officers
9	involved leading in complaints were the 8th precinct
10	and at 8%, the 9th precinct at 7%, and the 6th precinct
11	at 6%.
12	The 88 cases filed in October 2015 involved
13	157 allegations where the leading area for concern were
14	procedure at 29% demeanor at 24%, service at 14% and
15	property at 10%. Just point of fact, procedure and
16	demeanor have always been at the highest number of
17	complaints or allegation.
18	Closed complaints for the year. 98 cases
19	were closed in October 2015 and they involved
20	allegations where the findings were as follows: Not
21	sustained 40%, exonerated at 17%, unfounded at 15% and
22	sustained at 13%. The leading cause of concern in the
23	98 cases were as follows: Procedure 35%, demeanor at
24	30%, service at 12% and force at 7%, and that concludes
25	my statistical report. Are there any questions?

1	VICE-CHAIRPERSON BELL: Commissioners?
2	COMMISSIONER CRAWFORD: Yes, ma'am, through
3	the Chair, sir. The caseload or workload of the
4	investigators in the distribution of the cases, how's
5	that done, because I read all the citizen complaints
6	that I get and review, and I notice there are certain,
7	I guess you call them teams or something. I get a lot
8	from particular teams. I don't know if that's just by
9	random or whatever, but I was curious about the
10	distribution in terms of the workload. And also, too,
11	the course and number of the investigators that you
12	have.
13	C.I. DAVIS-DRAKE: We currently have 15
14	investigators. Again, as I stated last time, I
15	provided a report to the Board, I believe that was on
16	the 9th, that we are interviewing and will be
17	interviewing very shortly for the one replacement of
18	one investigator.
19	In answer to your other question about the
20	distribution of cases, it is very fair and impartial.
21	We have a list that are administrative assistant
22	reviews on a regular basis and she just assigns the
23	cases as the names pop up. So it is in order of teams.
24	But each team, we do kind of a round-robin, so each
25	team gets one case and then they go to the next team,

1	that team gets a case and then as follows. So it's
2	very very random and it is very impartial.
3	COMMISSIONER CRAWFORD: Yes, ma'am. I was
4	just concerned make sure that no one's overworked or
5	underworked.
6	C.I. DAVIS-DRAKE: No, sir, that is my
7	concern as well.
8	COMMISSIONER CRAWFORD: The work is getting
9	done.
10	C.I. DAVIS-DRAKE: Absolutely. The work is
11	getting done and we are fair in the distribution of
12	cases.
13	COMMISSIONER CRAWFORD: Yes, ma'am. Thank
14	you.
15	C.I. DAVIS-DRAKE: You're welcome.
16	VICE-CHAIRPERSON BELL: Any other questions
17	or concerns?
18	C.I. DAVIS-DRAKE: Thank you.
19	VICE-CHAIRPERSON BELL: Thank you. I'd like
20	to recognize that Commission Donnell White has joined
21	us about five minutes ago. Thank you for your
22	presence. And also Deputy Chief Washington and also
23	Director of Personnel Gail Oxendine is in the house.
24	Thank you for your presence.
25	Any others that might have okay. If not,

1	I guess we move over to Assistant Chief White.
2	A.C. WHITE: Good afternoon. Once again, the
3	Chief had a meeting with the union calls for his
4	attention so he could not make it today.
5	For my report, crime continues to trend in
6	the right direction. It's down across the board.
7	Officers are doing a phenomenal job out in the field.
8	A couple of things of note. As you all are aware, this
9	past week we had an officer from the 9th precinct shot.
10	The officer has been released from the hospital and is
11	recovering at home resting and is doing very well,
12	thank goodness.
13	Also, there's a detective, Detective Danielle
14	Harrison, who is fighting a very courageous battle with
15	cancer, so keep her in your thoughts and prayers,
16	please. She's also home resting comfortably after a
17	recent procedure.
18	My report will be very brief. The 5th
19	precinct we're excited that that's coming on line very
20	soon, 3500 Conor. It is going to be quite the
21	facility. A lot of the, a lot of the efficiencies we
22	want to get in all the precincts are going to be in
23	that particular precinct, particularly the security
24	doors on that precinct will be similar to that that you



see at banks. When you come in, you'll go through a

1	scanning system, and that's significant because that
2	allows us to put that officer back on the street who's
3	sole job it is to do that screening process. So that's
4	a win for us. But besides that, the entire facility is
5	state of the art.
6	The work station for the officers computer
7	technology that's going in the building will be a very
8	fine building that the Department will be proud of for
9	years to come. So once we get a firm day on the
10	opening, I'll make sure the Board's aware and can
1	attend the opening for that building.
12	And then lastly, we are still working on
13	identifying a contract. I think our contract was
4	identified, I have to check with GSD for the build-out
15	of Merrill Plaisance, which is the location that the
16	chief investigator will be housed at going forward. So
17	with that, any questions?
18	VICE-CHAIRPERSON BELL: Questions? Concerns
19	commission?
20	A.C. WHITE: Okay. That's my report.
21	VICE-CHAIRPERSON BELL: Thank you, sir.
22	Standing committee reports? If not, we would move to
23	new business. And Mr. Burton is this new business

20	referencing the fiscal or calendar years?
21	COMMISSIONER BURTON: Beginning from 2016 to
22	2017.
23	DIRECTOR OXENDINE: Okay. The calendar years
24	of January through December?
25	COMMISSIONER RURTON. Vas malam



1	DIRECTOR OXENDINE: So we currently have
2	we're looking to fill all the vacancies. That's
3	probably the short answer. And we have over 200
4	vacancies at this time. So that's our goal is to fill
5	all the vacancies with respect to the budget.
6	COMMISSIONER BURTON: Okay. And is it true
7	that right now we have 1470 some officers currently
8	right now to date for this month?
9	DIRECTOR OXENDINE: At the rank of police
10	officer, we do have 1478. With respect to total sworn
11	officers, we have 2246.
12	COMMISSIONER BURTON: Thank you.
13	DIRECTOR OXENDINE: You're welcome.
14	COMMISSIONER MOORE: Through the Chair.
15	VICE-CHAIRPERSON BELL: Yes.
16	COMMISSIONER MOORE: It was stated in the
17	record that there would be an academy class once a
18	month. Is that true?
19	DIRECTOR OXENDINE: That is our goal. We are
20	struggling to get a class every two months. So we're
21	starting another class on Monday. That's eight weeks
22	from last class that we started and, unfortunately, we
23	only have 17 candidates in that class. So it is
24	difficult to get a number of candidates. Our goal is
25	25 to 30, but we continue to strive and work towards

2	COMMISSIONER MOORE: Is there anything the
3	Board can do to assist you in your efforts?
4	DIRECTOR OXENDINE: Continue to spread the
5	word that we're hiring. Pass out those little cards
6	that you got. Continue to spread the word that we're
7	hiring.
8	VICE-CHAIRPERSON BELL: Commissioner Brooks?
9	COMMISSIONER BROOKS: Police academy. Is our
10	academy free or do the students pay?
11	DIRECTOR OXENDINE: The academy is free.
12	COMMISSIONER BROOKS: Thank you.
13	VICE-CHAIRPERSON BELL: If I might add, we
14	have one of the top notch academies and we've been
15	interacting, looking forward to interacting with the I
16	guess the class was scheduled for January. Any other
17	commissioners, once we set a date, we will share that
18	with you in case you want to take an hour block, just
19	speak directly to the academy and they will do
20	something in terms of exchange. Appreciate that.
21	I understand, I looked at your report again,
22	the extensive recruiting effort, you are out there in
23	terms of recruiting.
24	DIRECTOR OXENDINE: We are.
25	VICE-CHAIRPERSON BELL: You cover a broad

1	base and I'll share that all the time in terms of my
2	community activity. I hope other commissioners too is
3	to advocate that we are recruiting and we need good
4	qualified people.
5	DIRECTOR OXENDINE: Yes, sir.
6	COMMISSIONER VANN: Mr. Chair, I just wanted
7	to follow up on something I know we discussed before,
8	that you've given us some information on with regard to
9	the attrition that we received from officers having
10	been trained by Detroit, which has a superior training
11	apparatus as we have spoken of, but are there some
12	safeguards in place? I think we alluded to this
13	before, but could you reiterate the safeguards that are
14	in place with regard to the amount of service that an
15	officer must give after they've been after they've
16	come to the academy?
17	DIRECTOR OXENDINE: That currently is not in
18	place and there has been an attempt in the past to put
19	those safeguards in place. And there were some legal
20	issues with respect to that. However, the mayor is
21	currently taking another look at that. And doing some
22	research with the law department to determine what
23	safeguards are possible.
24	COMMISSIONER VANN: Okay.
25	COMMISSIONER CRAWFORD: Through the Chair.

Yes, ma'am. And perhaps the attorney could speak to
this in terms of those safeguards because I'm very
familiar with years ago where there was an attempt to
as a matter fact, the current Deputy Mayor was Police
Chief at that time when we tried to put some safeguards
in place to prevent people from leaving, or if they
left, at least reimburse the City of Detroit for the
training. At that time, I think it was like 50 to
\$100. I know it's much more now today per recruit.

I understand about the legality of it, but I think it needs to be taken to another level, perhaps to the state legislature. Maybe I need to talk to my state rep and those of us on the Board perhaps could talk to ours in terms of the State connecting with MCOLES to put something in place because it's not only Detroit and Detroit Police Academy, but all the other academies that exist around the State of Michigan perhaps. And I'm sure these other police chiefs of all these other police departments in the state and even mayors of all these other cities would prefer to have something in place where an individual upon graduation of the academy there's some sort of commitment there, you know, to stay within that, to stay with that police department for two years or something of that nature or reimburse the -- or prorate it, even reimbursement for

1	the training because we I mean we've been going
2	through this for years with Detroit. Some people, they
3	walk across and they graduated in one hand, they
4	graduated in the other hand. Two weeks later, they're
5	gone. They're gone to another police department. And
6	there are police departments in this area that tell
7	people go to Detroit. Get your certification. Come
8	see us. So we may need to take it to, you know, on the
9	level of the state and connect with MCOLES. And I will
10	talk to my state rep and try to see if there's anything
11	we can look at in terms of that because we just need a
12	commitment. And I'm sure all the other cities in the
13	state of Michigan do too.
14	DIRECTOR OXENDINE: We'll take it under
15	advisement.
16	VICE-CHAIRPERSON BELL: Thank you, ma'am.
17	Any other questions or comments?
18	COMMISSIONER MOORE: Just one final comment,
19	Mr. Chairman. I think it ultimately as you well know,
20	Director, a safety issue because we are losing more
21	officers a month than we are gaining. So I just think
22	that all hands need to be on deck and that needs to be
23	a critical cornerstone going forward with the Police
24	Department and recruiting.



A.C. WHITE: And I will say in answer to

24

1	that, you are correct, sir. We are working diligently
2	to get the officers back to the street. As I have
3	alluded to in the past, the director is working at the
4	top of the program to civilian-ize those programs that
5	we can civilian-ize and that's a tough tough task
6	because you have to train and redeploy those officers
7	to the street. We are looking at every hand that we
8	can put on deck and avail them to patrol.
9	COMMISSIONER MOORE: In addition to the
10	recruits.
11	A.C. WHITE: In addition to the recruits.
12	VICE-CHAIRPERSON BELL: Thank you, Director
13	Oxendine. Thank you Assistant Chief.
14	DIRECTOR OXENDINE: Thank you.
15	VICE-CHAIRPERSON BELL: With all our
16	concerns.
17	At this time I guess we move to oral
18	communication from the audience. Just please come
19	forward to give your name and you have two minutes and
20	this is your opportunity to speak to the Board.
21	MR. WELLBORN: Afternoon, Board. Bill

6	I know the 5th was suppose to move into the building
7	January, and I understand they haven't moved yet. And
8	I had a lot of people ask me the status of the move.
9	Do you have any information on that?
10	A.C. WHITE: Yes, sir. Through the Chair.
11	The 5th precinct you're correct. We were supposed to
12	move in in September, and again, we were supposed to
13	move in October. There were construction problems and,
14	you know, construction delays that are sometimes
15	unavoidable. So the new date is the first week of
16	December for the 5th.
17	The 7th precinct, we're quite a ways away for
18	a permanent home for number 7. The plan right now is
19	to create a temporary situation for them at 3501 Chene,
20	which is the Old Water Board Building. That's been
21	converted to a police operation. Currently now we have
22	gaming operating out of there. We met about a week ago
23	to secure some funding to do a temporary build-out for
24	temporary home for number 7.



VICE-CHAIRPERSON BELL: Okay. Thank you.

1	Thank you, sir. Any other comments?
2	MS. MORGAN: Hello, people.
3	THE BOARD: Hello.

All right. The next thing I want to let you know about. We are having so much crime going on and I do want to recommend to the police department to be careful out here. We're having too many shootings at the police. I don't like it, and I know most of you don't either. But as the Chief has stated, we do not like anyone shooting at the police. I don't like it, and I'm sure all the rest of us that's in this room don't like it. They have risked their lives being on the force and I, again, implore whoever has authority, give them more money. \$14 is not sufficient in my estimation and everybody else for their lives. 


