Resolution & Memorial:

(A) Upon the request of the Chair, **Ms. Teresa Blossom**, BOPC staff read into the record a resolution in Support of Justice Department's Role in Consent Decrees and Law Enforcement Oversight.

RESOLUTION IN SUPPORT OF JUSTICE DEPARTMENT ROLE IN CONSENT DECREE AND LAW ENFORCEMENT OVERSIGHT

WHEREAS In 2003, the City of Detroit and its Police Department entered into two consent decrees with the U. S. Justice

Department to address systemic changes needed for law enforcement, including procedures for police training, the use of deadly force, and the process for arrest and detention of suspects. Today, the police department is better organized and provides better service to the community as a result of the reform process initiated and

completed in 2016 by the consent decrees; and

WHEREAS President Donald Trump's Administration through Attorney General Jeff Sessions is signaling it no longer

intends to fully support police reform through consent decrees like the ones that successfully lead to DPD improvements. On April 3, 2017, Mr. Sessions ordered a full Justice Department review of all consent decrees and reiterated his erroneous belief that federal oversight of police departments is usually unwarranted and stems from the "misdeeds of individual bad actors." His belief ignores facts and evidence that consent decrees do not target a few "bad actors" but rather departments with systemic and often long patterns of civil rights and other constitutional abuses or ingrained problems that undermine the effectiveness of law enforcement,

the strength of police confidence and community relations, and the achievement of justice; and

WHEREAS The consent decree provided the City of Detroit, its police department and its citizens with a clear path for

reform and with a shared goal for ensuring a law enforcement organization that met standards for justice and community service. The Police Department was able to strengthen the quality and professionalism of its police force and operations, emerging as a more organized and constitutional police department. Among reforms, the department significantly reduced serious uses of force and ended the practice of arresting and detaining witnesses without a warrant. Furthermore, the department established an audit team of sworn and civilian auditors to track the performance of all aspects of the DPD and added compliance liaison officers, along with an Inspection Unit and a Force Investigation Section to help ensure acceptable police practices from the

precinct to the command levels; and

WHEREAS The Justice Department review and evaluation, along with court oversight, provided valuable feedback and

technical assistance to ensure that DPD's reform efforts were embedded and sustained for the future. The city of Detroit, its residents, and its stakeholders today have a stronger and better law enforcement serving the community, and the Department acts daily with a renewed commitment to being known as one of the best in

law enforcement; and

WHEREAS Detroit's experience and outcomes show the benefits of federal oversight. Indeed, other mayors and civic leaders in communities with police departments under consent decrees have spoken out against Attorney

General Sessions reducing or possibly ending federal oversight, including Mayor Catherine Pugh of Baltimore, who will "strongly oppose any delay in moving forward" with the new decree for her city. Also, according to criminologists, many other communities have benefited from the role of the Justice Department in reviewing law enforcement for patterns and practices of abuse and have used the federal assistance to make changes even when no consent decree was involved.

NOW THEREFORE BE IT RESOLVED

That the Detroit Board of Police Commissioners, speaking for the citizens of Detroit and the Detroit Police Department, calls upon U.S. Attorney General Jeff Sessions to heed the evidence of systemic law enforcement abuses and discrimination in many U.S. cities and towns and to maintain the use of consent decrees and other tools of the Justice Department's federal oversight for the essential protection of citizens and their civil rights.

WHEREAS Mr. Walton's community involvement includes: Sponsoring the Eleventh Precinct's Breast Cancer Awareness

Luncheon, The Detroit Police Department's Reserve Officers Retirement Luncheon, Eleventh Precinct's Annual Police Week activities, National Night Out, Eleventh Precinct's Community Relations Council Christmas Party,

and the Eleventh Precinct's Beautification Project.
