Again, I thank you for allowing me to serve as your Detroit City Councilman and I look forward to our continued growth and prosperity.



Parental Leave



The City of Detroit is proud to announce the implementation of a Paid Parental Leave program effective January 1, 2023. This initiative, spearheaded by Councilman Scott Benson, places us among many progressive municipalities that recognize the value of supporting new parents during a crucial time in their lives. Eligible employees who are full-time, civil service or regular appointed, and in good standing, may receive up to six weeks of Paid Parental Leave for the birth,


adoption, or foster placement of a child. To be eligible, employees must be active and have worked at least 1250 hours during the 12 months prior to the life event.

This benefit runs concurrent with FMLA, and if an employee exhausts their FMLA, they will still have six weeks of Paid Parental Leave to use. Leave must be taken on a continuous basis. The process to apply for Paid Parental Leave is simple. Eligible employees can complete and submit a

Parental Leave Request Form to absenceleavemgmt@detroitmi.gov or apply online at https://myleavecod.presagia.com/iZoneWeb/.

The implementation of Paid Parental Leave is a huge benefit for new parents, and we are proud to offer this support to our employees. We believe that this program will have a positive impact on our workforce and will help to attract and retain top talent in our city.

Neighborhood Beautification Program



Councilmember Scott Benson joined other elected officials and community groups to celebrate the 34 recipients receiving the City's Neighborhood Beautification Program (NBP) grants. The new program gives Detroit groups from \$500 to \$15,000 to help improve and beautify their blocks. This year, almost \$500,000 will be awarded to winners all over the city, including every Council district.

The NBP grants provide funding for Detroit-based neighborhood associations, block clubs, faith-based organizations and nonprofits that currently own the property where they want to carry out a project. The program was created to support three types of projects:

clean-up activities, community gardens, and public spaces and activities.

The funds can be used to fuel creative ideas, spark neighborhood revitalization, or strengthen connections between neighborhood-based groups. The City of Detroit will provide resources to allow the eligible organizations and residents to become actively engaged in the health and well-being of their community and to encourage residents to get involved in making their neighborhood better.

For those hoping to beautify their community but do not own the land, the Neighborhood Beautification Program will assist organizations with purchasing or leasing vacant

lots owned by the Detroit Land Bank Authority. Up to 50 projects a year will receive funding.

The next application round opens early next year, and organizations will be able to apply then at waynemetro.org/neighborhood-beautification-grant. For more information, residents can e-mail Wayne Metro at NBG@waynemetro.org or call (313) 388-9799.

NSO celebrates completion of Detroit Healthy Housing Center



City and state leaders, along with the local community, have celebrated the completion of the Neighborhood Service Organization's Detroit Healthy Housing Center, which marks a key step in the fight to end chronic homelessness in southeast Michigan. The center is a 56-bed facility that pairs emergency shelter with wraparound health care and support services, and it's the second and final phase of NSO's Healthy Housing Campus, a \$22 million comprehensive site aimed at offering an innovative approach to stop homelessness.

The Detroit Healthy Housing Center focuses on those experiencing homelessness, including those medically at risk, offering transformative health and social services for its residents and community. It helps these unhoused individuals transition into permanent housing, with a 17-bed medical respite program for posthospitalization in Detroit. The 360 Neighborhood Wellness Center. a Certified Community Behavioral Health Clinic, is also integrated into the center and offers primary care, behavioral health, and dental services open to the public. The center offers a holistic, first-ofits-kind approach to pair access to healthcare with efforts to end homelessness, which will relieve stress on the system of care in Detroit. NSO's president and CEO, Linda Little, noted that "Equity is about meeting people where they are to address their needs. Our healthy housing approach is created to do just that."

The first phase of the Detroit
Healthy Housing Campus, the Clay
Apartments, opened in September
2020. The two-story, 42-unit
affordable housing complex in the
McDougall Hunt neighborhood offers
one-bedroom apartments for single
adults. Thirty percent of the units
are designated for individuals with
complex medical conditions. The
apartments are 100% occupied and
offer permanent supportive housing,
which includes supportive services
to address the economic, health,
and social barriers to stability.

The Detroit Healthy Housing Campus was funded through a combination of public and private funding, including a \$4.1 million Community Development Block Grant-CARES from the City of Detroit's Housing & Revitalization Department. Other key funders include the Ballmer Group, Bank of America Charitable Foundation, Bollinger Foundation Inc., The Carls Foundation, DMC Foundation, Gregory Terrell, The Kresge Foundation, KLA Foundation, Rocket Community Fund, Metro Health Foundation, and Total Health Care Foundation.



Grow Detroit's Young Talent to provide summer jobs for 8,000 youth ages 14-24

The ninth year of Detroit's summer work experience program, Grow Detroit's Young Talent, has launched with a goal to provide over 8,000 summer employment opportunities for Detroit youth ages 14-24. In 2022, over 8,000 Detroit youth were employed through the program, and it's the eighth straight year of exceeding the program's target of 8,000. The target budget for GDYT this vear is \$13.8 million, a portion of which will come from more than \$12 million in American Rescue Plan Act funds appropriated for the program last year. The registration portal will remain open until May 31, 2023.

The program was launched in 2015 and has been managed by the City of Detroit's workforce agency, Detroit Employment Solutions Corporation. Despite the COVID-19 pandemic, the program has continued to operate at full capacity every summer. The program is supported by a large number of both big and small companies in the Detroit metro area, as well as major national corporations such as JPMorgan Chase. The program is also supported by the Skillman Foundation, which has historically been one of the most engaged in supporting the goals of Grow Detroit's Young Talent and advocating for youth opportunities in general.

The 2023 program will introduce new enhancements, such as further embedding conflict resolution and problem-solving into the program, incorporating additional financial literacy training, and including additional consumer education to assist young adults who utilize social media in correctly identifying issues that concern the public as well as how to protect themselves. Detroit youth interested in a summer job can apply at GDYT.org, and organizations interested in becoming a sponsor or providing summer work experiences for Detroit youth may also register at the GDYT website.

Motor City Match awards more than \$1.3 million to support 32 Detroit businesses

The Detroit Economic Growth Corporation (DEGC) awarded over \$1.3 million in grants to 32 new and existing Detroit businesses through Motor City Match's 21st round. The funds will support entrepreneurs in establishing new brick-and-mortar businesses and help existing businesses make physical improvements to their buildings.

The businesses include a communityowned grocery store, a training hub for construction trades, a production and education facility for a national fashion brand, and many restaurants, bakeries, and personal care services. The 17 new businesses receiving grants are distributed across 15 Detroit neighborhoods. A total of \$965,000 in grants was awarded to 17 new businesses to open a brick-and-mortar location in the city, while another \$341,000 was given to 15 existing businesses for improvements to their current space, thanks to funding from the American Rescue Plan Act. Additionally, 48 businesses received technical assistance through the program's Business Plan, Develop and Design tracks.

Since 2015, Motor City Match has

awarded over 1,600 businesses, resulting in 143 new brick-and-mortar businesses currently operating in the city. The program has leveraged ARPA funding to increase the number of grants and scope of services available. The quarterly grant pool has been increased to \$1 million for new businesses, while \$250,000 in grants is available for existing businesses operating in the city for at least one year.

Through 21 rounds of the program, 84% of the businesses are minority-owned, 74% are women-owned, and 69% are owned by Detroit residents.

Detroiters are shown how to access \$100M in adult scholarships



Five adult scholarship programs that will allow Detroiters to access a share of \$100m in funding from the American Rescue Plan Act. The funding is designed to help those who are unemployed or seeking training to move into a new job.

The scholarships are divided into five categories, offering assistance for residents at different stages of their career paths. The programs include "Learn to Earn" scholarships for residents who read below an 8th-grade level and "High School Diploma"

scholarships for those scheduled to graduate before 2018, who want to obtain their diploma or GED. There is also the "Skills for Life" scholarship, which offers job opportunities and training in a range of careers, including truck driving, information technology, and healthcare. In addition, the city offers 50 different career training scholarships, including programs in health care, logistics, skilled trades, and hospitality.

Finally, the "Jump Start" scholarship is available for any Detroiter who has been unemployed for at least the past six months, with enrollment open to receive assistance from programs like the Learn to Earn and High School Diploma programs. 
