## **Council Comments/Questions & Answers**

- Is New Freedom still on the table? The ADA Coordinator -Scharron Rambus will consult with DDOT Paratransit to find out the status and report to the LAC members.
- What is the radius for traveling outside of Wayne County? The radius is ¾
   of a mile outside the service area.
- How does a person who need to travel beyond the ¾ of a mile get to doctor appointments, 10 Mile or 12 Mile? The Compliance Manager, Alicia Miller stated that there was a need to transfer to SMART paratransit.
- How is the transfer between DDOT Paratransit and SMART Paratransit set up? The ADA Coordinator will send a follow up email to the LAC members containing the DDOT Paratransit Service Are map, the transfer process between DDOT and SMART Paratransit, and an update on any new Paratransit services.
- Tamara Perrin suggests having ASL at all LAC meetings. Compliance
   Manager- Alicia Miller states that they are present at all LAC meetings.
- LAC members thanked Lakenya Sheffield for her time serving as the ADA coordinator.
- Tamara Perrin stated that she observed a driver vaping. How to report it? Compliance Manager Alicia Miller stated that DDOT has reasonable suspicion. To call immediately.



- Tamara Perrin asked if the drivers had conflict resolution training.
   Compliance Manager Alicia Miller responded yes, DDOT calls it deescalation training.
- ADA Coordinator Scharron Rambus shared his contact information with the LAC members.
