- 1 VICE CHAIRPERSON SMITH: It is now 6:30 PM, I would
- 2 like to call this meeting into order. My name is Tamara
- 3 Liberty Smith. I am the Vice Chair of the board. Thank
- 4 you and welcome. I would like to announce Reverend
- 5 Richard White, the third senior pastor of Dexter Avenue
- 6 Baptist Church tonight to give the invocation and words
- 7 of welcome.
- 8 REVEREND WHITE: Alright, well good evening to each
- 9 of you and welcome to Dexter Avenue Baptist Church. I'm
- 10 Reverend Richard White III. I serve as a senior pastor
- 11 here at Dexter, and we are so honored to have you all
- 12 here with us today. So I certainly feel welcome. If I was
- 13 in a church, I would say give the Lord a great hand clap
- 14 of praise, but I don't know if I can do that here. So
- 15 I'll say welcome to each of you. But we are certainly
- 16 honored to have you all here today, and just know that
- 17 the doors of Dexter are always open whenever we can be
- 18 able to serve the community to help to make a difference.
- 19 we are glad to do this. So certainly to each of you, we
- 20 welcome you today. Let us pray. Lord, we come to you
- 21 right now. We thank you for this day. We thank you oh
- 22 God, that you saw fit to wake us up this morning and
- 23 allowed us to see a brand new day. Now, God, we ask that
- 25 anowed us to see a brand new day. 170 m, God, we ask
- 24 you bless this meeting of God, that you would bless the
- 25 deliberations that would take place, oh God, that we may

- 1 that we have a quorum. So I'm asking our acting
- 2 secretary, Mr. Robert Brown, do we have any public
- 3 comments?
- 4 MR. BROWN: Madam Chair, you probably want to do the,
- 5 or you can do the public comments or we can go to the
- 6 Chief Investigator Community Impact Report. It's your
- 7 pleasure. What would you like to do?
- 8 VICE CHAIRPERSON SMITH: Okay, well then I just went
- 9 in the order of this paper. Okay. So we can go to Mr.
- 10 Warfield.
- 11 MR. BROWN: Yes.
- 12 CI WARFIELD: Thank you. Good evening, Madam Chair
- 13 and to the public. Tonight, I want to share with you the
- 14 Office of the Chief Investigator's report as it relates
- 15 to where we are in our case and where we are in our
- 16 improvement plan. I do want to say this, I want to thank
- 17 the board for approving our automated form. It is still a
- 18 work in progress as we continue to improve it, to make it
- 19 more efficient, but we thank you for your vote of
- 20 confidence as we use it as, and as some of you will see
- 21 as you're signing our investigations, that that form is
- 22 actually in play now. And so the reports look different
- 23 from what it did before as you were signing the reports.
- 24 As relates to our ROCI mission statement, the mission of
- 25 the Office of the Chief investigator is to fairly

- lead and strengthen and in power. We ask that you bless
- 2 our police department in a special way. Continue to watch
- 3 over them and keep them and lead them and guide them.
- 4 Bless our chief and his staff, continue to be with them.
- 5 Oh God, we lift up, oh God, this department, oh God,
- 6 these commissioners, we ask so God, that you would bless7 them in a special way, that you would lead them, oh God,
- 8 in their decision making, that you would continue to give
- 9 them wisdom as only you can, oh God, and that you would
- 10 bless them in a special way.

- We ask God, that you would keep them in your care
- 12 and bless all of those who are here, the community
- 13 partners who are here today. Bless them right now God,
- 14 bless all those who are on their way, our God. And we ask
- 15 that you would lead us and guide us and direct us. You
- 16 tell us that if we acknowledge you in all of our ways,
- 17 you would direct our path. God, we need you to direct our
- 18 city. We need your God to strengthen our city. We ask oh
- 19 God that you would be with us and keep us in your care,
- 20 we'll ever be mindful too. Give your name all the praise,
- 21 the honor and the glory is in Jesus name we pray, amen.
- 22 God bless you.
- 23 VICE CHAIRPERSON SMITH: Amen. Thank you. Thank you
- 24 so much for those words, and thank you for allowing us to
- 25 use your establishment. As I look around, I don't think

- 1 effectively and objectively receive, investigate, and
- 2 make recommendations regarding complaints concerning the
- 3 Detroit Police Department and its personnel.
- 4 It is the goal of OCI in improving the quality of
- 5 the life of law enforcement services by instilling
- 6 citizen confidence in the integrity of the Detroit Police
- 7 Department. As we look at our statistics for the month of
- 8 February we want to start with complaints versus
- 9 allegations. In the month of February, we had 121
- 10 complaints in our office. Of those 121 complaints, they
- 11 contain 280 allegations that needed to be investigated.12 When we look at how those complaints came in, the vast
- 12 When we look at now those complaints came in, the va
- 13 majority of those complaints, 67% came by way of
- telephone or 40% came in, walked in online and othervenues that it came in. In the month of February we
- 16 received 121 cases and we closed 56 cases. When we look
- 17 at our team alignments and how those cases were closed
- 18 you'll see that on the screen for those of you who are
- 19 here, for those of you who are online. But combining the
- 20 number of cases that were closed and the number of cases
- 21 that are still in review from February, we have a total
- 22 of 78 cases in house that our investigators have worked
- 23 on in the month of February that are either closed or in
- 24 the process of being closed. And again, those
- 25 investigators that are in rotation are still 12. So we



are still well under the number of investigations that we need to make a significant impact on the citizen

3 complaint reports that are in our office.

4 As we break the allegations down by category in the 5 month of February, about 65% of the allegations came by

way of procedure, service, and demeanor. Procedure

7 represented 27% of our allegations, demeanor represented

8 23% and service 15%. Harassment represented 9%, and the

9 rest of the allegations were under 10%. When we again

10 look at it by category, if you look at the aggregate

11 number, there were 77 complaints for procedure, 64

12 complaints for demeanor, and 42 for service 26 for

13 harassment, and force and property had 21 allegations

14 each. When we look at the command structure as it relates

15 to the Precincts and where the bulk of the allegations

6 we're coming from, we are looking at the 7th Precinct

17 with a total of 19, 8th Precinct with 15 9th pre the 9th

8 Precinct with 18, and the 11th Precinct with 15 for a

19 total again of 280 allegations across the command

20 spanned.

When we look at the number of cases that we have

22 today, we have received just this year alone, 319 cases,

23 just this year alone, and we have closed 116 cases. We

24 also have incorporated 280 cases from the OIG report that

25 our three brand new investigators are working on as we

speak, in an effort to expedite those cases that we

2 received back from the Office of the Inspector General

3 and we are making plans to address the other 550 cases

4 that came over to us as well from the inspector general

5 office. We received the Inspector General, as I said last

6 week, removed about 1,401 cases from our office. We got

7 those 1,401 cases back and 280 of those cases, we are

8 immediately looking into because those are the cases that

were said to be closed without proper investigations. And

10 so letters are going out to all citizens of all of our

11 backlog cases to let them know that your case is in

2 process and that we have not forgotten you, and we are

13 going to investigate all. That's my report, Madam Chair.

14 Thank you.

15 VICE CHAIRPERSON SMITH: Thank you. Thank you so much

16 for your report. Okay. Now, Mr. Robert Browner, acting

17 secretary, do we have any public comments?

18 MR. BROWN: Yes, ma'am, Madam Chair, we currently

19 have 3 speakers and I'll call those in attendance and for

20 the record, Madam Chair, because we'll allow an hour for

21 public comments. The cutoff time is 7:30, so you might

22 want to come back if we get any more, but I'll call those

three in attendance. Ms. Victoria Shah, followed by Ms.Bernie Smith, followed by Ms. Ray Baker.

25 MS. SHAH: Good evening commissioners. For the

1 record, my name is Victoria. I live in District 7, and I

2 see most commissioners are not here today, so please make

3 sure that they get this message. I know that each of you

4 volunteer for your positions and your schedules are

5 challenging, however you signed up for this and much more

6 than once a week commitment is required. Staff have

7 little to no authority to move the business of the board

8 forward without your consistent and timely engagement.

9 Staff is repeatedly put in an impossible position to try

10 to deliver on the goals approved by this board without

11 the board's engagement. How is OCI going to handle

12 citizen complaints without investigators? Last year when

13 I was secretary, I assisted this board through the

14 arduous and lengthy task of getting approval from HR,

15 budget, finance, and you to use excess budget dollars to

16 hire extra investigators.

17 Where are they? The applications were passed to all

18 commissioners at the January 11th meeting. There has not

19 been a personnel and training committee meeting yet to

20 interview these candidates. Candidate lists go stale

21 after this long. People are applying and accepting other

22 positions. This happens over and over and over again with

23 this board, and it's not because of staff, it's because

24 commissioners aren't available to interview. Staff and

25 city recruiting are in the office Monday through Friday.

1 Commissioners are the missing link. The city's fiscal

2 year ends on June 30th, and you're going to leave

3 budgeted funds on the table again as oversight goes

4 unfulfilled. When I resigned, I offered a transition plan

5 to continue to provide assistance to this board. You

6 voted to decline that assistance, and it's just as well

7 because there's nothing that I or any staff member can do

8 if commissioners don't do their part.

9 VICE CHAIRPERSON SMITH: Thank you,

10 MR. BROWN: Ms. Smith.

11 MS. SMITH: Sorry, it's taking me so long though.

12 COMMISSIONER BERNARD: Get your microphone.

13 MS. SMITH: Oh, sorry. All right. Thank you. Good

14 evening to everyone and to my commissioners. I'm not

15 going to say what I want to say because I want to keep

16 that until we go downtown because certain people are not

17 here presently. But I would like to tell the neighborhood

18 that we have a darn good police commissioner. All of them

19 sitting there, they're doing a good job, believe me. Take

20 my word for it. But this is what I want the citizens to

21 know and do. We must end the crime in our city. Enough is

22 enough. We must stop the shooting and the killings.

23 Detroit should be a peaceful city to love and not have

shooting 24 hours a day just about. If you have children still living at home, but not in school, don't have a

- job, check on them and see what they're doing. See what
- 2 their associates are doing. And above all, don't allow a
- gun in your home if it's not registered. And if you do
- 4 have one, put the lock on it so it can't be used by any
- 5 of the teenagers that's in your home.
- If you are not legal and, I'm sorry, the guns in a
- safe place. Check your children's associates, like I 7
- 8 stated. But the main thing is we must respect our police
- department. As you notice, within the last several days,
- 10 they have had shootings at the police, which is totally
- unnecessary. We should have respect for our police
- department and not continuously let the shooting and the
- 13 killing go on. The other day, you had police chasing
- people in their cars going through lights. This is
- 15 totally unnecessary, we're Detroiters, and we are not
- 16 gangsters in this city. And we should act like it, that
- we respect each other. My time is up. All right. See, I 17
- 18 respect you. Thank you so much for listening to me. But
- 19 remember, this is our city. Let's protect it.
- 20 MR. BROWN: Madam Chair, you currently have a quorum,

- COMMISSIONER BERNARD: This is a Resolution from the 1

- 12 Congratulations. Thank you.
- 13 COMMISSIONER BERNARD: Is that it? Have another one?
- 14 I'm sorry. Come on.
- 15 Go here.
- 16 MS. CARTER: I would like to thank the 10th Precinct.
- 17 I've only lived in two Precincts in my whole life. That
- was on Woodworth. I lived in Midtown, what they call
- Midtown now. And then I moved to the Westside. So I was
- 20 always in the 10th on the Westside when I was a teenager.
- And I appreciate all the community relations officers,
- all the 10th Precinct that has helped me so much down
- through the years. I used to be a third chair with
- community relations for many years. I did a lot with
- different organizations. I'm with Oakman Boulevard

- Director of Degrees of Opportunity and former Community
- Relations liaison, as well as working for Safeco/Liberty
- Mutual, where she worked in several different capacities, 3
- including adjuster, account manager, trainer and senior
- 5 subrogation agent.
- 6 Additionally, Ms. Lyles is a former accountant with
- 7 the Treasurer's Office and former senior accountant with
- the Township Office. While this briefly touches on the
- 9 professional background of Ms. Lyes, she has had an even
- 10 more extensive background in community involvement; and,
- 11 WHEREAS Ms. Lyes has a plethora of community
- 12 involvement being active with several organizations and
- 13 boards over the years, some of the organizations include
- Metro Detroit Youth Club support team, the CAC Community
- Advisory Committee for District 5, 10th Precinct Public
- Relations Team, Brilliant Detroit Community Engagement 16
- Board, Brilliant Detroit Dexter Linwood Advisory Board, 17
- Gilda's Club Community Advisory Board, LCBC, Lawrence
- 19 Collingwood, Burlingame Community Block Club. 5 Alive
- 20 Community Interaction for Change, books for Youth and
- 21 DPSCD, Faith-based Partnership. Additionally, Ms. Lyles
- 22 assisted in distributing food to 110 families weekly
- during the pandemic. Ms. Lyles prides herself on the work
- 24 she does with Sister Friends as a mentor, a program
- 25 dedicated to supporting and working with new mothers,

- Community Association now. I've been in my home for 55
- years. I have moved and I want a decent neighborhood
- around me, and that's why I work so hard to have a decent
- neighborhood around me and not let weather creep in, even
- though they closed up the Rite Aid Store. But we'll find
- a place. Thank you so very much. And Ricardo Moore,
- 7 appreciate your kindness.
- 8 COMMISSIONER BERNARD: Thank you.
- 9 MS. CARTER: Thank you.
- 10 COMMISSIONER BERNARD: Our next Resolution is
- 11 honoring Denise Lyles,
- 12 WHEREAS Denise Lyles was born in Detroit, Michigan,
- and when she was a child, her family relocated to East
- St. Louis, Illinois. She spent the majority of her 14
- 15 childhood and early adulthood in East St. Louis and
- 16 attended Southern Illinois University. Family needs led
- Ms. Lyes to return to Detroit in 2012. Since returning to
- Detroit, her passion for her community has driven her to
- be active in several community groups and organizations.
- 20 Ms. Lyles lives by the motto "Don't complain about a
- situation that you are not willing to roll up your 21
- 22 sleeves and try to make better." And,
- 23 WHEREAS Ms. Lyles has a rich and extensive
- 24 professional background. Over the years, Ms. Lyles worked
- with Metro Detroit Youth Clubs, being the former Detroit

- most of whom are young, with no family support; and, 1
- 2 Whereas Ms. Lyes is a god-fearing lady, a mother,
- 3 and someone who loves her family, friends, community, and
- life. Ms. Denise Lyes has a very diverse work history,
- 5 but one thread ties them all together, which is her
- passion for service, making sure she gives her best to

 - incident in the 6th Precinct where officers responded to
 - 5 a person with a weapon. As they got there, a car drove

 - 20 told there were great conversations, there was great
 - 21 dialogue. Some discussions ran deep. There were police
 - 22 officers of all ranks, all races. And that approximately
 - 23 20 men showed up to the event. Also yesterday, Lieutenant
 - 24 Velma Hampton retired after doing 27 years at DPD. And so
 - on Friday, March the 15th, our officer workplace, the

- week, during last week and early probably this week. So

- 2 DC PRITCHETT: Through the Chair. You know, our Peer
- 3 Support is on hand, and what normally happens is that
- 4 when they're involved in whether shots were fired at them
- 5 or they fired shots, they talk to a psychologist, and
- 6 they're put off for a couple days to get their minds
- 7 together. Most officers' take the time off to get their
- 8 minds together. But Peer Support is all over it. They
- 9 offer them, you know, psychological help as well as
- 10 mental help. So the department is very aware of the need
- 11 for officers to decompress and it is available.
- 12 COMMISSIONER WOODS: Thank you very kindly.
- 13 COMMISSIONER BANK: Through the Chair. Deputy Chief,
- 14 it's good to see crime going down in the city. Just want
- 15 to commend Chief White and the commanders of all the
- 16 Precincts. I just hear the numbers going down and that's
- 17 a blessing. I just wanted to get that out there.
- 18 DC PRITCHETT: Thank you. Through the Chair, thank
- 19 you. Chief White is committed and so are the deputy
- 20 chiefs, assistant chiefs and commanders, to ensure that
- 21 the citizens of City of Detroit are as safe as they can
- 22 be
- 23 COMMISSIONER WOODS: As well as, I have seen the news
- 24 reports in terms of the remarkable numbers as it relates
- 25 to, and some of the CVI zones where violent crime is down

- You can submit them directly to us, and we'll make sure
- 2 that they get to where they're supposed to be. But it's a
- 3 very prestigious honor for a woman to be honored at that
- 4 particular ceremony. As a matter of fact, it's the
- 5 highest honor they can receive. That's an honorary
- 6 recognition. Thank you.
- 7 VICE CHAIRPERSON SMITH: Thank you.
- 8 COMMISSIONER WOODS: Yes. I don't know if you wanted
- 9 to respond, Chief?
- 10 DC PRITCHETT: Through the Chair. Yes, the women in
- 11 blue is something that I attend monthly. I mean, yearly.
- 12 It is a great honor. Shinola also donated a watch, and it
- 13 is engraved to the officer that was selected as the
- 14 recipient. There's one for police and one for fire. So
- 15 they both are rewarded and acknowledged during that day.
- 16 So, you know, any DPD, any police women that you would
- 17 like to have nominated, please do so. Like Ms. Bernard
- 18 said you can do it right through the board. You can go to
- 19 any Precinct and nominate a female officer that
- 20 procedure's onboard.
- 21 COMMISSIONER WOODS: Yeah. So the question I have is,
- 22 you said that two officers were shot at in the line of
- 23 duty within the last week, right?
- 24 DC PRITCHETT: Two incidents.
- 25 COMMISSIONER WOODS: Two incidents, right? Are they

- 1 very significantly in terms of, I think even in the 10th
- 2 Precinct area where I believe Aaliyah, Harvey Quinn and
- 3 her group got it down by 70 some percent in this
- 4 particular area. So that was very impressive that you
- 5 guys continue to, or the city is working with the
- 6 residents of the City of Detroit and these CVI groups.
- 7 And it seemed like a great approach there.
- 8 DC PRITCHETT: Yeah. Through the Chair. We couldn't
- 9 do what we do without the community's help. You know,
- 10 it's a partnership and we need them as much as they need
- 11 us. So, I am proud to be part of Chief White's senior
- 12 management team and the relationships that I've garnered
- 13 throughout my years, you know, so, like I said, we can't
- 14 do anything without the community's help.
- 15 COMMISSIONER WOODS: Thank you.
- 16 COMMISSIONER BURTON: Madam Chair, question for the
- 17 Chief. For four weeks, I guess this will make the fifth
- 18 week. I've been raising the question about when it comes
- 19 to data sharing agreements with cities that the city of
- 20 Detroit police department is sharing their data with and
- 21 does their policies match up with the City of Detroit's
- 22 policies
- 23 DC PRITCHETT: Through the Chair. Commissioner
- 24 Burton, I don't have the information at hand, so I can't
- 25 speak on other agencies sharing policy. But what I can do



- 1 is that when I get back to work tomorrow, I'll give the
- 2 law department, Second Deputy Chief Grant Ha, who's over
- 3 our legal, and get the information for you and make sure
- 4 you get it.
- 5 COMMISSIONER BURTON: Thank you, Madam Chair, but
- 6 this has been five weeks we've been raising, you know,
- 7 the concern, especially when an article that was
- 8 published in the Wire. And so a lot of members, not only
- 9 in and around Detroit, but worldwide are talking about
- 10 that article and they want to know about their city and
- 11 their policies. But we definitely want to know about our
- 12 city and do those cities that have a data shared
- 13 agreement with the City of Detroit, does their policy
- 14 reflect the policies that we have? I was once the
- 15 chairperson of the policy subcommittee. Now, I'm
- 16 currently active on that committee with our Madam
- 17 Chairperson Linda Bernard, who happens to chair that
- 18 committee. And this is just a concern because from a
- 19 fiduciary responsibility, policies are definitely in our
- 20 purview, and we like to know if their policies reflect
- 21 ours. And we like to know the name of those cities
- DC PRITCHETT: Through the Chair. Mr. Burton, this is
- 23 my first time being asked that of...
- 24 COMMISSIONER BURTON: Commissioner Burton.
- 25 DC PRITCHETT: Commissioner Burton. This is my first

- 1 Chief White is on it. He's engaged and making sure our
- 2 homicide team knows that it's a priority of this
- 3 department.
- 4 VICE CHAIRPERSON SMITH: And also, have you all
- 5 noticed an influx of missing girls here in the City of
- 6 Detroit?
- 7 DC PRITCHETT: Through the Chair. You know on our
- 8 page each day, each week there's a posting on our page
- 9 that shows a number of people that are missing and how
- 10 many have been recovered. So there are a lot of runaways
- 11 who, initially they are missing, but they are recovered
- 12 because they're runaway. So it's not like there are
- 13 thousands of young ladies being snatched off the streets
- 14 of the City of Detroit. That is not happening. So, like I
- 15 said, we have a page on our DPD page, on our Facebook
- 16 page where it lists the number of missing, the number
- 17 that have been recovered, and how many of those may be
- 18 juveniles.
- 19 VICE CHAIRPERSON SMITH: Okay. Thank you, because the
- 20 communities want to know.
- 21 DC PRITCHETT: Absolutely.
- 22 VICE CHAIRPERSON SMITH: All right. Thank you so
- 23 much. Would that be all of the questions?
- MR. BROWN: Madam Chair, before you bring up the 10th
- 25 Precinct, that information that Commissioner Burton is

- 1 time being asked that request. Like I said, when I get to
- work tomorrow, I will definitely take it to Second Deputy
- 3 Chief Grant Ha of our legal department to get the
- 4 information to you.
- 5 COMMISSIONER BURTON: I appreciate you.
- 6 DC PRITCHETT: No problem.
- 7 VICE CHAIRPERSON SMITH: Thank you.
- 8 MR. BROWN: Madam Chair.
- 9 VICE CHAIRPERSON SMITH: Now I have a question as
- 10 well. For the community, we have the missing 13-year-old,
- 11 and I know it's not much that you can talk about the
- 12 case, but is it something that you could let the
- 13 community know what it is that they can do to help the
- 14 department in the return of her? She's been missing for
- 15 over two months now. Na'Ziyah Harris, who has been gone
- 16 since January 9th, 2024, 13-years-old, missing from the
- 17 Eastside of Detroit,
- 18 DC PRICHETT: Through the Chair. What I can say is
- 19 that she's still missing, we are actively looking for
- 20 her. There are some leads which I cannot get into detail
- 21 with, but if anyone was in that area who might know
- 22 someone that saw when she got off the bus, please say
- 23 something to our Homicide Department. Our 1800SPEAKUP,
- 24 our Crime Stoppers in Detroit. Rewards TV. But we are
- 25 actively looking for Ms. Harris. She is not forgotten.

- 1 requesting, that information has been sent to the
- 2 attorney, the board attorney, as well as the DPD's
- 3 Attorney, Mr. Ha. So he already has that information and
- 4 information concerning the data agreement with the other
- 5 law enforcements
- 6 COMMISSIONER BERNARD: Chair, just quickly.
- 7 VICE CHAIRPERSON SMITH: Yeah, go ahead.
- 8 COMMISSIONER BERNARD: I just want to remind the
- 9 community and really how courageous our Vice Chair has
- 10 been with respect to the issues involving the missing
- 11 young lady. You may have seen her on television this week
- 12 discussing it. She and the Chief. But I want the
- 13 community, when we're talking about this commander, I
- 14 mean Chief, Deputy Chief, I'm sorry. What is the reward
- 15 for information related to this young lady? Maybe we can
- 16 give the community an additional incentive.
- 17 DC PRITCHETT: You know, I don't know what the reward
- 18 is currently, but I know Crime Stoppers do pay and DPD
- 19 Rewards TV as well. So I can't give you the specific
- 20 amount that the reward is up to now.
- 21 VICE CHAIRPERSON SMITH: The flyer says up to 2,500.
- 22 DC PRITCHETT: Okay.
- 23 COMMISSIONER BERNARD: Thank you.
- 24 COMMISSIONER BURTON: Through the Chair. Real
- 25 quickly. You know, I just want to say for a point of



- information, I do not have that information that I've
- 2 been raising for the past five weeks. But also members of
- the community have been raising those same concerns these
- past five weeks. And I think that from a transparency
- standpoint, we owe them an explanation because you know,
- this board is very unique, like most cities, I mean,
- seven of us are elected or appointed, although we do have
- a fifth member of the board that happens to be appointed.
- So it's very from a transparent standpoint you know, the
- public has been raising these questions and concerns. We
- must update them as well. And so far I have not been
- updated, nor do I have that information, but I'm still 12
- seeking the information on data sharing agreements with
- other law enforcement agencies. Do their policies reflect
- the City of Detroit's policies? And so we've been calling
- for this for five weeks. And so I would just like an
- update on when we should receive that and when the 17
- public's going to be made aware.
- 19 VICE CHAIRPERSON SMITH: So we'll make sure that that
- 20 information is re-forwarded to you and that you
- 21 definitely have it. If you haven't received it, I'll make
- sure that it's re-forwarded. Okay. Thank you. So now 22
- 23 we're moving forward to the 10th Precinct's report. Do
- you have your report ready, please? Thank you, my friend.
- 25 COMMANDER ALVARADO: Good evening board. My name is
- Stacy Alvarado. I'm the Commander of the 10th Precinct. 1
- 2 In addition to the NPOs that you all have met, also with
- 3 me, I've brought Captain Michael Dicicco. For the 10th
- 4 Precinct in the first two months of 2024, we are overall
- down 23% in part one crime, specifically in violent 5
- 6 crimes. As of March 12th, we have a 50% decrease in
- homicides, an 84% decrease in non-fatal shootings, and a
- 50% decrease in robberies. We have a slight 18% increase
- 9 in sexual assaults. We have a 10% decrease in aggravated
- 10 assaults, 100% decrease in carjacking. In our part one
- property crimes, we have an increase of 40% in 11
- burglaries, 30% decrease in larcenies, and a 46% decrease
- in motor vehicle thefts. In the 10th Precinct, our
- strategy for violent crime is raids, OTE operations, and
- restoring peace targeted enforcement in high crime 15
- 16 hotspot areas.
- 17 We've increased patrols along the Davison corridor
- with our motor units. We're doing warrant sweeps, MDOC, 18
- home checks focused on perpetrators of gun crimes. We 19
- 20 have a ceasefire initiative app aimed at disrupting and
- dismantling groups and gangs. We target high impact and 21
- 22 known offenders. We mobilize patrol level enforcement
- 23 directed to hotspots. We have a BCJI grant program that
- allows us to fund one car per day for eight hours in key
- areas in ten one, ten two, ten three, ten four, ten five,

- ten six, and ten seven. We are using the burn
- discretionary housing and relocation assistance through a
- 3 pilot program in the 10th Precinct that combines our
- social workers, our PDU, our faith-based coordinators,
- resource coordinators to combat gun crimes. For property 5
- crimes. We have directed patrols based on data in areas 6
- 7 experiencing an increase in property crimes. We conduct
- surveillance in our hotspots. We work with Commercial
- 9 Auto Theft, Vice, other PDUs and collaborative
- 10 investigations for crimes that cross precincts.
- 11 We have deployed focused enforcement and hotspots,
- 12 and we're developing strategies by platoon to address the
- crimes that occur within their hours of operation. We 13
- have a robust PGL monitoring initiative where we 14
- increased physical and virtual checks of PGL locations.
- As you know, our NPOs do an extensive amount of work, but
- 17 I'm just going to highlight a couple of the things that
- 18 they do. They've participated in the Women's walk. They
- 19 have an Easter egg giveaway coming up at the Light of the
- 20 World Church, Bi-Monthly Coffee with a Cop. They do a
- 21 student reading program, Career Vision Day, and they have
- 22
- ongoing Gleaners and Goodwill donation drives. They're
- 23 also organizing our community Walk for Movement March at
- 24 5301 Tireman on March 26th. I believe that's 12 to 4?
- 25 Yes. And that is my presentation for the 10th Precinct.
- VICE CHAIRPERSON SMITH: Alright, thank you. We would 1
- 2 now like to move forward for 10th Precinct Community
- 3 Relations Council, Alvin Stokes.
- 4 MR. STOKES: Good evening, Madam Chair. It's a
- pleasure to make your acquaintance. To the board, my name
- is Alvin Stokes. I am the President of the 10th Precinct
- Community Relations Organization. We are doing great
- things over here at number 10. And we've bragged about
- 9 our NPOs and our officers over here at number 10, who do
- an outstanding job and with the community working with 10
- 11 them. As the commander said, our crime is down. We have
- several block clubs that are organizing within our 10th 13 Precinct. We have new ones, we've got one here, Desoto
- 14 Ellsworth Debo, who's looking to do some things over
- 15 there at Fenkell and Livernois through the Mayor's
- program and make that area a little bit better looking,
- anyway. We have the Dexter corridor that's coming through 17
- 18 here that's going to brighten up this spot. Also, we've
- 19 got block clubs on the other side of Joy Road and Dexter
- 20 that are organizing.
- 21 Matter of fact, I've had five calls this month to
- 22 help organize block clubs here in the 10th Precinct.
- 23 We've got block clubs over there on Davison, who expanded
- 24 their boundaries to include other blocks in that area,
- which is a great thing because some folks don't know how



- to start to organize. So for them to even expand their
- boundaries, to include them was an outstanding thing. And
- 3 I appreciate them over there, Ms. Clarington, and the
- work that they're doing. We are here at number 10. Let me
- ask number 10 just to stand up for a minute. And I like
- to say I would be nothing without this group here behind
- me. They do an outstanding job supporting everything that
- 8 DPD does, and we're just happy to be here, happy to host
- you and welcome. We look forward to the next time. God
- 10 bless you.
- VICE CHAIRPERSON SMITH: Thank you. Before I go to 11
- 12 Public comments, Commissioner Burton would like to
- recognize someone?
- COMMISSIONER BURTON: Thank you. Madam Chair, I want 14
- 15 to know, Madam Chairperson the city's council member, the
- honorable Mary Waters, please rise. It's always a
- blessing to see her out in the community fighting for the 17
- majority of Detroiters. Also want to acknowledge Sam
- Riddle, JD to please rise, who's no stranger to our
- community, who does a great job fighting for the majority 20
- 21 of Detroiters.
- 22 MR. RIDDLE: Thank you.
- 23 COMMISSIONER BERNARD: Just real quickly, I don't
- think the ladies and gentlemen in this room have a copy
- of what was opined as the community presentation. I just

- 1 Chairperson.
- 2 VICE CHAIRPERSON SMITH: Thank you for your reports,
- 3 the addition to your report.
- 4 COMMISSIONER BERNARD: This is in our report. They
- 6 VICE CHAIRPERSON SMITH: So right now we would like
- 7 to move forward with public comments. I know we started
- off earlier without having a quorum, but we would like to
- continue with public comments. So who do we have
- 10 speaking?
- MR. BROWN: Madam Chair, currently we have Ms. Ray 11
- 12 Baker, followed by Ms. Betty A. Varner, followed by CAC
- member, Mr. Scotty Bowman. Ms. Baker.
- 14 PROFESSOR BAKER: Hello, my name's Professor Rae
- 15 Baker. It took a long time. So I'd like to...
- 16 COMMISSIONER BERNARD: Can you speak up just a
- 17 little, please?
- 18 PROFESSOR BAKER: So, my name is Professor Rae Baker.
- 19 and I'm a resident of Bagley District 2. And I'm speaking
- 20 tonight about the recent public presentation of DPD's
- 21 ShotSpotter program and their data, both as a concerned
- 22 community member, as well as someone that teaches
- qualitative and quantitative research methods to criminal
- 24 justice students. Public reporting on the ShotSpotter
- 25 data has largely described the program as a success and

- want to read a couple of facts from it, which I did not 1
- know, which I think are very illustrative of this 2
- particular community. This is the home to 12th and
- 4 Claremont Streets, site of the police raid that sparked the 1967 rebellion against widespread police racism and
- 6 brutality. It is also home to some of Detroit's first new
- housing planned neighborhoods since post World War II,
- due to rebuilding after the rebellion. Joseph Walker
- 9 Williams Community Center opened in 1984 and was named as
- 10 a prominent leader in the area. Detroit's likely only
- remaining police mini station is in the 10th Precinct at 11
- 12 8675 Rosa Parks Boulevard, because the community fought
- 13 to keep it.
- 14 Finally, the report also says, we also have
- 15 neighborhoods and districts 2, 6, and 7. The 10th
- Precinct comprises three historic districts, Russell
- 17 Woods, which we all know well, Boston Edison and the
- 18 Oakman Boulevard community. A few other neighborhood
- neighborhoods are Nardin Park, LaSalle Gardens, and 19
- 20 Midwest. And there are several people in this room
- including the gentleman back there with the silver hair
- who has written many, many articles on the issue of the 22
- 23 rebellion and spoken on it reportedly Mr. Sam Riddle. So 24 I know that these facts are important to you and of
- course, to our Councilwoman Mary Waters. Thank you. Madam

- using DPD's community violence intervention equation, all 1
- six programs were recently given a score based on two
- factors, reductions in homicide and reductions in non-3
- fatal shootings. Only two of the programs were given
- scores higher than the score attained by all areas of the 5
- city, where no ShotStopper programs are operating.
- Overall in areas of the city where ShotStopper
- 8 programming does not exist, there's been a 37% reduction
- in these forms of violent crime. What we need to be 9
- curious about is what is happening in the rest of the 10
- city, the majority of the city that has contributed to 11
- reductions in homicide and non-fatal shootings? In the
- 13 absence of ShotSpotters. Seemingly 37% of the decrease in
- 14 violence prevention in both forced Detroit and Detroit
- friends and communities areas can be attributed to these 15
- 16 unnamed interventions. If we aggregate data in this way,
- 17 no ShotStoppers (sic) groups have reduced violence more
- than these areas and the unnamed interventions happening 18
- 19 in them without shot stoppers being present. If we look
- 20 at ShotStoppers, CVI scoring as an average, which is
- 21 31.7% across all six programs, areas of the city, sorry,
- 22 of this program, we need to take into account what's 23 happening in these areas without Shot Stoppers being
- present. Is it housing? Is it access to food? Is it
- 25 access to job training or GDE programming? Lastly, Chief



- White's Office is 11 weeks late in responding to an
- 2 inquiry regarding the procurement process for mobile
- 3 fingerprint readers.
- 4 VICE CHAIRPERSON SMITH: That's your time. Thank you.
- MR. BROWN: Ms. Varner. 5
- MS. VARNER: Thank you. Good evening, everyone. Now I 6
- want to say upfront I support my police department. 7
- Everybody who knows me knows I support my police
- 9 department. I'm in love with Precinct 10. I'm part of the
- at large member of the executive board. But I have to
- speak about an incident that happened last week to my
- family member. My daughter lives in District 1. She was
- out, she and my son-in-law, taking care of their
- business, got an alert that their home was being broken
- 15 into, the alarm was going off. They're looking at people
- breaking into their home on the video; calling 911 on the
- phone, telling the operator what's going on, step by 17
- step. They get to their property, they could see on the
- video as they're on route people running across the yard
- 20 with their merchandise in broad daylight. It took the
- 21 police over an hour to get to their property. I have a
- concern about that. Then one of the items that was stolen
- has a tracking device. They called the police department
- to let them know, I don't know if it was the police
- department, 911 or whatever, but called to let them know

- Detroit police officers who is still on duty. There is
- 2 also the matter of Daryl Vance who recently died, and
- this man deserves some justice. And I really hope that
- the Board of Police Commissioners is looking carefully
- into this man's death. It doesn't seem to me that there
- 6 was a justifiable reason that a person, there was no
- 7 self-defense or such type of merit as to why one would
- kill this man. And so I really think the Board of Police 8
- Commissioners needs to thoroughly investigate the Office
- of the Chief Investigator, actually should thoroughly
- investigate that case and see that whoever was 11
- 12 responsible for that death is held accountable.
- 13 VICE CHAIRPERSON SMITH: Thank you.
- 14 COMMISSIONER BERNARD: I'll respond to that.
- 15 VICE CHAIRPERSON SMITH: Go ahead.
- 16 COMMISSIONER BERNARD: Just real quickly, Scotty, the
- 17 matter is in the law department. The City of Detroit
- Police Department has been sued as a result of that
- 19 incident. It's a multimillion dollar lawsuit, and there
- 20 are a number of investigations going on. And it was the
- 21 Prosecutor's Office that decided not to charge the
- 22. officers. It was not the Board of Police Commissioners.
- 23 VICE CHAIRPERSON SMITH: But it was resubmitted,
- 24 correct? Was it resubmitted?
- 25 COMMISSIONER BERNARD: It was resubmitted, but they

- where one of the items were. Could not get anyone to go,
- go out to that property to investigate. That's a problem 2
- that I feel that someone should be addressing. That's
- very dangerous. Thank you for this time.
- 5 VICE CHAIRPERSON SMITH: Thank you. Do you have that
- 6 information with you right now?
- 7 MS. VARNER: My daughter can give you the
- 8 information. It was her home.
- 9 VICE CHAIRPERSON SMITH: Okay. You can bring that
- forward when we are finished, please. Thank you. 10
- 11 MS. VARNER: You're welcome.
- 12 MR. BROWN: Mr. Bowman.
- 13 MR. BOWMAN: A couple things. I'm not going to make a
- big deal about this because I'm not here speaking on 14
- behalf of the District 4 Community Advisory Council, but
- for the purpose of introductions, I am an elected
- 17 official. I know I'm not dressed like one right now, but
- I am so just a matter of accuracy on the introductions.
- 19 But I do feel honored to be here again, but I'm also
- disappointed that there are cases that are not being
- taken care of properly. As far as I know, there still has
- 22 not been a missing person's report put out for Shelby
- 23 Smith, as was requested by her sister Ashley. And we
- think we've all heard about her name before in regards to
- the unfortunate beating she received from one of the

- rarely changed their role, their position. 1
- 2 MR. BROWN: Madam Chair, your next set of speakers
- that are in attendance would be Ms. Michelle George, 3
- followed by Mr. Ronald Foster.
- 5 MS. GEORGE: So you should be saying evening to the
- honorable board, you know, congratulate Chief White. I
- know he was at the White House, and we were able to see
- 8 one of the young men in Washington, DC that's over at the
- Violent Task Force. But one of the things I want to 9
- stress is that we are definitely praying for Isaiah, but 10
- we've been talking about these missing children for a 11
- long time. There have been so many children missing in
- 13 the last year, and what needs to happen, regardless if
- 14 the child is a runaway, you need to make a press
- 15 conference when it's missing children. Now, we know black
- 16 children do not get reported as other races of children,
- 17 but what needs to happen, because I know there are only
- like two persons I know. 18
- 19 The Detroit Police Department gave a presentation
- 20 where it's like two people working in the department, and
- I'm praying for this young lady that they find because
- 22 there's something going on. I still think there is a
- 23 shortage of officers because I'm hearing more cases like
- 24 this lady has stated. But what we want to see with the
- Detroit Police Department, we want every child that's



- 1 missing. I don't care if it's a runaway or anything.
- 2 Because I brought this up to one of the police officers
- 3 at the 2nd police Precinct. I support the police
- 4 department, but when it comes to missing children, there
- 5 has to be a press conference about it, rather than they
- 6 ran away. And I believe that's how Isaiah was missed. I
- 7 do believe her picture, I didn't know I reported on it. I
- 8 didn't know it was after a month.
- 9 So every child that's missing, we are involved in
- 10 human trafficking. There is a lot going on with missing
- 11 children, and we are going to be on the forefront because
- 12 what's going to wind up happening is you're going to wait
- 13 until the national news media get a report on this. It's
- 14 not going to look good for the city. So that's what I
- 15 would like to see, is every child that's missing needs to
- 16 be reported. Thank you. And now congratulations to the
- 17 police department. After leaving Washington, DC I'm
- 18 telling everybody to vote. After being in the Senate this
- 19 week and the house, we need to vote whatever you vote
- 20 for, vote because...
- 21 VICE CHAIRPERSON SMITH: That's your time. Thank you.
- 22 MS. GEORGE: Thank you.
- 23 MR. BROWN: Mr. Foster.
- MR. FOSTER: Good evening. Through the Chair. Glad to
- 25 see you up there. So I know all the work that you do in

- 1 reiterate, our children have to be our focus. They have
- 2 to be our focus at all times. It's not just you all in
- 3 police, but city council are constantly every day
- 4 financing things, making sure that every development
- 5 includes these children. So it takes a whole communion
- 6 and everybody to work together to make sure that our
- 7 children are a priority.
- 8 VICE CHAIRPERSON SMITH: Thank you,
- 9 MR. BROWN: Madam Chair, I go to the six speakers on
- 10 Zoom, Metro Detroit, DSA, followed by Ms. Ana Shah,
- 11 followed by Diala.
- 12 COMMISSIONER WOODS: Madam Chair, before we do that,
- 13 if I can be recognized.
- 14 VICE CHAIRPERSON SMITH: Yes, go ahead.
- 15 COMMISSIONER WOODS: Can we ask the Deputy Chief
- 16 again to emphasize in terms of the missing children
- 17 that's in the City of Detroit, that is recorded on DPD's
- 18 website right now, or how does that work?
- 19 DC PRITCHETT: Through the Chair, I was told it's on
- 20 our DPD Facebook page. I know the Chief had given
- 21 instructions to our media public information. He wanted
- 22 that posted. He wanted each week to have an update of how
- 23 many people are missing year to date? How many have been
- 24 recovered? So it should be on our DPD Facebook page
- 25 because we talked about it in our Monday morning

- the community before you even took that position. So I'm
- 2 very grateful to see you there. I wanted to take the time
- 3 out today and just talk about NPOs. Our NPOs are not just
- 4 pay raises, they're not just some for people that've been
- 5 around for a while. They're called neighborhood police
- 6 officers. It is a special title associated with that.
- 7 Now, our NPOs are entrusted with our most vulnerable
- 8 citizens here, which are our children, our disabled, and
- 9 our seniors. Our community cannot afford, literally nor
- 10 figuratively, for the title of our NPO to be tarnished.
- 11 And so it's incumbent upon the NPOs to have integrity, be
- 12 meek, serve and protect and self-govern themselves. It's
- 13 important that you keep that title and that it be not
- 14 tarnished by any means.
- Which means that if your fellow officers are
- 16 compromising that trust within the community, then you
- 17 have to step up and keep that trust. You are all out
- 18 there on the front lines. The first encounter in the
- 19 community. It's imperative that these people, those
- 20 titles have integrity and be held to a higher standard
- 21 than just regular police officers. And so our NPOs are
- 22 required to be mothers to the motherless, brothers to the
- 23 brothers' sisters, and so forth and so on. It's a certain
- 24 spiritual character that you must have to encounter
- 25 those. And so I appreciate everything. And I want to

- 1 meetings.
- 2 COMMISSIONER WOODS: Okay. Thank you very kindly.
- 3 VICE CHAIRPERSON SMITH: Thank you.
- 4 MR. BROWN: Metro Detroit, DSA
- 5 METRO DETROIT, DSA: Good evening. Can I be heard?
- 6 VICE CHAIRPERSON SMITH: Go right ahead.
- 7 METRO DETROIT, DSA: Hi my name's Chris Gilmer Hill.
- 8 I'm a lifelong resident of the city's second district, so
- 9 I apologize I wasn't able to change my name when I joined
- 10 the Zoom. I firstly like to urge in the strongest
- 11 possible terms that this board should consider the
- 12 ceasefire resolution that Commissioner Burton attempted
- 13 to bring today. This is something that the board has had
- 14 that I know was sent to the secretary months ago. This is
- 15 something that the board ideally should have taken action
- 16 on way back when the City of Detroit passed a ceasefire
- 17 resolution citywide. This is also something that the
- 18 board should have a specific interest in because issues
- 19 of surveillance, issues of international police
- 20 injustice, these are issues that this board and the City
- 21 of Detroit should care deeply about. We all know as
- 22 Detroiters, an injustice anywhere is a threat to justice
- 23 everywhere. And what we have seen since October in Gaza
- 24 is absolutely a massive injustice and one that is
- 25 inextricable from the systems of police violence,



surveillance and oppression that have been set up in Gaza

- 2 in the West Bank and any number of other places around
- 3 the world.
- 4 We, as Detroiters, need to see our Board of Police
- 5 Commissioners stand up against that for any number of
- 6 reasons, not least because the violence that that creates
- 7 often gets brought home to our own streets and
- 8 perpetrated against black and brown Detroiters right here
- 9 in our community. I'd also like to echo Commissioner
- 10 Burton's serious concern. This is the fifth consecutive
- 11 week that the board has asked the police chief or deputy
- 12 chief point blank about what happens to or surveillance
- 13 data and when it's given to other suburban communities.
- 14 And they've still just not given any answer they've said
- 15 every single time. Oh, we'll be sure to get that to you.
- 16 They haven't, and they have never been able to give any
- 17 sort of information on that. It is past time for the
- 18 board to take action. It may have been understandable to
- 19 ask them for information once or twice, after five weeks.
- 20 Enough is enough. You need to suspend a ShotSpotter until
- 21 they can give you that information. Thank you.
- 22 VICE CHAIRPERSON SMITH: Thank you.
- 23 MR. BROWN: Ms. Shaw.
- MS. SHAW: Good evening. Can I be heard?
- 25 VICE CHAIRPERSON SMITH: Go right ahead.

- unimaginable and daily accelerating catastrophe in Gaza
- 2 and Philistine implemented by the IOF, with the Israeli
- 3 genocidal empire, having murdered over 30,000 present in
- 4 their current campaign of terror to decimate the people
- 5 of Gaza and level the land to the ground.
- 6 Detroit's Board of Police Commissioners has a moral
- 7 responsibility to stand on the side of justice,
- 8 especially on issues of police injustice and the abuse of
- 9 surveillance. Detroiters know that injustice anywhere is
- 10 a threat to justice everywhere. In addition, the people
- 11 of Detroit want to see peace and justice in Gaza, and
- 12 that means we want our elected officials to do the right
- 13 things. City council has already led the way on this, but
- 14 the use of military technology by police departments here
- 15 at home means that this is also a critical issue of
- 16 police oversight that the board should address. In
- 17 addition, surveillance technology developed for foreign
- 18 wards always ends up being used against black and brown
- 19 citizens in places like Detroit. And the Board of Police
- 20 Commissioners needs to stand up for all of our civil
- 21 rights and demand that Detroit should never use
- 22 surveillance technology with ties to international
- 23 violations of human rights. Through your vote to pass the
- 24 ceasefire resolution and the resolution for technology
- 24 ceaseffic resolution and the resolution for technology
- 25 divestment as well, you can shift the balance of power

- 1 MS. SHAW: Alright. I'm also going to echo the
- 2 sentiments that resident Chris spoke about. I'm also a
- 3 resident of Detroit. And I strongly urge the board to

- 9 VICE CHAIRPERSON SMITH: Thank you. Go right ahead.
- 10 BAD ROO: Good evening, everyone. It's for the joyous
- 11 heart that I report to you that the Michigan State Police
- 12 have turned over their findings of their review and
- 13 investigation into DPD's case 20-11112. That's the death
- 14 of Keniesha Coleman. I would ask that the Board of Police
- 15 Commissioners today ask that the Detroit Police
- 16 Department present a report with the findings of the
- 17 conclusion of the Michigan State Police. And now I want
- 18 to jump to the most important topic that everybody should
- 19 know about. We uncovered Detroit voter trap houses,
- 20 that's voter trap houses. This new lingo in Detroit story
- 21 history, voter trap houses. We have a number of them
- 22 identified in District 7. That's Fred Durhal's District.
- They've been cheating in the elections. Dennis Winfrey,who won her 5 elections in a row, just presented to
- 25 council during her budget hearing for her office as well

1 as the Department of Elections, she stated that there 2 were no findings.

3 There is Bear Trap still two irrefutable, concrete

proof, irrefutable evidence of absentee ballot fraud

being committed in the 2024 presidential primary. That's

the United States Presidential Primary, held February

27th, 2024 in the City of Detroit. There was a ballot 7

cast in the name of Mary Elaine Beckman from 12842 Sussex

9 Street. That's 48227. Mary Elaine Beckman does not live

at that address, and the residents who have been living

there for five months have no idea who Mary Elaine

Beckman is. We've been cheated in the elections and

that's how this city council has been stacked. This Board 13

of Police Commissioners has been stacked and all other

15 elected positions in the City of Detroit are now in

16 question.

17 VICE CHAIRPERSON SMITH: Thank you.

18 MR. BROWN: Former Commissioner Davis.

19 MR. DAVIS: Good evening. Can I be heard?

20 VICE CHAIRPERSON SMITH: You can go right ahead.

21 MR. DAVIS: Okay, good. I'd like to start off by

22 saying I too also support the ceasefire in Gaza. I also

would like to say I believe that a whole lot more needs

to be done for the missing people to come up missing than

25 not really thoroughly investigating black people. I mean,

black women, black girls, boys, all of this is going on 1

10 to resign. They are dead weight. And it makes the rest of

the board look bad in the event that they don't step up 11

12 and resign after you all asked them to. Then you all

13 should ask the governor to remove them. You know, we're

14 coming up on the 50th anniversary of the founding of the

15 Detroit Board of Police Commissioners and they are a

stain on you all. They make the rest of you all look bad.

17 You know, we need to be doing a whole lot more public

service announcements. We need to be doing more in the 18

19 community. I've been in the community. I've done stuff in

20 the community. I've helped search for people. You know,

we need to make sure that more is being done. We need to

22 make sure that these backlog of cases are closed. When I

23 was on the board, you know, they stopped letting me read

cases because I was asking too many questions. You all

need to ask questions. You all need to make sure that

this board is doing a better job and that people have

2 faith and trust in this board. How can they ask you to

oversee the police department if there's a lot of

questionable people on this board? Thank you.

VICE CHAIRPERSON SMITH: Thank you

6 MR. BROWN: Madam Chair, your last speaker would be

7 the caller with the last three numbers, 061.

8 VICE CHAIRPERSON SMITH: Caller, are you there?

9 CALLER 061: Can I be heard?

10 VICE CHAIRPERSON SMITH: Yes. Can I be heard?

11 VICE CHAIRPERSON SMITH: Yes, go right ahead.

12 CALLER 061: Yeah. This is James Ford from approved

13 Detroit streets. I just want to take my hat off to Bertha

Smith. I think she's there. I told her today that the

governor had granted September 18th for us to come up as

16 a group of Detroiters to complain about red light race,

17 red light running and drag racing, and she said she would

definitely be there. The cost would be \$35. We would be
