PROPOSAL SELECTION & EVALUATION CRITERIA

Proposals submitted by the deadline Friday, December 18, 2020 by 10:00AM (Eastern Daylight Time) and meeting the minimum threshold requirements will be reviewed and ranked by a proposal review panel. All applications will go through a selection and ranking process. Proposals will be selected and funded based on the applicant's ability to provide a quality proposal, demonstrate the need for funding, their proposal ranking and available funding.

Selected proposals must meet all of the CDBG and ESG-CV basic eligibility requirements to be considered for funding. Proposals that do not meet the eligibility requirement will be eliminated from consideration. Proposals will only be considered for funding if they meet the Threshold Requirements outlined in the RFP. Proposals passing threshold criteria review will be ranked and scored.
