- 5 Make necessary repairs to the roof to abate the elements. (Sec. 9-1-206)
- 6 Make necessary repairs to all water damaged walls, ceilings, and floors throughout. (Sec. 9-1-103)
- 7 Rid premises of insect/rodent and provide BSEED documentation from a licensed contractor. (Sec. 9-1-351)
- 8 Make necessary repairs to classroom door to fit square and plumb in the opening room 212. (Sec. 9-1-306)
- 9 Restore hot water to portable classrooms. (Sec. 9-1-411)
- 10 Replace all florescent tube fixture covers in portable classrooms. (Sec. 9-1-478)
