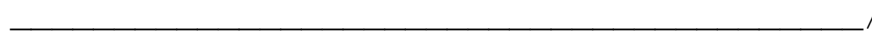

5 CHAIRPERSON TAYLOR: Good evening, and welcome  
6 to the Board of Police Commissioners meeting. I'm  
7 Commissioner Jessica Taylor, and I am joined by  
8 Commissioner Donnell White who is the vice chair, and  
9 Commissioner Warfield is on his way I believe. And we  
10 also have with us tonight our new commissioners,  
11 Commissioner Richard Shelby, Commissioner Wendell Byrd,  
12 Commissioner Reginald Crawford, Commissioner Willie  
13 Bell, Commissioner Willie Burton, Commissioner Lisa  
14 Carter and Commissioner Ricardo Moore. And from the  
15 Chief's office, I believe we have the chief himself,  
16 James Craig. No? Well, we have my favorite deputy  
17 chief, Deputy Chief Yost. I believe now we are going to  
18 do the swearing in ceremony.

19 MS. WINFREY: If the police commissioners to  
20 be sworn in would please rise?

21 (Commissioners Richard Shelby, Wendell Byrd,  
22 Reginald Crawford, Willie Bell, Lisa Carter and Ricardo  
23 Moore did rise to be sworn in).

24 After I recite the oath of office, you will  
25 respond with I will. Please raise your right hand.

1 Do you swear or affirm to support the  
2 Constitution of the United States and the Constitution  
3 of this state and the Charter of the City of Detroit, to  
4 faithfully discharge your elected duties as police  
5 commissioners?

6 COMMISSIONER SHELBY: I will.

7 COMMISSIONER BYRD: I will.

8 COMMISSIONER CRAWFORD: I will.

9 COMMISSIONER BELL: I will.

10 COMMISSIONER CARTER: I will.

11 MS. WINFREY: Congratulations, Commissioners,  
12 and welcome.

13 CHAIRPERSON TAYLOR: Now I'm going to ask the  
14 secretary to introduce the rest of the staff.

15 SECRETARY ANTHONY: Thank you, Madame Chair.  
16 For the record, George Anthony, secretary to the Board.  
17 We have present -- and if you would stand so that  
18 everyone can see who you are -- our chief investigator,  
19 Miss Pamela Davis-Drake seated in the front. She also  
20 has some of her staff here. We have Supervising  
21 Investigator Ainsley Cromwell and Supervising  
22 Investigator Lawrence Akbar (phonetic).

23 We also have present Mr. Robert Brown who is  
24 our office manager, Officer Kent Cooper from the Office  
25 of the Chief Investigator, Sergeant Allen Quinn who is

1 walking towards us and Miss Wendy Boer from Hanson Court  
2 Reporting Services who is taking a transcript. Thank  
3 you. That completes the introductions.

4 CHAIRPERSON TAYLOR: We're happy to be here at  
5 the Northwest Activity Center. And we just want to  
6 extend our thanks for them hosting this meeting for us.  
7 Is there a representative here? If so, if you could  
8 come forward and say a few words. I guess not. Well,  
9 then I need to -- is the chaplain here? Chaplain, yes,  
10 Chaplain Powell, come forward please? He's going to  
11 lead us in prayer.

12 CHAPLAIN POWELL: Happy new year to all of  
13 you. Let's look to the Lord. Lord God of Grace, in the  
14 name of Jesus, we thank and praise you for your tender  
15 mercy and your loving kindness, Lord, that you blessed  
16 us all, God. And protect us, Lord God, throughout last  
17 year and into this year, Lord. Ask you just to look  
18 down upon this meeting, look down upon our  
19 commissioners, look down upon the mayor, the chief, and  
20 all of their staff, Lord God, asking you just to bless  
21 and just touch -- Lord, we're asking you to look down  
22 upon our officers that serve this city. Bless them and  
23 strengthen them, give them that that they need. Give  
24 them wisdom, give them understanding. And Lord God,  
25 give them that mind, Lord God, to continually to be

1 about, Lord God, serving your people.

2 Lord, I ask you just to look down upon the  
3 citizens, look down upon all of us, Lord God. Help this  
4 city to become great, and help us, Lord God, to become a  
5 great people for this great city. We thank you, we  
6 magnify your wonderful name and your blessed name.  
7 Amen.

8 CHAIRPERSON TAYLOR: Well, at this time, we  
9 are going to ask Commissioner Byrd who is the -- oh,  
10 okay. We can take a recess while he is doing that.  
11 This is his district. So, we wanted him to read the  
12 responsibilities.

13 COMMISSIONER BYRD: Created by the City  
14 Charter of July 1st, 1974. Composition. The Board of  
15 Police Commissioners is composed of 11 members, seven of  
16 whom shall be elected from each non at large district,  
17 four members appointed by the mayor, subject to the  
18 approval of the city council. Appointed commissioners  
19 serve five-years terms and may not serve more than five  
20 years consecutively. Meets once a week and may recess  
21 during Thanksgiving, Christmas and New Years holidays.  
22 All meetings are open to the public.

23 Responsibilities. The Board of Police  
24 Commissioners has supervisory control and oversight of  
25 the police department as set in the 2012 City Charter

1 adopted by a vote of the people on November 8, 2011.  
2 Duties. Establish policy, rules and regulations in  
3 consultation with the chief and approval of the mayor,  
4 review and approve department budgets, review and  
5 approve department promotions, receive and resolve  
6 complaints concerning the operation of the police  
7 department as a final authority and imposing or  
8 reviewing discipline of employees of the department.  
9 Prepare an annual report to the mayor, the city council  
10 and the public of the department's activities during the  
11 previous year.

12 Staff. The Board appoints a Board secretary  
13 who attends all Board meetings, chief investigator and  
14 additional investigators, other staff as necessary to  
15 provide support to the Board. The police commissioner  
16 considers himself a liaison between the citizens of the  
17 city of Detroit and the police department.

18 CHAIRPERSON TAYLOR: Thank you. Come to the  
19 agenda. If there's no additions or corrections, a  
20 motion is in order to approve the agenda for January 9,  
21 2014.

22 COMMISSIONER WHITE: So moved.

23 CHAIRPERSON TAYLOR: Is there a second?

24 COMMISSIONER SHELBY: Second.

25 CHAIRPERSON TAYLOR: It has been moved and

1 second. Those in favor?

2 COMMISSIONERS: Aye.

3 CHAIRPERSON TAYLOR: Those opposed? Motion  
4 carries. There were no minutes from the last meeting  
5 because we had only one commissioner attending. So, we  
6 didn't have minutes from that meeting.

7 SECRETARY ANTHONY: Madame Chair, if I can  
8 just make a correction, the Thursday, December 12th  
9 meeting were not approved because we only had one  
10 commissioner present. On the 19th, these minutes need  
11 to be approved today. And they have been sent out.  
12 They were sent out to all of the commissioners.

13 CHAIRPERSON TAYLOR: Okay. Thank you.

14 SECRETARY ANTHONY: Those would be the  
15 December 12th minutes.

16 CHAIRPERSON TAYLOR: Okay, right. Under the  
17 Board's --

18 COMMISSIONER WHITE: Madame Chair, I think it  
19 would be appropriate, I move that the minutes for the  
20 Board of Police Commissioners dated for Thursday,  
21 December 12, 2013, be adopted.

22 COMMISSIONER WARFIELD: Support.

23 CHAIRPERSON TAYLOR: It's been moved and  
24 supported. Is there any discussion? If not, the  
25 minutes will be approved. Those in favor?



1 COMMISSIONERS: Aye.

2 CHAIRPERSON TAYLOR: Those opposed? Motion  
3 carries. Under the standing committee reports -- I mean  
4 under the Board of -- the chairperson, I don't have a  
5 report per se. But I do -- would like to give an update  
6 on the Order 11 letter that was sent to the emergency  
7 manager. I have a meeting scheduled with the emergency  
8 manager to meet regarding that Order 11. And I  
9 certainly will have a report from that meeting at the  
10 date that -- you know, depending on when we meet. We  
11 should -- we might meet tomorrow, and it may be early  
12 next week.

13 But we did get a response. And that's going  
14 to happen. Okay.

15 COMMISSIONER WHITE: Just a comment, Madame  
16 Chair, on your chairperson's report. I'm not sure if it  
17 has been -- but certainly we would be in favor of it  
18 being furnished, the actual communication that was sent  
19 to the emergency manager and the governor and the mayor  
20 and others, that that copy of that letter be submitted  
21 through the executive secretary to our new commissioners  
22 who are currently seated here today.

23 CHAIRPERSON TAYLOR: Mr. Secretary?

24 SECRETARY ANTHONY: Yes, ma'am.

25 CHAIRPERSON TAYLOR: Did you --

1                   SECRETARY ANTHONY: I did. And, in fact, just  
2 to the vice chair, those minutes were -- or that letter  
3 was reprinted in its entirety in the December 12th  
4 minutes. So, it's also there in the minutes as well.

5                   CHAIRPERSON TAYLOR: Now, is there any more  
6 discussion, Commissioners? Okay. Our report  
7 presentation from the Chief of Police's office on the  
8 12th Precinct? Oh, you're back, Chief. I thought it  
9 was Yost. All right.

10                  CHIEF CRAIG: Good afternoon. Good evening I  
11 should say. The good news, as I have made several  
12 reports, that we certainly ended the year with a crime  
13 reduction, overall crime. We ended the year with a 7  
14 percent reduction. When I arrived in July of this year,  
15 or last year now, we set a soft goal of 5 percent. But  
16 we exceeded our expectations, ended the year with a 7  
17 percent reduction in overall crime, 7 percent reduction  
18 in violent crime, a 7 percent reduction in property  
19 crime. But most notable is the 14 percent reduction in  
20 homicide, which translates into 52 fewer people were  
21 murdered in the city of Detroit as compared to the prior  
22 year.

23                  Another notable part of our crime statistics  
24 for last year was as relates to our non-fatal shootings,  
25 there were approximately 105 fewer, maybe 103, 105 fewer

1 people shot as compared to the year prior. And so, we  
2 end the year in a positive. But on the negative side,  
3 clearly, the fact that we ended the year with 333  
4 homicides in the city of Detroit in my judgment is far  
5 too many for a city of 713,000 when you compare that  
6 number to the city of New York, a city of eight million  
7 that also ended the year with 333 homicides and also  
8 when you look at the city of Los Angeles, a city of four  
9 million that ended the year with 259 homicides.

10 So, our work this year will be -- we have set  
11 a stretch goal if you will, we are seeking and will  
12 obtain a 10 percent reduction in overall crime. But we  
13 recognize that as we move toward that goal, yet we  
14 absolutely want to reduce the incidence of homicide.

15 The other news is that today, we provided the  
16 Commission with our plan of action. And by design, we  
17 wanted to release it at the beginning of the year. We  
18 worked on this plan with the consulting team for now  
19 probably four, four-and-a-half months. We have a  
20 finished product.

21 One of the most notable, we set a vision  
22 statement for the Detroit Police Department as follows.  
23 Detroit Police Department is a model of sustained  
24 policing excellence that places our neighborhoods and  
25 people first. And then we set some goals. And I will

1 briefly go through the goals that we set for 2014.

2 Goal one is reduce overall crime by 10 percent  
3 as compared to the prior year, which would be 2013. We  
4 have a goal set, a stretch goal as I call it, reduce  
5 response time to five minutes for all priority one calls  
6 for service. And again, those priority one calls for  
7 service are not the cat in the tree, not the burglary  
8 that occurred two hours ago, suspect is gone. It's  
9 those crimes in progress, shooting in progress, a home  
10 invasion where a suspect is inside the location. We  
11 have set a five-minute goal for that.

12 For homicides, it was reported when I arrived  
13 here in July that the clearance rate for homicide was 11  
14 percent. We started to look at our processes. It  
15 jumped up to about 42 percent. And we ended the year at  
16 about 50 percent clearance rate. Again, that was a  
17 percentage that was I was not at all excited about  
18 coming from agencies that routinely had 70, 75 percent  
19 clearance rate on homicide.

20 So, we have set for 2014 a 70 percent  
21 clearance rate for homicide. Another very important  
22 goal is to achieve 100 percent compliance with the  
23 mandated Department of Justice Consent Decree Judgment  
24 by the end of the second quarter of this year. Another  
25 goal is to hire 150 new officers by the end of the

1 second quarter of this year. Thank you. In fact, the  
2 good news is we have two classes in session now. We  
3 have one class set to graduate I want to say next week.  
4 That will be our first class since we started our hiring  
5 effort. And then five months after that, we should have  
6 the second class due to graduate.

7 You have heard me talk a lot about putting  
8 detectives, investigators back at the precinct level.  
9 You know, one of the concerns I had coming in the door  
10 was the fact that victims of crimes were not getting  
11 calls back. They didn't know the status of their  
12 investigations. So, we have started -- prior to the  
13 start of this year, we have started putting the  
14 detectives back in the precincts. We removed districts.  
15 Districts no longer exist. We have gone to precincts.  
16 And the idea of going back to precincts so that police  
17 stations are neighborhood based and that the community  
18 would have their neighborhood community police stations.  
19 So, we are going back to precincts. There will be 12  
20 precincts.

21 And, you know, part of that, I just want to  
22 also add, you've also heard me talk a lot about our  
23 neighborhood police officer program. That process is  
24 under way. We should be fully functional within the  
25 next 30 to 40 days. And basically what that is, is

1 looking at the precincts, we have divided the precincts  
2 up into sectors or areas. And those areas represent  
3 neighborhoods. Each neighborhood will have a neighbor  
4 police officer attached to it because I know having had  
5 this kind of experience working in LA, Cincinnati,  
6 Portland, Maine, we wrote out a very similar program.  
7 And what it does is connect -- directly connects our  
8 neighborhoods to our police officer. And that police  
9 officer will be more akin to a quality of life police  
10 officer.

11 I know many of you have had complaints about  
12 gas stations, liquor stores, drug houses in  
13 neighborhoods, you name it. Any kind of neighborhood  
14 complaint, that police officer will be a primary point  
15 of contact. So, through the work and leadership of the  
16 captains of these precincts, they will work very closely  
17 with the neighborhood police officer. But in addition,  
18 in my office, I have an overall neighborhood police  
19 officer coordinator.

20 Captain Roshay, will you please stand up so  
21 that everyone can see you? Captain Roshay's role out of  
22 my office will be to coordinate with all of the  
23 precincts so that the coordination is seamless and that  
24 we have a standardized approach to neighborhood based  
25 policing. So, we are really excited about that.

1           We are also -- another goal is to ensure that  
2           the members of the DPD receive adequate training and  
3           equipment to perform at optimal levels and continue to  
4           focus on improving the overall working environment of  
5           our officers.

6           You have heard me talk a lot about morale and  
7           the importance of morale. So, if morale is down, crime  
8           goes up. If morale is up, crime goes down. It sounds  
9           simple. But it's something I have seen in not one  
10          agency but three agencies. So, it's important when I  
11          say cops count, they really do count. You know, I talk  
12          a lot about during my first couple of months hearing  
13          that police officers were wearing expired body armor.  
14          We have fixed that. We have now deployed in excess of  
15          400 protective vests, body armor. Our officers are now  
16          wearing protective body armor.

17          Another important goal -- and this goes right  
18          to the heart of our neighborhood police officer program,  
19          improve our relationships with our community by engaging  
20          in sustained problem oriented policing exercises, with  
21          an emphasis on reducing the fear and perception of crime  
22          in the city of Detroit.

23          You know, I talk a lot about crime stats.  
24          It's great that I sit here and tell you that we have a  
25          14 percent reduction in homicide and that 105 or so

1 fewer people were shot. But the reality of it is,  
2 there's still a significant fear of crime in our city.  
3 And so, my gauge and our gauge is if you feel safer.  
4 And so, what we are going to be looking at is building  
5 those partnerships with you. And we are going to do  
6 that through the neighborhood police officer program but  
7 also maintain a transparency so that you know what we  
8 are doing in real time, not weeks later.

9 You remember not too long ago I was clear  
10 about the tragic death of one of our officers who was  
11 killed by friendly fire. And while as tragic as that  
12 may seem, it's important that you know the truth and you  
13 not get a shade of it. And lastly and as important a  
14 goal is that we talk about the neighborhood precincts  
15 and how important they are. For the life of me, I still  
16 can't understand why the most densely populated area of  
17 Detroit, the 8th Precinct, that that station was closed.  
18 That makes no sense to me.

19 And so, we are aggressively looking for a new  
20 home for the 8th Precinct. We have toured a couple of  
21 facilities. We have had conversations with Meijer  
22 Corporation because we know they are building a new  
23 store in the area where the old Number 8 was located.  
24 So, we are working on that. But the good news is, we  
25 will be opening a Number 5 and a Number 7 on the east



1 side of Detroit. We have identified a location. These  
2 are existing facilities that one is probably plug and  
3 play as I like to refer to it. Another one is going to  
4 need a little more work. We should start construction  
5 on that early next month. And we are hoping by early  
6 spring, we should have the 5th Precinct open. It's  
7 situated right across from the Jefferson Avenue plant.  
8 And so, that ends our goals and benchmarks for 2014.  
9 Now I'll take any questions from the Commission or  
10 anyone else that has any.

11 CHAIRPERSON TAYLOR: Commissioners, any  
12 questions for the chief?

13 COMMISSIONER BELL: With reference to  
14 representing District 14, I would hope that -- and I  
15 can't speak for the rest of the commissioners, but I  
16 would hope that you would entertain meeting with the  
17 newly elected commissioners in reference to bringing us  
18 up to speed in reference to some of our concerns,  
19 primarily some of your concerns. As you well know,  
20 there's a great deal of interest in terms of public  
21 safety. And this is a new day in terms of elected  
22 commissioners for the Board of Police Commissioners  
23 representing the districts.

24 So, I would appreciate that we have an  
25 opportunity to meet with you as soon as possible in

1 terms of your schedule. Would you entertain that?

2 CHIEF CRAIG: Absolutely, I would entertain  
3 and welcome that opportunity. You know, one of the  
4 things that is a source of frustration for me and  
5 certainly my team is -- and I have said this publicly,  
6 and I'm blunt as always. But I just don't get a sense  
7 that people get excited enough about some of the ills  
8 and issues in this city. So, it takes this police  
9 chief, an outsider, to come in here to deal with a  
10 historic problem. Yes. I'm talking about the Colony  
11 Arms. That problem didn't just happen three to  
12 five months ago. But it's a historic issue. And so,  
13 this police department is committed and dedicated, went  
14 into an area to deal with an issue that was long  
15 overdue.

16 Then there was another location, source of  
17 concern for our community. I'm talking about the Martin  
18 Luther King homes. But again, it took this department  
19 during this time to focus in on those issues. And then  
20 a historic drug location not far from here in the 10th  
21 Precinct. We have 20 location search warrants were  
22 served. So, I absolutely welcome bringing you up to  
23 speed. I welcome the support and our work together and  
24 making Detroit one of the safest cities in America  
25 instead of one of the most violent. I think together we

1 can do it.

2 I will also tell you to give you a snapshot,  
3 we plan to continue to take back our neighborhoods. We  
4 are planning another such operation. I won't go into  
5 the details of it at this session. But we are planning  
6 one this month. Assistant Chief Jones, when is that, a  
7 couple weeks?

8 ASSISTANT CHIEF JONES: Yes, sir.

9 CHIEF CRAIG: We are looking forward to that.  
10 We want to set the tone early in the year because we are  
11 absolutely committed to really reducing violence in this  
12 city. Thank you for that.

13 COMMISSIONER BELL: I just want to make one  
14 more brief comment, that publicly, I just want to say  
15 that I support your approach. I think this is a new day  
16 in reference to the DPD. As a former member of DPD, I  
17 like your approach in terms of what you have initiated  
18 so far. And I just want to say that a whole lot of  
19 people have expressed that same opinion. So, I'm really  
20 proud that we are moving forward, that we have a DPD  
21 that we can be proud of once again. Thank you.

22 CHIEF CRAIG: Thank you for that.

23 CHAIRPERSON TAYLOR: Mr. Secretary, there was  
24 some -- you sent a list of meetings that are going to be  
25 in all of the districts. And can you give us a little

1 information about those meetings?

2 SECRETARY ANTHONY: I don't have it. I can  
3 pull them up for you and get it to you.

4 CHAIRPERSON TAYLOR: While he is doing that,  
5 Chief, I'd like to ask a question. Can we have a copy  
6 of that report? I'm sorry. I didn't see it. We have a  
7 horse shoe because you can't see.

8 CHIEF CRAIG: Captain Balinski from the 12th  
9 Precinct has a presentation.

10 CHAIRPERSON TAYLOR: Okay.

11 CHIEF CRAIG: My oversight.

12 CAPTAIN BALINSKI: Thank you very much. Thank  
13 you for the opportunity to talk about the 12th Precinct.  
14 And congratulations to the newly elected Board, many of  
15 whom I have had the pleasure of working with in the  
16 past. The 12th Precinct is located at 1441 West 7 Mile,  
17 just down the street from here, Woodward and 7, about  
18 15.5 square miles. And we are bordered by 8 Mile to the  
19 north, Linden to the south with the railroad tracks. We  
20 have James Couzins and Schaefer to the west and Woodward  
21 Avenue going to the east.

22 Some of the properties we have that are in the  
23 12th Precinct, private and public, first one we are  
24 sitting in right now, Northwest Activities Center. And  
25 we also have the Detroit Golf Club which is over on

1 Pontchartrain. According to the most recent census  
2 numbers, we have approximately 92,000 citizens that  
3 reside in the 12th Precinct. And we also have 18  
4 learning facilities, schools. Four of them are high  
5 schools, 12 are elementary schools and middle schools.  
6 And we have two centers of higher learning, University  
7 of Detroit and Madonna College that are in the 12th  
8 Precinct.

9 Just a few highlights. The 12th Precinct, we  
10 deploy a home invasion task force who during the year of  
11 2013 was able to reduce our home invasions by 21 percent  
12 in the 12th Precinct. Thank you. And community  
13 relations officers along with that call some of the  
14 Board remember how community relations officers used to  
15 call people, talk to them about their burglaries and  
16 trying to help them to secure their homes better, giving  
17 them better ideas on how to make sure that that doesn't  
18 happen again. Our community relations officers are  
19 engaged in that process also.

20 Currently we have 14, 12th Precinct Youth  
21 Explorers. Also during Police week, I know that  
22 Sergeant Bledsoe who is here tonight puts together a  
23 good program in partnership with crime prevention  
24 strategies. That's coming up. And she starts her  
25 planning early on, and for May of this year. We also

1 have very strong radio patrols, Greenacres, University  
2 District, Martin Park, Grenwich, Blackstone, McDowell,  
3 Should (phonetic) and Bagley. And if I could see the  
4 hands of all of our radio patrol people or stand up that  
5 are here, very dedicated people. And let me tell you,  
6 they keep me working. They keep my e-mail going and my  
7 cell phone going because when they have a problem, they  
8 let me know about it. And we take care of their  
9 problems for them.

10 This August 5th also along with the nation  
11 we'll be hosting the National Night Out, which is a  
12 yearly event of crime prevention, showing neighborhoods,  
13 having things over at the precinct where people can come  
14 and visit and the kids and schools can come and visit.

15 And also, we do a lot of charity work, very  
16 involved, our community relations officers, with the old  
17 News Boys, Goodfellows. And this year, the 12th  
18 Precinct also participated in Toys for Tots, and also  
19 they distribute a lot of food baskets during the holiday  
20 period, Thanksgiving and Christmas. And lastly, the  
21 12th Precinct through the hard work of its officers and  
22 supervisors were able to reduce part one crimes by  
23 15 percent and property crimes by 4 percent in 2013.  
24 Thank you. Any questions?

25 CHAIRPERSON TAYLOR: Questions?

1 CAPTAIN BALINSKI: Thank you very much.

2 CHIEF CRAIG: Just a fun fact about the good  
3 captain. We started around the same time here in the  
4 Detroit Police Department. I want to say that was 1977,  
5 about December. We also both went to LA, except he went  
6 to that funny brown uniform department called the LA  
7 County Sheriff. But he got back here a lot sooner than  
8 I did. But he's doing a great job. I did want to also  
9 just share another piece of this whole neighborhood  
10 police officer program, we do have the good fortune of  
11 the Skillman Foundation has agreed to equip each of our  
12 neighborhood police officers with cell phones and ipads  
13 so that you, the community, can have instant access to  
14 our officers. That's how important this program is.

15 And lastly but as important, you know, the  
16 boundaries of the Detroit police precincts have probably  
17 been the same for 50 years. Certainly it's no secret  
18 that, you know, when I worked here in the 70's, I think  
19 the population was more like 1.5; and now it's 700,000.  
20 Crime has shifted, neighborhoods have changed. And one  
21 of the things that's clearly important to us and I know  
22 it's important to you is making sure we have  
23 neighborhoods intact. So, as we begin the work of  
24 making shifts, we made some modest changes to the  
25 boundaries so that neighborhoods would be intact so that

1 we could equitably divide up the areas for the  
2 neighborhood police officers.

3 And I want to acknowledge one of our deputy  
4 chiefs, Deputy Chief Yost, who really engaged in Yo  
5 person's work. To get this effort done, she brought the  
6 community in, she brought line officers. I put a  
7 tremendous value on the officer on the beat because they  
8 know what's going on. If you want to know what's going  
9 on in the police department, ask the cops on the beat.  
10 So, Vicki really did a great job. And I'd just ask you  
11 to give her a round of applause for that effort.

12 And certainly another person that I have  
13 affectionately referred to as my party planner, you  
14 know, we call her operations, last year parties,  
15 celebrations to the community for the work. But the  
16 chief party planner is my Assistant Chief Eric Jones  
17 sitting here. Will you stand? That's all the comments  
18 I have at this point.

19 CHAIRPERSON TAYLOR: Thank you, Chief. Under  
20 standing committee reports, Commissioners, I think you  
21 received a list of committees. And I know that it's  
22 customary to appoint to a committee. But what I would  
23 like to do if it's appropriate to just wait until I talk  
24 with you and find out which committee you might be good  
25 at, and then I will do the appointments. Thank you.



1 Okay.

2 And under new business, Mr. Secretary, I think  
3 you had some things you wanted to share with us  
4 regarding 40 years of the Commission, 40th year for the  
5 Commission. You had some information.

6 SECRETARY ANTHONY: And you want me to share  
7 it?

8 CHAIRPERSON TAYLOR: Yes, sir.

9 SECRETARY ANTHONY: This year marks the 40th  
10 year of the Detroit Board of Police Commissioners being  
11 in existence. That's a monumental achievement for  
12 oversight. The Board of Commissioners -- the Detroit  
13 version of the Board of Police Commissioners is one of  
14 the strongest commission setups in the country. There  
15 are different sort of oversight bodies within the United  
16 States. But this Board is one of the strongest forms of  
17 oversight. And I think that's to be commended.

18 The Board will probably throughout the year  
19 look to honor those former commissioners and have other  
20 activities that will, you know, point to the past, with  
21 a vision to the future as to how it goes forward. So,  
22 we are just very proud that this Board has endured. And  
23 it's a testament to the ideal for oversight. Thank you.

24 CHAIRPERSON TAYLOR: Okay. Commissioner  
25 Warfield has joined us. I didn't see you, sir.

1 COMMISSIONER WARFIELD: Thank you, ma'am.

2 CHAIRPERSON TAYLOR: Just in time because I  
3 believe your -- yes. We are going to do the Resolution.  
4 This is the most exciting part of the meeting. And  
5 Commissioner White is going to provide the Resolution  
6 for Mr. Donald Johnson. Is Mr. Johnson present?

7 COMMISSIONER WHITE: Now, if I didn't know any  
8 better, I wouldn't know why everybody was going crazy  
9 and yelling and screaming. But I do know better. And  
10 Brother Johnson, your reputation definitely precedes  
11 you. I have seen you on the other side congratulating  
12 people on numerous occasions for the great work that  
13 they are doing and being a follower of sorts.

14 But tonight is your night. And we are glad to  
15 present you with this token of our appreciation. On  
16 behalf of the Board of Police Commissioners, a  
17 Resolution honoring Mr. Donald Johnson.

18 Whereas, Mr. Donald Johnson is a proud and  
19 life long resident of the City of Detroit. He is a  
20 proud product of the Detroit Public School System and  
21 received his Bachelor's degree in business and finance  
22 from Wayne State University as well as a Master's degree  
23 in business and finance from Central Michigan  
24 University.

25 And whereas, Mr. Johnson has been an active

1 member of the 12th Precinct Community Relations Council  
2 for 15 years and currently serves as its president.  
3 Through his leadership, the organization's membership  
4 has grown in numbers. Mr. Johnson works tirelessly to  
5 address community issues and makes himself available  
6 24/7 to assist others with their problems and concerns.

7 And whereas Mr. Johnson is a strong advocate  
8 for the community and helps lead the charge in getting  
9 things done. He does not hesitate to dig deep into his  
10 own pocket to donate financially to assist with  
11 community events, including helping to feed the less  
12 fortunate and providing bags of candy for Halloween  
13 party events. He also helps purchase, prepare and serve  
14 food for Police week activities at the precinct.

15 In addition, he often invites the community to  
16 break bread with the officers and purchases turkeys for  
17 seniors within the area. During the month of December,  
18 you can always find Mr. Johnson decorating the three  
19 Christmas trees in the lobby of the 12th Precinct.

20 And whereas, Mr. Johnson attributes his growth  
21 in community relations to the great team work of the  
22 Detroit Police Department, the community relations  
23 executive committee and the people working together  
24 towards the one goal of making the city of Detroit a  
25 greater and safer place for everyone to live, work and

1 play.

2 Mr. Johnson has been a community activist,  
3 organizer and supporter of the Detroit Police Department  
4 for over 35 years. His number one objective is to help  
5 everyone who needs and wants help.

6 And whereas, for the last six years,  
7 Mr. Johnson has volunteered his time to help the 12th  
8 Precinct by answering the telephones in the community  
9 relations office for two to four hours every Monday.  
10 Last August, Mr. Johnson, through a grant he received  
11 from DTE Energy, spearheaded the cleanup project at the  
12 Joe Louis Field. With that grant, he was able to bring  
13 in large machinery to clean the graffiti from the school  
14 walls and help remove large tree stumps and debris from  
15 the park. He also assisted the Greening of Detroit  
16 organization in cleaning Wells Park, making it more  
17 community friendly.

18 Now, therefore, be it resolved that the  
19 Detroit Board of Police Commissioners, speaking on  
20 behalf of the citizens of the City of Detroit and the  
21 Detroit Police Department, acknowledge the dedication  
22 and persistence of Mr. Johnson, his highly displayed  
23 commitment to community service and his ability to  
24 build, sustainable community partnerships, merit our  
25 highest regards. We thank and congratulate you,

1 Mr. Donald Johnson. Signed, the Detroit Board of Police  
2 Commissioners. Adopted this day, January 9, 2014.

3 CAPTAIN BALINSKI: Just to add, we also wanted  
4 to give Don an Outstanding Community Service Award for  
5 all the things that you just heard about him. And one  
6 of the big things is that his dedication not only to the  
7 city of Detroit but to our police department and our  
8 police officers.

9 CHIEF CRAIG: I take great honor, you know,  
10 when you talk about what makes a community work, it's  
11 the people that work hand in hand with the police  
12 department in solving the problems, not problem givers  
13 but problem solvers. And certainly Don Johnson is one  
14 of those folks. So, I take a great deal of honor to  
15 present him with a Certificate of Recognition from the  
16 Detroit Police Department for his involvement in the  
17 community and service to the city of Detroit, who  
18 demonstrates a spirit and commitment that is worthy of  
19 recognition. Today's date, signed by me. Thank you.

20 MR. JOHNSON: Thank you, Chief. I appreciate  
21 it. That isn't fair. I know real quick, none of this  
22 -- to this distinguished and newly elected Board, I say  
23 thank you and welcome. I look forward, Mr. Byrd, to  
24 working with all of you very closely, with all the rest  
25 of our community folks so that we can make this city a

1 better place that we know it can be.

2 But I just want to say one thing. Every one  
3 of you sitting here in this room, whether you're a  
4 police officer or a community person or whatever, these  
5 awards don't belong to me. It belongs to all of us  
6 because we all work together to do what we do at the  
7 12th Precinct and the other precincts, which is our big  
8 competition, the great Northwest. But we communicate  
9 together. We work together. And all I want us to do is  
10 stay together. And as I told the chief, we got your  
11 back. Thank you.

12 CHAIRPERSON TAYLOR: Before we move to old  
13 business, I believe Cathy, Wayne County clerk, Cathy  
14 Garrett -- is Mrs. Garrett here?

15 CHIEF CRAIG: I had an oversight. Would it be  
16 proper to acknowledge some of the other folks in our  
17 team that is here today?

18 CHAIRPERSON TAYLOR: You're the chief.

19 CHIEF CRAIG: Anyway, Assistant Chief White,  
20 who is standing there with the stern look in the back,  
21 certainly the left and the right side of the police  
22 department. He certainly is oversight of all of our  
23 administrative functions as well as the Consent  
24 Judgment. I would ask the team, we have a couple of  
25 deputy chiefs, commanders, captains, chief of staff,

1 could you stand and be acknowledged, please? I just  
2 want to publicly thank them for being the all stars that  
3 they are, you know. The Detroit Lions couldn't do it,  
4 but the Detroit Police Department will.

5 CHAIRPERSON TAYLOR: Under our old business  
6 but before I turn this over to Commissioner Warfield for  
7 the towing Resolution, administratively, I just want to  
8 announce that --

9 SECRETARY ANTHONY: Before we get started,  
10 there is a motion -- we need to have a motion to accept  
11 the Resolution.

12 CHAIRPERSON TAYLOR: Yes, that's right. Is  
13 there -- we need to have a motion to accept the -- I'm  
14 sorry, I just lost my -- the Resolution for Mr. Donald  
15 Johnson. Is there a motion?

16 COMMISSIONER WARFIELD: Ma'am, I move that we  
17 accept the Resolution honoring Mr. Donald Johnson and  
18 that it be become part of our permanent archives.

19 COMMISSIONER MOORE: Second.

20 CHAIRPERSON TAYLOR: It's been moved and  
21 seconded. Is there any discussion? All in favor?

22 COMMISSIONERS: Aye.

23 CHAIRPERSON TAYLOR: All opposed? Motion  
24 carries, and the Resolution will become a part of our  
25 permanent archives. Thank you, Mr. Secretary. At this

1 time, I'm going to announce that Commissioner Warfield,  
2 this is his last night. He is resigning. And we wanted  
3 to do something for him tonight. But we -- it's going  
4 to be February 13th. We are going to have a going away  
5 ceremony for Commissioner Warfield. And, Commissioners,  
6 if you missed being under his leadership, you really  
7 missed something. He was a dynamo. So, I will still be  
8 calling him. So, okay. Now, Commissioner Warfield, we  
9 have the towing Resolution we want to read into the  
10 record.

11 COMMISSIONER WARFIELD: Thank you, Madame  
12 Chair. Yes, ma'am. Thank you, Madame Chair. To  
13 brother vice chair and to all of the commissioners here  
14 tonight, to all of you, this is an issue that has come  
15 before us a few months ago as relates to towers not  
16 being able to secure the cars in their lots. And so, we  
17 want to make sure that the safety and security of our  
18 citizens and the safety and security of those who do  
19 business with the Detroit Police Department, more  
20 specifically our authorized towers, are in order.

21 Resolution of the Board of Police  
22 Commissioners, administrative fee. Whereas the  
23 municipal code for the city of Detroit, The Code, was  
24 adopted by the Detroit City Council and published in  
25 1983, pursuant to authority granted by the Michigan Home



1 Rule City's Act, MCL 117.5B, MSA 5.201842. And whereas  
2 the code provides in section 55-15-5 and 14-85, that the  
3 Detroit City Council has the authority to establish  
4 maximum and standard rates for police authorized towers.

5 And whereas the Detroit City Council approved  
6 the rate -- I'm sorry, approved the rate fee schedule  
7 recommended by the Tow Rate Commission. And whereas the  
8 approval rate for fee schedule includes a \$75  
9 administration fee, which is designated for the City of  
10 Detroit. And whereas, the \$75 administration fee  
11 applies to all impounded vehicles, boats, trailers,  
12 recreational vehicles or any miscellaneous items  
13 hereafter if impounded properly items.

14 And whereas the owner of the impounded  
15 property item is responsible for paying \$75  
16 administrative fee before being given access to their  
17 property, regardless whether it is to redeem the  
18 impounded property item, to inspect it and/or to  
19 retrieve personal articles from it. And whereas, if the  
20 administrative fee is not collected from the owner and  
21 the unclaimed impounded property item is scheduled for  
22 auction, then the \$75 administrative fee shall be added  
23 to the opening bid amount for the impounded property  
24 item that is offered for sale at public auction.

25 And whereas the authorized towers, police

1 authorized towers, PAT, are responsible for collecting  
2 the \$75 administration fee and paying the collected fee  
3 directly to the City of Detroit. And whereas, the  
4 Detroit Board of Police Commissioners, the Board, has  
5 the responsibility under the 2012 City Charter to  
6 establish policy rules and regulations for the Detroit  
7 Police Department.

8 And whereas the Board supports the Tow Rate  
9 Commission's recommendation authorizing the police  
10 authorized towers to collect the \$75 administrative fee  
11 and to pay the same to the City of Detroit, which  
12 recommendation was approved by the Detroit City Council.

13 Now therefore be it resolved that the Board of  
14 Police Commissioners authorizes the Detroit Police  
15 authorized towers to continue or begin collecting the  
16 \$75 administration fee in accordance with the  
17 aforementioned paragraphs of this Resolution and direct  
18 the Detroit Police Department to promulgate, add a  
19 directive that immediately implements the above  
20 requirements. Dated on January the 9th, 2014.

21 Ma'am, I would move for the adoption of the  
22 Resolution.

23 CHAIRPERSON TAYLOR: Commissioners, this is I  
24 believe the first time some of you have seen this. Are  
25 you ready to vote?

1 COMMISSIONER MOORE: I have a question. Is  
2 that -- through the Chair, is that in addition to the  
3 regular tow fees, the \$75 fee or is this just the  
4 regular \$75 fee?

5 COMMISSIONER WARFIELD: Through the Chair,  
6 this fee is in addition to the tow -- I mean, not in  
7 addition, it's part of the regular fee. Here was the  
8 issue for those who need clarification. The issue is  
9 when the Tow Rate Commission raised the fee and the City  
10 Charter -- the city council approved the fee,  
11 unfortunately what happened was someone had sent out a  
12 memo which basically allowed people to go to their cars,  
13 retrieve things from their cars while it was on the lot  
14 of the towers.

15 The issue with that is certainly it's a  
16 liability issue. Certainly the city is not able to  
17 collect its fee, its administrative fee as well when  
18 things like that happen. So, this makes sure that the  
19 towers are protected, the citizens are protected as well  
20 as the City of Detroit is protected.

21 CHAIRPERSON TAYLOR: Any other discussion?

22 COMMISSIONER BELL: Madame Chair, have we had  
23 any public comments in reference to this towing fee or  
24 is this the first time this is coming before this Board?

25 COMMISSIONER WARFIELD: Through the Chair, we

1 have had about a year-and-a-half worth of public comment  
2 regarding the tow fee. This is not a new fee. This fee  
3 is already in place. All we are saying is that the  
4 towers need to collect it before anyone can go to the  
5 car and inspect anything in the car or get anything out  
6 of the car. That's all it says. So, there is no new  
7 fees added. There's no new dollars added. It just  
8 again, it protects the citizens, and it protects the  
9 towers in the city as well.

10 CHAIRPERSON TAYLOR: Any other discussion?  
11 Commissioner White?

12 COMMISSIONER WHITE: Thank you for this  
13 Resolution, Commissioner Warfield. My question is  
14 certainly I'm in agreement with the fee as discussed  
15 previously by this body. My question would be -- and if  
16 it hasn't been, maybe the question is to the secretary.  
17 But what -- have we had a legal opinion as relates to  
18 our ability to prevent people from removing property or  
19 is this a practice that's in place in other  
20 jurisdictions or are we -- I just want to make sure that  
21 we are on legal ground that we can prevent people or  
22 that we would even recommend through a Resolution the  
23 preventing of individuals from removing property. And  
24 the second piece is that if I don't -- if I recall  
25 properly, I believe the first rendition stated some

1 exclusions that referenced items such as prescriptions  
2 and other things as well. And I'm wondering if that was  
3 removed totally for a reason or will these items still  
4 be a consideration? Thank you, Madame Chair.

5 COMMISSIONER WARFIELD: Through the Chair, to  
6 Mr. Vice Chair, two answers to that question. First of  
7 all, this is what the city council actually passed. And  
8 so this is already in place. What we are asking is that  
9 the Detroit Police Department initiate a memo sending it  
10 out to all of the towers letting the towers know that  
11 this is the policy of the Detroit City Council and this  
12 Board because someone within the department sent the  
13 memo out saying not to charge, which went against the  
14 Detroit City Council, which was against the Charter.

15 So, this basically just says we are in  
16 agreement with the Detroit City Council as relates to,  
17 you know, what items can be collected. They can collect  
18 all of their items if the fee is taken care of. And  
19 that's per the Detroit City Council. So, we are  
20 basically saying we want to follow the council's  
21 ordinance, that's all.

22 CHAIRPERSON TAYLOR: Is there any more  
23 discussion?

24 COMMISSIONER WHITE: Commissioner Warfield,  
25 just as a followup, again, not in disagreement with the

1 collecting of the fee but speaking more specifically to  
2 the removal of the items. So, even if I relinquish  
3 control of my vehicle and I have no intent of paying the  
4 fees, does this ultimately say I'm not entitled to the  
5 items that were left in my vehicle?

6 COMMISSIONER WARFIELD: Well, exactly. You  
7 have to pay the city's administration fee in order for  
8 you to have access to that vehicle. So, if you  
9 relinquish the vehicle, you still need to pay the city  
10 the administrative cost for what it costs the city to  
11 make sure that the car was towed off the street. So,  
12 that's basically what that \$75 takes care of. It takes  
13 care of the cost to tow the car off the street to a lot,  
14 and it goes straight to the City of Detroit through the  
15 tower.

16 COMMISSIONER WHITE: And, Madame Chair, I  
17 guess -- and I'm sorry to belabor this. But I guess at  
18 this point I would, through the Chair to the Secretary,  
19 is there an opinion, Mr. Secretary, as relates to the  
20 removal of items, personal items, opposite paying the  
21 fee prior to being able to remove those items?

22 SECRETARY ANTHONY: I think your concern deals  
23 with like medicines and things like that. And the  
24 towers will utilize discretion from what I understand in  
25 doing that. They just need this -- they need the

1 authorization because the department told them that they  
2 could not charge, period. And basically if they don't  
3 collect the fee, then they are responsible to the city  
4 themselves for the fee.

5 DEPUTY CHIEF YOST: Also, through the Chair,  
6 if someone from the police department gave them an  
7 order, can we have the specifics on that?

8 COMMISSIONER WARFIELD: Sure. Now or after  
9 the meeting? Through the Chair, would you like it now  
10 or after the meeting?

11 DEPUTY CHIEF YOST: Right now is fine.

12 COMMISSIONER WARFIELD: It came through the  
13 Office of Management Services, and it was through  
14 Officer Roland Clark.

15 DEPUTY CHIEF YOST: Do you have the date on  
16 that?

17 COMMISSIONER WARFIELD: If one of the towers  
18 are here, they may have that specific date. But I know  
19 we have been going -- we have been talking about this  
20 for at least a month, a month and a half. Bare minimum,  
21 it's been a month and a half, ma'am. But we can get you  
22 the exact date.

23 DEPUTY CHIEF YOST: We'd appreciate the  
24 precise information.

25 COMMISSIONER WARFIELD: Yes, ma'am, not a

1 problem.

2 CHAIRPERSON TAYLOR: Is there any other  
3 discussion?

4 COMMISSIONER BYRD: Excuse me. Through the  
5 Chair, if you pay this administrative fee, this goes to  
6 the City of Detroit, correct? So if my car was towed,  
7 do I have to pay the other fees that's connected with my  
8 car being towed to remove my personal possessions?

9 COMMISSIONER WARFIELD: Through the Chair, if  
10 all you want to do is remove your personal possessions  
11 and you're not going to claim the car, the answer to  
12 your question is no. You're only responsible for the  
13 \$75. However, if you're reclaiming your car, you need  
14 to pay the storage fees and the fee that it cost the  
15 tower to tow it and the administrative fee that it cost  
16 the police department to be on the scene to tow it.

17 And I think it has to be clear that we are  
18 only talking about police authorized tows. We are not  
19 talking about any other type of tows, just when the  
20 police has to respond to the scene and put personnel on  
21 the street and, you know, get -- basically bill the city  
22 for those hours.

23 COMMISSIONER BYRD: I see. So, it's strictly  
24 restricted to a police tow, not a private towing  
25 company?



1 COMMISSIONER WARFIELD: Yes, exactly. Thank  
2 you, sir.

3 CHAIRPERSON TAYLOR: Is there any more  
4 discussion?

5 COMMISSIONER WHITE: Call for the question,  
6 Madame Chair.

7 CHAIRPERSON TAYLOR: Motion is in order. Is  
8 there a motion?

9 COMMISSIONER WARFIELD: Ma'am, there's already  
10 a motion on the floor. I moved to adopt it, and there  
11 was a second.

12 CHAIRPERSON TAYLOR: It was already? Was  
13 there a second?

14 COMMISSIONER WHITE: I support, Madame Chair.

15 CHAIRPERSON TAYLOR: It's been moved and  
16 supported. Is there any more discussion on that? All  
17 in favor?

18 COMMISSIONERS: Aye.

19 CHAIRPERSON TAYLOR: All opposed? The motion  
20 carries to adopt the collection of the towing  
21 administrative fees.

22 COMMISSIONER WHITE: Madame Chair, I do have  
23 another point of old business. At our December  
24 community meeting, there was a situation that this Board  
25 asked for followup through the Chief's Office. And that

1 was a communication as related to the elevator not  
2 properly working at the 2nd Precinct, preventing the  
3 citizens of the Citizens' Community Council from holding  
4 that meeting at that location and also preventing those  
5 who may have physical challenges from accessing the  
6 second floor community space.

7 And I would just ask through the Chair,  
8 Mr. Secretary, if there is an update or through the  
9 Chief's Office, if that situation has been corrected to  
10 date.

11 CHAIRPERSON TAYLOR: The Board did send a  
12 letter. We did send a letter, but there has been no  
13 response from the company. And we will be pursuing that  
14 next week.

15 DEPUTY CHIEF YOST: Through the Chair, my  
16 apologies that you have not received a response. I will  
17 make sure that it is brought to the attention of the  
18 chief.

19 CHAIRPERSON TAYLOR: Thank you, ma'am. All  
20 right. Then is there no more old business? I can then  
21 announce next Thursday, January 16th, 2013, at 3:00,  
22 p.m., will be the next meeting at the Detroit Public  
23 Safety Headquarters. Again, the next meeting is  
24 Thursday, January 16th, 2014, at 3:00 p.m., at the  
25 Detroit Public Safety Headquarters.

1                   Now we will entertain oral communications from  
2                   the audience. I really like this part. So, please,  
3                   will you come up? Will you please limit your comments  
4                   to two minutes and address your issues to the Board,  
5                   please?

6                   MR. JOHNSON: I'm going to do it real quick  
7                   and then sit down. First, again, my name is Don  
8                   Johnson, president of 12th Precinct community relations.  
9                   And first of all, I want to thank my captain and my  
10                  police community relations group 'cause without them, we  
11                  wouldn't be where we are. My question concerns this.  
12                  And I don't know if you can answer the question, but I  
13                  ask this question all the time. When will our officers  
14                  who is out there protecting and serving us get some of  
15                  their money back?

16                  They have lost 10 percent of their pay two or  
17                  three times over the past two or three years. And I  
18                  know there is a lot of things happening in Detroit, a  
19                  lot of things are going on. Is there a plan somewhere  
20                  with somebody to get these officers their money so that  
21                  they can improve their way of life with their families  
22                  'cause 10 percent pay cut two or three times, that makes  
23                  it hard to keep your family intact. Thank you.

24                  CHAIRPERSON TAYLOR: Is there anyone from the  
25                  -- Chief Yost, did you want to address that?

1 DEPUTY CHIEF YOST: I think it was well said.

2 CHAIRPERSON TAYLOR: Go ahead. Your name?

3 Please state your name.

4 MR. GOLSON (Phonetic): Okay. Good evening.  
5 My name is Thomas Golson (phonetic) or as I sign my  
6 letters to the editor, Thomas Golson, Jr. I'm the vice  
7 president of as we directly refer to ourselves as the  
8 great Northwestern District police community relations  
9 organization. It's a whole lot to say and a lot to  
10 write. Anyway, I don't really have a question. But I  
11 just want to bring up an article that Rochelle Riley had  
12 written. I think it was in last week's Detroit Free  
13 Press. And it was about celebrating the Detroit Police  
14 or as I call them, Detroit's finest. And they should be  
15 celebrated.

16 As Mr. Johnson or Don has just finished  
17 saying, they have taken 10 percent cut after 10 percent  
18 cut after 10 percent cut. And they get up in the  
19 morning, they put the uniform on and their badge. And  
20 they go out there to uphold the oath that they took to  
21 protect and to serve. And you all, you know, we should  
22 celebrate the police every time we get a chance. And,  
23 you know, the folks who want to sit there and down the  
24 police because one officer did something, as I said,  
25 stupid. You want to take a broad brush and just paint

1 all of them? No. You remove that officer, and we hold  
2 the rest of them up because as Don said, a 10, 20,  
3 30 percent cut, over however long it is, that's a whole  
4 lot to put a serious dent into their style of living.

5 And, I mean, I agree with them, when is there  
6 going to be something done? And I understand about  
7 concessions. Once it's conceded, there ain't no coming  
8 back. But, I mean, we would like to see them get back  
9 to that. And, you know, my hat is off to them. They do  
10 a job I wouldn't do. You couldn't give me enough money  
11 to do what some of you guys up here have done as well as  
12 the women and for it to be safe for me to go out there  
13 and do my business and for my kids and my grand kids to  
14 go out and play and have fun and what have you. And  
15 well, thank you for the time for letting me speak.

16 CHAIRPERSON TAYLOR: Thank you, sir.

17 MR. GADDIES: My name is Lee Gaddies. I'm  
18 here representing the Bagley Community Council. I'm on  
19 the executive board. I'd like to welcome Mr. Byrd from  
20 District 2. Congratulations on your appointment to the  
21 Board. I'm here to express my desire to have the  
22 equestrian unit that works out of Palmer Park expanded  
23 as a tool for community relations. Over the course of  
24 the last several years, I have seen how families have  
25 come out of their homes and engaged the police officers

1 on horseback. And I think that can be utilized as a  
2 tool for information gathering for the police department  
3 and also to build good will and trust between the  
4 community and the police, especially with our young  
5 kids, you know.

6 I particularly remember Tiny stands out. I  
7 mean, the police officer's came up to me on here when he  
8 is on that horse. But it's a giant black draft horse.  
9 But, you know, just the fact of that presence and  
10 there's a living animal and it's something that kids  
11 don't see every day, you know, because that horse -- and  
12 I think it's a good way to build, like I said, relations  
13 and do outreach to the community with those horses.

14 And I think it's an underutilized resource  
15 that's right here in our neighborhood and especially for  
16 Northwest Detroit. And I think that the citizens would  
17 be happy to see more of a police presence. I mean, it's  
18 good to see cars driving up and down the street. When  
19 you're able to actually walk out of your house and speak  
20 directly to the police officer and have that interaction  
21 between the police and the community, I think that's a  
22 very important information gathering tool because you  
23 have enough time to explain that, hey, this is going on  
24 down the street and that's going on over there you know  
25 and really get to know the feel of the community.

1           And I'm thinking by having them anchored here,  
2           it gives us a unique opportunity that other  
3           neighborhoods don't have to build that type of  
4           repertoire with the officers. And even when we walk the  
5           trails, you know, you go back and you give them apples  
6           and carrots to the horses. And they are always really  
7           receptive about that, you know. So, I just wanted to  
8           lay that before this Commission. And hopefully I can do  
9           something to help expand this type of outreach with that  
10          resource that we have.

11           MR. CUMMINGS: Good evening, Board. My name  
12          is Markus Cummings. I'm the vice president of the  
13          Schaefer 7, 8 Lodge Community Association. First of  
14          all, let me say congratulations to you all.  
15          Commissioner Warfield, thank you for your service.  
16          Commissioner Byrd, congratulations. We look forward to  
17          having you at our community meetings this year. I'm  
18          here today actually because I talked to several  
19          neighbors. We have had a plethora of issues during the  
20          summer time. I know it's winter. But I just wanted to  
21          instill this now in terms of trying to correct some  
22          policy.

23                 The issue we have -- now, we are not anti-fun  
24          police, but it's with the basketballers. We don't mind  
25          certainly some kids playing basketball. But we have

1 grown men in the streets and it certainly has led to  
2 fights. We have actually had a gang fight on one  
3 street, Freeland. So, we want to cut this down. One,  
4 we want to get these basketball hoops off the street.  
5 Anyway, it's illegal as we all know. It's a state law.  
6 It's blocking the street. We need some sort of policy  
7 to make sure, one, either they're told, impounded or  
8 fined or citations or whatever, just something to make  
9 sure they're removed from the street because I have too  
10 many neighbors who are afraid to even sit on their porch  
11 because you have grown men playing basketball, and it  
12 leads to a fight. So that's one we definitely need to  
13 hammer out before the summer.

14 Another is fireworks. Now, 4th of July, I as  
15 a kid played with fire crackers. But at Vern Elementary  
16 School on July 4th, just call it Hart Plaza. Now, what  
17 we need -- and our president is here, Mr. Blackman.  
18 Last year we were out. We do thank DPS Police. They  
19 came out because it is DPD property. Patrolled, they  
20 stayed there as long as they could. As soon as they  
21 left, the party was on. We had over 400 people in just  
22 a two-block radius surrounding that school.

23 Now, DPD did come out. Unfortunately, I  
24 understand it is a holiday. So, it might not be that  
25 much manpower. But when they came out, they realized



1 they couldn't do anything because you got to let  
2 something like that die down. We need more manpower on  
3 July 4th watching over Vern Elementary so this does not  
4 happen again. This is not -- and like we said, we are  
5 not anti-fun. But it's a safety hazard because if there  
6 was a shooting or one of these fireworks flew into  
7 somebody's home and caught fire, fire trucks wouldn't be  
8 able to get through there. There be would mass chaos.  
9 That's something we look forward to hopefully fixing  
10 this year. Thank you again for your service.

11 DEPUTY CHIEF YOST: Through the Chair, we  
12 actually don't need a policy as relates to basketball  
13 hoops. We have a policy. Captain Balinski is  
14 completely empowered as are the officers that work for  
15 him to follow that policy and remove the hoops. They  
16 don't need to get anybody's permission. They can  
17 absolutely do it. We expect that they will. I know  
18 where Captain Balinski was previously assigned, they had  
19 one day a week where they would go pick up the  
20 basketball hoops. So, I imagine that something like  
21 that is coming to a precinct near you.

22 And the fireworks, I would encourage you to  
23 reach out again to Captain Balinski. He can work with  
24 DPS so they can secure their property. But I'm sure he  
25 can help you in that area. If he needs any assistance,

1 he knows he can reach out to Commander Fitzgerald or  
2 myself directly, and we will be happy to help.

3 MR. CUMMINGS: Thank you.

4 MR. WARD: Good evening. My name is Jim Ward.  
5 I'm president of Greenacres Woodward Community Radio  
6 Patrol. The community of Greenacres, we're located --  
7 our north boundary is 8 Mile Road. The south end is  
8 Pembroke Avenue, on the east is Woodward Avenue and on  
9 the west is Livernois Avenue. Within that community are  
10 about a thousand homes. And I just want to say thanks  
11 to Captain Balinski and the fine crew of the 12th  
12 Precinct. For the year 2013, we experienced a  
13 25 percent reduction in crime. Thank you.

14 MR. WELBORNE: Good afternoon to the Board.  
15 Congratulations on the new commissioners. My name is  
16 Bill Welborne, W-e-l-b-o-r-n-e. I'm president of City  
17 Wide Community Relations. I would like to say with the  
18 new commissioners coming in, I'd like to see you all  
19 attend more of the precinct meetings. Before, we didn't  
20 have enough people. But myself, I go to every precinct  
21 at least once a year. I try to make these meetings once  
22 a year because I think that's the only way I can get to  
23 meet the people and the people get to meet me and know  
24 what's going on in each precinct. That's the only way I  
25 can do it. When it comes to the meeting, I have a

1 chance to do as much.

2 Another thing is, I instituted a program city  
3 wide. We had our first awards ceremony at the 12th  
4 Precinct where we awarded 11 officers and one civilian a  
5 certificate for duty up above and beyond the call of  
6 duty. And it was real -- it made me feel real good when  
7 you got a guy that's 6 foot 2, 500 pounds come to you  
8 with a tear in his eye saying, you know, this is --  
9 nobody did this for me before and say I really  
10 appreciate it. You got a couple officers here tonight  
11 that got awards. And they -- you know, this is just for  
12 the police officers, the police officers, not for the  
13 sergeants or lieutenants and on up. It's for the guys  
14 -- the low ranking guys.

15 I'm a former military man. And I spent  
16 35 years in the service. And I always got credit for my  
17 men doing things you know. And they are the ones made  
18 me look good. And I think these guys should get some  
19 credit. And I'm going to tell you, every month -- next  
20 month, we are going to the 9th Precinct. It's going to  
21 get awards. We are awarding four officers in the 9th  
22 Precinct. And I think it's the -- I think it's the 9th  
23 Precinct. No, the 7th Precinct I think. But I'll check  
24 with my committee to see who is getting the awards.

25 CHAIRPERSON TAYLOR: Thank you, Mr. Welborne.

1 We just want to give the other guests equal time. Your  
2 time --

3 MR. WELBORNE: Time up? Okay. I didn't know  
4 he came back, just came back there.

5 MS. LOVE: Good evening, Commissioners.  
6 Congratulations, Mr. Byrd, representing District 2 where  
7 I live and Officer Shelby, and Mr. Bell and all of you.  
8 I just know you all personally. So, congratulations.  
9 Last year, I had an extraordinary experience because of  
10 my work in the community as precinct delegate and  
11 educator and I worked with young adults --

12 CHAIRPERSON TAYLOR: Excuse me. Your name?

13 MS. LOVE: My name is Leslie Love. I have --  
14 I work with a lot of LGBT communities. And if you don't  
15 know what those initials mean, gay, lesbian bisexual.  
16 And one of them came to me because they were raped. And  
17 I took them to the 12th Precinct. The experience at the  
18 12th Precinct showed me that there probably needs to be  
19 some sensitivity training in regards to dealing with  
20 those communities. And so, anybody who is representing  
21 Palmer Park or Palmer Woods, that area, and even Mumford  
22 High School and just in that area in general, there is a  
23 growing population of that. And I ask those officers  
24 and captains and commanders who are representing 12th  
25 Precinct and this area to be particularly sensitive to

1 those communities because if that was my child, if it  
2 was my daughter even, the way that was handled is not  
3 appropriate to me.

4 So, I hope that that's a part of the  
5 consideration and something that as Commissioners, that  
6 you make sure the officers are trained on if they are  
7 not already.

8 CHAIRPERSON TAYLOR: Thank you.

9 DEPUTY CHIEF YOST: Through the Chair, please  
10 get with Captain Balinski so we can find out the  
11 specifics of what happened. And let me assure you that  
12 the department has a policy that is very open and  
13 inviting. And it's certainly not the intent for us to  
14 have treated anybody in a way you don't think was  
15 appropriate. So, like I said, please give the specifics  
16 to Captain Balinski. Thank you.

17 COMMISSIONER WARFIELD: Madame Chair, just to  
18 piggyback on Sister Yost, I do know that the department  
19 is very serious about making sure that all of our  
20 citizens are treated with respect. And I know that  
21 there have been efforts and that there also has been a  
22 task force established within the department to make  
23 sure that that sensitivity is there. So, if that is not  
24 there, we certainly want you to reach out to our chief  
25 investigator here, Miss Pamela Davis-Drake, as well as

1 the department so that we can follow up on any issues  
2 because if we need to retrain, we certainly will do  
3 that.

4 But that is absolutely positively not  
5 acceptable in the city of Detroit. Thank you, ma'am.

6 DEPUTY CHIEF YOST: Through the Chair, one  
7 more thing. I just was told that the Chief is actually  
8 having an open forum with the LGBT community the end of  
9 February. Captain Roshay can give you the details. But  
10 there is apparently a forum scheduled.

11 MS. LOVE: Okay. Thank you.

12 CHAIRPERSON TAYLOR: Get with Miss Drake.  
13 Thank you.

14 MS. GARRETT: Good evening and happy new year  
15 to the new commissioners. And my Commissioner Byrd,  
16 welcome. I'm Cathy L. Garrett, and I'm the Wayne County  
17 clerk. I had no intention of coming to the mic.  
18 However, I am here seeking understanding. And I'd like  
19 to be educated by whoever. As I peruse the panel up  
20 here, the commission, I notice that I didn't see  
21 Commissioner Burton. So, I'm wondering can I be  
22 directed to the portion of the Charter or whatever the  
23 by-laws are that states that not only did I, the Wayne  
24 County clerk, he had a 3rd District Circuit Court judge  
25 swear him in because our city clerk was not obliging to

1 him.

2 And this is not to cause any distention here.  
3 But I'm a little perplexed. If I represent county wide  
4 and the judge is county wide, how is it that he is not  
5 allowed to sit? Is it in the Charter or in your  
6 by-laws?

7 CHAIRPERSON TAYLOR: Mr. Secretary?

8 SECRETARY ANTHONY: Yes, ma'am. I had a  
9 conversation with the corporation counsel, Mr. Butch  
10 Hollowell. And he indicated that the only way that they  
11 could be seated and conduct business is they have to be  
12 sworn in by the city clerk. And that is in the Charter,  
13 that they are sworn in by the city clerk.

14 MS. GARRETT: Okay. But again, not to cast  
15 any dispersions or anything, but I happen to be in the  
16 office. And prior to this gentleman had sought out our  
17 city clerk who would not avail herself to him. So, the  
18 fact he went to a circuit court judge that is a higher  
19 status than the city clerk, then because he was still  
20 uncertain if he was going to be okay, then I happened to  
21 be in the office, I obliged him.

22 So, I'm just putting on the record that if  
23 that was the case, then the city clerk should have made  
24 him aware of that and availed herself to him. So, thank  
25 you because I was quite surprised not to see him sitting

1 and to be educated to this point. Thank you.

2 CHAIRPERSON TAYLOR: Just a minute.

3 Mr. Secretary, with this new information, can you check  
4 again into that?

5 MS. GARRETT: And let's make sure no politics  
6 and bias plays into this. It's a new year. It's all  
7 about transparency and good government.

8 SECRETARY ANTHONY: For the record, we did  
9 advise Commissioner Burton that we will try to get him  
10 in tomorrow, that we will make appointments for him, and  
11 he was advised.

12 MS. GARRETT: Well, maybe they will make it  
13 happen for him.

14 CHAIRPERSON TAYLOR: He did tell me --

15 MS. GARRETT: A judge and the county clerk,  
16 give me a break. All right. Thank you.

17 CHAIRPERSON TAYLOR: Thank you.

18 COMMISSIONER BELL: Ms. Garrett, I'm glad you  
19 brought that issue up because as a newly elected  
20 commissioner, there was a lack of communication in terms  
21 of the process for the commissioners. I thought that we  
22 were not treated properly in reference to tradition of  
23 the council and the clerk and others. So, I think that  
24 this is good to be on record because we want to make  
25 sure that it does not happen again because we're duly



1 elected officials. And we are entitled to the Charter  
2 mandate in a timely manner because I pursued that by the  
3 city clerk prior to December 31st, going out of town.  
4 And some other commissioners sought a judge, which was  
5 not proper. So, I think that I'm glad you brought it  
6 up, and we can rectify that because this is something  
7 that should not be happening.

8 CHAIRPERSON TAYLOR: And yes, Ms. Garrett, we  
9 will look into that.

10 MS. GARRETT: I just felt that it's unjust to  
11 him. He's elected just like everyone else. But I will  
12 shut up.

13 CHAIRPERSON TAYLOR: Wait.

14 COMMISSIONER WHITE: Madame Clerk, before you  
15 step away -- and I heard the Secretary say that we are  
16 seeking to find a remedy for Mr. Burton who won his  
17 election. Would you be willing to write an opinion to  
18 this body that we could use, if you wouldn't mind? And  
19 Mr. Secretary, if you could share your contact  
20 information with the clerk, an opinion I believe would  
21 help us in our voice of advocacy to do what we need to  
22 do on our end.

23 MS. GARRETT: No problem at all. Thank you.

24 MS. SMITH: Good evening, Bernice Smith,  
25 political activist. On that subject, the mayor, the

1 council and the commissioners were all sworn in  
2 Wednesday. I was there. So, what happened that he is  
3 not sitting there tonight? That's my reasoning because  
4 I got after him because he didn't have a coat on, and I  
5 wanted him to look proper sitting there. So, I don't  
6 know what's going on tonight in regards to him. But I  
7 will let you take care of it, Mr. Secretary.

8 My thing is this. Deputy Chief, good to see  
9 you, dear. And to all the rest of the commissioners, I  
10 hope that you deserve sitting in those seats because of  
11 the fact that I am very very supportive of the police  
12 department. I come every Thursday, and I am looking to  
13 see all of you every Thursday. I talked with Lisa, and  
14 she understands the importance of being here at each and  
15 every one of the meetings that we have on Thursdays.

16 Now, if you're working, you're going to have  
17 to make some kind of adjustment, let your boss know that  
18 the police department meets every Thursday at 3:00, and  
19 I hope to see you there. I'm not sitting there because  
20 there was a little quirk in with Mr. Orr. So, I'll talk  
21 to him anyway. But in the meantime, I do wish for you  
22 to have support for our police department, I do. And I  
23 want all of you to also.

24 You did mention tonight about their salary. I  
25 have been fighting about that for the longest, for them

1 to get their money back and also for the insurance to  
2 come back to them. They living in the city of poverty  
3 in other words because they are not making it the way  
4 that they should and what they are used to making. I  
5 understand we do have four retirees on the Board. So,  
6 that makes me feel good to know that they understand  
7 what the police is going through.

8 In the meantime, I still say I want you to do  
9 a hell of a good job sitting there. And I want you to  
10 defend and know what the crime is all about out here.  
11 You have been in it. You know what it's all about.  
12 Rickie, I know you do because we go way back a long  
13 time. But in the meantime, the rest of you, I want you  
14 to know it is very important. These men that wear the  
15 uniform, they are out there risking their lives for us.  
16 And I want you to realize that. We got to take care of  
17 them. We got to give them all the support that we can  
18 give and the women. I was going to get to that. See,  
19 that's another retiree over here.

20 But in the meantime, I do wish you success and  
21 the best for you. And I will be here each and every  
22 Thursday to see that you're going to be here and see  
23 what you're going to contribute to our dear police  
24 department. And you, Warfield, I'm going to miss you  
25 because of the fact that you're very instrumental in

1 helping us understand what's going on. And I do wish  
2 that the towing company would be here, more of them be  
3 here so that they can hear that Resolution that you had.  
4 And I hope that you'll be able to give them a copy.

5 In the meantime, Chairperson, keep up the good  
6 work. And I'm very proud of you also. And we're going  
7 to have towers here on February 13th because they're  
8 going to be interested in knowing what this Resolution  
9 is all about. Thanks again for letting me speak to you,  
10 and good luck to all of you.

11 MS. HINES: Good evening. My name is Sandra  
12 Hines with the Detroit Coalition Against Police  
13 Brutality. I want to give you much kudos, Reverend  
14 Warfield, for the job that you did as our commissioner,  
15 chairperson. You did an excellent job. You really made  
16 the whole Commission, Board, professional. I have been  
17 here since all the way back to Reverend Holly, numerous  
18 ones. And it was never run as smoothly and  
19 professionally as under your leadership. And I really  
20 thank you.

21 I am from the 5th District where Mr. Burton  
22 represents. It's the largest district in the city of  
23 Detroit as it relates to the districts that was divided  
24 up. I feel that I'm finding out by being here that he  
25 is not sitting there. I don't know why. I just think

1 it needs to be fixed because we need to have him at the  
2 table because he is representing more people than any of  
3 the other commissioners here in the district. Well,  
4 close. Well, if he's not, he's one of the ones that's  
5 represented most of the people. It's a large district.  
6 And all I'm saying is that he deserves to be at the  
7 table to represent the people from the 5th District.  
8 And so, I don't know what happened. But let's get it  
9 together. And, Mr. Burton, I don't know if that's your  
10 empty seat. But if it is, you need to take it.

11 CHAIRPERSON TAYLOR: Mr. Burton, have you been  
12 here all night because I just realized that you were  
13 here.

14 MR. BURTON: Yes, I have been standing in the  
15 back there.

16 CHAIRPERSON TAYLOR: I'm looking at your  
17 information. We will talk to you later.

18 MR. BACHAND: Good evening, Nicholas Bachand,  
19 B-a-c-h-a-n-d. I welcome the new commissioners. I do  
20 come to almost every one of your meetings. I represent  
21 several of the different police area towers. And I look  
22 forward to working with you in the coming months and the  
23 coming year to make the city better, the police  
24 department better and the towing situation better.  
25 Thank you very much for being here.

1 CHAIRPERSON TAYLOR: Thank you.

2 MR. SCOTT: I'm Ron Scott. I wasn't going to  
3 say anything. I just wanted to say, Commissioner  
4 Warfield, thank you for your leadership over the years.  
5 And in addition to that, I just wanted to add an  
6 additional receptive response to the new commissioners.  
7 Many of you I know, so forth, because when somebody said  
8 that some of you were police officers, there was some  
9 reticence about whether or not police officers could be  
10 objective. In fact, that's what we have been fighting  
11 for all these years is for objective policing. So, I'm  
12 glad to see that some of you there are those kinds of  
13 individuals who have upheld both the badge and I know  
14 you will uphold the framework of the Commission. So,  
15 good to see you here.

16 Secondly, Commissioner, I'm so glad to say,  
17 Commissioner Taylor, it's always good to see a woman  
18 rise to power. And I'm glad to see that she is here.  
19 And Commissioner White, I'm pointing out the letter that  
20 you wrote, Commissioner White, relative to restoring the  
21 powers of the police commission. And I hope that you as  
22 commissioners will look at that and take that up because  
23 we did not have the efforts to have an elected  
24 commission, which many of us have fought for for years,  
25 to have it lost in relationship to essentially a

1 non-democratic process.

2 So, I want to give kudos to Commissioner White  
3 and also Taylor in addition to that. So, I hope that  
4 you would take that up and that you have read that in  
5 the record, have you not, Commissioner Taylor?

6 CHAIRPERSON TAYLOR: Yes. But I don't know if  
7 you were here when I announced that I'll be meeting with  
8 the emergency manager either tomorrow or early next  
9 week in reference to that. So, we did get a response  
10 back from his office.

11 MR. SCOTT: If you need us to go there and  
12 have your back, we will.

13 CHAIRPERSON TAYLOR: I got your number, Ron.

14 MR. SCOTT: I always wanted to say, I have to  
15 fight to get money from the emergency manager. So,  
16 okay.

17 CHAIRPERSON TAYLOR: All right. Thank you,  
18 sir. Are there any other communications? Are there any  
19 other communications? Are there any other  
20 communications? If not, I move -- I'm sorry.

21 COMMISSIONER WHITE: Madame Chair, if I could,  
22 just a point of special privilege, one, to the new  
23 commissioners that are here, certainly I welcome you  
24 with an open hand and invitation. If there's anything  
25 that I can do to help the transition on to this body,

1 certainly my line of communication is open.

2 And the tenets of what this body has been  
3 charged with, I believe you know. If you didn't know,  
4 it's clear this evening that we have a very spirited  
5 community that is engaged with this body who comes to  
6 our meetings regularly to insure that, one, like  
7 Ms. Bernice say, we are doing what we supposed to do;  
8 but two, that we uphold as Executive Secretary Anthony  
9 has stated, one of the strongest models of civilian  
10 oversight that you will find anywhere in the country.

11 As a commissioner, we belong to the  
12 organization NACO, the National Association for Civilian  
13 Oversight of Law Enforcement. And as we look at models  
14 that exist around the country, certainly the Detroit  
15 model is one of the strongest models vested into the  
16 citizens to make sure that its police department work in  
17 tandem, which they have been.

18 But we have some very real challenges in front  
19 of us as relates to the powers of this Board and the  
20 powers vested in this Board as Mr. Scott stated. So  
21 please do review that letter. And I'd be happy to  
22 discuss it further in detail with you if you wish.

23 And to my colleague, Commissioner Warfield,

5 your endeavors. And I believe as is customary, with  
6 American tradition, that when someone has done their
