5 CHAIRPERSON CARTER: Good afternoon. Welcome
6 to the weekly Board of Police Commissioners meeting.
7 My name is Lisa Carter, Chair of the commission.

8 At this time I'm going to ask that
9 commissioners introduce -- no. I'm going to do the
10 invocation first.

11 I'm going to ask that Commissioner Bell --
12 thank you.

13 COMMISSIONER BROOKS: Welcome back.

14 COMMISSIONER BELL: Thank you.

15 CHAIRPERSON CARTER: We missed you last week.
16 I'm going to ask that Commissioner Bell do the
17 invocation, please.

18 COMMISSIONER BELL: Let us pray.

19 Heavenly Father, we thank you for this day.
20 We thank you for this afternoon. We thank you for this
21 meeting. We thank you for our Board of Police
22 Commissioners. We ask a blessing on the board and
23 their family. We extend that to Chief Craig and the
24 DPD family and all the citizens of the City of Detroit,
25 Heavenly Father. We ask that you continue to bless us,

1 keep us. And as we move forward in this meeting we
2 want to look out throughout this nation, that
3 individuals are having issues as we all know, we want
4 to lift them up in terms of their safety and their
5 well-being. We express our concern for those who need
6 a healing touch. Lord, we ask that you touch them in
7 so many ways. Those who are in bereavement and
8 sympathy, we pray for those families, Heavenly Father.
9 We just thank you that we have this opportunity as the
10 board as we move forward. We just thank you over and
11 over again for your blessing each and every day.

12 Let the church -- let's try that again. Let
13 the house say amen.

14 AUDIENCE: Amen.

15 CHAIRPERSON CARTER: Thank you, Commissioner
16 Bell.

17 And we're going to begin introductions.
18 Let's start to my right with Commissioner Sanders.

19 COMMISSIONER SANDERS: Commissioner Derrick
20 Sanders, At-Large.

21 COMMISSIONER MALLET: Commissioner Conrad
22 Mallett.

23 COMMISSIONER BROOKS: Commissioner Elizabeth
24 Brooks, At-Large.

25 VICE CHAIRPERSON DEWAELESCHE: Commissioner

1 Eva Garza-Dewaelsche, At-Large and Vice Chair.

2 COMMISSIONER BELL: Commissioner Willie Bell,
3 District 4.

4 COMMISSIONER CRAWFORD: Commissioner Reginald
5 Crawford, District 3.

6 COMMISSIONER VANN: Commissioner Edgar Vann,
7 District 2.

8 And I have a preaching license for
9 Commissioner Bell before he leaves.

10 CHAIRPERSON CARTER: Thank you, Commissioner
11 Vann.

12 At this time, commissioners, you have before
13 you the agenda for September 7th, 2017.

14 What's your pleasure?

15 VICE CHAIRPERSON DEWAEELSCHÉ: Move for --

16 COMMISSIONER MALLETT: Move for adoption.

17 VICE CHAIRPERSON DEWAEELSCHÉ: Second.

18 CHAIRPERSON CARTER: It's been moved and
19 supported that we approve the agenda for September 7,
20 2017.

21 Is there any discussion?

22 Those in favor?

23 COMMISSIONERS: Aye.

24 CHAIRPERSON CARTER: Those opposed?

25 The motion carries.

1 At this time, commissioners, you have before
2 you the approval for the minutes from August 31st,
3 2017.

4 COMMISSIONER MALLETT: So moved.

5 COMMISSIONER SANDERS: Second.

6 CHAIRPERSON CARTER: It's been moved and
7 supported that we approve the minutes from August 31st,
8 2017.

9 Is there any discussion?

10 Those in favor?

11 COMMISSIONERS: Aye.

12 CHAIRPERSON CARTER: Those opposed?

13 The motion carries.

14 At this time, Mr. Hicks, would you please
15 introduce the rest of the staff.

16 MR. HICKS: Thank you, Madam Chair. I do
17 want to indicate just before we get to those
18 introductions that Sergeant Quinn is taping the session
19 this afternoon, Media Service is doing audio visual
20 work, and that Sheila Rice is the court reporter.

21 And to my immediate right is, of course,
22 Mr. Brown. And if we go to -- I do want to note that
23 HR Director Oxendine is still away from the office.

24 And then if we go to the first row, starting
25 in the corner here is Mr. Wyrick who is our attorney,

1 of course, and Ms. Johnson who's in the fiscal area,
2 Ms. Blossom who's in our media community outreach, Ms.
3 White who is our policy person, of course.

4 And then I go to Interim Chief Investigator
5 Lawrence Akbar who will in turn introduce himself and
6 other members of his staff as well who are here.

7 MR. AKBAR: Good afternoon, honorable board.
8 I'm Chief Investigator Lawrence Akbar from the Office
9 of Chief Investigator. I have the pleasure of
10 introducing my talented staff. I'm going to start off
11 with Acting Supervising Investigator LiSonya Sloan,
12 Senior Investigator Adela Rivera, Investigator Carolyn
13 Nichols, Investigator Coleman, Investigator Marquitta
14 Stanton (ph) and last -- Investigator Gianna Coulter
15 (ph), and last but not least Investigator Daniel
16 Calloway. Thank you.

17 MR. HICKS: And, Madam Chair, you do have a
18 quorum.

19 CHAIRPERSON CARTER: Thank you. I'd like to
20 acknowledge the presence of Commissioner Willie Burton.

21 COMMISSIONER BURTON: Present, Madam Chair.

22 CHAIRPERSON CARTER: Thank you for joining
23 us.

24 At this time I'd like to introduce standing
25 in for Chief Craig is Assistant Chief Williams.

1 A.C. WILLIAMS: Through the Chair, thank you
2 very much. The Chief he has a certain amount of
3 vacation days. Last year he didn't use all of them so
4 they took them. So he utilized one of those days.

5 Again, I'm going to start off with Deputy
6 Chief Barren and ask for all our members if you'll
7 raise your hand and just state who you are and where
8 you work for all the department members.

9 D.C. BARREN: Deputy Chief Barren,
10 Neighborhood Policing East.

11 COMMANDER SIMS: Deshaune Sims, Commander of
12 number 12 precinct.

13 CAPTAIN CHAMBERS: Captain Michael Chambers,
14 Internal Controls.

15 LIEUTENANT PECK: Lieutenant Joseph Peck,
16 Office of Neighborhood Policing.

17 SERGEANT HEWITT: Sergeant Gerald Hewitt,
18 Office of the Chief.

19 SERGEANT TORRES: Sergeant Torres, Office of
20 (Inaudible).

21 (Inaudible)

22 SERGEANT ENGEL: Dawn Engel, SVU.

23 (The balance of the staff introductions were
24 inaudible.)

25 CHAIRPERSON CARTER: Is that it, sir?

1 A.C. WILLIAMS: That's it.

2 CHAIRPERSON CARTER: Thank you. Thank you
3 all for coming.

4 At this time are there any elective officials
5 or representatives of elected officials? If so, please
6 stand and give your name for the record.

7 MR. DIVERS: Members of the board, I'm Arthur
8 Divers. I'm the liaison for the Honorable George
9 Cushinberry, Detroit City Council, District 2.

10 CHAIRPERSON CARTER: Thank you, Dr. Divers.

11 At this time, as the Chair mentioned in his
12 invocation, on behalf of the board we continue to
13 express our support and concerns for our fallen
14 officers and their families.

15 Also on the agenda today we will not have a
16 presentation today from Human Resources as Director
17 Oxendine is still away from the office dealing with a
18 death in her family. And I've asked Director Oxendine
19 to provide us with her normal update in October. So
20 she'll be giving two reports in October.

21 As I'm sure everyone is aware, the southern
22 parts of our nation continues to be lashed by tropical
23 storms and hurricanes. We express our condolences to
24 the families whose lives have been changed by these
25 dramatic storms. Within the next few days I am

1 encouraging commissioners to support the Chief in
2 outstanding efforts to help support First Responders in
3 that region.

4 I also understand that the DOPC staff is
5 looking at ways that we can make a more direct
6 contribution to the relief effort even as we will be --
7 even though we will be away from the city attending the
8 NACOLE conference next week. So please expect an
9 E-mail with those details.

10 I've also added to the agenda the Chief's
11 recommendations for the fourth round of departmental
12 promotions for lieutenants and sergeants. A summary of
13 the promotional package was E-mailed to the board
14 members on Tuesday. I'm hopeful that we can move on
15 this matter later in the meeting.

16 Our conference packages for NACOLE are
17 available today and you should have binders. Those of
18 you who don't have binders will receive them even
19 though you're not going to the conference. And I want
20 to thank the staff for putting together the binders.
21 They are very well done. And hopefully, commissioners,
22 you'll get a chance to look at everything in the
23 binders.

24 Again, because of the conference we have
25 cancelled the September 14th meeting. Our next meeting

1 we will return is a community meeting to be held
2 Thursday, September 21st, 2017 at the Operating
3 Engineers, Local 324 located at 1550 Howard Street,
4 Detroit, Michigan. Our commissioner host for the
5 community will be Commissioner Sanders and myself.

6 And last but not least, many of our young
7 people have already begun to return to school. I ask
8 the department and members of our community to extend a
9 watchful eye in an effort to protect our young people
10 as they engage in one of the most important and
11 challenging endeavors of their lives. The education of
12 our children is one of the most important
13 responsibilities that we have as a society. We
14 encourage all to take special advantage of the
15 necessary preparation toward our collective futures.

16 And, I'm sorry, in conclusion, I want to end
17 my report by letting Detroiters with families in the
18 regions affected by Harvey, and now Irma, that we stand
19 with you. And to all those impacted we are praying for
20 you, and we hope you stay safe and experience the best
21 possible outcomes.

22 So that concludes my report, commissioners.

23 At this time we're going to have a report
24 from A.C. White.

25 A.C. WILLIAMS: So I'll put on my A.C. White

1 hat.

2 CHAIRPERSON CARTER: Williams. I'm sorry.
3 Okay. W, W. I'm sorry.

4 A.C. WILLIAMS: That's okay. I'm going to
5 look back at all of the recorded sessions we have and
6 see how many times I was actually called Williams.

7 CHAIRPERSON CARTER: Okay.

8 A.C. WILLIAMS: Because I think I'm actually
9 going to change my name tomorrow.

10 So we continue to trend down. Currently for
11 our violent crime we're at seven percent reduction
12 year-to-date compared to 2016. And also with our
13 property crime we're seven percent down year-to-date.

14 The one thing I do -- I would like to do is
15 just talk about the officers we have going down to
16 Texas and help out Houston. And what they're literally
17 doing is it's a drive to assist the First Responders
18 who are responding to all those individuals who have
19 need down in Houston. And a lot of times a lot of us
20 will forget that the First Responders are also citizens
21 of the community. So not only are they affected, but
22 they have to -- in addition and overcoming being
23 affected by Hurricane Harvey, they also have to make
24 sure that they take care of everybody who's affected by
25 it.

1 So this drive was basically put together to
2 get down needed items that those First Responders would
3 have who are working some up to 20 hours a day to
4 ensure that they can continue doing what they're doing
5 down there.

6 We have ten members who volunteered to go
7 down. They're going to be going in a RV and they'll be
8 escorting the semi down.

9 Chief Craig who was on a vacation day today
10 actually came in to see that truck off and to do a
11 brief news conference prior to that. I tried to talk
12 to him for a brief second. He said, "I'm on vacation,
13 Arnold, so make this quick."

14 But after the brief conversation it's a great
15 thing that the entire community, not just the city of
16 Detroit, but outside agencies, outside cities, all came
17 in and donated, members who are on the department,
18 members of the community, business members. It was
19 just a great thing to see.

20 So that's pretty much all I have. Are there
21 any questions for me about crime or anything else I'll
22 take at this time?

23 CHAIRPERSON CARTER: Commissioners?
24 Commissioner Bell.

25 COMMISSIONER BELL: Madam Chair, I just want

1 to appreciate the Chief's initiative to respond to the
2 First Responders under those situations. As you well
3 know, we had a police officer from Houston PD trying to
4 make it to report to duty and lost his life. And I was
5 in Memphis recently and encountered some of the people
6 who had fled out even, you know, from the Mississippi
7 to Memphis area in terms of that situation. So I think
8 that's really a noble effort to have that, you know,
9 initiative to respond in that manner.

10 And I want to compliment D.C. Barren for
11 attending the Fifth Precinct police community meeting
12 last night and sharing introduction and also sharing
13 some of their concerns with the people there. It was
14 well attended, as you well know.

15 And I just want to encourage that perhaps we
16 need to do more as police commissioners. We have about
17 11 different police community organizations that have a
18 citywide meeting. But, as I tried to explain, most of
19 them do not attend our meetings, or even when we host
20 in that area. And I got a little feedback in terms of
21 our last meeting, you know, at the marina there.

22 So I want to try to challenge us to -- first
23 of all, we need to really go to them and have some type
24 of interaction, some Powerpoint, to really explain the
25 role of what we take for granted. But police community

1 relations have been around for -- ever since I was on
2 the department back in 1902.

3 I had to throw that out for Commissioner
4 Mallett, because he always --

5 COMMISSIONER MALLETT: I was waiting.

6 COMMISSIONER BELL: He always dates me.

7 COMMISSIONER MALLETT: That was going to be a
8 nice slow one right down the middle. I was going to
9 knock that one out of the park.

10 COMMISSIONER BELL: But I think it's crucial
11 that -- and I talked to Ms. Pannell and -- you know, we
12 just need to do more of that to -- because sometimes I
13 think they sort of lose their thrust. But the thrust
14 is they're a police community forum. That's why
15 they're there. And we want to make sure that they
16 stick to their mission and they're on focus point. So
17 they change leadership quite often. And I think we
18 just need to have more interaction in each district
19 especially and then also at large. So I just want to
20 commend the D.C. for taking time out in terms of his
21 scheduling.

22 So on a little note, there's no vacation time
23 for a Chief of Police so -- but I understand if he
24 wanted to get away for a minute, but I appreciate that.

25 Thank you, Madam Chair.

1 COMMISSIONER BURTON: Through the Chair.

2 CHAIRPERSON CARTER: Commissioner Mallett.

3 COMMISSIONER MALLETT: Go ahead, Burton.

4 COMMISSIONER BURTON: I just want to just
5 bring a correction. You mentioned for the Third
6 Precinct community relations meeting when we come back
7 that you and Commissioner Sanders will be hosting that.
8 I also have a large portion of 3. I think you and I
9 are the two commissioners that represent 3. So I was
10 not mentioned as a cohost.

11 CHAIRPERSON CARTER: Okay. Commissioner
12 Mallett.

13 COMMISSIONER MALLETT: Along the same lines
14 as Commissioner Bell, I'm wondering in order,
15 Commissioner -- Madam Chairperson, in order to make our
16 police committee meetings more effective, I wonder if
17 we could consider coordinating the precinct community
18 meeting. Why couldn't we have our Board of Police
19 Commissioners meeting before the precinct meeting or
20 somehow or another coordinate the schedules? Because
21 if part of what we want to do is educate the community,
22 from the hospital business increasingly we have to go
23 where the people are and stop expecting that if we
24 really want to change their health status they have to
25 come to us, because when they come to us it's an

1 emergency. If we're going to intervene in an organized
2 manner, we have to go to them.

3 So I would think that maybe we would have the
4 secretary of the board think about ways for us to be
5 present in an organized manner where the 11 community
6 agencies that Commissioner Bell was talking about are
7 already having something. Maybe we can tag on and
8 maybe we can -- because I was at a community meeting
9 last night.

10 And, Madam Chairperson, this is just an
11 interesting thing. I was looking at the administrative
12 messages here on license plate readers. And I read
13 through it real quickly, because lots of people who I
14 thought were thoroughly informed who are telling me --
15 and, A.C. Williams, maybe you can inform me, because
16 this does not appear to support what was being said.
17 But last night people in the community were saying that
18 the police department has the ability to drive down the
19 street and through some mechanism determine whether or
20 not they have current insurance.

21 Is that right?

22 COMMISSIONER CRAWFORD: That's the state.

23 A.C. WILLIAMS: So right now through our Law
24 Enforcement Information Network if we run your
25 registration or your VIN it should come back if you

1 have valid insurance.

2 COMMISSIONER MALLETT: So if you run the --
3 so I'm driving in my car and let's suppose that I make
4 a right turn that you might think is a little faster
5 than it should have been. So you can check to see
6 whether or not obviously the car is stolen, this, that
7 and the other, but then also you determine whether or
8 not we have insurance?

9 A.C. WILLIAMS: Yes. And that's going to be
10 connected through SOS. So when you apply for your
11 registration you have to provide proof of insurance.

12 COMMISSIONER MALLETT: Right.

13 A.C. WILLIAMS: So that's how that is
14 attached to the actual plate when we do the stop.
15 Sometimes it doesn't work for us. So what the state
16 has done is they changed the laws. You don't have to
17 have paper proof of insurance. You can show it to us
18 on your phone.

19 So what the whole purpose of it is to
20 actually aid the citizen to more accurately or more --
21 I guess have a greater availability to show proof of
22 insurance in case they lose that piece of paper.

23 COMMISSIONER MALLETT: But when you come up
24 to the car you already know if my insurance is valid?

25 A.C. WILLIAMS: Yes, for the most part. Now

1 sometimes the system doesn't work, but that can happen.

2 COMMISSIONER MALLETT: Wow.

3 A.C. WILLIAMS: Because the LEIN is slow
4 sometimes or the LEIN is not working sometimes, but if
5 everything is in a perfect world and everything is
6 working, I'll know when I go up to your car if it's a
7 valid registration and if you're insured.

8 COMMISSIONER CRAWFORD: Through the Chair.

9 COMMISSIONER MALLETT: Well, hold on
10 Crawford. I ain't done.

11 COMMISSIONER CRAWFORD: I didn't hear
12 anything.

13 COMMISSIONER MALLETT: Well, I'm trying to
14 get over being stunned, man.

15 So I mean -- and so now, Madam Chairperson, I
16 mean obviously I'm a member of the Board of Police
17 Commissioners and I did not know that. And so there
18 are -- there was a lot of confusion in the audience
19 about whether that was true, A.C. Williams, whether it
20 was not what would prompt -- and so what would prompt
21 the occasion to investigate whether or not the license
22 actually was proper and everything associated with it
23 was current.

24 So I do -- this goes back then to the point
25 that Commissioner Bell was making. There's just a ton

1 of information about the rules and regulations of life
2 in general, but particularly as it relates to how we
3 manage ourselves in public that people just don't know.

4 I remember we were talking about the very
5 unfortunate incident involving Bishop Vann, about the
6 level of tint associated with your window, number one,
7 and number two what the requirement is of the citizen
8 if you have a tinted window, what you're supposed to do
9 when the police officer walks up to your car. I
10 guaranty you 99.9 percent of the people in the city of
11 Detroit don't know that.

12 And, A.C. Williams, then obviously what was
13 being said last night was true. What they were saying,
14 Madam Chairperson, was that then the whole towing
15 controversy then pops back up, because if you're now
16 driving in the car and it's not properly licensed and
17 you're -- let's suppose they see that your driver's
18 license is also expired or something like that. So
19 you're not supposed to be driving, the car gets towed.
20 I mean, this -- what they were really suggesting that
21 this was some kind of conspiracy around getting cars
22 towed. And I couldn't answer the question
23 appropriately, because I didn't have any -- I didn't
24 have the information to respond.

25 So I just point out that to Bell's point

1 about educating the community somehow or another we
2 have got to produce a citizen guide to little known
3 facts about citizen responsibility. Because, I tell
4 you, every time I come here I learn something that I
5 did not know, and I'm the former Chief Justice of the
6 Michigan Supreme Court. And I just did not know, man,
7 that you could drive down the street and figure out
8 that if my insurance was current. And for a lot of
9 people, of course, that's a huge issue, particularly
10 the people who are getting LA Insurance that's seven
11 days long.

12 So I mean it's just an issue. And we have to
13 do a better job I think of presenting this information
14 so that people don't attach to the police departments'
15 very appropriate execution of their responsibility, you
16 know, some kind of bad intention, but people when they
17 don't know assume the worst.

18 Thank you, Madam Chair.

19 A.C. WILLIAMS: And through the Chair, just
20 to make one quick address to that, what we glean from a
21 plate we can't stop. If we run a plate and we find out
22 that your vehicle is an unregistered vehicle, I can't
23 stop you because what I read is the vehicle is a
24 unregistered vehicle. It has to be some type of a
25 moving violation or some infraction where I can stop

1 you where I actually can say, okay, now I see that your
2 vehicle is unregistered. It has to be something. It
3 has to be some visible violation.

4 COMMISSIONER MALLETT: Well, A.C., now come
5 on.

6 A.C. WILLIAMS: Well, listen --

7 COMMISSIONER MALLETT: I mean, that may be
8 very true in Detroit, but I drive through Ferndale
9 taking my kid to school regularly, and the police swoop
10 in right in behind me, and they're trying to make damn
11 sure that the African-American man in this Cadillac
12 with this kid is properly in the place where he is
13 currently. So --

14 A.C. WILLIAMS: I'm not talking about -- I'm
15 talk about running LPRs. So for the license plate
16 reader, or if I'm typing your plate in, if I see that
17 you don't have insurance I'm not going to stop you
18 because you don't have insurance. I did misspeak. If
19 I type it in, it shows that your plate is not
20 registered or that the registration is expired, I can
21 stop you for that. But, if it shows that you don't
22 have insurance, I can't stop you for that.

23 COMMISSIONER MALLETT: Okay. And so I hope
24 you're always the person behind me, because I don't
25 believe that for a second.

1 COMMISSIONER VANN: Yeah, I don't either. I
2 don't either, not after what I've been through.

3 CHAIRPERSON CARTER: Mr. Crawford.

4 COMMISSIONER CRAWFORD: Yes, ma'am, through
5 the Chair and through Commissioner Mallett.

6 What I want to say is that I think that took
7 effect approximately maybe a year or so ago where the
8 State starting entering all this information into the
9 system. And as Chief just expounded on also, too, your
10 license plate readers will show that automatically
11 without even manually entering that into the system
12 that your insurance is expired. And also, too, if you
13 don't -- I mean expired outside of even 30 days. If
14 you don't renew your insurance, it will automatically
15 show up, because the insurance companies send that
16 information to the State. I believe it's like every
17 couple weeks that data is updated. So if you don't
18 renew your insurance.

19 And also, too, everything is paperless now.
20 It's gone high tech. You can keep it on, as was
21 stated, on your cell phone. There are cell phone apps
22 that if you go to your insurance website you can
23 download a mobile app and it will put this on your
24 phone. And, of course, you're supposed to have the
25 actual proof of insurance, which is paper in your car,

1 but if you don't to my understanding it is acceptable
2 for them to just look on your phone and see that it is
3 current, so ...

4 CHAIRPERSON CARTER: Thank you, Commissioner
5 Crawford.

6 Commissioner Dewaelsche.

7 VICE CHAIRPERSON DEWAEELSCHÉ: I actually had
8 a question about -- I'm going to go back to the Houston
9 initiative we have with the department. How many
10 officers were we sending and also how long were they
11 going to be there or do we have an idea?

12 A.C. WILLIAMS: So we're sending ten
13 officers. And they're literally just going to be there
14 to deliver the supplies that they have, but they are
15 going to stay for that sergeant's funeral. So after
16 the sergeant's funeral they're going to come back.

17 VICE CHAIRPERSON DEWAEELSCHÉ: Okay. Great.
18 And then I just -- one other comment. Thank you,
19 Chief. One comment regarding what Commissioner Mallett
20 is indicating about having the meeting in one of the
21 precincts, you know. They have 12 meetings a year, I
22 believe, and we could schedule one meeting. I think
23 the challenge would be that the precinct would not be
24 large enough --

25 COMMISSIONER MALLETT: Yeah.

1 VICE CHAIRPERSON DEWAELSCHE: -- to hold, you
2 know, our police commission meeting. I'm just thinking
3 of 12 --

4 COMMISSIONER MALLET: No, no. I hear you.

5 VICE CHAIRPERSON DEWAELSCHE: -- where we
6 have the meetings. But we could, you know, one meeting
7 a year for that precinct we could have it at a
8 different venue. I think that's an excellent idea.

9 And I agree with Commissioner Mallett. There
10 are a lot of things that they just don't know, and this
11 would be a great -- an opportunity for us to provide
12 them with that to educate them. So I agree with that.

13 Thank you.

14 CHAIRPERSON CARTER: Thank you.

15 Commissioner Crawford.

16 COMMISSIONER CRAWFORD: Yes, ma'am, through
17 the Chair.

18 Assistant Chief, if Deputy Chief Barren could
19 come up and expound on something we discussed last
20 week, the issue pertaining to outside units coming into
21 the city of Detroit, the procedure, protocol and policy
22 that is now in place or soon to be implemented.

23 D.C. BARREN: And through the Chair, I'll
24 touch back on what Commissioner Bell was referring to,
25 because this issue did come up at the community

1 meeting. They were very concerned about what happened
2 with the West Bloomfield incident. And so we'll go
3 back to what the Detroit Police response is. After
4 this aired and became such a big deal, the Police Chief
5 directed us to come up with a protocol for the courtesy
6 call of a outside agency calling us to let us know
7 they're going to exercise a search warrant or an arrest
8 warrant in our city.

9 And the reason I put the emphasis on courtesy
10 call is because once their warrant is signed by a judge
11 or a magistrate there's no law that makes them contact
12 us or have us present at the search warrant or arrest
13 warrant. So it's a courtesy.

14 We do, as Detroit Police Department, when we
15 go outside the city we give courtesy calls, and
16 generally that agency will send someone with us. And
17 so we're asking these agencies do the same.

18 And before I go on to the actual protocol, we
19 did make contact with a number of agencies outside the
20 city, verbal phone calls, to include the task force
21 that did exercise that warrant in the city that drew
22 the controversy. They were excited about the protocol
23 once we went over the parameters of it and said it
24 makes sense.

25 So dive into the actual protocol. So the

1 outside agency wants to exercise a search warrant or an
2 arrest warrant in the city of Detroit. They will call
3 Communications. Communications will then collect the
4 information by way of who's calling, what the agency is
5 and a phone number and then a staging area so that we
6 can send a DPD liaison to meet with them.

7 The Communication section will then contact
8 Detroit Police Department's metropolitan division
9 captain, commander and deputy chief in ascending order.
10 And so the captain who received the first call he would
11 assign a supervisor from the metropolitan division to
12 rendezvous with that agency, and then again that
13 supervisor will serve as the liaison.

14 And so the definition of what the liaison is,
15 so the liaison responsibility will be to, one, provide
16 a presence, a visible presence that DPD is on scene and
17 available. And the liaison would interact with the
18 community who would come out and have concerns. The
19 liaison would call for additional units or call for EMS
20 when those needs arise.

21 And again, and I'll put the emphasis on this
22 point, because in that particular incident there was
23 allegations of some mistreatment to our citizens. So
24 that supervisor would be responsible for and have the
25 courage to report or intervene in any misconduct geared

1 towards the citizens or refute any allegations of the
2 same.

3 One thing that the liaison would not do, he
4 would not be involved -- he or she would not be
5 involved in the tactical deployment, and they will not
6 report directly to the location for obvious safety
7 reasons. I will not go straight there, but rather ask
8 permission before I go to the staging area and come in
9 together.

10 This process is working. As recently as
11 today, Dearborn called for a narcotics warrant. Prior
12 to that FBI and another agency before that. So it is
13 working, and we are deploying that liaison.

14 Any questions?

15 CHAIRPERSON CARTER: Any questions,
16 commissioners?

17 Commissioner Crawford.

18 COMMISSIONER CRAWFORD: Yes, ma'am. Thank
19 you for that, Deputy Chief. Above all of this I think
20 it's most important just about safety, too, is the
21 safety of the officers. You know, officers coming in
22 and outside the city, it's a matter of officer safety.

23 Years ago, I mean some 30 years ago, I worked
24 undercover for seven years, and every time we left the
25 city of Detroit we did a lot of surveillances in

1 suburbia. Sometimes we started them out there and came
2 in because of information we had most often we went
3 from the city of Detroit there. We always notified
4 outside agencies. We didn't -- and oftentimes they
5 won't tell you what they're doing out there or what
6 they -- you know, why we were there, but we let them
7 know that we were there, for the purposes that we're
8 there, we're in that particular area, you know. We
9 don't have to basically tell them, and they didn't
10 really mind. But, like you said, it goes even beyond
11 -- well, I say it even goes beyond courtesy. It's
12 about officer safety.

13 And then, of course, what happened in these
14 two incidents in the city of Detroit is, you know,
15 people in the neighborhood, the community didn't -- you
16 know, they realize you got armored vehicles coming down
17 the street, and this is an outside agency and things
18 are done.

19 So I just want to commend you and the
20 department and the Chief and all who are involved in
21 basically -- you know, this is nothing new, because
22 this has been going on for years where, you know, we
23 always made outside notifications. But now, you know,
24 the protocol, procedures and policies in place that
25 this will be done just, you know, like you said, a

1 courtesy phone call, just let us know, you know,
2 citizens of the police department first and foremost
3 that you're coming in here and doing something.
4 Because, you know, we don't just go -- I mean, I'm
5 certain we don't just go into other cities and just do
6 things without making a phone call letting that police
7 department know that we're there.

8 So I want to thank you and, you know, I look
9 forward to things -- like you said, it's working
10 already with just the incidents that occurred today.

11 A.C. BARREN: Right. And through the Chair,
12 I would like to go back and talk about kind of what you
13 were pointing to. Deconfliction is what we call it.
14 What that is is a mechanism in place. And that is more
15 a mandate outside of the courtesy call. With
16 deconfliction you call in to the number and they will
17 alert the raiding crew, if you will, as to if there's
18 another unit or agency targeting that same location so
19 there won't be a blue on blue type situation. So that
20 is more of a mandate, but the actual courtesy call is
21 what it is and we have put structure to that.

22 In addition to that, I know I shared within
23 the AC's office we do have a teletype out with this
24 information containing what the procedure is, and I did
25 enforce the AC's office to --

1 A.C. WILLIAMS: It's still under review at
2 this time.

3 A.C. BARREN: So it will be out within a day
4 or so.

5 COMMISSIONER CRAWFORD: Yes, sir.

6 COMMISSIONER SANDERS: Through the Chair.

7 CHAIRPERSON CARTER: Yes, sir.

8 COMMISSIONER SANDERS: This question is for
9 A.C. Barren. Is it possible this board can get a
10 protocol of that here?

11 COMMISSIONER MALLETT: A copy.

12 COMMISSIONER SANDERS: A copy of it.

13 A.C. BARREN: Yes, sir.

14 COMMISSIONER SANDERS: The protocol.

15 CHAIRPERSON CARTER: It's still under review.

16 A.C. WILLIAMS: So the actual teletype is
17 still under review, but we can send out the tentative
18 plan that we actually submitted to all outside
19 agencies. So we can send that to the board. And then
20 the teletype, once the teletype is complete, I'll make
21 sure I send a copy to Mr. Hicks.

22 COMMISSIONER SANDERS: Thank you.

23 CHAIRPERSON CARTER: Any other questions?

24 COMMISSIONER BELL: Madam Chair, I just want
25 to make one more point in terms of all this dialogue

1 that people have a perception of police in America, and
2 that's based on all these TV shows. There's nothing
3 from "CSI" to "Law and Order," there's nothing about
4 protect and serve. If you want to watch policing in
5 action doing everything wrong, then if you tune in on
6 those TV shows that's the reality of Hollywood
7 presenting and that's what people see, and they feel as
8 though that's how we respond.

9 So Commissioner Mallett's correct. We must
10 enlighten commissioners. We must enlighten the public
11 also about our really role to serve and protect,
12 because young people growing up with that mentality,
13 with the video games and all that portrayed, and we
14 grew up with "Dragnet," now you've got "Law and Order."
15 See, there's nothing positive and redeeming about those
16 shows, but that is the image of law enforcement in this
17 country. So some people tie into that, police officers
18 tie into it, the public feel as though that's how we
19 respond.

20 You see them all the time, right? You watch
21 those shows. People love those shows, but there's no
22 redeeming value because there's no balance there. And
23 people have that perception of policing in America, and
24 that's something we're trying to buffer and trying to
25 encounter positively.

1 COMMISSIONER VANN: Madam Chair.

2 CHAIRPERSON CARTER: Commissioner Vann.

3 COMMISSIONER VANN: A couple of questions.

4 Since we were talking about the protocols and what have
5 you, unfortunately I was not able to be here last week.
6 And I know that you probably discussed ad infinitum the
7 incident with Damon Grimes, but I was just wondering
8 was there an update on the situation?

9 A.C. WILLIAMS: Right now the department is
10 still conducting their independent investigation. We
11 have not completed it. Once it's completed it will be
12 submitted to the prosecutor's office, Prosecutor
13 Worthy's office.

14 COMMISSIONER VANN: I want to add that I
15 think that what Commissioner Mallett has said has great
16 value to citizens of Detroit. We're just sitting here
17 in our meeting talking about various changes of
18 protocols and policies that the police are observing
19 that the citizens know nothing about. And this could
20 be the reason for much of the disconnect that takes
21 place during traffic stops. And I'm trying not to be
22 an advocate for, but this could very well be.

23 For example, and I've raised this before, and
24 I don't know -- people don't particularly think it's
25 important. But this new thing with bike lanes here in

1 Detroit.

2 COMMISSIONER MALLETT: Nobody understands
3 that.

4 COMMISSIONER VANN: Nobody understands this.
5 They don't even understand even the logic behind why
6 certain bike lanes are put in certain neighborhoods.
7 No one understands that. And so when people don't
8 understand the thing they automatically become negative
9 and they begin to think that something is
10 conspiratorial. And the conspiratorial narrative
11 continues to proliferate, because people don't have an
12 understanding of what's happened. They don't have --
13 we've not educated anyone about what they're supposed
14 to do with a bike lane, do they drive in it, do they
15 not drive in it.

16 You know, I was going down the street the
17 other day and this biker just comes straight across
18 while I'm going straight legally, while I'm going
19 straight legally, not running a red light, of course,
20 and going straight. And, you know, had I hit that
21 individual it would have been an, Oh, Lord, have mercy
22 situation.

23 But the thing is that the average citizen,
24 and especially citizens who have lived in this city for
25 many, many years and believe that they know their city,

1 believe that they're accustomed to rules, regulations,
2 laws, ordinances and other kinds of things that they
3 are supposed to observe and believe in their hearts
4 that they're doing the right thing. And yet we have
5 all kinds of -- we can sit up here today and ratify ten
6 different protocols and say, ha-ha, we've done some
7 great stuff, and nobody out there knows anything about
8 it.

9 And I just think it's -- I think it's going
10 to lead to more and more of a disconnect between
11 indigenous Detroiters and -- I mean that, indigenous
12 Detroiters and law enforcement in a lot of different
13 areas. It's not good to be a commissioner and sit in a
14 community meeting --

15 COMMISSIONER MALLETT: And not know.

16 COMMISSIONER VANN: -- and stuff is being
17 discussed and people are angry and you're there
18 representing them. These are your constituents, and
19 you can't assuage them in any way because you don't
20 even have the proper information. I mean, that doesn't
21 make any sense to me.

22 And we're changing a lot of the thought and
23 the narrative in this city, whether you agree with it
24 or don't agree with it. It's changing anyway at an
25 accelerated pace. And I just think it's important for

1 not only us to know, but it's important for everybody
2 to know what the protocols, procedures are, what can I
3 be stopped for and what I cannot be stopped for so I
4 can make up in my own mind, ah-ha, you know, maybe you
5 made up this traffic infraction so that you can stop me
6 for something else or whatever. I just think we need
7 to know, and I think the citizens deserve to know.

8 CHAIRPERSON CARTER: Any other comments,
9 commissioners?

10 That issue was addressed when we brought that
11 up to the Mayor and the Chief in a monthly meeting
12 maybe two months ago, the lack of communication with
13 the public with regards to the bike lanes, with regards
14 to the Q-Line, not knowing how to maneuver around the
15 Q-Line, and it's a huge issue.

16 And I brought up to the Mayor that I saw in
17 midtown where a car was pulled over -- no. There were
18 police officers actually on the Q-Line track, and the
19 Q-Line couldn't move because the officers were on the
20 track and, you know, just maybe the officers don't know
21 either.

22 COMMISSIONER VANN: Right.

23 CHAIRPERSON CARTER: You know, there's a lot
24 of information that actually needs to come to light.
25 And I think that we should move forward with -- I'll

1 bring that up again to the Mayor. We talked about
2 doing PSAs, public service announcements, in regards to
3 the bike lanes and things like that. But I think that
4 the Chief already has a platform for some of these
5 things through his Facebook, and maybe even we can
6 start doing a Facebook page where we actually put
7 information out there until we can come up with a
8 permanent solution. So I like the idea of the booklet,
9 but it's going to take some time to --

10 COMMISSIONER MALLETT: No question, yeah.

11 Madam Chairperson, I think that's a wonderful
12 suggestion. And I know nobody wants to hear this, but
13 I do think that when we renew our licenses, instead of
14 it being automatic you should be forced to take the
15 test. And the reason I say that is is because the test
16 ain't hard. You read the thing five minutes before you
17 take the test, but you would stop when you got to the
18 bike lane portion because you've never seen that
19 before. And you would say, now, what is this about.

20 And I do think -- or the tinted window
21 portion of it. I do think, Madam Chairperson, that the
22 assumption that we are going to be able to get this
23 information out granularly where everybody sees it
24 could be very, very hard. If we don't create a
25 mechanism where people are forced to digest the

1 information that the police officer -- the police
2 department is putting on in one form or another. So I
3 know it will be a burden. I know nobody wants to take
4 the test. I like mailing in my license, I just want to
5 get it back, why do you want me to stand in a line, on
6 and on and on. But, you know, I mean I'll admit it.

7 I don't -- can I turn -- whose responsibility
8 is it to stop when it's time for me to turn right and
9 there's a bike lane. My car weighs three or 4,000
10 pounds. I'm assuming that the biker is clear that if
11 there's an argument between my car and his bike he
12 loses, but maybe not. Maybe I'm supposed to stop so he
13 can go, but I don't know the answer to that. And I've
14 got a bike lane now near my house so it would be good,
15 because I'm also right near the Twelfth Precinct. So I
16 probably should get right on this.

17 A.C. WILLIAMS: And through the Chair, just a
18 short point of explanation. A bike on the roadway has
19 to obey the same rules as a motor vehicle on the
20 roadway.

21 AUDIENCE MEMBER: They don't.

22 A.C. WILLIAMS: Yes, they do. They have to
23 stop at a stop sign, and they have to signal if they're
24 going to turn. And they can actually be issued an
25 ordinance violation if they fail to do so.

1 Now, is it enforced? Not so much, no. But
2 is it on the books? Yes. So just to explain that --
3 and it's like you said, it's going to be very difficult
4 to get that type of information out.

5 The last thing I'll say is for police
6 officers how we learn about the laws we either look
7 them up or we -- for the most part we look them up. We
8 look them up either online or we get a book. And we
9 buy the book from --

10 COMMISSIONER MALLETT: And you do this, I
11 hope; right?

12 A.C. WILLIAMS: Those are for department
13 directives, for department members, and that is not
14 specifically all the time covering laws. They're
15 covering policies, procedures, and sometimes they cover
16 laws outside the department for what every citizen has
17 to obey. But for the most parts when we do our
18 teletypes and we do our administrative messages they're
19 to get information out to our actual members to what
20 department policy is. And also sometimes we do cover
21 what the laws are or what specific laws we can enforce
22 or can't enforce.

23 COMMISSIONER MALLETT: Yeah, but, A.C.
24 Williams, you -- just so I'm clear, you -- the
25 department executive leadership takes the

1 responsibility of informing the department police force
2 of what the laws are.

3 A.C. WILLIAMS: Yeah. So whenever we --

4 COMMISSIONER MALLETT: They may be looking
5 them up, and that may be somebody's responsibility, but
6 the officer on the street driving a squad car is going
7 to be looking to his or her commander for an update.

8 A.C. WILLIAMS: So this is what we -- this is
9 what happens. When you look to the academy, you
10 receive a booklet that has all the laws for the state
11 of Michigan. It gives you your traffic laws and it
12 gives you your criminal laws. From that book the
13 officer is basically -- he has his guide of what he can
14 enforce and what he can't enforce.

15 Now, when updates do come and when we receive
16 updates, we do put those out, and that's usually either
17 from the academy or from our legal -- our attorney that
18 we have that advise the Chief.

19 COMMISSIONER BURTON: Through the Chair.

20 CHAIRPERSON CARTER: Commissioner Burton.

21 COMMISSIONER BURTON: I want to just add
22 yesterday I had an opportunity to attend West Village
23 community meeting, and everybody just misses the former
24 commander from number 7, which was A.C. Williams here.
25 And they love how you informed the community.

1 Everybody was informed of what was going on downtown
2 and all around number 7.

3 And I know there was some concerns before
4 like with the bike lanes and stuff like that with a lot
5 of the bikers, but when A.C. was the commander over at
6 number 7, I mean he did a great job as far as working
7 with those communities within number 7. And now you've
8 got a lot of families, you know, that's pulling out
9 their bikes and they out there riding with Slow Roll.

10 So it was that relationship with -- when A.C.
11 was the commander over there working with the
12 community. And now I'll look at that community right
13 now and they're more informed this year than they were
14 three years ago.

15 COMMISSIONER VANN: Madam Chair.

16 CHAIRPERSON CARTER: Commissioner.

17 COMMISSIONER VANN: Is there still such a
18 thing as a bike license? When I was a kid -- I know
19 I'm old, but when I was a child you had to have a
20 license to ride in the street.

21 A.C. WILLIAMS: So -- and through the Chair,
22 to your point, you can purchase a license. You should
23 be able to purchase a license from each precinct. I
24 don't what the cost is, but I know you go to the
25 precinct to buy the license. Again --

1 AUDIENCE MEMBER: A dollar.

2 A.C. WILLIAMS: -- it is not -- thank you.
3 That's exactly, it's a dollar. That is not something
4 that's always enforced either.

5 COMMISSIONER VANN: So in the scenario that
6 Commissioner Mallett mentioned that I have a right to
7 make a right turn and then there's a biker coming
8 through with no license and I'm making a right -- I
9 mean, I'm just saying where do we draw the line here?
10 I mean, this is very serious. They'll be some very
11 injured people with regard to this, and we're not
12 educating the public, the driver or the bikers. The
13 bikers are receiving no education either. So what are
14 we going to do?

15 COMMISSIONER CRAWFORD: Through the Chair.

16 CHAIRPERSON CARTER: Commissioner Crawford.

17 COMMISSIONER CRAWFORD: Yes, ma'am. Again,
18 this is an educational moment for me. It always is,
19 just in life every day. Commissioner Mallett is right
20 and so is Commissioner Vann. I think some of the onus
21 is on us as commissioners, too, to use this platform
22 that we have to educate the public.

23 We oftentimes from the number of people from
24 the department and even outside to come in here and
25 discuss various issues. It's very informative. I

1 submit to Commissioner Vann that we bring someone in
2 here to talk about the biking, the bike safety and the
3 bike process, licensing and whatever. And I seriously
4 doubt that those license plate readers can read a bike
5 license whether or not it's expired or not. But I just
6 want to say that. And I mean just all of the issues,
7 you know, perhaps we can use more of our time at some
8 of these meetings just to bring individuals in.

9 A couple weeks ago I was talking about the
10 transit system, and look forward to hearing from Chief
11 Ricky Brown who's over the transit system and talk
12 about, you know, the ridership and the safety of it and
13 even the Q-Line. We talk about the Q-Line, but we
14 actually need to bring some people before us to explain
15 this process and what's going on. And, you know, not
16 the park on the track B, whether or not you're the
17 police or not, because you're holding up the Q-Line.

18 So I just want to advocate that we, you know,
19 set aside more time in our meetings to bring in these
20 individuals who have this information and expertise on
21 these particular issues. It's not only going to be
22 educational to us, but also to the public.

23 CHAIRPERSON CARTER: Thank you.

24 COMMISSIONER BURTON: Through the Chair.

25 CHAIRPERSON CARTER: Commissioner Brooks and

1 then Commissioner Burton.

2 COMMISSIONER BROOKS: I just have a comment
3 to make. Something does have to be done, because Henry
4 Ford Health System and HAP have 10 to 12 bikes in every
5 area that you can rent. And you can't walk in a lot of
6 places. I have nothing against bikes. I enjoy
7 watching people ride, but there needs to be some rules
8 and regulations so that we as citizens will know what
9 to do when a bicycle is coming, either driving or
10 walking.

11 CHAIRPERSON CARTER: Commissioner Burton.

12 COMMISSIONER BURTON: Through the Chair. You
13 know, I look at the neighborhood associations and stuff
14 like, you know, in number 7 and also number 3, you
15 know. What I like about number 7, when you had A.C.
16 over there, A.C. Williams and Captain Hope, they did a
17 great job as far as working with the community,
18 updating them, keeping them properly informed. And
19 that relationship with the community, I mean just
20 watching them going to different community meetings and
21 community relations feeds, that actually worked over at
22 number 7.

23 I think if we can look at each precinct and
24 allow them to -- not to say they doing it or not doing
25 it, but I just know that number 7 did a phenomenal job

1 as far as working with those communities as far as with
2 the bikers and things of that nature.

3 Like I said before, some of the issues that
4 we had with the bikers three years ago taking over all
5 the lanes we don't really have that issue today. I
6 mean, you know, this year versus three years ago or
7 four years ago. So a lot of -- you know, I think a lot
8 of people are becoming more aware or cautious about
9 those bike lanes and things of that nature. And I
10 start to see a lot of the communities starting to speak
11 about this as well as sending out in their newsletters.

12 CHAIRPERSON CARTER: Anything further,
13 commissioners?

14 Thank you. I'm going to ask that the staff
15 look into those two things to see what we can do.

16 Commissioners, on the agenda we have an item
17 regarding the fourth round promotions from Chief Craig.
18 The information was E-mailed to everyone on Tuesday, I
19 believe.

20 MR. HICKS: Tuesday, yes.

21 CHAIRPERSON CARTER: Tuesday. So it's not in
22 the packet, though.

23 MR. HICKS: No, it's not in the media packet.
24 It was distributed this past Tuesday. And there was
25 also a notation in that distribution that we would put

1 that on the -- for board action for today.

2 CHAIRPERSON CARTER: Okay.

3 COMMISSIONER MALLETT: Madam Chairperson,
4 move adoption.

5 COMMISSIONER BROOKS: Second.

6 CHAIRPERSON CARTER: It's been moved and
7 supported that we approve the fourth round promotions
8 from the Chief of Police.

9 COMMISSIONER BELL: Discussion.

10 CHAIRPERSON CARTER: Discussion.

11 COMMISSIONER BELL: Madam Chair, I think we
12 need to highlight promotion -- promoting these from
13 lieutenant to sergeant. Do we have those names? We
14 must read those into the record in terms of who we are
15 promoting at this time before we can move this item to
16 some type of resolution.

17 MR. HICKS: This is a chart that was mailed
18 out and was prepared by Ms. White. And given that it's
19 her chart and, therefore, she's more familiar with the
20 way in which the chart is broken down, can I have Ms.
21 White just go to the podium and read off the names?

22 CHAIRPERSON CARTER: The names. That's fine.

23 COMMISSIONER SANDERS: Madam Chair, I know we
24 can prior ratify this, but there was two names on there
25 that I thought maybe we would take a look at that I

1 kind of noticed something was going on that I think all
2 the commissioners need to look at before we pass
3 judgment on this, look at this thing and what was going
4 on with them in these records. It was two names that I
5 looked at personally, and I think that this board
6 should take a chance and look at it before they ratify
7 it.

8 CHAIRPERSON CARTER: Okay. Any other
9 discussion, commissioners?

10 COMMISSIONER BELL: I agree. If there's some
11 unreadiness in terms of them, we can address that in
12 closed session in terms of personnel matters at that
13 time. I think that we had taken that step in the past.
14 But we need to hear the names and then we can discuss
15 before we approve it after we have that discussion in
16 terms of closed session.

17 MS. WHITE: Good afternoon, your honorable
18 board. I am Melanie White, Executive Manager of Policy
19 and Planning. The following names are in promotion to
20 the position of lieutenant:

21 Sergeant Devin Dunbeck, Sergeant Richard T.
22 Firsdon, Sergeant Derrick Maye, Sergeant Heather
23 Cameron, Sergeant Sharon McClure, Sergeant Michael
24 Russell, Sergeant Andre Brooks, Sergeant Alexander
25 Roths, Sergeant William Jackson, Sergeant Jerrod

1 Willis, Sergeant Walter Merida.

2 And those are the names for the position of
3 lieutenant. The remaining names are for the position
4 of sergeant.

5 Corporal Beverly Wilson, Police Officer
6 Thomas Kozlowski, Police Officer Myron Watkins, Police
7 Officer Craig Pomaville, Detective Jarmiare McEntire,
8 Detective Tremayne Burton, Officer Robin Cleaver,
9 Officer Rhonda Sherman, Officer Dennis Smith and
10 Officer Elena Chavez.

11 CHAIRPERSON CARTER: Thank you. So at this
12 time we're going to act on promotion as set forth by --

13 COMMISSIONER MALLETT: Yes, ma'am. Executive
14 Commissioner Brooks.

15 COMMISSIONER BELL: I think Commissioner
16 Sanders asked if we could table that until we have an
17 opportunity to discuss that in closed session in terms
18 of his concern.

19 COMMISSIONER SANDERS: I really think,
20 Commissioner Mallett, that you should look at this.

21 COMMISSIONER MALLETT: I have.

22 COMMISSIONER BROOKS: I have, too.

23 COMMISSIONER MALLETT: But I'll be -- Madam
24 Chairperson, I'll follow any direction that you give
25 me.

1 CHAIRPERSON CARTER: Okay. So we'll take up
2 the matter in closed session.

3 COMMISSIONER SANDERS: Thank you.

4 CHAIRPERSON CARTER: When we go into closed
5 session.

6 MR. HICKS: Madam Chair, you do have a closed
7 session scheduled for this meeting.

8 CHAIRPERSON CARTER: Yes.

9 MR. HICKS: This is a session based upon a
10 recommendation by the Chief of a change-of-duty status
11 where the officer requested to go into closed session.
12 So we automatically go into that one.

13 CHAIRPERSON CARTER: Okay. So where is that
14 on the --

15 MR. HICKS: It is following the practice that
16 we had established --

17 CHAIRPERSON CARTER: Okay. Got it.

18 MR. HICKS: It's further down the agenda.

19 CHAIRPERSON CARTER: Okay.

20 MR. HICKS: And that gave that opportunity
21 for people who did not want to stay or gives
22 opportunity for oral communications.

23 CHAIRPERSON CARTER: Right. I got it. Thank
24 you.

25 At this time, commissioners, are there any

1 standing committee reports or ad hoc committee reports?

2 And we'll have at this time the board
3 secretary's report.

4 MR. HICKS: Thank you, Madam Chair. As you
5 can see, there's a list of seven communications that
6 have come into the office over this period of time, and
7 all of these items are listed, just information for
8 you. They're not marked for action, if you will.

9 There's no one in particular that I wanted to
10 highlight other than the change-of-duty status for
11 Police Officer Earl Crutchfield, which you'll be
12 handling later on the agenda.

13 And that completes my report for today.

14 CHAIRPERSON CARTER: Thank you, Mr. Hicks.
15 Commissioners, any old business?

16 COMMISSIONER BELL: Madam Chair, I'd like to
17 respond to Mr. Hicks' report. I would request that we
18 through via the attorney, our attorney, receive a
19 briefing from the Law Department in terms of matters
20 that are legally pending. I think at some point in
21 time we just cannot say it's still within the realm of
22 the Law Department. I think we need to be briefed at
23 some point in reference to that, with our attorney,
24 then he can brief this board as far as information that
25 is privileged or whatever that is, but these matters

1 could be spinned on and on indefinitely. At some point
2 in time I think we need to be up to date in reference
3 to where we are. I think that type of briefing would
4 be in order for us to undertake in terms of any matter
5 dealing with this towing or Nationwide or whatever. We
6 need some type of update.

7 We're not monitoring what's happening in the
8 legal arena, but I think at some point we should be
9 privileged to some information beyond what we just
10 received, you know. I think that would be more
11 appropriate for us as we move forward.

12 MR. HICKS: Commissioner, just to call their
13 attention, and this came in yesterday and, therefore,
14 didn't make the cutoff on this particular list. There
15 was an update that was given to us by A.C. White
16 yesterday. It was -- and it was immediately circulated
17 to the board.

18 But the essence of that update was that while
19 the city was involved in the lawsuit with -- I think it
20 was Nationwide Towing, that communications relative to
21 discussions and so forth had to essentially cease. And
22 there was a notation that A.C. White -- well, a meeting
23 that A.C. White had with the Law Department and in turn
24 that was the basis in which he sent the communications
25 to us. Not that we were the target of discussing these

1 particular items, but it was a cautionary I think piece
2 of information coming from the Law Department.

3 So you should note that when we receive any
4 information that it relates to lawsuits or legal issues
5 we do bring them, but in most cases a lawsuit where we
6 might get an initial influx of at least the filings or
7 something like that at the beginning, we probably don't
8 see any resolution for things for some years. So we
9 are making an effort to bring forth all the
10 information.

11 But consistent with the commissioner's
12 request, I will task Mr. Wyrick. We will go through
13 everything that we have, and he'll give a similar
14 update like he did I think about a month ago or so.
15 And we can even regularize those updates.

16 CHAIRPERSON CARTER: I think that more
17 importantly that we as a board, as the commission,
18 should be getting information from the corporation
19 counsel. And I think that that's basically what
20 Commissioner Bell is getting at, as opposed to through
21 the police department.

22 MR. HICKS: Sure. Commissioner, and not to
23 prolong the conversation, we do have -- and this was
24 one of the outstanding issues. We do have an
25 outstanding request to receive information relative to

1 settlements and judgments that the department's
2 involved in.

3 If you recall, we did get a partial report at
4 one of our community meetings where Corporation Counsel
5 Hollowell came in and gave a very generalized report in
6 that area. Our follow-up on that was to request
7 specific details so that we could share that detail
8 with you all.

9 So we are trying to make -- follow through in
10 that regard, but we don't have a line of information
11 specifically on that type of information that's flowing
12 through the commission at this point. We're working to
13 get that.

14 CHAIRPERSON CARTER: Thank you.

15 Anything further?

16 COMMISSIONER BELL: I just -- you know, Madam
17 Chair, we had a meeting scheduled with the corporation
18 counsel. Unfortunately, that meeting did not take
19 place, and that was to address those issues. So we
20 must reschedule that meeting in the near, near future
21 to try to bring it to some type of head, because those
22 matters are still pending. So I think those are in
23 line with what you suggested, and I think we're on the
24 same page. We just cannot sit ideally by and say
25 what's in the legal field, but I think there's certain

1 information that we should be privileged to where we
2 are, you know, some point in type updates and that type
3 of thing. That meeting was to resolve some of those
4 issues with the corporation counsel. Unfortunately,
5 that meeting did not take place, and we would have to
6 reschedule that.

7 MR. HICKS: And, Madam Chair, if I can add
8 one other thing, and I'm sorry for being longwinded
9 here. On the specific question of the towing, which is
10 one of the areas where we have at least a difference,
11 it has been -- from the staff's perspective, it has
12 been our work pursuit to essentially to look at our
13 towing rules, to review those towing rules with the
14 commission where the commission, at least the towing
15 committee of the commission, had made some
16 recommendations that was flowing through the department
17 that what one of the issues that came up was whether or
18 not we had the right to even do or revise those towing
19 rules.

20 So we are doing the work on the side to make
21 sure that we meet our obligations as given to us by
22 ordinance, but at the same time we are poised to one,
23 receive, information back from the department on their
24 reaction to the suggestions that we've made in terms of
25 the towing rules.

1 And then typically what occurs when the
2 department then responds to us from the towing
3 committee, then the towing committee kind of, you know,
4 harmonizes both what the department has said and what
5 the recommendations have been, and then that comes
6 through the full commission to review and to act at its
7 pleasure.

8 So we're still in that process and waiting
9 for the department to return that information. And
10 then, of course, there's still the dispute in terms of
11 our authority in this area from the Law Department,
12 which as I understand there is an individual who is
13 going to be reaching out to us soon who's supposed to
14 essentially help us to facilitate a discussion between
15 the Law Department on this particular item.

16 CHAIRPERSON CARTER: So I'm going to ask that
17 you contact him instead --

18 MR. HICKS: Sure.

19 CHAIRPERSON CARTER: -- of waiting, because
20 we've waited two -- three weeks.

21 MR. HICKS: Sure.

22 CHAIRPERSON CARTER: Three weeks. And it was
23 supposed to be a week before he contacted us. So he
24 hasn't contacted us. So reach out and contact that
25 person.

1 MR. HICKS: That will be done tomorrow
2 morning.

3 CHAIRPERSON CARTER: Tomorrow morning, okay.
4 Thank you.

5 Any new business, commissioners?

6 Under announcements, our next Board of Police
7 Commissioners meeting will be Thursday, September 21st,
8 2017 at 6:30 p.m. in the Third Precinct at the
9 Operating Engineers, Local 324, located at 1550 Howard
10 Street, west of Trumbull, north of West Fort hosted by
11 Commissioner Burton, myself and Commissioner Sanders.

12 There will be no Board of Police
13 Commissioners meeting on Thursday, September 14th,
14 2017, as we will be attending -- most of us will be
15 attending the NACOLE conference in Spokane, Washington.

16 Our next community meeting will be Thursday,
17 October 12th at 6:30 p.m. in the Seventh Precinct,
18 location is forthcoming.

19 At this time we will have oral communications
20 from the audience. Please give your name for the
21 record and limit your comments to two minutes, please.

22 MR. BROWN: Madam Chair, I currently have
23 five cards. Our first speaker will be --

24 MR. BOWMAN: I don't get a card?

25 MR. BROWN: -- Ms. Faith followed by Ms.

1 Foster.

2 MS. FAITH: Can you all hear me?

3 COMMISSIONER MALLETT: Yes, ma'am.

4 MS. FAITH: Okay. Again, I commend y'all for
5 the success and everything running smoothly as usual
6 and the way you conduct yourselves amongst each other
7 on very sensitive matters.

8 I was thinking about the publications or the
9 communications to the citizens to be on the same page
10 as the officers and the commission board about the laws
11 and the different things, about the bicycle lanes and
12 about the traffic and how for the cars as well as for
13 the bikes. I was thinking about that myself if they
14 had -- if everybody was on the same page and everybody
15 was abreast of what each other knew and it was open to
16 the public it would cause things to be a lot -- run a
17 lot more smoothly if everybody was educated about the
18 same thing as far as the laws in the street and as well
19 as the citizen laws.

20 And I was thinking, too, about civil
21 liberties and civil laws, too, if there was a
22 publication made out that was readily available to the
23 citizens that the officers were abreast of all the
24 time.

25 And also I'm going to really -- another

1 suggestion I had. If the families would know -- be
2 educated about different things also, that would be I
3 guess under the civil laws. And if there was a
4 publication or something sent out or even in the
5 libraries where we can go and see if maybe even online
6 or even in a book, that would be very wonderful.

7 And with that being said that I have one
8 minute left, congratulations for a very successful
9 meeting. Keep up the good work. Thank you.

10 COMMISSIONERS: Thank you.

11 MR. BROWN: Ms. Foster followed by Mr. Davis.

12 MS. FOSTER: Hello.

13 COMMISSIONERS: Hello.

14 MS. FOSTER: My name is Tamilikia Foster. I
15 am -- I live in Lansing, Michigan. I came August 19th
16 to the festival for a few people, enjoyed ourselves,
17 went downtown. I'm sitting on the hood of my car at
18 about two o'clock in the morning. A drunk driver hit
19 me twice where I flew on the back of the hood and flew
20 out, ended up with a fractured heel, a meniscus disc
21 and a whole other things.

22 The reason why I bring this forth is because
23 two officers that were there refused to do a report
24 even though the gentleman was clearly intoxicated.
25 They threatened to arrest me, because I was trying to

1 tell them how to do their job.

2 I'm not here to insult you, but I'm a nurse
3 and I worked hard to get my career. And so my body
4 right now is battered. And the officer himself said
5 don't make a report, it is not necessary, it's only
6 \$200 worth of damage.

7 The gentleman got out the car and accused me
8 of hitting him, a nonmoving car, told me to take \$200,
9 that's all it was worth. The cops stood there and
10 allowed this man to belittle me and berate me. I'm
11 sitting there bleeding and battered, and the cops
12 refused to make a report. They said that -- I said you
13 can't let this man drive, he's drunk. The officer said
14 I'm going to let her drive, because she's not as drunk
15 as him.

16 Okay. I am not from your city. I come to
17 visit. And for me as a citizen to come here to the
18 city that I thought was on the rise, to encounter that
19 was insulting and belittling. And to have your officer
20 tell me what the value of my car, my life is, was
21 insulting. And to have them stand there and belittle
22 me was insulting.

23 I don't mean to cry, but I'm standing here
24 injured and I'm at a risk of my career because of this
25 injury that was \$200. So your officers refused to make

1 a report that I had to make a report on. Your officers
2 refused to call an ambulance that I had to go to the
3 hospital for. Your officers refused -- they wanted to
4 arrest me, and they said because they knew him, because
5 he was a good guy, they let him go. And I'm insulted
6 and I don't know what to do and I have rights, so ...

7 CHAIRPERSON CARTER: I'm going to ask A.C. --
8 did you want to say --

9 A.C. WILLIAMS: I think your answer was going
10 to be the answer that I was going to give, so --

11 CHAIRPERSON CARTER: Go ahead.

12 A.C. WILLIAMS: I'm very appalled by what I'm
13 hearing. What you have is a complaint, and that's part
14 of what this board does. And basically I was going to
15 turn it over to the Chair.

16 CHAIRPERSON CARTER: Yes. So I need you to
17 see --

18 MS. FOSTER: I did file a complaint, but I'm
19 going to keep coming to you until somebody does
20 something.

21 CHAIRPERSON CARTER: Okay.

22 MS. FOSTER: Because when I filed my
23 complaint here, I was told that the officers will never
24 apologize and that they will never show no wrong.
25 These were called secondary officers. And the officer

1 said he does special crime victims, the officer in
2 question down there, and that he doesn't know how to do
3 a traffic report. And they refused to give me their
4 names and their badges and told me to shut up and go
5 home.

6 COMMISSIONER CRAWFORD: Through the Chair.

7 CHAIRPERSON CARTER: Yes.

8 MS. FOSTER: And there was witnesses, and
9 your cameras did catch this on camera. Everybody was
10 in shock. So nobody was able to get their cameras out.
11 They were too busy helping me. My heel was caught
12 under the heel of the car. That's how I ended up with
13 a right fractured heel, multiple contusions. My spine
14 is moved.

15 So I mean I'm a nurse. I'm a labor delivery
16 nurse. I need my body.

17 CHAIRPERSON CARTER: So, Commander -- I mean,
18 Commissioner Crawford, did you want to --

19 COMMISSIONER CRAWFORD: Yes, ma'am, through
20 the Chair.

21 Yes, ma'am. Ms. Foster, I offer my apologies
22 for the actions or lack thereof. Just to go on record,
23 it's really irrelevant as to the amount of damage to
24 your car, the value. It was an injury accident,
25 because you were injured.

1 And getting back to policy we so often talk
2 about, that is the state law that you have to do an
3 accident report when there's an injury involved. So I
4 mean if it was \$5 worth of damage to the car that's
5 totally irrelevant. You were injured. I mean, you
6 were seated on the car, wherever you were.

7 So I'm sure I'll -- you filed a complaint
8 with the Chief Investigator's office?

9 MS. FOSTER: I came last week, yes.

10 COMMISSIONER CRAWFORD: You did?

11 MS. FOSTER: Um-hmm.

12 COMMISSIONER CRAWFORD: Okay. All right,
13 ma'am. Thank you.

14 CHAIRPERSON CARTER: Okay. So we'll wait
15 until we get some more information with regards to what
16 they do, what they find out, and we'll be in contact.

17 MS. FOSTER: Thank you.

18 CHAIRPERSON CARTER: Thank you.

19 COMMISSIONER VANN: Madam Chair. Madam
20 Chair.

21 CHAIRPERSON CARTER: Yes, Commissioner Vann.

22 COMMISSIONER VANN: I'd like to know what the
23 protocol is for an officer apology, and I'm very
24 serious about it. I just think that when -- it it's
25 proven that an officer is -- I don't think that, you

1 know, officers should just give apologies, you know,
2 profusely, but I think if an officer has made an error,
3 if an officer is wrong, if we're wrong, I think that
4 there needs to be an apology to that particular citizen
5 or to that particular person. I think it would go a
6 long, long way in helping to, you know, foster good
7 community relations if a mistake has been made that an
8 apology is given. I mean, I think that is just proper
9 protocol for us as human beings, and I don't understand
10 why it would not be so. I don't understand why I've
11 never received an apology.

12 So I can sympathize with the lady who came to
13 us today, because if, in fact, what she says bears out
14 and is true, then I think that someone ought to say
15 we're sorry that happened or give some sort of an
16 apology to the person that it happened to.

17 CHAIRPERSON CARTER: I'm in agreement with
18 that.

19 A.C. WILLIAMS: Through the Chair.

20 CHAIRPERSON CARTER: Yes.

21 A.C. WILLIAMS: For the department we have no
22 mechanism or procedure, to answer Commissioner Vann's
23 question, where we can compel an officer to make an
24 apology. But what the department does is we make an
25 apology as representatives of the department for that

1 individual if something happens.

2 And, Commissioner Vann, I'll say this, for
3 anything that you experienced that caused you distress,
4 I do apologize to you on behalf of the department. And
5 I don't know if that's good enough, but I can let you
6 know that it is never our intent to cause anybody undue
7 stress or harm. Some of what we do may cause that and
8 some of it we do by omission or by default or by a
9 problem that -- like we received with this complaint.
10 We make mistakes, and when we make those mistakes as
11 leaders of the department we know they're going to be
12 made. We know we have bad apples. We know we have for
13 the most part majority great officers, but when those
14 mistakes are made us who lead the department we are
15 going to make those apologies and we're going to push
16 to make sure our officers are comfortable doing it, but
17 we have no mechanism to compel them to make an apology.

18 CHAIRPERSON CARTER: So, A.C. Williams, just
19 so that we are clear, even if an officer is working
20 secondary employment they still have to abide by all --

21 A.C. WILLIAMS: If an officer is working
22 secondary employment and they see an accident take
23 place with injury, a report should have been, and we
24 also should have requested for medical assistance for
25 that individual.

1 CHAIRPERSON CARTER: Thank you. Yes, sir.

2 MR. BROWN: Mr. Davis followed by Ms. Smith.

3 MR. DAVIS: Hello. My name is William M.

4 Davis. I'm the president of the Detroit chapter of the
5 National Action Network.

6 I thought I would pre-inform you all that we
7 are planning to do an informational action on Tuesday
8 at the opening of the Red Wings Arena. And we want to
9 make sure everything is coordinated and it's going to
10 be a peaceful, nonviolent type of informational action,
11 even though we recognize it's a possibility that others
12 may have different agendas, you know.

13 So we just wanted to reach out and if
14 possible help to coordinate, you know, let you know in
15 advance that there are a number of people that are
16 very, very upset and displaced with our tax dollars
17 going towards the arena, and especially displeased by
18 the fact, you know -- like I'm also like a city
19 retiree. And a lot of retirees are especially upset
20 the fact that somebody that never disemboweled the
21 waving of the confederate flag has an opportunity to
22 make money off of our -- that they shouldn't be making.

23 So there's a number of people that's going to
24 be displeased, but we are advocating and pushing a
25 nonviolent, informational type action. And we want to

1 see if there's anybody that would like to help
2 coordinate and make sure that everything -- because it
3 may be others that may not want to be as peaceful.

4 COMMISSIONER CRAWFORD: Civil.

5 A.C. WILLIAMS: Through the Chair. We're
6 aware of a number of protests that will be taking place
7 at the beginning of the Kid Rock concerts to open up
8 the LCA. And we will have officers that will be
9 responding and that will be stationed there.

10 CHAIRPERSON CARTER: Thank you.

11 Thank you, Mr. Davis.

12 MR. BROWN: Ms. Smith followed by Ms. Butler.

13 MS. SMITH: Good afternoon, Chief,
14 commissioners.

15 COMMISSIONERS: Good afternoon.

16 MS. SMITH: I wrote what I had to say down,
17 because I couldn't say it all at once.

18 We're living in trying times. People are
19 angry, multiple shootings and killings. And today
20 Detroit's future is full of challenges. Racism have
21 invaded the city of Detroit. State Police shooting and
22 killing of a young boy with a Taser gun because he
23 didn't stop riding his ATF (sic) bike fast he didn't --
24 and he paid with his life. Detroiters are asked why is
25 it taking ten days to prosecute or investigate this

1 incident and why is it taking so long.

2 Chief Craig was on Nolan's program this
3 morning, and nothing was mentioned about this crime.
4 This officer has a record listing two former shootings
5 against him, and that was dismissed, and now he has
6 three lawsuits, including the one that's present in
7 this latest shooting.

8 We are -- will we ever improve this racism
9 system in our city? Ron Scott would raise hell if he
10 was alive today. He truly loved the people of Detroit,
11 and they loved him. He would be standing here today
12 instead of me.

13 Now, on a pleasant note, I got in touch with
14 Hall's office, Renee Hall, because I was concerned
15 about the condition there in Texas knowing that she's
16 in Dallas. I talked with her aide. She was at a
17 meeting at the City Council. And she told me -- we
18 talked at length, and she told me that they're 500
19 miles from the flood section. So, therefore, they
20 weren't in danger, but she loves her job and she gives
21 the best to all of us and she will get in touch with
22 me. She told me that she'll give her my -- you know,
23 greetings that I called her.

24 So I just want to let you all know that we're
25 losing some good officers. We've got some good ones

1 still here. But the fact is that Detroit -- we live in
2 a good city and we want to maintain it that way.

3 So, therefore, I just want the police to be
4 careful what they're doing, and the State Police above
5 all know what their position is in the city here of
6 Detroit.

7 And thank you for your time.

8 COMMISSIONER CRAWFORD: Through the Chair.

9 Yes, Ms. Smith.

10 MS. SMITH: Yes.

11 COMMISSIONER CRAWFORD: In reference to the
12 shooting and killing of Damon Grimes who was riding the
13 ATV, I was in communication with the Wayne County
14 prosecutor today. And as you well know, they're two
15 investigations, one by the State Police and an
16 independent investigation by the Detroit Police.

17 MS. SMITH: Yes, I am. Yes.

18 COMMISSIONER CRAWFORD: So nothing has been
19 turned over to her as of today. So we talk about the
20 prosecution and it's been ten days. She, being the
21 Wayne County Prosecutor, Kym Worthy, has to await the
22 completion of the investigations.

23 MS. SMITH: Between the two?

24 COMMISSIONER CRAWFORD: Yes, ma'am.

25 MS. SMITH: All right. Well, I have to tell

1 you this. They're going to do a marching tomorrow in
2 front of the prosecutors --

3 COMMISSIONER CRAWFORD: Yes, ma'am, I know.

4 MS. SMITH: -- building so -- Bullock and his
5 group. So I hope that things will work out well with
6 her and her investigation, that she will do the right
7 thing in regards to the situation, because we don't
8 need anymore killings in our city. It's too much. And
9 it makes people scared to even go out at night and it's
10 terrible. We don't want to have no kind of bad
11 reputation. And I hope everything will work out for
12 the best for all of us in this city, because I love
13 this city. And I just hate it when I hear the news
14 what's going on in the city and what's going on.

15 Gilbert is buying buildings like mad down
16 here in my area. They came in my building a month
17 ago --

18 CHAIRPERSON CARTER: Ms. Smith, your time is
19 up. Thank you.

20 MS. SMITH: All right. You're welcome.
21 Thank you very much for your attention.

22 CHAIRPERSON CARTER: Thank you.

23 MR. BROWN: Ms. Butler followed by
24 Mr. Bowman.

25 MS. BUTLER: Good afternoon.

1 CHAIRPERSON CARTER: Good afternoon.

2 MS. BUTLER: My name is Freida Young-Butler
3 (ph) and I'm a community activist. I came to correct
4 something that I said August 31st. I had read it in
5 the Free Press that it was Ms. Mary Waters and instead
6 I did call to verify it's Ms. Mary Smith. And I'd like
7 to correct whatever -- if I do something in error, I
8 would like to correct that.

9 Another thing, I would like to thank
10 Commissioner Carter that you recognized a certain a
11 concern last Thursday and you directed that concern to
12 someone who tried to be of help. So I appreciate that.
13 So thank you.

14 CHAIRPERSON CARTER: Thank you, ma'am.

15 MR. BOWMAN: Hi. I'm Scotty Bowman. I
16 respect the two-minute time limit. And my question is
17 is it appropriate for a commissioner at a community
18 meeting to demand going over the two-minute time limit
19 because of his commissioner status?

20 And secondly, I was just wondering who paid
21 for or how is paid for this particular pamphlet?

22 And I'm referring to Commissioner Bell at
23 last night's Fifth Precinct community relations
24 meeting.

25 CHAIRPERSON CARTER: So your first question

1 is the two-minute limit?

2 MR. BOWMAN: There was a two-minute limit at
3 the Fifth Precinct board -- Fifth Precinct community
4 relations group meeting. And the organizer, Jay
5 Henderson, had allotted two minutes for Mr. Bell to
6 speak. He spent over five minutes arguing as to why,
7 as an elected official, it would be disrespectful for
8 him not to get two minutes, and then he proceeded to
9 comment some more after that.

10 CHAIRPERSON CARTER: So I would say that that
11 would be an issue that you would have to discuss with
12 the person who was chairing the meeting, not
13 necessarily --

14 MR. BOWMAN: Well, he had a two-minute time
15 limit. Is it appropriate for a commissioner to use
16 their elected status as a reason to defy that?

17 COMMISSIONER CRAWFORD: Through the Chair.

18 CHAIRPERSON CARTER: Sometimes the
19 commissioners can have information they want to give to
20 the public. So I would say that sometimes it takes
21 more than two minutes to give that information.

22 So you would have to discuss that with the
23 persons who, like I said, organized the meeting or in
24 charge of the meeting, because actually at this meeting
25 if there's information that we need we allow more than

1 two minutes.

2 COMMISSIONER CRAWFORD: Through ...

3 CHAIRPERSON CARTER: Commissioner Crawford.

4 COMMISSIONER CRAWFORD: Through the Chair.

5 Yes, sir. With all due respect, I would
6 think that the individual -- I wasn't there, but
7 perhaps yielded more than two minutes to Commissioner
8 Bell. So that's what one would think. And according
9 to Robert's Rules of Order and things in order, yes,
10 everyone's allotted two minutes. But if you wanted
11 five, sir, right now or six, like I used to do when I
12 used to go to meetings, I would take individuals from
13 my community with me and they would stand up in front
14 of me and state that they reside in the city of Detroit
15 and yield their two minutes --

16 MR. BOWMAN: That isn't what I observed.

17 COMMISSIONER CRAWFORD: Okay. And they would
18 yield their two minutes to me, and that would give me
19 -- sometimes it's like showbiz. And I'll say, well,
20 all I need -- sometimes I had ten minutes, but I'll say
21 I would just take five, like showbiz.

22 But I consider it somewhat disingenuous that
23 you have a complaint about this about Commissioner Bell
24 and you're in the same race as Commissioner Bell.

25 MR. BOWMAN: Well, I'm -- but I'm respecting

1 a time limit. I just feel that regardless of whether I
2 just happen to be a member of that organization sitting
3 at the meeting or whether I be a candidate, the point
4 is that I would not see it appropriate for a public
5 official to somehow feel they can override the will of
6 that body or of that organizer.

7 COMMISSIONER CRAWFORD: Yes, sir. I don't
8 believe Commissioner Bell stole additional minutes. I
9 believe --

10 COMMISSIONER BELL: Madam Chair, Commissioner
11 Bell can speak for himself.

12 Commissioner Bell, as a police commissioner
13 of this body since 2014, and I interact with not just
14 only the Fifth Precinct, but throughout the city of
15 Detroit, but primarily the Fifth and Ninth Precinct,
16 which I will be attending the meeting tonight, I have a
17 longstanding relationship with Mr. Jay Henderson. You
18 heard him speak at our meeting last month in terms of
19 the two minutes remark. It's some lack of humor,
20 whatever that is.

21 But I am an elected police commissioner,
22 elected or appointed. These meetings are for public
23 safety issues, police community meetings. And,
24 therefore, unlike any other meeting I might attend this
25 is a meeting that I have the privilege of speaking, the

1 same vein that DPD. It is a meeting for police
2 community relations. I am a commissioner of the Board
3 of Police Commission. So I must remind Mr. Henderson
4 of that, but I asked permission of the audience there,
5 and they know Commissioner Bell real well. And so I
6 honor whatever is appropriate, but there was some
7 serious dialogue. Therefore, I wanted to share and I
8 was granted. But you should take that matter up --
9 this is not the setting for it.

10 As far as the pamphlet, the pamphlet
11 addressed the Board of Police Commission. It took us
12 about three or four years to get that type of
13 circulation, no different than the council, the Mayor,
14 Wayne County Commission. They share information about
15 the role of their particular entity. And that's why
16 that was circulated. That is not a campaign
17 literature, sir. You should know the distinct
18 difference. You --

19 MR. BOWMAN: The only difference I noticed
20 was --

21 COMMISSIONER BELL: Sir, you do not have the
22 mike. You do not have the mike.

23 So I just want to convey those are concerns
24 that you must address, but I thought I was proper. The
25 community commended me in terms of speaking to the

1 issue. And, in fact, the D.C. was there and others,
2 Commander Ewing and a good body, which I tried to
3 promote for the last three years that we must bring the
4 people together.

5 And the commissioner have a role. And I also
6 emphasized I'm there for that purpose only, speaking as
7 a commissioner, in the same vein they would give a
8 council person, the Mayor or the commander or any other
9 forum they feel as though. But I think I have a
10 standing right in that type of setting only because of
11 the police community meeting, but I respect
12 Mr. Henderson and I respect the office there. I am
13 also a member of that since 1974 of the Fifth Precinct.
14 That's where I live and I reside and I work. So that
15 is my commitment to the Fifth Precinct.

16 But we can talk offline. But mostly you
17 should address Mr. Henderson. I think he will explain
18 that we have a good working relationship.

19 CHAIRPERSON CARTER: Thank you.

20 Thank you, sir.

21 MR. BROWN: Madam Chair, that's your last
22 speaker.

23 CHAIRPERSON CARTER: Thank you, Mr. Brown.

24 At this time, commissioners, we have a
25 personnel -- well, we have personnel issues to discuss.

1 VICE CHAIRPERSON DEWAELESCHE: Madam Chair,
2 can I make an announcement before we go into closed
3 session?

4 CHAIRPERSON CARTER: Sure.

5 VICE CHAIRPERSON DEWAELESCHE: Most of you
6 have probably heard about the President's action or the
7 administration's action against DACA, children who were
8 brought here undocumented. As children, through no
9 fault of their own, their parents brought them. And
10 they were enrolled in a program that President Obama
11 initiated about five years ago, are living in fear now
12 that they're going to be deported to a country that
13 they do not know.

14 And so I just want to make an announcement
15 that there's going to be a forum this Saturday, and
16 it's going to be held at LASED. We have held some of
17 our meetings at LASED for the Police Commission. It's
18 going to be this Saturday, September 9th at eleven
19 o'clock at 7150 West Vernor, which is near Green. It's
20 at the senior center. And there will be people there
21 that will be able to help, you know, families who have
22 DACA children. And so please spread the word.

23 And, you know, I just want to say that I'm
24 heartbroken that this is happening. It's terrible to
25 happen to children, and really young adults now, but

1 they were children when they came. So I want that
2 information to get out.

3 Thank you so mush.

4 CHAIRPERSON CARTER: Thank you for sharing
5 that information with us. Hopefully we'll have some --
6 You won't be there, will you?

7 VICE CHAIRPERSON DEWAEELSCHÉ: Yeah. I'm
8 going to try to go.

9 CHAIRPERSON CARTER: You won't be gone?

10 VICE CHAIRPERSON DEWAEELSCHÉ: Sunday I'm
11 leaving.

12 CHAIRPERSON CARTER: Okay.

13 MR. HICKS: Madam Chair, if there's a written
14 communication on this, we can facilitate some type of
15 E-mail blast-out in connection with that.

16 VICE CHAIRPERSON DEWAEELSCHÉ: I'll forward
17 that to you. Thank you.

18 CHAIRPERSON CARTER: Thank you.

19 At this time we have personnel matters to
20 discuss, so ...

21 COMMISSIONER BELL: So moved, Madam Chair.

22 COMMISSIONER CRAWFORD: Second.

23 VICE CHAIRPERSON DEWAEELSCHÉ: Support.

24 CHAIRPERSON CARTER: It's been moved and
25 supported that we go into closed session.

1 Are there any discussions?

2 Those in favor?

3 COMMISSIONERS: Aye.

4 CHAIRPERSON CARTER: Those opposed?

5 Motion carries.

6 (At 4:34 p.m. the Commissioners went into
7 closed session. Back on the record at
8 5:21 p.m.)

9 CHAIRPERSON CARTER: Commissioners, we are
10 back on the record.

11 Is there a motion to --

12 COMMISSIONER MALLETT: Madam Chairperson,
13 Commissioner Conrad Mallett. I'd like to amend my
14 previous motion to exclude until further review from
15 the promotion list Officers Rhonda Sherman, Myron
16 Watkins and Jarmiare McEntire.

17 COMMISSIONER VANN: Second the motion.

18 CHAIRPERSON CARTER: It's been moved and
19 second that we exclude the names of ...

20 COMMISSIONER MALLETT: Rhonda Sherman, Myron
21 Watkins and Jarmiare McEntire.

22 MR. HICKS: Madam Chair, just for consistency
23 in terms of rules, Member Mallett made the original
24 motion.

25 CHAIRPERSON CARTER: Yeah.

1 MR. HICKS: The motion was second by
2 Commissioner Brooks, the original motion. So in this
3 particular instance for the amendment I think that you
4 have to get Commissioner Brooks to concur with the
5 amendment.

6 COMMISSIONER BROOKS: I second the motion.

7 CHAIRPERSON CARTER: Thank you.

8 Is there any discussion?

9 Those in favor?

10 COMMISSIONERS: Aye.

11 CHAIRPERSON CARTER: Those opposed?

12 The motion carries.

13 And just for the record, can we get those
14 names that are approved read into the record?

15 COMMISSIONER MALLETT: Madam Chair, we don't
16 have the list with us.

17 CHAIRPERSON CARTER: Okay.

18 COMMISSIONER MALLETT: But we can do that
19 when we come back --

20 CHAIRPERSON CARTER: Okay.

21 COMMISSIONER MALLETT: -- at the next
22 meeting.

23 MR. HICKS: Number one, the complete list and
24 your action will be reflected in your minutes. And
25 when you approve your minutes, which will be -- well,

1 when you return --

2 COMMISSIONER MALLETT: Right.

3 MR. HICKS: -- they will be listed including
4 the --

5 COMMISSIONER MALLETT: Right. So, Madam
6 Chairperson, that's exactly right. So when we get to
7 the amended portion we can make special --

8 CHAIRPERSON CARTER: Okay.

9 COMMISSIONER MALLETT: Absolutely.

10 CHAIRPERSON CARTER: Thank you, Commissioner
11 Mallett.

12 At this time, commissioners, we have before
13 us the Chief's recommendation for Officer Crutchfield,
14 Earl Crutchfield.

15 MR. HICKS: Madam Chair, just so that you're
16 reminded, this is a recommendation from the Chief to
17 change-of-duty status or to put the individual on
18 administrative or suspend the individual without pay.
19 And under the charter there's a higher threshold in
20 terms of your vote if you -- given the members who are
21 currently here, the members of the board. If you want
22 to concur with them, at least seven members would have
23 to sustain -- would have to vote in the affirmative.

24 CHAIRPERSON CARTER: Okay. So is there a
25 motion with regard to this matter?

1 COMMISSIONER MALLETT: Move the adoption of
2 Chief Craig's recommendation that Officer Crutchfield
3 be suspended without pay.

4 COMMISSIONER BELL: I support that with the
5 understanding that we are reading into the record the
6 matter of the discipline action appearing before the
7 board. Based on past practice, that's something we
8 normally would engage in is to cite exactly what we're
9 voting on and have a record to that effect.

10 CHAIRPERSON CARTER: So can we get that read?

11 MR. HICKS: Madam Chair, the allegation here
12 is that the individual officer, Mr. Crutchfield,
13 Officer Crutchfield, issued checks and --

14 VICE CHAIRPERSON DEWAEELSCHE: Payroll checks.

15 MR. HICKS: Payroll checks, duplicate payroll
16 checks, and executed on both of those checks. And the
17 department has pursued a charge, an attempt for him --
18 it was a fraud charge essentially. And, as I
19 understand it, the matter was presented to the
20 prosecutor's office and a warrant was issued in
21 connection with this particular charge.

22 CHAIRPERSON CARTER: Is there any discussion?
23 Those in favor?

24 COMMISSIONERS: Aye.

25 CHAIRPERSON CARTER: Those opposed?

1 MR. HICKS: Madam Chair, if I can make sure
2 that we have our record straight, can we have a
3 individual vote on these so that we'll make sure that
4 our records are straight because of the high threshold
5 that we need. So if I can call the roll.

6 Commissioner Sanders?

7 COMMISSIONER SANDERS: Aye.

8 MR. HICKS: Commissioner Mallett?

9 COMMISSIONER MALLETT: Yes.

10 MR. HICKS: Commissioner Brooks?

11 COMMISSIONER BROOKS: Yes.

12 MR. HICKS: Commissioner Dewaelsche?

13 VICE CHAIRPERSON DEWAELSCHÉ: Yes.

14 CHAIRPERSON CARTER: Commissioner Bell?

15 COMMISSIONER BELL: Yes.

16 MR. HICKS: Commissioner Burton?

17 COMMISSIONER BURTON: Yes.

18 MR. HICKS: Commissioner Crawford?

19 COMMISSIONER CRAWFORD: Yes.

20 MR. HICKS: Commissioner Vann?

21 COMMISSIONER VANN: Yes.

22 MR. HICKS: Chairperson ...

23 VICE CHAIRPERSON DEWAELSCHÉ: Carter.

24 CHAIRPERSON CARTER: Yes.

25 MR. HICKS: Chairperson Carter?

1 CHAIRPERSON CARTER: Yes.

2 MR. HICKS: Commissioner, you have one, two,
3 three, four, five, six, seven, eight, nine -- nine
4 commissioners voting in the affirmative, and based upon
5 that vote you have agreed with the Chief of Police and
6 suspended this individual without pay.

7 CHAIRPERSON CARTER: Thank you. The motion
8 carries. Thank you.

9 Any further business, commissioners?
10 Comments?

11 COMMISSIONER MALLETT: Move to adjourn.

12 COMMISSION VANN: Second.

13 CHAIRPERSON CARTER: It's been moved and
14 supported that we adjourn.

15 Those in favor?

16 COMMISSIONERS: Aye.

17 CHAIRPERSON CARTER: Those opposed?

18 Motion carried.

19 (The meeting was adjourned at 5:27 p.m.)
