EXECUTIVE ORDER NO. 3

TO: THE HONORABLE CITY COUNCIL, HEADS OF DEPARTMENTS,
BOARDS AND COMMISSIONS

SUBJECT: ADVISORY COMMISSIONS

Adequate representation of all the people is the best assurance of governmental responsiveness to community needs. That representation is achieved through elected officials, and also by means of citizens' commissions which advise those elected officials and their appointed executives.

Under the new Charter, the Mayor of Detroit is granted additional opportunities for the creation of such commissions by Executive Order. To provide for maximum community input to governmental decisions, I am hereby announcing the creation of nine Advisory Commissions with a total of 63 members.

Appointments to these bodies are at the discretion of the mayor. Announcements of the persons who will serve will be made under separate cover. Where it is so specified and reasons are stated, non-residents of the city may be appointed to serve.

AIRPORT COMMISSION

Nine members shall be appointed to terms ending on February 14, 1978. At least five members must be residents of the City of Detroit, but non-residents may be appointed because the Airport facility serves in a unique manner the entire metropolitan area.

CIVIC CENTER

Seven members shall be appointed to terms ending on February 14, 1978. At least five of the members must be residents of the City of Detroit, but non-residents may be appointed because the Civic Center facilities serve in a unique manner the entire metropolitan area.

CORRECTIONS

Seven members shall be appointed to terms ending on February 14, 1978. At least five of the members must be residents of the City of Detroit, but non-residents may be appointed because the women's facility is the only institution of its kind in the entire state.

ENVIRONMENTAL PROTECTION

Nine members shall be appointed to terms ending on February 14, 1978. All members must be residents of the City of Detroit.

FIRE

Four members shall be appointed to terms ending on February 14, 1978. All members must be residents of the City of Detroit.

HEALTH

Seven members shall be appointed to terms ending on February 14, 1978. All members must be residents of the City of Detroit.

MUNICIPAL PARKING


Five members shall be appointed to terms ending on February 14, 1978. At least three members must be residents of the City of Detroit, but non-residents may be appointed because the parking facilities are meant to serve people from the metropolitan area.

RECREATION

Eight members shall be appointed to terms ending on February 14, 1978. Each of the members shall be a resident of a different one of eight regions, contiguous with those regional boundary lines designated by the Detroit Board of Education.

TRANSPORTATION

Seven members shall be appointed to terms ending on February 14, 1978. All members must be residents of the City of Detroit.
