#### **NEW BUSINESS**

• The Illitch Red Wings Redevelopment Project: Mr. Litt is a member of the Neighborhood Advisory Group for this project which ensures that potential hires come from the Detroit area as well as, studying the effects of this project to the area and people residing there. Mr. Litt stated that the Electrician's Local could be in a position to help the Detroit youth not only become electricians, but also find employment within this project.

Mr. Litt made a motion: The Board should invite the Business Agent of Local 58, Mr. Ric Preuss, and the Director of the Training Board, Mr. Gary Polulak, to the next Board meeting to see what can be done cooperatively with the Local to affect this change.
