NOTICE OF FUNDING AVAILABILITY, REQUEST FOR PROPOSALS

Funded by the U.S. Department of Housing and Urban Development, Community Development Block Grant (CDBG), the City of Detroit's Planning and Development Department (the "City") seeks Request for Proposals (RFPs) to obtain qualification statements from experienced planners and designers for the following target sites:

- 1. Jefferson Chalmers (RFP#17MC949): Planning and design services to create a neighborhood development and implementation plan with specific focus on commercial corridor improvements, historic preservation, rehabilitation development, and green stormwater infrastructure. The planning area is bounded by Vernor to the North, the Detroit River to the South, Alter to the East and Connor to the West.
- 2. Campau/Banglatown (RFP#17EJ952): Planning and design services to create a neighborhood development and implementation plan with specific focus on landscape stewardship, rehabilitation development, and the strengthening of commercial corridors. The planning area is bounded by Davison/McNichols to the North, Carpenter/Conant/Caniff to the South, Mound to the East and Dequindre to the West.
- Russell Woods/Nardin Park (RFP#17BW953): Planning and design services to create a neighborhood and economic development strategy for the Russell Woods and Nardin Park Neighborhoods. Economic development will focus along the Dexter, Livernois, and Grand River Corridors with special attention to the stabilization of vacant homes in the historic Russell Woods neighborhood. The Nardin Park services will focus on a land stewardship strategy for vacant land throughout the neighborhood, with a focus on stabilizing vacant homes, vacant schools and vacant multifamily buildings of historic significance. The area is generally bounded by Oakman to the North, Grand River to the South, Dexter to the East and Livernois to the West.

Qualified Minority Owned Enterprises, Women Owned Enterprises, Disadvantaged Business Enterprises, Veteran Owned Enterprises, Detroit Businesses, and HUD Section 3 Certified Business Concerns are encouraged to submit proposals.

Additionally, potential suppliers must register (free) with the U.S. Federal Government's System for Award Management at www.SAM.gov Contracted suppliers also must register (free) with the City of Detroit, Oracle Supplier Portal and submit an ACH Direct Deposit form for payments.
