CITY OF DETROIT RIGHT-OF-ACCESS

The City of Detroit grants permission to your company, including its employees, representatives, and agents (collectively, "User"), to enter the above-referenced location (hereinafter "Site") for the sole purpose of conducting a site walk through, while accompanied by a City of Detroit representative, scheduled for (provide date of access) _____, 20_____. User warrants that it will not engage in any further activities (*i.e.*, intrusive, subsurface, environmental, construction, etc.) during the site walk through. User is entering upon and using the Site at its own risk, and accepts the Site "As Is." The City of Detroit makes no representation or warranty as to the status of title or the physical or environmental condition of the Site, or its fitness for any particular use. User is required to follow all guidelines and direction provided by City of Detroit during use of the Site.

User agrees to hold the City of Detroit harmless, defend and indemnify the City of Detroit from and against any and all claims, damages, obligations, penalties, costs, charges, losses, demands, liabilities, and expenses (including, without limitation, fees and expenses for attorneys, expert witnesses and other consultants) that may be imposed upon, incurred by, or asserted against the City of Detroit or its departments, officers, employees, or agents for property damage and bodily or personal injury arising from or related to User's use of the Site and this Right-of-Access.

User agrees to waive, release and discharge the City of Detroit or its departments, officers, employees, or agents from any and all liability, claims, demands, and causes of action whatsoever, legal and equitable, because of damages, losses, or injuries to User or User's property or both, arising from or related to User's use of the Site and this Right-of-Access. User agrees and covenants not to sue the City of Detroit or its departments, officers, employees, or agents, and to refrain from instituting, continuing, presenting, subrogating, collecting or in any way aiding or proceeding upon any claims, judgments, debts, causes of action, suits and proceedings of any kind at law or in equity arising from or related to User's use of the Site and this Right-of-Access.

User's Right-of-Access shall terminate upon completion of the site walk through, except that the provisions in the paragraphs above shall survive after the termination of this Right-of-Access. This Right-of-Access will be effective only upon execution of the acknowledgment by User's duly authorized representative, and upon delivery of same to Maurice Cox, Director, Planning and Development Department.
