4 CHAIRPERSON CARTER: Good afternoon. My  
5 name is Lisa Carter, and I am the Chair of the Board. I  
6 represent District 6, and I will serve as -- I will be  
7 conducting today's meeting. On behalf of the Board for  
8 those in attendance, thank you for joining us. For  
9 people viewing the meeting on your government cable  
10 channel, thank you for viewing our meeting.  
11 Commissioners Annie Holt and Willie Burton are excused  
12 from today's meeting.

13 Today we have invited Chaplain Leonard  
14 Jackson to provide the invocation.

15 (Invocation given).

16 CHAIRPERSON CARTER: Chaplain, thank you.  
17 At this time, we'll have an introduction beginning to my  
18 far right with Commissioner Davis.

19 COMMISSIONER DAVIS: Good afternoon. Police  
20 Commissioner William Davis, District 7.

21 COMMISSIONER BURCH: Good afternoon.  
22 Shirley Burch, District 3.

23 MS. BROOKS: Good afternoon. Elizabeth  
24 Brooks, At-Large.

25 MS. GARZA DEWAELSCHÉ: Good afternoon. Eva

1 Garza Dewaelsche At-Large Vice Chair.

2 COMMISSIONER BELL: Willie Bell, District 4.

3 COMMISSIONER GRIFFIE: Evette Griffie,  
4 District 3.

5 COMMISSIONER BROWN: Darryl Brown, District  
6 1.

7 SECRETARY HICKS: Madam Chair, you have a  
8 quorum.

9 CHAIRPERSON CARTER: Thank you,  
10 Commissioners. It's good see each of you this  
11 afternoon. Commissioners, you have before you the  
12 agenda for today.

13 COMMISSIONER BELL: So moved.

14 GARZA DEWAELSCHÉ: Support.

15 CHAIRPERSON CARTER: It's moved and  
16 supported that we approve the agenda for October the  
17 31st, 2019. Is there any discussion? Those in favor?

18 COMMISSIONERS: Aye.

19 CHAIRPERSON CARTER: Those opposed. Motion  
20 carries. Commissioners, you have also the minutes from  
21 October 24th, 2019.

22 COMMISSIONER BROOKS: So moved.

23 COMMISSIONER BELL: Second.

24 CHAIRPERSON CARTER: It's been moved and  
25 supported that we approve the minutes from October 24th,

1 2019. Is there any discussion? Those in favor?

2 COMMISSIONERS: Aye.

3 CHAIRPERSON CARTER: Those opposed? Motion  
4 carries.

5 COMMISSIONER BROWN: Nay.

6 CHAIRPERSON CARTER: At this time, Mr.  
7 Hicks, would you introduce the BOPC staff.

8 SECRETARY HICKS: Thank you, Madam Chair.  
9 Just prior to making that introduction, I do want to  
10 indicate that today's meeting is being taped by Sergeant  
11 Quinn, Media Services is providing the audiovisual work,  
12 and Mindy Womack is the court reporter today. And then  
13 I will just ask for members of the BOPC staff to just  
14 stand and give their names for the record, and then when  
15 we exhaust them, we go to the Office of the Chief  
16 Investigator. Dr. Polly McAllister, can you make the  
17 introductions on behalf of Investigators who are here  
18 today.

19 MR. WYRICK: Jermaine Wyrick.

20 MR. BROWN: Robert Brown, Board staff.

21 MS. WHITE: Good afternoon, Melanie White,  
22 Executive Manager of Policy.

23 DR. ANDERSON: Dr. Marcella Anderson, Police  
24 Personnel.

25 MS. JOHNSON: Fay Johnson, Board

1 Accountant.

2 DR. McALLISTER: Good afternoon, Board. I'm  
3 Dr. Polly McAllister and attending today's meeting with  
4 me is Senior Investigator Moses, and Investigator  
5 Murphy, Investigator Nealy, Investigator Hunter, and Ms.  
6 Angela Cox.

7 CHAIRPERSON CARTER: Thank you. At this  
8 time sitting in for the Chief is Deputy Chief Todd  
9 Bettison. Good afternoon, sir.

10 DC BETTISON: Good afternoon.

11 CHAIRPERSON CARTER: Introducing the staff.

12 DC BETTISON: Yes.

13 (Whereupon DC Bettison introduced himself  
14 as well as his staff)

15 CHAIRPERSON CARTER: Thank you. At this  
16 time, if there are any elected officials, VIPs, or civic  
17 leaders or their representatives, please stand and give  
18 your name, please.

19 CHAIRPERSON CARTER: Yes, ma'am.

20 (At this time, audience member  
21 introduced herself)

22 CHAIRPERSON CARTER: And Commissioner Jim  
23 Holley has joined us. Thank you for joining us, sir.

24 If there's nothing further, we'll go into my  
25 report. On behalf of the Board, I want to express our

1 concern and support for fallen and injured officers and  
2 their families. Our concerns for officer safety and  
3 citizen protection is ranked as two of the most  
4 important priorities of the Board. Our Board receives a  
5 weekly report from the Department listing injured  
6 officers, and I would ask that Deputy Chief Bettison  
7 during your remarks please provide us with any  
8 additional information related to injured and fallen  
9 officers.

10           The Board of Police Commissioners meets  
11 every week except for Thanksgiving and Christmas holiday  
12 periods. We meet at Police Headquarters three weeks in  
13 the month on Thursdays at 3 p.m. We also meets in the  
14 community every second Thursday of the month at 6:30  
15 p.m.

16           Under the Detroit City Charter Article 7,  
17 Chapter 8 of the Board Police Commissioners, the Board  
18 of Police Commissioners is empowered to provide civilian  
19 oversight and supervisory control of the Police  
20 Department. Our Board investigates noncriminal citizen  
21 complaints, monitors the Department for compliance with  
22 all laws and reviews and modifies police policy,  
23 eliminate misconduct, discriminatory police practices  
24 and unnecessary use of force by police.

25           As a civilian oversight agency, we protect

1 the civil rights of our citizens. Our objective is to  
2 increase the quality of life for residents and visitors  
3 to Detroit.

4 I want to point to several items for your  
5 consideration and information. I also want to repeat  
6 some of the information I've already shared with you in  
7 several of our past meetings. In several meetings,  
8 issues have been raised about provisions of the Open  
9 Meetings Act. The Board does not require anyone to  
10 identify themselves as a precondition to participate in  
11 our meetings.

12 Our Board meets weekly. Our schedule is  
13 very demanding. Our practice has been to meet in one  
14 convenient location so the public is aware of our  
15 meetings and can get to the Board in time. We also make  
16 every effort with our community meetings to meet in  
17 every police precinct across the city. This too is an  
18 outreach effort to connect citizens with police  
19 services.

20 Given some of the concerns to spread our  
21 meetings beyond Police Headquarters, we are inquiring  
22 into the utilization of other spaces to hold our  
23 meetings. This process will take time. Meeting dates  
24 and locations are scheduled well in advance of the  
25 actual meeting dates.

1 I should add that the Michigan Municipal  
2 League has agreed to provide the Board with training on  
3 parliamentary procedures and the Open Meetings Act. The  
4 current schedule for the training is Monday December 9,  
5 2019 at 6:00 p.m. The training session will take place  
6 in our conference room. If you are unable to attend,  
7 please contact attorney Wyrick. The training will have  
8 new information and it will also confirm that many of  
9 our current practices are within the meaning and spirit  
10 of the Open Meetings Act. The training will cost the  
11 Board \$1500, and will be taken from our training account  
12 number 628200.

13 The Board has received three notifications  
14 this week. The Police Academy as of Monday, October 28,  
15 2019 started a new class. The academy will also start  
16 another class on November 25th, 2019. We are arranging  
17 a time at the Academy for members of the Board to speak  
18 with new recruits. While Commissioner Bell oftentimes  
19 speaks new recruits, the invitation is open to any and  
20 all Board members to address recruit class. At this  
21 time, the Office of the Chief Investigator also makes a  
22 presentation to the new recruit class.

23 The Elected Officials Compensation  
24 Commission has contacted us requesting information for  
25 adjustments to the salaries of elected officials. In



1 their resolution distributed to the City, they ask for  
2 information to help determine the salaries of elected  
3 officials.

4           Given that members of the Board do not  
5 receive a salary, it appears the Elected Officials  
6 Compensation Commission is not likely to take up our  
7 continuing request for financial adjustments and the  
8 reimbursement that we receive as Police Commissioners.

9           Each Board member should have a report from  
10 the Office of the Inspector General in connection with  
11 one of our investigative teams in the Office of the  
12 Chief Investigator. I should note, these members of our  
13 staff belong to a Collective Bargaining Unit Local 212.  
14 Members -- the members of that unit have due process  
15 protection, a chain of command, and an internal  
16 grievance process. The Board is the final step in their  
17 grievance process. The Board is reviewing the report  
18 with great interest and will wait to see how the due  
19 process protections and chain of command procedures  
20 unfold.

21           Also in the package is a report from the  
22 Chief of Police on facial recognition. From our last  
23 meeting we made several suggestions around the creation  
24 of the report. Two of the most outstanding requests was  
25 to have cumulative data in the report, and to have the

1 report go back to the beginning of the Department's use  
2 of Facial Recognition. It does not appear that that  
3 information is in the report. I've asked staff to  
4 review the report, and we will be making a written  
5 submission to the Chief on many of the areas of concern  
6 that have been expressed by the Board.

7 Last week I informed the Board of the  
8 request for legal representation for one our  
9 investigators, Delvata Moses. At the proper time, I  
10 will be requesting a formal vote to provide Investigator  
11 Moses with legal representation by and paid for by the  
12 City.

13 Also in your package is a copy of the  
14 Chair's brief and agenda. In the past, several  
15 references have been made that the Board's leadership is  
16 involved in secret meetings in violation of the Open  
17 Meetings Act. The Board is a voluntary board made up of  
18 the elected and appointed people who are not employees  
19 of the City and who have agreed to do this work part  
20 time. As I indicated last week, to manage this effort,  
21 better than a year ago with the data process when the  
22 Chair received and administrative debriefing from staff  
23 each Wednesday. I ask you to look closely at the  
24 administrative briefing agenda. The information  
25 contained in that agenda is a direct reflection on the

1 information that is transmitted to the full board in  
2 your Tuesday package, and is repackaged for you on  
3 Thursday.

4 We take this extra measure to share  
5 information with the Board so that we can effectively  
6 move through the business of the organization. Again, I  
7 bring this to your attention because of the false  
8 suggestion that we have secret meetings. Today we have  
9 two presentations on the agenda. A presentation from  
10 Deputy Chief Marlon Wilson on the work of the Detective  
11 Bureau, and our standard monthly report on citizens  
12 complaint received and processed by the Office of the  
13 Chief Investigator. Doctor Polly McAllister will be  
14 making this report.

15 Under the Chief's report, I requested an  
16 update on the citywide crime statistics and any critical  
17 issues facing the department. Please note that I have  
18 adjusted the flow of the meeting to allow for public  
19 comments in advance of a closed session wherein we will  
20 be consulting with Board legal counsel, attorney Wyrick.  
21 At the appropriate time, I will be requesting a motion  
22 to go into closed session. Under the Open Meetings Act  
23 we should have any votes on the matter. We will  
24 reconvene the regular meeting to take any voting items  
25 in public view, open public view.

1           So towards the midpoint of the meeting, we  
2 will have public comments. Please make sure you put  
3 your name on the speaker's card. Cards are located in  
4 the back on the table where you can obtain one from Mr.  
5 Brown seated in the front of the room. We will need  
6 your card before the end of the Chief's report. We will  
7 hold each speaker to the allotted two minutes, and I ask  
8 that everyone please place your cell phones or  
9 electronic devices on vibrate to make sure that they are  
10 not interrupting the meeting.

11           As a final matter, I would like to encourage  
12 cooperation and order at our meetings. We have  
13 discussed this in the past to treat people, to treat  
14 each other with respect, and to control our behavior  
15 within limits of professionalism. Commissioners do not  
16 have the floor and should not speak until they are  
17 recognized by the Chair. I am asking Commissioners to  
18 restrict their comments to the issues that are relevant  
19 to the agenda and to be brief so that we have ample time  
20 for public comments.

21           For the attending audience, please make note  
22 that there's time on the agenda for citizen input and  
23 feedback. My objective today is to run an orderly  
24 meeting, including public comments, and have us out of  
25 the meeting by 4:30 p.m.

1                   At this time, we'll go to Deputy Chief  
2 Bettison.

3                   DC BETTISON: Thank you, chairperson.  
4 Greetings on behalf of Chief Craig. Talked to the  
5 Chief. He wished he could have been here today. The  
6 Chief is currently in New York at the New York  
7 University School of Law participating in a round table  
8 discussion and doing a presentation on facial  
9 recognition.

10                   Earlier this week, Chief Craig attended the  
11 IACP, the International Association of Chiefs of Police,  
12 and also the Major City Chief's Conference. They are  
13 the topic, of course a hot topic, facial recognition.  
14 The Chief spoke to a audience of police professionals  
15 about it and how the Detroit Police Department utilized  
16 that. The Chief wanted me to relate to the Board that  
17 the Detroit Police Department stated in policy when  
18 facial recognition has more rigor than other departments  
19 that he is aware of and that he has encountered.

20                   The Department is a benchmark, and the Chief  
21 wanted me to thank this Board for your participation in  
22 assisting us, the Department, in drafting and approving  
23 the rigorous facial recognition policy that ensures our  
24 citizens civil liberties, and yet, assists our  
25 detectives in identifying violent offenders.

1           They're looking at the way that we do it.  
2   The Chief just has an experience other departments and  
3   they're asking him, he's becoming a subject matter  
4   expert on it, I say is a subject matter expert, and with  
5   our policy he hasn't encountered any other department  
6   that has more rigor.

7           Also last week, you know, there was a  
8   discussion at the table concerning the topic of whether  
9   there was a unanimous vote by Detroit City Council to  
10   approve facial recognition. The Chief has publically  
11   stated that City Council unanimously approved the  
12   purchase of facial recognition. On July 14, 2017, there  
13   were six yeas and zero nays. The chief and the DPD  
14   leadership considered that unanimously approved.

15           Also I will go into our crime at this point.  
16   With our criminal, our criminal homicides are up 2%,  
17   sexual assaults are down 3%, and aggravated assaults up  
18   5% -- well, down 5%, and nonfatal shootings slightly up  
19   by 2%, with our robbery showed a 3% reduction compared  
20   to same period of time last year, and our carjacking is  
21   down 21%. Total violent crime down 3%.

22           As requested, Chairperson Carter, officers  
23   critically injured in the line of duty, Waldis Johnson  
24   is still in a nursing care facility suffering from a  
25   gunshot wound that he received. Really not any updates,

1 just the same as the previous week. Nothing new to  
2 report in regards to our critically injured and fallen  
3 officers.

4           And today is a special day for me, and I  
5 will say that because it's the first Halloween that I'll  
6 get a chance to actually take my eight year old son  
7 trick-or-treating. Every other Halloween, we've always,  
8 DPD, should I say with over the years the angel's night,  
9 devil's night. You know, last night was that night, but  
10 guess what, it was just a normal night. And a lot of  
11 folks forgot about it. But we didn't have to work. Our  
12 citizens, it's just normal. So Halloween in the D  
13 activity it's all about trick-or-treating. And even  
14 though it's a rainy day, we still expect thousands of  
15 kids to come out to our precincts and fire stations and  
16 recreation centers. And we have a whole lot of candy to  
17 give out. So with that being said, at every precinct  
18 station in the city, we will have candy. And in some of  
19 them, they're cooking hot dogs and hamburgers. And the  
20 beautiful thing about it is it's all free to the public.  
21 So I want to thank the public and philanthropic folks  
22 out there who donated candy to the Detroit Police  
23 Department because we got a lot of candy. And no need  
24 to worry. Where we could, we moved our operations  
25 inside. So over at the 8th precinct, for example, even

1    though they don't have a garage, they moved it inside  
2    the lobby or auditorium.  In other places, they moved it  
3    inside the garage, and that is my report out.

4                   CHAIRPERSON CARTER:  Thank you, Deputy  
5    Chief.  Commissioners, questions for Deputy Chief?

6                   COMMISSIONER GRIFFIE:  Through the Chair.

7                   CHAIRPERSON CARTER:  Commissioner Griffie.

8                   COMMISSIONER GRIFFIE:  So I had a chance to  
9    take a look at the report that was in response to the  
10   facial recognition.  Last week I expressed some  
11   opportunity for us to I think sharpen this, and I  
12   appreciate the fact that the Chief used the word  
13   benchmark, and hopefully with the help of my colleagues,  
14   we can make this a successful program.

15                   However, I just want to -- I think last week  
16   my comments were what do we think the succession of this  
17   program is, and I really would like to see us place some  
18   metrics around where we want to go.  So I think on the  
19   report it has the date of the poll whether the leave was  
20   positive or negative, and the various crimes that it was  
21   pertaining to.

22                   I'd like for us to think about a year from  
23   now when this Board is evaluating the efficacy of this  
24   program, what kind of metric will be placed on that.  Is  
25   it a percentage of leaves that are positive versus



1 negativity, or how many are actually prosecuted and  
2 tried successfully. I don't know what that is myself.  
3 But I'd like for the Chief and his administration to  
4 think about that. And think about December 31st, 2020,  
5 what would you come back to this Board and say what's  
6 success. What are the goals for this program.

7 I think this report is fine. I think it  
8 needs to be refined, and we'll probably do that over the  
9 next couple weeks. But I really want to make sure that  
10 as we are governing this program and being accountable  
11 to the citizens about this program that we really think  
12 about what its intended purpose is and make sure we're  
13 tracking that overall, in addition to the weekly  
14 reports, which gives us information.

15 DC BETTISON: Through the Chair to  
16 Commission Griffie, I definitely understand that being  
17 data driven. And in the spirit of continuous  
18 improvement, we definitely welcome working with this  
19 Board because I think with the oversight and with the  
20 Board's input collectively, we've drafted a great policy  
21 and we can continue to work towards making sure that we  
22 capture those metrics so that we have a opportunity to  
23 be able to showcase our program based off of metrics and  
24 data.

25 CHAIRPERSON CARTER: Any other questions?

1 COMMISSIONER BELL: Madam Chair, since the  
2 Deputy Chief brought up the issue of the voting of the  
3 counsel, I stand by your statement last week that the  
4 vote was six of the present council members. There was  
5 not nine present. That meant unanimous means nine.  
6 This Board is 11, and but you took a vote that was  
7 present. That means 11 all agreed. That's my  
8 interpretation. If Mr. Wyrick could look into this  
9 matter, perhaps we can resolve this. But I'm old  
10 school. My math is very simple that six voting is not  
11 nine. That's unanimous. I don't want you to debate,  
12 but I want Mr. Wyrick to get an understanding because  
13 the Chair made a strong statement on that and I  
14 supported, we support that statement that six is not  
15 majority. I mean it's a majority vote, but it's not  
16 nine. It's not a unanimous vote. So if that's his  
17 interpretation, I want to get clarity because I stand by  
18 the Chair in terms of her position on this matter.

19 CHAIRPERSON CARTER: Any other?  
20 Commissioner Brown.

21 COMMISSIONER BROWN: The unanimous decision  
22 he could be speaking of it was the quorum that was  
23 there. And if that's the quorum that was there, there  
24 was only six members there and only six members that  
25 voted. Yeah, that is a unanimous decision.

1           The other point I wanted to bring out with  
2 Commissioner Griffie's ongoing thing with metrics in  
3 these reports. Some us on this Board may not understand  
4 what metrics are. In the spirit of teams improvement, I  
5 would like to see if we could look into maybe what they  
6 got white belt training.

7           COMMISSIONER GRIFFIE: Yellow, green, black.

8           COMMISSIONER BROWN: Yellow would be fine,  
9 because I know the City is on the verge of doing  
10 greenbelt change training. They have things coming up  
11 right now. But if we could maybe schedule some type of  
12 training for yellow belt or some initial training to  
13 train some of the Commissioners that don't understand  
14 when we're talking about metrics, talking about all  
15 these goals and everything with the data that's driven,  
16 and if we could just take a class for some of the  
17 Commissioners that may not be following that continuous  
18 improvement lingo.

19           CHAIRPERSON CARTER: I'll have the staff  
20 look into that. No other questions? Commissioner  
21 Burch. Yes, ma'am.

22           COMMISSIONER BURCH: Yes, ma'am. To DC  
23 Bettison. I'd just like to thank you personally for  
24 attending our meeting. As you know, my whole heart is  
25 about the speeding in our neighborhoods. So soon you

1 will see changes that will hopefully stop the decreasing  
2 or the increasing of the speeding of motorists. So I  
3 wanted to thank you personally for coming to our  
4 meeting; that we had the right people at the table that  
5 can make a change in a neighborhood. That's all I  
6 wanted to say. Thank you.

7 DC BETTISON: Through the Chair, just in  
8 response, I just want to add one other thing I think  
9 that the community should know. We talked about and  
10 Mrs. Burch meeting as well, radio patrol. So I have  
11 good news to report. We have hired a radio patrol  
12 coordinator. We've been trying to get her a long time.  
13 So Myra Gracie, many of you know her, will start this  
14 Monday. So November the 4th, Myra Gracie starts. So it  
15 should be an interruption in our program for her. So  
16 this is good news for everybody.

17 COMMISSIONER BELL: Madame Chair, I have one  
18 more comment. This is domestic violence at the end of  
19 the month. I just went to Commander Eric Ewing at the  
20 5th precinct for having a domestic violence forum that  
21 was attended. I had an opportunity to see a portion of  
22 it. It was well attended and was necessary. I think it  
23 was very informative for the Commander and 5th precinct  
24 to conduct that type of forum on domestic violence. I  
25 think that the attendees and the people who engaged in

1 was really eye opening in terms of what's happening with  
2 the domestic violence. I just want to cite Commander  
3 Ewing of the 5th precinct for his effort in terms of  
4 spearheading that.

5 DC BETTISON: Thank you so much. And I know  
6 that oftentimes I participated in, of course, the breast  
7 cancer awareness, and also this month was domestic  
8 violence. And oftentimes victims and members of  
9 domestic violence feel like they're overlooked. So  
10 thank you for that. Of course we get our domestic  
11 violence car for this month, and we have a breast cancer  
12 car also. So the DPD, we definitely try to give equal  
13 attention to both during the month. Thank you.

14 COMMISSIONER HOLLEY: Madam chairperson.

15 CHAIRPERSON CARTER: Mr. Holley.

16 COMMISSIONER HOLLEY: I listened to your  
17 remarks, and I'm looking at the agenda. I don't see  
18 nothing in here about deciding or mentioning the passing  
19 of Congressman John Conyers. And I just feel like that  
20 it would be a tremendous dismissal on our part. So I  
21 just want to think that we ought to -- if we don't do  
22 nothing to today formally, then we ought to do something  
23 next week, next meeting. To go this far and not to  
24 mention the passing of John Conyers is -- I'm just  
25 asking.

1 CHAIRPERSON CARTER: Absolutely,  
2 Commissioner Holley, and I apologize for that. There's  
3 a lot on the mind.

4 COMMISSIONER HOLLEY: Sure.

5 CHAIRPERSON CARTER: And yes. At this time,  
6 I'm just going ask for a moment of silence in honor and  
7 recognition of Congressman John Conyers, Jr.

8 (Moment of silence)

9 CHAIRPERSON CARTER: Thank you.

10 COMMISSIONER BROOKS: Madam Chair.

11 CHAIRPERSON CARTER: Commissioner Brooks.

12 COMMISSIONER BROOKS: Yes. I would just  
13 like to say something to you concerning domestic  
14 violence. COTS is a great organization. If anyone  
15 knows anyone that's involved in domestic violence where  
16 children have no place to live COTS will take you in.  
17 So that's what they take in domestic violence, women  
18 from domestic violence. They take in homeless women  
19 with children, and they also have room for human  
20 trafficking victims. So I just want to remind you of  
21 that.

22 CHAIRPERSON CARTER: Thank you. Any other  
23 questions? Comments? Concerns? Questions? And I just  
24 want to say for the record that last week my comments  
25 about the City Council issue was not -- it said and I

1 think I was talking about words matter. And that's the  
2 only point that I wanted to make; that when you say  
3 words, they matter. And when you say that a, a --  
4 something is unanimous, and there are nine members of  
5 council, I was just expecting nine members to have voted  
6 on the issue. But that's the only point I was trying to  
7 make was that words matter. So thank you, Chief  
8 Bettison.

9 DC BETTISON: Yes, ma'am.

10 CHAIRPERSON CARTER: We will move on. At  
11 this time, we have presentations from the Detective  
12 Bureau. Deputy Chief Marlon Wilson.

13 DC WILSON: Good afternoon, Board. Deputy  
14 Chief Bettison. For the record, Deputy Chief Marlon  
15 Wilson assigned to the Detective Bureau. Today I got my  
16 team with me, and we're going to provide a brief  
17 overview of operation of the Detective Bureau.

18 I will begin a presentation with my slide,  
19 which will give you overall flow of the commands  
20 assigned to the Detective Bureau. There's four main  
21 areas of the Detective Bureau, first being major crimes,  
22 which is headed by Commander Tiffany Stewart. That  
23 encompasses homicide, special victims unit such as sex  
24 crimes, child abuse, and domestic violence. Our auto  
25 theft unit and our public order crimes, which includes

1 cyber crimes and our team that focuses on graffiti and  
2 other blight issues.

3 Next we have organized crimes which is  
4 headed by Commander Jacqueline Pritchett and Captain Ian  
5 Severy. That includes major violators, or some might  
6 know us as narcotics, vice, task force administration,  
7 which is our federal task forces, and our gang  
8 intelligence unit which drives our ceasefire unit.

9 Next we have our investigative operations  
10 unit. That his headed by Captain John Svec. That  
11 includes our crime services unit and our property  
12 section, our records unit and our investigation liaison  
13 which runs all the court work for our precinct detective  
14 unit.

15 Up top we have the Crime Intelligence  
16 Bureau. That is a direct report to me. Captain Aric  
17 Tosqui is the person that's in charge of that.

18 As we continue the presentation, I'm going  
19 to have each command officer assigned to each area come  
20 up and give a brief overview. So with that, I'm going  
21 to have Commander Stewart talk about homicide.

22 COMMANDER STEWART: Hi. Good afternoon,  
23 commissioners. How are you? My name is Commander  
24 Tiffany Stewart, and I am in charge of the major crimes  
25 division which encompasses quite a bit of the -- well, a



1 few of the violent crimes, part one crimes that we look  
2 at on a daily basis within the City of Detroit. We're  
3 going to start with homicide. Homicide responds to and  
4 investigates all homicides, including infant deaths,  
5 suicides, and unnatural deaths within the City. An  
6 unnatural death could be looked upon as an overdose,  
7 something of that nature. Just for your knowledge, it  
8 has six squads that investigate crimes all within the  
9 City of Detroit, and that's not including the homicide  
10 task force, which is a task force with Michigan State  
11 Police and they investigate high-profile homicides,  
12 homicides where there are multiple victims who are  
13 murdered in one instance, officer involved shootings.  
14 So that's what the task force investigates.

15 Imbedded within homicide unit are several  
16 smaller units that also investigate crime. One of those  
17 is a fatal squad which investigates fatal and critical  
18 vehicular accidents. We saw a presentation from them  
19 last week. We have an inactive case squad. They  
20 investigate cases that have been classified as having no  
21 further investigative follow-up with the goal of  
22 identifying new investigative leads. It might be where  
23 we didn't have -- where DNA was unable to be looked at,  
24 and now with the technological advance, maybe we can  
25 resubmit and see if we can get some traction on that

1 case.

2 Headquarter surveillance is a team of  
3 officers who go out and they actually apprehend and make  
4 an arrest on our murder suspects as well as suspects of  
5 various other violent crimes within the City of Detroit.

6 Missing person unit, they identify  
7 endangered and long-time missing persons. They work in  
8 conjunction with precinct detectives unit. They provide  
9 additional support and follow-up resources to help the  
10 precinct with missing -- certainly if they believe that  
11 the missing could be possibly deceased. They are  
12 alerted call for all Amber, Amber alerts too. You know,  
13 when your cell phone goes off in the middle of the night  
14 with those Amber alerts.

15 And lastly, we have an arson unit which is  
16 joint fire investigation unit with fire personnel. We  
17 have police officers who are also trained in fire  
18 investigation, and their goal is to investigate fires  
19 with the cause of origin related to arson.

20 The next unit on the major crime is the  
21 special victims unit. As D.C. Wilson said, that  
22 encompasses domestic violence, sex crimes, and child  
23 abuse. Domestic violence investigates married, formerly  
24 or currently reside together, if they were married or  
25 were not married or children in common. They also

1 investigate elder abuse, 65 and older. Precinct  
2 detectives investigate dating relationships only,  
3 boyfriend and girlfriend. Investigate in the precinct  
4 if there's a sibling involved, you know, two siblings  
5 got into a physical altercation. So just so you know,  
6 there's difference in what domestic violence  
7 investigates versus what they investigate in the  
8 precinct that's classified as domestic violence because  
9 live together in a household, in a residence.

10 The sex crimes unit is broken down into  
11 various squads. Unknown or stranger squad. The known  
12 squad. The kiddy squad, which is 16 and under. And  
13 then sexual assault kit squad. That squad investigates  
14 follow-up leads on all sexual assault kits from years  
15 prior that we finally were able to send to the lab for  
16 analysis.

17 Also under sex crimes unit, which is not on  
18 the slide is the VAP program, the Victims Assistance  
19 Program, and that is 23 members. They are actually  
20 licensed social workers as well as two victims advocates  
21 and we have a dryer to help with support for our victims  
22 of domestic violence and child abuse, just so you know.  
23 I'm sorry. Domestic violence and sex crimes.

24 And lastly we have child abuse unit. That  
25 unit investigates child abuse crimes of victims 16 and

1 under.

2           Lastly under the major crimes unit is the  
3 auto theft and the public order crimes. Auto theft unit  
4 handles carjacking, stolen vehicles. Those are straight  
5 steals. You go outside, park your vehicle, go outside,  
6 come back in the morning, your vehicles gone. That's a  
7 straight steal. And they handle auto parts inspections.  
8 That can be business inspections of auto-related  
9 facilities. Those are collision shops, dealerships.  
10 They go in and conduct inspections on those, make sure  
11 that the business is running on par since they actually  
12 have businesses licenses.

13           And lastly we have public order crimes.  
14 Obviously, those are crimes getting a lot of attention.  
15 Those are lot of the phone calls you get to your NPOs as  
16 well as the unit up under me that deals with some of the  
17 most egregious institutes. They handle dumping,  
18 electricity, theft, scrapping and graffiti.

19           And finally we have cyber crimes unit. Even  
20 though it doesn't fall into the other four, cyber crimes  
21 unit investigates computer related crimes, warrants type  
22 submitted on computer related crimes, they also do  
23 digital forensics. And at this point time, I'm going to  
24 turn it over to Commander Pritchett so she can go over  
25 organized crime.

1                   COMMANDER PRITCHETT: Good afternoon.  
2     Jacqueline Pritchett, Commander of organized crime.  
3     Organized crime has number all it is, major violators,  
4     prison process and planning analysis. There's vice,  
5     gang intel, task force administration. So major  
6     violators currently we have three raid crews throughout  
7     the City, primarily do all the narcotic raids in the  
8     City of Detroit. We have an opioid task force that  
9     works with the DEA on a daily basis. My prisoner  
10    processing unit, they evaluate all arrests for  
11    violations of the Controlled Substance Act and vice  
12    unit. Let me go back. Planning and Analysis office was  
13    not on here. They receive, evaluate, process, and  
14    distribute all narcotic complaints. They capture and  
15    maintain all statistical data, as well as maintaining  
16    case and complaints of vice. They are responsible for  
17    enforcement of prostitution, obscenity, illegal liquor  
18    activity sales and consumption, and illegal gambling.  
19    They also enforce City ordinances related to hotels and  
20    motels, rental hauls, scalping, massage parlors, and any  
21    adult entertainment venue, as well as human trafficking.  
22                   Task Force Administration. We have several  
23    entities up under Task Force Administration. Violent  
24    gang and violent gang task force works with FBI. They  
25    investigate violent crimes for federal or state

1 prosecution, they investigate all gang violent crimes as  
2 well as investigate bank robberies, ATM thefts and  
3 murder for hire. Our firearm investigative team  
4 investigates violent -- works with ATF on a daily basis.  
5 They investigate violent gang activities for federal or  
6 state prosecution, they investigate all firearms  
7 trafficking, and they review all gun arrests for federal  
8 prosecution.

9           The Joint Terrorism Task Force works with  
10 the FBI. They investigate allegations of terrorist  
11 threats of federal prosecution. The Detroit Fugitive  
12 Apprehension Team works with the US Marshal and they  
13 serve fugitive warrants of violent crimes of federal and  
14 state.

15           Also, our newest unit of Violent Crime  
16 Reduction Initiative, they work with the Wayne County  
17 Sheriff's Department on a daily basis and they serve  
18 warrants for crimes that occur in the City of Detroit.

19           And last, but not least, is our gang  
20 intelligence. Our gang intel they gather intelligence  
21 and perform analysis of illegal organized gang or group  
22 dynamics, they conduct precision enforcement through  
23 intelligence led policing on organized gang and or  
24 groups. They also provide support to community  
25 outreach, precincts, Detroit Public Schools, Homicide

1 through our federal and state enforcement partners.  
2 They also investigate and suppress emerging gang members  
3 involved violence in ceasefire precincts. Currently the  
4 3rd and the 10th precincts are the only ones that are  
5 not ceasefire precincts, but they are coming aboard.  
6 I'm not sure of the dates, but they are coming aboard.  
7 And last but not least ceasefire promote the ceasefire  
8 initiative throughout the City of Detroit. And that's  
9 it for organized crime.

10 CAPTAIN SVEC: Good afternoon. I'm Kevin  
11 Svec. I'm responsible for the Evidence Tech Unit,  
12 collection and preservation of evidence. It's a unit  
13 staffed by sworn and civilian personnel. They work  
14 around the clock 24/7. Year to date they've responded  
15 to over 4,500 scenes and worked requests. The latent  
16 prints AFIS unit, which is automated fingerprint  
17 identification system. They are responsible for  
18 identifying, classifying lifted prints from crime  
19 screens and entering those prints into AFIS system.

20 Property control, they're responsible for  
21 security and storage of all evidence. Year to date  
22 they've processed over 55,000 pieces of evidence. The  
23 NIBIN unit conducts comparison of firearm evidence in  
24 their national database work with the ATF with this  
25 system.

1 Data quality control, they review all RMS  
2 reports for proper coding and assignment, report all  
3 crime statistics to MICR, which is Michigan Incident  
4 Crime Reporting. Records Management maintains and  
5 disseminates department records in response to FOIA  
6 requests, Freedom of Information requests.

7 Customer service desk, they handle crime  
8 reports, accident reports, and firearm registration.  
9 Identification, positively identify all arrestees,  
10 conduct MDOC checks, and conduct applicant and  
11 background checks.

12 PDU Management, coordinate investigative  
13 policies and processes among all precinct detective  
14 units. Compstat unit, conduct biweekly audits of the  
15 entire department for matters concerning the patrol,  
16 investigative and administrative function of the  
17 department. Court Liaison, liaison for DPD with the  
18 courts, and assist with all arrangements. PDU court  
19 officer manage all court work regarding in custody  
20 prisoners and not in custody warrants. And they're a  
21 liaison with the Wayne County Prosecutor's Office.

22 Thank you.

23 CAPTAIN TOSQUI: Good afternoon. Captain  
24 Aric Tosqui of the Crime Intelligence Unit. Under crime  
25 intelligence we have the realtime crime center.



1 Everyone here has visited that. It's a 24/7 operation  
2 that's staffed with approximately say about three  
3 quarter civilian, one quarter sworn. It's goal is to  
4 provide realtime actual information to the folks on the  
5 street in terms of crime analysis, various projects as  
6 relates to crime intelligence work. We have the Project  
7 Greenlight Team. Specifically we have the Compliance  
8 Team and Executive Managers that deal with Project  
9 Greenlight. They help facilitate the memorandums  
10 between the various businesses that enter into the  
11 project. And then we make sure that the compliance  
12 between the agreements made by the City and the various  
13 businesses are maintained throughout the duration of the  
14 program.

15 We have our Counter Terrorism Threat  
16 Analysis Team whose goal is to conduct ongoing daily  
17 assessments which relates to domestic, foreign,  
18 international, local terrorist activities, any types of  
19 threats to various events we vet those threats. We vet  
20 threats against the mayor, against the Chief. We'll  
21 look into persons of interest who have any kind of a  
22 threat against the City or any of its institutions.

23 Lastly, we have the Audio Visual Extraction  
24 Response Team, and that is they have a couple functions.  
25 One is a Greenlight function. So any time that we have

1 a business that's in the pipeline for Greenlight, AVERT  
2 goes out and determines the best place where the cameras  
3 will be installed so the police have the final say in  
4 that as far as the MOU. They will go out and make sure  
5 that the videos are properly working and that as well.  
6 And then anytime a part one crime occurs or crime in a  
7 Greenlight location occurs, then the video evidence has  
8 to be extracted. AVERT has been recalled out to the  
9 scene in the video is extracted for evidentiary purposes  
10 there.

11 DC WILSON: So that concludes our  
12 presentation. So questions?

13 CHAIRPERSON CARTER: Commissioner Burch and  
14 then Commissioner Davis.

15 COMMISSIONER BURCH: Thank you, Madam Chair.  
16 This is for commander Pritchett, if you could come.  
17 Thank you. Regarding say gains, and I think the proper  
18 term is sex workers, okay. Now just giving you the  
19 street, for example. If there's a lot of activity on  
20 Gratiot, or John R, whatever street, that you have both  
21 of these activities going on, do you find that they work  
22 hand in hand? Do they work together, or are they  
23 singularly like territorial, you do your thing, I do  
24 mine, but we do not interfere with one another? How  
25 does that work?

1                   COMMANDER PRITCHETT: Through the Chair. As  
2 far as my understanding of it, when the investigation,  
3 some of these established gang, group and gang members  
4 do work with the sex in the adult, the sexual  
5 trafficking spectrum, so we have a vice unit that  
6 investigates the sex trafficking, and we have the gang  
7 intel that investigates the gangs. So I wouldn't say so  
8 much territorial, it's just that what the gang is known  
9 for doing. Some gangs use credit cards. Some gangs are  
10 into selling drugs. And some gang members now are  
11 starting to involve, engage in human trafficking.

12                   COMMISSIONER BURCH: So what is the success  
13 of you capturing the gangs?

14                   COMMANDER PRITCHETT: As matter of fact,  
15 just last week -- I'm sorry. This week we had a, I  
16 don't want to get into any details, had a group member  
17 that was identified involved in human trafficking  
18 dealing with online with Instagram. So our gang intel,  
19 they watch on social media all the time, so they are  
20 very engaged in looking to seeing what's going on, being  
21 able to identify by the words being used or what's being  
22 said to determine if it is sex trafficking. If so,  
23 turns it over to vice and they work together to arrest  
24 people that responsible for committing the sex  
25 trafficking, as well as the gang activity.

1 COMMISSIONER BURCH: So thank you. That  
2 should be a decrease then, right?

3 COMMANDER PRITCHETT: I should be. Yes,  
4 ma'am.

5 COMMISSIONER BURCH: Yes. Thank you so  
6 much.

7 COMMANDER PRITCHETT: You're welcome.

8 CHAIRPERSON CARTER: Commissioner Davis.

9 COMMISSIONER DAVIS: My question is for the  
10 Deputy Chief. The Department Report does not have any  
11 information to tack the success or the failures of the  
12 unit. Should we have some numbers to show what trends,  
13 what's going on and broken down, and shouldn't we be  
14 able to look at that, and shouldn't we have that  
15 sometime soon.

16 DC WILSON: Yes, you can. Because actually,  
17 each one of my units we have where the smart sheets or  
18 shared database where we track all the warrants  
19 submitted, closure rates, all that is tracked daily. We  
20 have administrative staff that support that function.  
21 So yes. I can provide that for each one of the units.

22 COMMISSIONER DAVIS: Okay. Because I was  
23 the manager of the law department and we used to like to  
24 see numbers.

25 DC WILLSON: We're data driven.

1 COMMISSIONER DAVIS: I love numbers.

2 DC WILSON: And we provide it to him on a  
3 daily basis.

4 COMMISSIONER DAVIS: Okay.

5 DC WILSON: So we can provide that to the  
6 Board.

7 COMMISSIONER DAVIS: Looking forward to it.  
8 Also as relates to the Freedom of Information Request,  
9 is there a flat fee, a sliding scale related to cost  
10 associated with that?

11 DC WILSON: There is a flat fee based on an  
12 hourly rate, based on the lowest person that can perform  
13 the job. So if we can have an administrative person  
14 that's a civilian, we'd utilize that hourly rate. If  
15 it's a police officer, we'll use that hourly rate. So  
16 there's a calculation, there's a formula that we use  
17 depending on the number of documents that need to be  
18 copied or researched. There's a formula that we use  
19 when we calculate the number of hours, and it's based on  
20 an hourly rate.

21 COMMISSIONER DAVIS: And the person gets  
22 that right up front.

23 DC WILSON: That's correct.

24 COMMISSIONER DAVIS: Okay.

25 COMMISSIONER GRIFFIE: Through the Chair.

1 CHAIRPERSON CARTER: Commissioner Griffie.

2 COMMISSIONER GRIFFIE: I just want to echo  
3 the statement of my colleague. This is all very  
4 informative. I think we should try to make a practice,  
5 and I'm looking at our staff. I don't know who needs to  
6 work with the Police Department, but when we have a  
7 Department level report that comes before this Board, I  
8 think that we should be looking at some form of a score  
9 card, and not just for this report out, but other report  
10 outs as well. It's nice to know information that we  
11 could have read in the email. I think the more  
12 substantial conversation that I'd like to have as a  
13 Commissioner is what's happening, what's successful,  
14 what's not successful, and what we need to be doing to  
15 help support those efforts. And so as we think about  
16 how we work with the Department on future updates, I  
17 want to make sure that we let them know that the  
18 pre-spec for this is that we have more information  
19 around what the performance of that Department.

20 DC BETTISON: Through the Chair.

21 Understood.

22 CHAIRPERSON CARTER: Any other questions?

23 Commissioner Bell.

24 COMMISSIONER BELL: Yes, Madam Chair. Chief  
25 Craig had a conversation on our 45th anniversary with

1 our retired Deputy Chief Mary Jerrett Jackson,  
2 conversation surrounding our crime lab. I know the  
3 Chief would love to have a crime lab, DPD. How can we  
4 have a long-range plan to have our own crime lab again?  
5 I know we rely on Michigan State Police, but the focal  
6 point is Detroit. When you're talk about sex crime,  
7 when you're talking about homicide, you're talking about  
8 all the issues, narcotic, it's Detroit. And somehow or  
9 another, I know we lost the lab, but it should be some  
10 long range plan with the mayor and the council to  
11 understand DPD necessity to have their own crime lab.  
12 So I would like to put that out there and see how we can  
13 broker that in terms of long-range plan budget wise to  
14 make that happen.

15 DC BETTISON: Through the Chair. I'll take  
16 that question. Sounds like you've been talking to Chief  
17 Craig.

18 COMMISSIONER BELL: It's the chief  
19 conversation.

20 DC BETTISON: Absolutely. I know that the  
21 Chief has had a conversation with AC White to do some  
22 research. So I will definitely relay the message to the  
23 Chief, and we'll continue this conversation and work on  
24 putting some action behind it. Thank you.

25 CHAIRPERSON CARTER: Any other questions,

1 comments Commissioners? Thank you.

2 Next is our OCI monthly report from Chief  
3 Investigator, Polly, Dr. Polly McAllister.

4 CI McALLISTER: For time's sake, I will  
5 start. Good afternoon again. Today I will be  
6 presenting the August report. We did miss a month  
7 because we were busy with NACO. So for the month of  
8 August we did have a 5% decrease. In 8/19 we had a 104  
9 versus 8/18 we had 110, which gave us a 5% decrease.  
10 It's not much, but it's a start.

11 For our alleged units involved, the  
12 different precincts that you see, also, people don't  
13 panic, these are just allegations. Thank you. These  
14 are just allegations. We haven't proven anything yet,  
15 but these are the ones that come in. So what I did want  
16 to mention is a couple weeks ago, a citizen asked me  
17 what is an unknown command. This is when a citizen  
18 files a complaint and they do not know the officer's  
19 name, badge number, car code, very little information.  
20 They file a complaint and we have to go in and try to  
21 determine who the officers are. So that's with the  
22 unknown. And although it's rather high, majority of our  
23 officers are seasoned, our investigators are seasoned  
24 and they're skilled enough where we can track down a  
25 good percentage of those involved.



1           Okay. Well for time's sake, we'll keep it  
2 moving. So for profanity use, something Commissioner  
3 Bell has been monitoring for the last year. For July we  
4 had four uses of profanity, three uses of the F word,  
5 and four offensive slurs. For August we had, it almost  
6 mirrored July. We had four uses of profanity, three  
7 uses of F word, and only three offensive slurs. An  
8 offensive slur can be anything from shut up, calling  
9 somebody fats or anything along those lines. For our  
10 citizens complaints closed for August 2019, the arrests  
11 where we had a total of three demeanor, we had 36, entry  
12 we had three, force we had seven, harassment we had  
13 seven, and for procedure we had 51. Property for seven,  
14 and search for four, and service 21. And these are just  
15 closed complaints and it's always -- procedures always  
16 pretty high, and demeanor is always pretty high. For  
17 electronic evidence, one thing I think we're going to  
18 see decrease in a lot of complaints because the  
19 Department sent out a directive reminding officers to  
20 not shut their cameras off during a raid until the raid  
21 is over. If they have casual contact, the body room  
22 camera should be activated and on. So they just gave  
23 them a gentle reminder of the importance of the body  
24 worn cameras. So I'm hoping within the next few months  
25 that will be read in different roll calls and the

1 officers will take heed to it.

2 So out of 34 of the 42 incidents, we were  
3 able to capture those. We had a few that were not  
4 captured that may have come from a citizen filing a  
5 complaint after the 90 says, we were not able to pull  
6 that video.

7 And for our DPD members for seniority and  
8 rank, for our lieutenant, lieutenant we had one  
9 complaint. We had a decrease by four. For our police  
10 officers, we had 90. We had a decrease by 57  
11 complaints. Detectives we're actually down four, and  
12 for members with ten to 19 years we're down 14, and for  
13 sworn members with 20 to 29 years we're down 14, and  
14 sworn members with 30 years and above, we're down by 12.  
15 So that's pretty good, considering we've always had  
16 really, really high numbers.

17 And as always, how to file a complaint with  
18 our office. And also in your package you have two  
19 sheets of paper that explains disciplinary results.  
20 Take time to read it. Look at the different commands  
21 and what type of punishment they're implementing. If  
22 that's not kind of like suitable, I think that we should  
23 kind of like request some additional information, or say  
24 that we want something in a different form. So I would  
25 take the time to review it. We get it every month.

1 Some of the names are carryovers from the last month,  
2 but, for the most part, they have been consistent. I  
3 make sure that Mr. Hicks has a copy. So if you need a  
4 copy, an extra one, just let me know. But it is  
5 important to kind of like keep track of complaints and  
6 then the disciplinary actions that are implemented  
7 later. Are there any questions?

8 COMMISSIONER DAVIS: Yes.

9 CHAIRPERSON CARTER: Commissioner Davis.

10 COMMISSIONER DAVIS: Question. I know since  
11 I've been on the citizens review to the Complaints  
12 Committee, I see a number of times cases are referred to  
13 the Chiefs for discipline and review. What percentage  
14 are the ones you request discipline or review? Are they  
15 generally -- do they usually follow through with that or  
16 is that delay or sometimes no action?

17 CI McALLISTER: Through the Chair. Since  
18 I've been here, we've only submitted three. One was  
19 Commissioner Brown, and one -- two other's were  
20 Commissioner Bell's request to review several incidents  
21 that had happened. We have not heard back on that, so I  
22 have not seen their names appear on the disciplinary  
23 roster either.

24 COMMISSIONER DAVIS: How long ago was that?

25 CI McALLISTER: About four or five months

1 ago.

2 COMMISSIONER DAVIS: That's extremely long.

3 DC BETTISON: Yeah. I need to see the  
4 report, and I'll make sure that we get you a response.  
5 So I'll check into it.

6 CI McALLISTER: Okay. I'll get it in to  
7 you.

8 DC BETTISON: Is it a full report? I don't  
9 understand what was the request.

10 CI McALLISTER: These were complaints that  
11 were over and above normalness, and two of the officers  
12 were off duty and they got accused of something, and  
13 Commissioner Bell submitted a letter to the Chief for  
14 his review. So he reviewed it and we didn't hear  
15 anything back. And another officer, she got in trouble  
16 numerous times, but then she got in trouble off duty.  
17 So I think they're handling that first, and then I guess  
18 they'll go back to it.

19 DC BETTISON: I'll have a formal response  
20 prepared for the Board for next week letting you know  
21 the status of each one the particulars, so at least  
22 you'll have status update what's going on.

23 CHAIRPERSON CARTER: Thank you.  
24 Commissioner Griffie.

25 COMMISSIONER GRIFFIE: Through the Chair.

1 There are a number of names on this report where I'm not  
2 going to list the actual names, but where it says we  
3 recommended a penalty, and then the penalty was  
4 dismissed. Can you elaborate on what circumstances that  
5 would happen or whose discretion it is or is it the  
6 discretion of the Chief?

7 CI McALLISTER: That, I don't know. That's  
8 strictly with disciplinary.

9 COMMISSIONER GRIFFIE: Okay.

10 CI McALLISTER: I think what we can do is  
11 have them come here and give us an explanation of the  
12 report. We just started getting the reports about three  
13 to four months ago. So I think that's something that  
14 they can come -- I believe that's handled at the command  
15 level, and they can either dismiss it or give them a  
16 written reprimand or give them three days suspension.

17 COMMISSIONER GRIFFIE: So through the Chair.  
18 I mean I would like to have some governance around this,  
19 right. We have a whole staff of employees whose jobs  
20 are to recommend, to review complaints, and do due  
21 diligence. And I'll be honest, from the time I read a  
22 lot of these complaints, if we actually found an officer  
23 to be, to be guilty of the offense, there usually was a  
24 substantial amount of evidence that had to go along with  
25 that accusation or that complaint. And so for us to go

1 through that entire process and then it be dismissed is  
2 a little bit concerning to me, and so I don't know what  
3 our governance process looks like for this, and I'm sure  
4 there's, I'm hoping there's some explanation as to why  
5 there's a lot of names on here where we've requested  
6 reprimand dismissed, three-day suspension dismissed, and  
7 I'd like to understand why that's happening so many  
8 times.

9 DC BETTISON: Through the Chair.

10 CHAIRPERSON CARTER: Bettison.

11 DC BETTISON: I can weigh in. That right  
12 there is the discretion of the Chief of Police or his  
13 designee. And depending on the level of discipline, a  
14 panel is impaneled, and they have union representation  
15 and individuals are able to present the facts. And the  
16 trier of facts will look at it. And based off our  
17 progressive disciplinary skill where mitigating  
18 circumstances can make a determination whether to  
19 dismiss a reprimand, etcetera, taking into account the  
20 totality of the circumstances. So I think that we need  
21 to all sit down and, you know, as far as communication,  
22 be able to relay that information back to you on each  
23 one of those cases and say that this is what happened.  
24 I think it's a feedback move or something is missing.  
25 So for that because you're not getting what you need to

1 understand why.

2 COMMISSIONER GRIFFIE: So through the Chair.  
3 I think our office, I'd like our office to track the  
4 number of times this has happened. So I see an  
5 officer's name on here twice, that was the first thing I  
6 saw, for two different offenses. So I don't know what  
7 kind of tracking mechanism we have in place. I'm sure I  
8 know we have something when we're looking at where  
9 there's multiple offenses. But if there's a case of --  
10 I'd be personally interested to know if there's cases  
11 where there are officers who are receiving multiple  
12 complaints of being found guilty or those complaints are  
13 sustained, and the Department is then dismissing  
14 multiple times or what's happening, because that's to  
15 me, if I have to think about where I'm going to spend my  
16 time, that's where I want to hone in at. And so I don't  
17 know if we have reporting structures that support that,  
18 but I'd like us to consider that.

19 CI McALLISTER: Well, I can also contact  
20 Director Gravelyn to see if there's an extra set of  
21 metrics that they can put in there, so we can kind of  
22 like monitor that. How many instances have the officer  
23 had. They may only do it for like a year, but it's  
24 something that we can talk about. I'll email him today.

25 SECRETARY HICKS: Excuse me, Madam Chair.

1 You have a, you have a letter that was sent to the Chief  
2 and to -- and copied to Director Gravelyn which not only  
3 asks for this information, the piece of the pie that  
4 you're looking at through this report is complaints  
5 related to citizens complaints. In your letter that was  
6 transmitted a couple of weeks ago, it not only asks for  
7 the results of the citizen complaints, but it also asks  
8 for the results relative to other investigations that  
9 has taken place in the Department through Internal  
10 Affairs, Force Investigations, and others. And we've  
11 identified it for a long period of time, about four or  
12 five sections, that does these types of investigations,  
13 because what we've been trying to do is to bring you  
14 back a comprehensive view of what's happening, because  
15 you don't get a full view of officer conduct, just  
16 through the investigations through the citizens  
17 complaints. So that letter is there. We're awaiting  
18 the response, and we would hope that the response to  
19 that letter, and I can for the purposes of the Board, I  
20 can recirculate the letter to the Board just so that  
21 you'll have another record of that. It was in your  
22 packet a few weeks ago.

23                   And then lastly, Senior Investigator Rosie  
24 Madrigal, she does a report that on the citizens  
25 complaints, there's a little more detail that you may



1 want to pay attention to as well. And I know in that  
2 report, she captures under the direction of the Chief,  
3 she captures the repeat offenders, and they track that  
4 for, I think their window was at least a three-month  
5 window where they track it. I suspect if the  
6 information came back that you need to track it on a  
7 larger scale that they could do that. But Rosie's  
8 report that she prepares, and I will pull the last one  
9 that we receive and send that out to the Board just so  
10 you get a sense of the information. Because in this  
11 particular case, especially with that report, they do  
12 track a good amount of that. But again. The focus of  
13 their report is only citizen complaints. And what  
14 you've also asked for is for a broader view what's  
15 happening inside the Department with other investigative  
16 units who are looking at police conduct.

17 CHAIRPERSON CARTER: Can you please  
18 recirculate the letter?

19 SECRETARY HICKS: Yes.

20 CHAIRPERSON CARTER: Make sure Deputy Chief  
21 Bettison gets the letter.

22 SECRETARY HICKS: Sure.

23 CHAIRPERSON CARTER: Thank you.  
24 Commissioner Dewaelsche.

25 COMMISSIONER GARZA DEWAELSCHÉ: Yes. Thank

1 you, Chair. I just, maybe some comment, because I was  
2 trying to follow the flow of this report. I think this  
3 is information that's going to be helpful. But, you  
4 know, in terms of like the time period that this covers,  
5 is this one month? Are these cases that were closed in  
6 September? Is that what this is? I was trying to  
7 figure out what is this chart? It has a lot of  
8 information.

9 CI McALLISTER: Everything is for August.  
10 Do you have September? You were given September too  
11 because we missed a month so.

12 COMMISSIONER GARZA DEWAELSCHE: I'm looking  
13 at the August package. That's why I'm asking that  
14 question because the reception, is that the date that  
15 you referred this case to the Chief's office? It's the  
16 first column. It says reception. I don't know what  
17 that means, but those dates go back to April. And then,  
18 and then you have some cases that went before the Chief  
19 in September, and then many that did not, you know.

20 CI McALLISTER: Are you talking about the  
21 disciplinary report?

22 COMMISSIONER GARZA DEWAELSCHE: I'm talking  
23 about the chart.

24 CI McALLISTER: Yeah. We don't use those.

25 COMMISSIONER GARZA DEWAELSCHE: I know, but

1 we're analyzing it to see whether it's going to be  
2 helpful for us, and I'm just making these comments or  
3 recommendations or whatever just so we can understand  
4 what this information is telling us. And I'm trying to  
5 understand, where should I be honing in, and right away  
6 I saw that several of the cases did not get referred to  
7 the Chief. So, you know, maybe we need to find out what  
8 types of cases get referred. And then those that got  
9 referred, some of them were dismissed, and there's a  
10 date. And all of the dates, the ones that were referred  
11 and that weren't referred, they all were closed in  
12 September. So I'm trying to understand, is this chart  
13 just reflective of cases that were closed in September.  
14 I guess that's what I'm trying --

15 CI McALLISTER: The first page you may have  
16 some from April, but what I would suggest is read and  
17 then make notes to say this is what you would like to  
18 see and how you would like to see it, and we could sit  
19 back down with Director Gravelyn and revise it. We just  
20 got this started. So we're going to have some issues  
21 where I want see this, but I'm not seeing this. So we  
22 can easily kind of like however you want to see it, let  
23 me know. I'll sit down with him and we can revise it.

24 COMMISSIONER GARZA DEWAELSCHÉ: And then  
25 just to understand what the report is telling us,

1 basically. Thank you.

2 CHAIRPERSON CARTER: Commissioner Holley.

3 COMMISSIONER HOLLEY: I'm fine, Madam  
4 Chairperson.

5 CHAIRPERSON CARTER: You're fine?

6 COMMISSIONER HOLLEY: Thank you.

7 CHAIRPERSON CARTER: Any other questions?

8 COMMISSIONER BURCH: Yes, Madam Chair.

9 CHAIRPERSON CARTER: Commissioner Burch.

10 COMMISSIONER BURCH: Dr. McAllister, I just  
11 wanted to ask you regarding the body cam, okay.

12 Remember back a few months ago whenever a report was  
13 made about sometimes they malfunction, and we asked the  
14 question, are they allowed to continue their run or to  
15 go back to the precinct to get a new one. So could you  
16 give us some numbers? Has that happened? Has it  
17 decreased, or increased as far as them coming back in  
18 with that body cam fully working? How do you track  
19 that?

20 CI McALLISTER: We don't necessarily track  
21 that, but if we get a citizens complaints and we pull it  
22 and the officer noted on there did they have issues with  
23 their body worn camera and they went back, they switched  
24 it out, they have a whole new number, we take them at  
25 their word for that because there's other mechanisms in

1 place. They have to notify the supervisor. The  
2 supervisor signs it back out.

3 So that's going to happen, but we haven't  
4 had it to the point where it's like we may have two a  
5 month maybe. But as long as the officers are notating  
6 on their activity log that they had issues with their  
7 body worn camera, as soon as they finish their run, they  
8 go right back to the precinct and they switch them out.  
9 It's all noted on there, so we take them at their word  
10 on that.

11 COMMISSIONER BURCH: So it could be a better  
12 way of making them more accountable that when you bring  
13 in the body cam, just like they have to turn in their  
14 guns or whatever, you know it worked all day, I'm just  
15 saying, could we find a way to know that it was working  
16 all day when they turn it in. I think that would be  
17 good.

18 CI McALLISTER: Well, they do a test before  
19 they leave the precinct.

20 COMMISSIONER BURCH: Right.

21 CI McALLISTER: And I don't know if they  
22 test it out through the day. I don't know if they  
23 really know if it's working or if it's not working if  
24 they're handling a police run until something happens.  
25 But the minute they notice that something is wrong, the

1 majority of them will go back and switch it out. So we  
2 haven't had that as a major issue.

3 COMMISSIONER BURCH: Thank you.

4 COMMISSIONER HOLLEY: Madam Chairperson, I  
5 did think of something. Thank you for the report, as  
6 always, Doctor. AC, and also you can see how important  
7 it is to us if we spend maybe 25, maybe 45 minutes per  
8 case. And if you give us three cases, it's a good three  
9 hours. And we do it, you know, diligently and then we  
10 make the recommendation. And then we don't know the  
11 recommendation we give, then what's the point. If we  
12 oversight and there's no feedback, so you can understand  
13 why we would all be concerned about that.

14 CI McALLISTER: Absolutely.

15 COMMISSIONER HOLLEY: Let me ask you this in  
16 60 seconds or so. How do you feel in 11 months, how do  
17 you feel we're doing in terms of policing community with  
18 complaints and with the Police Department, how do you  
19 feel that we're doing, if you can? Just give us a --  
20 what's your feeling.

21 CI McALLISTER: I think we're okay. I think  
22 more people are more comfortable with calling our office  
23 filing complaints. We even have people that call from  
24 out of state when something happens in Detroit and they  
25 want to file a complaint on the incident. So more

1 people are comfortable. They're learning more. I think  
2 more people are watching the program and they're  
3 learning how to file a complaint, you know, what  
4 constitutes a complaint, and I think that's why the  
5 unknowns are always so high because even if they don't  
6 know who the officer is, they still make an attempt to  
7 file the complaint and it goes into the unknowns. But I  
8 think we're doing pretty good.

9 COMMISSIONER HOLLEY: I'm very impressed  
10 with all that. Thank you.

11 CI McALLISTER: You're welcome.

12 CHAIRPERSON CARTER: Thank you. Any other  
13 questions, comments, Commissioners? Thank you, ma'am.

14 Standing Committee or Ad Hoc Committee  
15 reports at this time. At this time, we'll have the  
16 reports from Board Secretary.

17 SECRETARY HICKS: Thank you, Madam Chair. I  
18 simply want to call your attention to the three items  
19 that are listed on the agenda. And again, a number of  
20 the items that are listed on the agenda in this spot are  
21 oftentimes things in which by the time you get to me on  
22 the agenda that you've already reviewed. So this is  
23 really a record of incoming items into the office.

24 And, of course, the first one had to do with  
25 the facial recognition report. And the notice,

1 notification for the Elected Officer's Compensation  
2 Commissioner and, of course, the notification from DPD  
3 HR on the new class of the Police Academy. So those are  
4 really items that you've already gone over. And what I  
5 try and do is to, aside from just giving you the list in  
6 the Chair's report, is to put a little more context to  
7 those things because oftentimes the Chair kind of puts  
8 those in perspective in the Chair's remarks. So with  
9 that, I don't have any other items which I'd like to  
10 bring to the attention of the Board, and I'm open for  
11 questions.

12 CHAIRPERSON CARTER: Thank you. Any  
13 questions? If not, we'll move on to new business  
14 regarding the legal representation for Investigator  
15 Delvata Moses.

16 COMMISSIONER BELL: Madam Chair, I so move  
17 that we support legal representation for Investigator  
18 Moses.

19 COMMISSIONER GARZA DEWAELESCHE: Support.

20 CHAIRPERSON CARTER: It's been moved and  
21 supported that we approve the request for legal  
22 representation for Investigator Delvata Moses. Is there  
23 any discussion?

24 COMMISSIONER BROWN: Yeah, Madam Chair, just  
25 one question. When we talk about the legal



1 representation, is that going to be through City Law  
2 Department and Corporate Counsel.

3 CHAIRPERSON CARTER: Yes, it is.

4 COMMISSIONER BROWN: Okay.

5 CHAIRPERSON CARTER: Those in favor?

6 COMMISSIONERS: Aye.

7 CHAIRPERSON CARTER: Those opposed?

8 Discussion? Motion carries. Thank you.

9 At this time announcements. Our next  
10 meeting will be Thursday, November 7th at 3 p.m. here at  
11 Detroit Public Safety Headquarters located at 1301 Third  
12 Street. Or next community meeting will be Thursday,  
13 November 14th at 6:30 p.m. in 6th Precinct and Second  
14 Grace United Methodist Church located at 18700 Joy Road.

15 At this time, we'll have oral communication  
16 from the audience. Please give your name and limit your  
17 comments to two minutes please.

18 MR. BROWN: Madam Chair, I currently have  
19 three cards. The first speaker will be Miss Tenay  
20 Hankins, followed by Ms. Faith, followed by Ms. Valerie  
21 Green.

22 MS. TENAY: Good afternoon. Thank you for  
23 this opportunity. Thank you for this opportunity.  
24 Request your assistance with my formal complaint against  
25 the 10th precinct in this culture of ambivalence. They

1 appear to not take seriously my fear for my safety. I'm  
2 not respected and seen as a victim of calculated danger  
3 from my next door neighbor who threatened to shoot me.  
4 They are aware of the harassment, and stalking is  
5 getting worse. This is not a neighborly feud. I want  
6 the police to consider advanced action such as holding  
7 her accountable under the law up to, and including,  
8 prosecution. Like most abusers, my neighbor lashes out  
9 at me every time I push back. Talking to her is  
10 obviously not enough or I would not have to go to the  
11 police in the first place.

12           The police are aware my neighbor pops up out  
13 of nowhere on my property and hers, taking pictures of  
14 me, my family, my visitors, my minor grandchildren and  
15 violates my right to privacy. Daily I have to contend  
16 with her literal garbage, environmental hazards and  
17 waste. An officer will not allow me to file a police  
18 report that included my ten-year-old grandson's  
19 statements that he didn't want to come over my house  
20 because of the crazy lady next door.

21           When I asked police for assistance, officers  
22 have made condescending statements such as if you don't  
23 like it, and you can't take it, you should move. He's  
24 too busy and it will be months denying me a meeting with  
25 the commander. He or she the officer would not tolerate

1 the abuse or stop it. It is stalking if it was them.

2 Police are not in the business of prevention.

3 The same pathology will be treated  
4 differently, taken more serious, handled if my neighbor  
5 was my boyfriend, family member, nursing home abuser, if  
6 I was a neighbor or any other scenario that's not mine.  
7 All I ask of the Police Department is why not treat me  
8 like their own family and do what they would do to stop  
9 the abuses if it was them.

10 I mailed you all a copy of the formal  
11 complaint. Your consideration is appreciated. And  
12 Madam Chair, if I can give an update, I know I'm out of  
13 time. I did talk to Commander Kyriacou on Monday. Is  
14 that okay?

15 CHAIRPERSON CARTER: That's fine.

16 MS. TENAY: He hadn't heard me. He had  
17 never gotten the request for me to meet with him. He  
18 didn't know of my circumstances, and the only thing that  
19 he suggested is I go back to the proceedings that I have  
20 been going through for the last few months. And from  
21 that I have not heard any -- I take that back. I  
22 apologize. I talked to Officer Parker. We work  
23 together a lot in the community. He called to ask if I  
24 was okay, but nothing as regards to my complaint that  
25 you all have in email. Okay. Thank you.

1 DC BETTISON: I'd like to respond to her as  
2 well. Definitely so sorry for that. You are important.  
3 So we have Deputy Chief Fitzgerald here. He's over all  
4 west side precincts. Fitzgerald, he's right there. So  
5 he's a Deputy Chief that runs the west side. I'd like  
6 for you to talk to him and we're going to do our best  
7 for you. Okay. Yes, ma'am.

8 MS. TENAY: I have faith.

9 CHAIRPERSON CARTER: You know how to get in  
10 contact with us if nothing happens.

11 MS. TENAY: I would like for you to all  
12 proceed forward because of my past experiences, and it's  
13 getting worse, as I said. So by the time I work with  
14 the officer, what have you, I appreciate if it could be  
15 concurrent, if that's okay with you.

16 DC BETTISON: Yes, ma'am.

17 MS. TENAY: Okay. Thank you.

18 CHAIRPERSON CARTER: Thank you, ma'am.  
19 Thank you for coming down.

20 MR. BROWN: Miss Faith.

21 MS. FAITH: Well, for the record my name is  
22 Miss Faith. Can't hardly hear me? Can you hear me  
23 better now? All right. I'm just amazed by you all all  
24 the time, every time I hear you all and see you all and  
25 how you conduct yourselves. The speaker before myself,

1 Chief Bettison deserves, as you call it, kudos, rising  
2 to the occasion and given her direction immediately to  
3 her request. And that you all do all of the time  
4 helping me or anybody else, it doesn't matter. And as I  
5 say openly, you all don't look at me like well, we're  
6 going to take her under our wing and do everything for  
7 Miss Faith. Uh-uh. It's not that way. All five years  
8 I've seen you help everyone that come up and ask any  
9 question, have a grievance, whatever, complaint, it  
10 didn't matter.

11 Chief Bettison, he's working, and our Common  
12 Core Commissioner over here, all the time you're always  
13 doing what you're supposed to do that you're hired to  
14 do. The rest of you all doing the same thing. There's  
15 always balanced, it's always professional, there's  
16 always good straight off the cuff. And you are very,  
17 very much appreciated for everything that you've done  
18 standing up in your purview. And Commissioner Brooks  
19 have been always standing to help anything she can do.

20 And commissioner Dewaelsche, and  
21 Commissioner Carter. One thing I want to say about  
22 Commissioner Carter, I never said this openly, but she  
23 reminds of a person that's a fan that's been left on her  
24 window open. Each time any kind of a circumstance would  
25 arise, so something, a sensitive matter, she's always

1 like someone lift the window open, the expression on her  
2 face. She's so professional and she's a very powerful  
3 woman, I would say, to be able to conduct herself that  
4 way.

5 I would reflect back on the rest of you and  
6 your training that you got from the Chief and your other  
7 superiors. Very commendable. I appreciate you all very  
8 much. My time is just about up and thank you all for  
9 letting me speak.

10 MR. BROWN: Ms. Glenn.

11 MS. GLENN: Good afternoon, Commissioners.  
12 My name is Valerie Glenn. I just want to remind you on  
13 this time I brought the section in the Open Meetings Act  
14 that spells out our concern about having to show state  
15 issued ID to come in here.

16 On page 13, establishing individuals. No  
17 one may be excluded from a meeting otherwise open to the  
18 public except for a breach of the peace actually  
19 committed at the meeting. Two. Identifying public  
20 attendees. No one may be required to register or  
21 otherwise provide his or her name or other information  
22 or otherwise to fulfill a condition precedent to attend  
23 a public meeting. Three. Building security at the  
24 meeting site may cause issues. Members of the public  
25 might object, which we do, based on the Open Meetings

1 Act, to register and to gain access to the building  
2 where a public meeting is being held. We, therefore,  
3 recommend that the public bodies meet in facilities or  
4 areas not subject to public access restrictions. Thank  
5 you.

6 CHAIRPERSON CARTER: Thank you, Miss Glenn.  
7 And like I mentioned earlier, we are in the process of  
8 making that happen.

9 COMMISSIONER HOLLEY: Make what happen,  
10 Madam Chairperson?

11 CHAIRPERSON CARTER: Complying with the Open  
12 Meetings Act.

13 COMMISSIONER HOLLEY: Oh, okay.

14 MR. BROWN: Madam Chair, that was your last  
15 speaker.

16 DC BETTISON: Madam Chair, if I may?

17 CHAIRPERSON CARTER: Yes.

18 DC BETTISON: I just wanted to in going back  
19 to the report when I talked about with the communication  
20 feedback as well, I got a text, and I just wanted to let  
21 you all know that one of the things we -- we have been  
22 taking notes when it comes to the top offenders, when it  
23 comes to disciplinary, and I got the note that one of  
24 the individuals, and I won't name a name that we talk  
25 about it, Commissioner Griffie didn't name a name as

1 well. However, going through a risk assessment and we  
2 actually removed the individual from a specialized  
3 command so that they could be more closely monitored.  
4 So as a result of numerous continuous complaints, we did  
5 take action. So on that on all of type of cases I want  
6 to work more closely with your staff to make sure that  
7 you get the information you need so that you know that  
8 are responsive to your time and the reports.

9 CHAIRPERSON CARTER: Thank you.

10 COMMISSIONER GRIFFIE: Through the Chair.

11 CHAIRPERSON CARTER: Commissioner Griffie.

12 COMMISSIONER GRIFFIE: I'd like to move that  
13 we go into a closed session. My apologies.

14 CHAIRPERSON CARTER: We've done all that.  
15 Unfinished business.

16 COMMISSIONER GARZA DEWAELSCHÉ: Support.

17 CHAIRPERSON CARTER: It's been moved and  
18 supported that we go into closed session.

19 COMMISSIONER DAVIS: Point of information.

20 CHAIRPERSON CARTER: Yes, sir.

21 COMMISSIONER DAVIS: Will corporate counsel  
22 and representatives from the Inspector General Office  
23 also be in there so we can ask them questions?

24 CHAIRPERSON CARTER: I don't know, but  
25 they're more than welcome to come. They're local



1 counsel.

2 COMMISSIONER DAVIS: If I may, Chair.  
3 Through the Chair, the law department is here and will  
4 be happy to participate. I don't know if anyone from  
5 the OIG is here.

6 CHAIRPERSON CARTER: Thank you. Discussion?  
7 Those in favor?

8 COMMISSIONERS: Aye.

9 CHAIRPERSON CARTER: Those opposed?

10 COMMISSIONER BROWN: Nay.

11 CHAIRPERSON CARTER: Nay? Motions carries.  
12 We will -- we are going into closed session. We will  
13 reconvene after our discussion with legal counsel.  
14 Thank you.

15 (Recess).
