# Domestic Violence Mission Statement and Purpose

The goal of the Detroit Police Department Domestic Violence Unit is to stop intimate partner violence in our community by serving as the epi-center of a multidisciplinary criminal justice effort.

These efforts will be used to prevent what has been identified as the most frequent and least reported crime across the nation.

Specially trained detectives conduct detailed investigations as well as referrals to our resource network.

- Provide equal protection under the law
- Provide resource and referral information to victims
- Maintain and improve partnerships with other agencies (prosecutors, social workers, etc.)
- Educate public and police on laws, procedures and policies for processing domestic violence cases
