**Postponed from May 26, 2020; Line Item 26 on June 9, 2020 Revised Agenda**

The Supply Schedule No. 3 for Security Guards and Vehicles, Security Services, including Traffic Control was reported to the City Council by Budget, Finance and Audit Committee on May 26, 2020. The Supply Schedule was reported pending the receipt of affidavits and clearances for each vendor on the schedule. The vote on May 26 has been postponed twice, while affidavits and clearances continued to be obtained.

The Legislative Policy Division has been informed that the joint venture of Inter City Protective Services and Pyratech Security Services will be cancelled. The proposed Supply Schedule No. 3 for Security Services will now include: H & P Protective Services, Jhohman, dba Lagarda Security, and Inter City Protective Services.
