PRECINCT BOUNDARIES

101.8 - 1 **PURPOSE**

The purpose of this directive is to clearly outline precinct boundaries within the corporate limits of the city of Detroit, which consists of 139.4 square miles and *eleven* police precincts.

101.8 - 2 Boundaries





- 1. Located at 20 Atwater, Detroit, Michigan 48226, Downtown Services encompasses an area of 2.2 square miles and consists of Central Events and Gaming.
- 2. It is bounded on the west by the centerline of Cabacier from the Detroit River to the centerline of West Fort Street (including the imaginary line of Cabacier from the river to the roadway); by the centerline of West Fort Street from the centerline of Cabacier to the center median of the Lodge Freeway; and by the center median of the Lodge Freeway from the centerline of West Fort Street to the center median of Myrtle Street (Martin Luther King, Jr. Boulevard).
- 3. It is bounded on the north by the center median of *Myrtle Street (Martin Luther King, Jr. Boulevard)* from the center median of the Lodge Freeway to the centerline of Woodward, where Myrtle Street (Martin Luther King, Jr. Boulevard) becomes

Mack Avenue. This north boundary continues eastward on Mack Avenue from Woodward to the center median of the Chrysler Freeway.

- 4. It is bounded on the east by the center median of the Chrysler Freeway from the center median of Mack Avenue to the centerline of Schweizer Place; and by the centerline of Schweizer Place from the center median of the Chrysler Freeway to the Detroit River (including the imaginary line of Schweizer Place from the roadway to the river).
- 5. It is bounded on the south by the Detroit River from the centerline of Schweizer Place to the centerline of Cabacier.





- 1. Located at 13530 Lesure, Detroit, Michigan 48227, the Second Precinct encompasses an area of 10.3 square miles.
- 2. It is bounded on the west by the centerline of Greenfield from the city limits of Dearborn (at Tireman) to the centerline of West McNichols.
- 3. It is bounded on the north by the centerline of West McNichols from the centerline of Greenfield to the centerline of Schaefer, by the centerline of Schaefer from the centerline of West McNichols to the centerline of Fenkell; and by the centerline of Fenkell from the centerline of Schaefer to the centerline of Wyoming.
- 4. It is bounded on the east by the *centerline of Wyoming* from the *centerline of Fenkell* to the *center median of the* Jeffries Freeway, including all Detroit Terminal Railroad property; by the center median of the Jeffries Freeway from the *centerline of Wyoming* to the centerline of Grand River, by the centerline of Grand River from the center median of the Jeffries Freeway to the centerline of Livernois; and by the centerline of West Warren Avenue.
- 5. It is bounded on the south by the centerline of West Warren Avenue from the centerline of Livernois to the Dearborn city limits; by the Dearborn city limits from the centerline of West Warren Avenue to the centerline of Tireman; and by the centerline of Tireman from the Dearborn city limits to the centerline of Greenfield.

101.8 - 2.3 Third Precinct



- 1. Located at 2875 West Grand Boulevard, Detroit, Michigan 48202, the Third Precinct encompasses an area of 8.8 square miles.
- 2. It is bounded on the west by the *Grand Trunk Western Railroad from the center median of Michigan Avenue to the centerline of West Grand Boulevard; by the centerline of West Grand Boulevard from the Grand Trunk Western Railroad to the Lodge Freeway; by the <i>Lodge Freeway from the* centerline of West Grand Boulevard to the centerline of Clairmount; by the centerline of Clairmount from the Lodge Freeway to the centerline of Woodward; and by the centerline of Woodward from the centerline of Clairmount to the Highland Park city limits (near Tennyson Street).
- 3. It is bounded on the north by the Highland Park city limits (near Tennyson Street) from the centerline of Woodward to the city limits of Hamtramck (near the Grand Trunk Western Railroad).
- 4. It is bounded on the east by the Hamtramck city limits (near the Grand Trunk Western Railroad) from the city limits of Highland Park (near Tennyson Street), following the Hamtramck city limits southward and running along the centerline of St. Aubin Street; from the centerline of St. Aubin Street (at the Hamtramck city limits) and following the Hamtramck city limits (the centerline of Hamtramck Drive) to the centerline of East Grand Boulevard; by the centerline of East Grand Boulevard from the centerline of Hamtramck Drive to the center median of the Chrysler Freeway, including all railroad property; by the center median of the Chrysler Freeway from the centerline of East Grand Boulevard to the centerline of Mack Avenue, following Mack Avenue westward past Woodward where Mack Avenue becomes Martin Luther King, Jr. Boulevard to the center line of Martin Luther King, Jr. Boulevard to the centerline of West Fort Street.
- 5. It is bounded on the south by the centerline of West Fort Street from the center median of the Lodge Freeway to the centerline of Cabacier Street; by the centerline of Cabacier Street from the centerline of West Fort Street to the Detroit River (including the imaginary line of Cabacier Street from the roadway to the river); by the Detroit River from the centerline of Cabacier Street (including the imaginary line of 14th Street from the roadway to the Detroit River); by the centerline of

14th Street (including the imaginary line of 14th Street from the roadway to the Detroit River) from the Detroit River to the centerline of Michigan Avenue; and by the centerline of Michigan Avenue from the centerline of 14th Street to the Grand Trunk Western Railroad.

6. Cultural Center

- a. On the west it is bounded by Cass Avenue north from Warren Avenue to the Edsel Ford Freeway;
- On the north it is bounded by the Edsel Ford Freeway eastward from Cass Avenue to the Chrysler;
- c. On the east it is bounded by the Chrysler Freeway south from the Edsel Ford Freeway to Warren Avenue; and
- d. On the south it is bounded by Warren Avenue from the Chrysler Freeway to Cass Avenue.
- 7. <u>Central Events</u> Locations are specific to major events *with*in the *Downtown Services area*.
- 8. <u>Gaming</u> Locations are specific to the Greektown, MGM Grand, and Motor City Casinos.

101.8 - 2.4 Fourth Precinct



- 1. Located at 4700 West Fort Street, Detroit, Michigan 48209, the Fourth Precinct encompasses an area of 14.3 square miles.
- 2. It is bounded on the west by the Melvindale city limits (near the northbound Fisher Freeway Service Drive) from the center median of West Outer Drive to the centerline of Schaefer, by the center median of West Outer Drive from the Melvindale city limits (near the southbound Fisher Service Drive) to the Dearborn city limits (near Mellon Street); and by the Dearborn city limits (near Mellon Street) from the centerline of Schaefer, following the Dearborn city limits to the centerline of West Warren.
- 3. It is bounded on the north by the centerline of West Warren from the Dearborn city limits to the center median of West Grand Boulevard; by the center median of West Grand Boulevard from the centerline of West Warren to the Grand Trunk Western Railroad; by the Grand Trunk Western Railroad from the centerline of West Warren to the center median of Michigan Avenue; and by the center median of Michigan Avenue from the Grand Trunk Western Railroad to the centerline of 14th Street.
- 4. It is bounded on the south by the Detroit River from the centerline of 14th Street (including the imaginary line from the roadway to the river) to the Zug Island Canal

(River Rouge city limits); by the Zug Island Canal/River Rouge (River Rouge city limits) from the Detroit River to the Detroit city limits (near Bassett Street); and by the centerline of Bassett Street from the River Rouge city limits to the centerline of West Outer Drive.

101.8 - 2.5 Fifth Precinct



- 1. Located at 3500 Conner, Detroit, Michigan 48215, it encompasses an area of 12.0 square miles.
- 2. It is bounded on the west by the centerline of Marquette from the Detroit River (including the imaginary line from the roadway to the river) to the centerline of East Jefferson; by the centerline of East Jefferson from the centerline of Marquette to the centerline of Cadillac; by the centerline of Cadillac from the centerline of East Jefferson to the center median of the Ford Freeway; by the center median of the Ford Freeway from the centerline of Cadillac to the centerline of Gratiot; and by the centerline of Gratiot from the center median of the Ford Freeway to the centerline of Conner.
- 3. It is bounded on the north by the centerline of Conner from the centerline of Gratiot to the center median of the Ford Freeway; by the center median of the Ford Freeway from the centerline of Conner to the Harper Woods city limits (at Kingsville Street); and by the Harper Woods city limits (at Kingsville Street) from the center median of the Ford Freeway to the center median of Mack Avenue.
- 4. It is bounded on the east by the *center median of Mack Avenue from the centerline of Kingsville Street* to the *centerline of Alter; and by the centerline of Alter from the center median of Mack Avenue to the* Detroit River.
- 5. It is bounded on the south by the Detroit River from the centerline of Alter to the centerline of Marquette Drive (including the imaginary line from the roadway to the river).

101.8 - 2.6 Sixth Precinct



- 1. Located at 11450 Warwick St., Detroit, Michigan 48228, *the Sixth Precinct* encompasses an area of *14.2* square miles.
- 2. It is bounded on the west by the *Dearborn Heights* city limits (near Ann Arbor Trail) from the centerline of West Warren Avenue to the Redford Charter Township limits (near Joy Road); and by the Redford Charter Township limits (near Joy Road) to the Dearborn Heights city limits to the centerline of Fenkell.
- 3. It is bounded on the north by the centerline of Fenkell from the Redford Charter Township limits (near Telegraph Road) to the centerline of Evergreen; by the centerline of Evergreen from the centerline of Fenkell to the centerline of Schoolcraft; and by the centerline of Schoolcraft from the centerline of Evergreen to the centerline of Greenfield.
- 4. It is bounded on the east by the centerline of Greenfield from the centerline of Schoolcraft to the Dearborn city limits (at Paul Avenue).
- 5. It is bounded on the south by the *Dearborn* city limits (at *Paul Avenue*) from the centerline of Greenfield to the Southfield Freeway; by the Southfield Freeway from the centerline of Paul Avenue (Dearborn city limits) and following the Dearborn city limits (near Ford Road) to the Dearborn Heights city (near Evergreen); from the Dearborn Heights city limits (near Evergreen) to the centerline of West Warren near Heyden Street; and by the centerline of West Warren from the Dearborn Heights city limits (near Heyden Street), following the Dearborn Heights city limits to Ann Arbor Trail.

101.8 - 2.7 Seventh Precinct



- 1. Located at 5100 East Nevada Rd., Detroit, Michigan 48234, the Seventh Precinct encompasses an area of 13.5 square miles.
- 2. It is bounded on the west by the centerline of Schweizer Place (including the imaginary line of Schweizer Place from the roadway to the river) from the Detroit River to the center median of the Chrysler Freeway (including the imaginary line from Schweizer Place to the Chrysler Freeway); by the center median of the Chrysler Freeway from the

centerline of Schweizer Place to the Grand Trunk Western Railroad; and by the Grand Trunk Western Railroad from the Chrysler Freeway to the city limits of Hamtramck, but not including any railroad property.

- 3. It is bounded on the north by the Hamtramck city limits from the Grand Trunk Western Railroad to *the center line of* Miller Road; by the centerline of Miller Road from the Hamtramck city limits to *the centerline of* Van Dyke; by the centerline of Van Dyke from *the centerline of* Miller Road to *the centerline of* Grinnell; *and* by the centerline of Grinnell from *the centerline of* Van Dyke to the centerline of French Road.
- 4. It is bounded on the east by the centerline of French Road from the centerline of Grinnell to the centerline of Gratiot; by the centerline of Gratiot from the center median of the Ford Freeway to the centerline of Cadillac Boulevard; by the centerline of Cadillac Boulevard from the center median of the Ford Freeway to the centerline of East Jefferson; by the centerline of East Jefferson from the centerline of Cadillac Boulevard to the centerline of Marquette; and by the centerline of Marquette from the centerline of East Jefferson to the Detroit River.
- 5. It is bounded on the south by the Detroit River (to include Belle Isle) from the centerline of Marquette Drive (also to include Belle Isle) to the centerline of Schweizer Place (including the imaginary line from the roadway to the river).





- 1. Located at 11450 Warwick, Detroit, Michigan 48228, the Eighth Precinct encompasses an area of 15.0 square miles.
- 2. It is bounded on the west by the *centerline of Five Points* (Redford *Charter Township* limits) from *the centerline of Puritan* to *the center median of* West Eight Mile Road.
- 3. It is bounded on the north by the *centerline of* West Eight Mile Road from Five Points (Redford Charter Township limits) to the *center median of the* Lodge Freeway.
- 4. It is bounded on the east by the center median of the Lodge Freeway from the center median of West Eight Mile Road to the centerline of Greenfield; and by the centerline of Greenfield from the center median of the Lodge Freeway to the centerline of Schoolcraft.
- 5. It is bounded on the south by the centerline of Schoolcraft from the centerline of Greenfield to the centerline of Evergreen; by the centerline of Evergreen from the centerline of Schoolcraft to the centerline of Fenkell; by the centerline of Fenkell from the centerline of Evergreen to the Redford Charter Township limits (near Dale Street); by the Redford Charter Township limits (near Dale Street) from the centerline of

Fenkell to the centerline of Puritan; and by the centerline of Puritan to the centerline of Five Points (Redford Charter Township limits).

101.8 - 2.9 Ninth Precinct



- 1. Located at 11187 Gratiot Avenue, Detroit, Michigan 48215, the Ninth Precinct encompasses and area of 12.1 square miles.
- 2. It is bounded on the west by the *Detroit City* airport property line at Erwin from the centerline of Grinnell to the centerline of Lynch Road; by the airport property line at Lynch Road from the centerline of Erwin to the centerline of French Road; by the airport property line at French Road from the centerline of Lynch Road to East McNichols; by the airport property line at East McNichols from French Road to East Outer Drive; by the centerline of East Outer Drive from East McNichols to the Grand Trunk Western Railroad (at East Outer Drive); and by the Grand Trunk Western Railroad (at East Outer Drive) to the center median of East Eight Mile Road.
- 3. It is bounded on the north by the *center median of* East Eight Mile Road from the Grand Trunk Western Railroad to *the center median of* Kelly Road.
- 4. It is bounded on the east by the center *median* of Kelly Road from the center median of East Eight Mile Road to the end of the Harper Woods city limits (at Kingsville Street); by the Harper Woods city limits (at Kingsville Street) from the center median of Kelly Road to the center median of the Ford Freeway.
- 5. It is bounded on the south by the center median of the Ford Freeway from the Harper Woods city limits (at Kingsville Street) to the centerline of Conner; by the centerline of Conner from the center median of the Ford Freeway to the centerline of Gratiot; by the centerline of Gratiot from the centerline of Conner to the centerline of French Road; by the centerline of French Road from the centerline of Gratiot to the centerline of Grinnell; and by the airport property line at Grinnell from the centerline of French Road to the centerline of Erwin.

101.8 - 2.10 Tenth Precinct

101.8 Precinct Boundaries

- 1. Located at 12000 Livernois, Detroit, Michigan 48206, the Tenth Precinct encompasses an area of 10.4 square miles.
- 2. It is bounded on the west by the centerline of Livernois from the centerline of West Warren Avenue to the centerline of Grand River; by the centerline of Grand River from the centerline of Livernois to the center median of the Jeffries Freeway; by the center median of the Jeffries Freeway from the centerline of Livernois to the centerline of Wyoming; and by the centerline of Wyoming from the centerline of Livernois to the center median of the Lodge Freeway.
- 3. It is bounded on the north by the center median of the Lodge Freeway from the centerline of Wyoming to the Penn Central Railroad; and by the Penn Central Railroad from the center median of the Lodge Freeway to the Highland Park city limits (at Thompson Street).
- 4. It is bounded on the east by the Highland Park city limits (at Thompson Street) from the Penn Central Railroad to the Highland Park city limits near Webb; by the Highland Park city limits near Webb from the Highland Park city limits at the center median of the Lodge Freeway to the centerline of Woodward; by the centerline of Woodward from the Highland Park city limits near Webb to the centerline of Clairmount; by the centerline of Clairmount from the centerline of Woodward to the center median of the Lodge Freeway; and by the center median of the Lodge Freeway to the center median of West Grand Boulevard.
- 5. It is bounded on the south by the center *median* of West Grand Boulevard from the center median of the Lodge Freeway to the centerline of West Warren Avenue; and by the centerline of West Warren from the center median of West Grand Boulevard to the centerline of Livernois.

101.8 - 2.11 Eleventh Precinct



- 1. Located at 5100 Nevada, Detroit, Michigan 48234, the Eleventh Precinct encompasses 14.0 square miles.
- 2. It is bounded on the west by the *Grand Trunk Western Railroad* from the *centerline* of Carpenter (including the imaginary line from the roadway to the railroad) to the center median of East McNichols; by the center median of East McNichols from the Grand Trunk Western Railroad to the centerline of John R; and by the centerline of John R from the centerline of East McNichols to the center median of East Eight Mile Road.
- 3. It is bounded on the north by the *center median of* East Eight Mile Road from the *centerline of John R to the* Grand Trunk Western Railroad *(near Hoover).*

- 4. It is bounded on the east by the Grand Trunk Western Railroad (but not including any railroad property) from the center median of East Eight Mile Road to the centerline of East Outer Drive; by the centerline of East Outer Drive from the Grand Trunk Western Railroad to the centerline of East McNichols (at the airport property line); by the airport property line at East McNichols from East Outer Drive to French Road; by French Road from East McNichols to Lynch Road; by the airport property line at Lynch Road from French Road to Erwin; by the airport property line at Erwin from Lynch to the centerline of Grinnell; by the centerline of Grinnell from Erwin to the centerline of Van Dyke; and by the centerline of Van Dyke from the centerline of Grinnell to the centerline of Miller Road.
- 5. It is bounded on the south by the centerline of Miller Road from the centerline of Van Dyke to the city limits of Hamtramck (near Vincent Street); by the city limits of Hamtramck (near Vincent Street) from the centerline of Miller Road following the Hamtramck city limits to the centerline of Conant; by the Hamtramck city limits from the centerline of Conant to the centerline of Carpenter; and by the centerline of Carpenter from the centerline of Conant to the Grand Trunk Western Railroad.

101.8 - 2.12 Twelfth Precinct



- 1. Located at 1441 West Seven Mile, Detroit, Michigan 48201, the Twelfth Precinct encompasses an area of 13.0 square miles.
- 2. It is bounded on the west by the centerline of Schaefer from the centerline of Fenkell to the centerline of West McNichols; by the centerline of West McNichols from the centerline of Schaefer to the centerline of Greenfield; by the centerline of Greenfield from the centerline of West McNichols to the center median of the Lodge Freeway; and by the center median of the Lodge Freeway from the centerline of Greenfield to the center median of West Eight Mile Road.
- 3. It is bounded on the north by the *center median of* West Eight Mile from the *center median of the* Lodge Freeway to *the centerline of John R*.
- 4. It is bounded on the east by the centerline of John R from the center median of West Eight Mile Road to the centerline of West McNichols; by the centerline of West McNichols from the centerline of John R to the Highland Park city limits (near Log Cabin); and by the Highland Park city limits (near Log Cabin) from the centerline of West McNichols to the Detroit Terminal Railroad.
- 5. It is bounded on the south by the Detroit Terminal Railroad from the Highland Park city limits to the *center median of the Lodge Freeway*; by the *center median of the Lodge*

Freeway from the Detroit Terminal Railroad to the centerline of Wyoming, including all railroad property; by the centerline of Wyoming from the center median of the Lodge Freeway to the centerline of Fenkell; and by the centerline of Fenkell from the centerline of Wyoming to the centerline of Schaefer.
