MISSION:

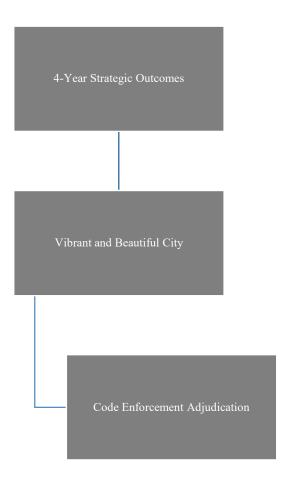

The DAH is an independent administrative hearings bureau that adjudicates blight violations and assesses civil fines and costs pursuant to the schedule in the anti-blight ordinances and reviews administrative decisions of City departments and agencies and makes the final agency decisions. Since its opening in 2005, the DAH has conducted over 450,000 hearings. The tribunal is run by a director, manager, support staff, informational technology staff, and the hearings officers.

STRATEGIC PRIORITIES:

- Adjudicate blight code violations issued by authorized City agents with sensitivity to the violations' impact on the escalating problem of blight in Detroit.
- Enhance collectability of fines and fees through garnishments and liens utilizing the Department's decisions and orders.
- Review and make final decisions on administrative decisions of City departments and agencies.
