The City of Detroit Office of Contracting and Procurement (OCP) requests a statement of qualifications from nonprofit organizations to provide a range of services to increase the accessibility, efficiency, and efficacy of housing counseling activities for person who are residents of the City of Detroit, as part of the City of Detroit's COVID-19 community stabilization response.

Services will include the development and maintenance of a single point of entry for housing counseling services; the development and maintenance of a central Client Management System that integrates with housing counseling agencies' existing data management systems; and ongoing technical assistance and support to a network of housing counseling agencies.

All proposals must be prepared and submitted online using the City's "Oracle" system. Proposal applicants must register on Oracle before a proposal can be submitted. Proposals must be submitted via Oracle by 4:00 p.m. (Eastern Daylight Time) on Wednesday, July 7, 2021. Paper copies of Proposals will not be accepted. PROPOSAL SELECTION & EVALUATION CRITERIA

Proposals submitted by the deadline, **Wednesday**, **July 7**, **2021**, **by 4:00 p.m.**, and meeting the minimum threshold requirements will be reviewed and ranked by a proposal review panel. All applications will go through a selection and ranking process. **Proposals that do not meet the eligibility requirement will be eliminated from consideration.** Your proposal will only be considered for funding if you meet the Threshold Requirements.

The Assessment Criteria is as follows:

- Experience/expertise in managing a resident portal/application for public services: 15 Points
 - Experience/expertise in implementing and managing a multi-organization Client Relationship Management system: 15 Points
- Experience/expertise in delivering training/technical support to community-based nonprofit organizations to improve service delivery: 12 Points
- Experience/expertise in administering Community Development Block Grant funds (or other Federal funds): 9 Points
- Experience/expertise in delivering housing counseling and other housing stability services to low income populations: 12 Points
- Physical presence and history of providing services in Detroit: 9 Points
