## Sec. 3.5.2. Joint Committees.

Joint committees are created by City Council from two or more standing committees to perform a specific task for a limited duration. In the case of a joint committee, the Chair of the committee designated first by the President in order of referral shall serve as Chair of the joint committee and the Chair of the committee designated second shall serve as the vice Chair of the joint committee subject to the approval of the City Council.

- Section 4.2 Board of Review and 4.2.1 Members
  - o Delete "Property Assessment" it is not referenced in the Charter
- Sec. 4.2. Board of Review.

Pursuant to Section 9-401 of the 2012 Detroit City Charter, there shall be a Board known as the Property Assessment Board of Review to hear and determine appeals from property tax assessments.

Sec. 4.2.1. Members.

The Assessment Board of Review consists of nine members with at least seven (7) members appointed from each of the non-at-large districts.

• Section 4.4.1 - City Planning Commission

Sec. 4.4.1. Appointment.

The nine-member City Planning Commission shall be appointed by and serve at the pleasure of the City Council. Seven of the members shall be appointed, one each, from the two (2) non-at-large districts. No more than two members shall be appointed from any one district. As far as possible, different professions and occupations shall be represented on the Commission.

• Section 9.12 – Agenda

The 2021 Rules Committee approved amendment for Section 9.12 was inadvertently omitted from the resolution setting the Public Hearing to amend the Council Rules.

The amendment approved by the Rules Committee (underlined) changes the section to read as follows:

The agenda for each Standing Committee shall be composed of items referred by the President and items added at the discretion of the Chair of that committee. The Chair shall determine the order of the items on the agenda. All items referred to a standing committee shall appear on the agenda within 30 days of being referred. The Committee will review and discuss the items and then send them to Formal Session for consideration. Items shall be referred to Formal Session within sixty (60) days after appearing on the Committee agenda. Walk-ons shall be permitted at the discretion of the chair.

#### **OTHER ITEMS**

- It is unclear when the MOTION should be made to assign reports to LPD and who keeps a record. The current language reads:
  - Sec. 18.1 Assignment Procedure. All assignments to the Legislative Policy Division shall be made in the form of a motion and given in typewritten form, through the Committee of the Whole, Formal Session, Adjourned Session, Special Session, Special Committees, or Standing Committees.
- 13.5 VERBAL REQUESTS the responses should be in writing AND forwarded to the Clerk for inclusion on the agenda and shared with all council members and LPD.
  - o Sec. 13.5. Verbal Requests. All verbal requests and directions to the City Clerk shall be followed up with a written memo within 24 hours of the request.
  - RECOMMENDATION: Responses from Departments to written/verbal requests from at Standing Committee's should also be provided in writing on the respective Standing Committee agenda.
- Insert language reflecting the resolution and policy relative to Public Hearings (ex. Tax abatements) that are being held by Standing Committees:

"When the initial petition appears on the Formal Session agenda and a statutory public hearing is required, once the item is referred to the Planning and Economic Development Standing Committee, the chair of the (PED) Standing Committee is authorized, upon consultation with the Clerk, to set the date of the hearing."

• NOTE: For PEDS, this needs to be restricted to tax incentive public hearings (inclusive of <u>tax</u> <u>abatement and brownfield hearings</u>). Mr. Todd mentioned in our last PED committee meeting that certain public hearings regarding zoning may have specific statutory requirements.
