### A RESOLUTION ESTABLISHING THE RENTERS PROTECTION TASK FORCE

# **By Council Member Mary Waters**

WHEREAS The pandemic moratorium on evictions has ended and federal assistance monies

will soon run out, more individuals and families in Detroit will find themselves

without safe secure housing, and

WHEREAS Thousands of Detroiters are rent burdened paying more than 30% of income for

housing related expenses. Twenty-five percent of Detroit renters are severely rent burdened paying more than 50% of their income on housing related expenses with 60% of renters paying over 30% of their income on housing

expenses, and

WHEREAS Detroit housing stock currently remains majority owner occupied, at just over

50%, a rise from 48% in 2019. Rental rates have dramatically increased in the city

while overall incomes have fallen, and

WHEREAS Unscrupulous landlords have collected rents for years failing to put money back

into their properties, feeding upon the desperation of people to have a place to

stay with a roof overhead, and

WHEREAS Tenants deal with a myriad the issues involving maintenance of the dwellings,

monetary disputes, blatant violations of renters' rights, and non-owner-

occupied foreclosures, unaware of any available resources, and

WHEREAS Of the average 30,000 evictions filed in Detroit each year, many tenants face

eviction for withholding rent while being housed in unlivable conditions, most

of these cases involve single mothers with children, and

WHEREAS Creating more affordable housing and upgrading the city's existing naturally

affordable housing stock could be a viable solution, it will require significant effort

from government and private entities as well as long term planning, and

WHEREAS The city embarked on a mission to have all landlords bring their properties into

compliance by 2020. Partially due to the pandemic, these efforts have fallen

woefully short, and

WHEREAS Council Member Mary Waters and the Detroit City Council recognizes the

extraordinary scope of this problem in our city and believes careful examination of the issues and thoughtful discussions are the only ways to change the course of this crisis that effects such a large part of our community and our cities future,

NOW, THEREFORE BE IT

# **RESOLVED**

That the Detroit City Council through Council Member Mary Waters hereby establishes the Renters Protection Task Force to be chaired by Council Member Mary Waters for the purpose of exploring and offering recommendations to the Council on the following:

- Reducing the current eviction rate
- Establishing and protecting tenants' rights
- Ensuring that quality and affordable rental units are available
- Supporting tenant associations
- Establishing a reporting mechanism for property owner violations
- Advising on future housing developments in the city, **BE IT FURTHER**

# **RESOLVED**

That the Renters Protection Task Force include representatives from the housing and tenant rights community, tenants, landlords, community representatives, the Building Safety Engineering and Environmental Department, as well as other participants, subject to the discretion of the Chairperson.
