Re: Community Benefits Ordinance Biannual Report - Executive Summary

The Civil Rights, Inclusion, and Opportunity (CRIO) Department has been given the responsibility, under Ordinance 2021-4, of monitoring Community Benefits Agreements (CBA). The Community Benefits Ordinance (CBO) requires a biannual compliance report be submitted to City Council and each NAC associated with a Tier 1 Project within the City of Detroit. The following report, the release of which was delayed, details compliance with each Community Benefits Provision commitment.

Eleven projects are currently in the enforcement phase and included in this report:


