Museum of African American History

FY 2023-2024 Budget Analysis by the Legislative Policy Division

The Charles H. Wright Museum of African American History ("The Wright"), located in Detroit, Michigan, provides research, compilation, presentation, publication, and dissemination of knowledge relating to the history, growth, development, heritage, and culture of people of African descent and the human struggle for freedom. Additionally, The Wright provides a means of collecting and restoring artifacts and other source material to be used in research on the history of the people of African descent.¹

The Mayor is recommending a \$1,900,000 subsidy for the Charles H. Wright Museum of African American History for FY 2024, in appropriation 26350 - Cultural Institutions Support, in cost center 350290 - Charles H. Wright Museum of African American History, located in the Non-Departmental budget (Pg. B35 - 9). This subsidy of \$1,900,000, is a \$700,000 (26.9%) decrease from the current FY 2023 subsidy of \$2,600,000 for the museum.

The Non-Departmental budget provides funds for activities, which are not the responsibility of any other single agency. Non-Departmental is also the depository agency for General Fund subsidy appropriations, enterprise activities and for a wide variety of General Fund revenues that cannot be credited to any specific department.

Questions:

- 1. In the Four-Year Financial Plan², for FY 2023-2024 (FY 24), the Mayor is recommending a \$1,900,000 subsidy for the Charles H. Wright Museum of African American History for FY 24, a \$700,000 (26.9%) decrease from the current FY 23 subsidy of \$2,600,000 for the museum. What is the rationale for this decrease?
- 2. What is the projected impact of the decreased subsidy to the daily operations and exhibits of the museum?
- 3. According to page 7 of the Charles H. Wright Museum of African American History annual financial statements as of June 30, 2022, the museum's total net position went from \$4.67 M in 2021 to \$16.83 M in 2022, a \$12.16 M increase. Please explain this significant increase.
- 4. What major initiatives/capital expenses does the museum have planned for the upcoming FY 2024?
- 5. Please provide the budgeted level of positions, actual level of positions filled as of February 28, 2023, and amount of vacancies. Does the museum plan on filling these vacancies?
- 6. Are there any plans for the museum to modify its staff or visiting hours in the upcoming FY 24?
- 7. Please provide the museum's FY 2023 operating budget, and the FY 2024 operating budget, if available.
- 8. Please provide an update on State of Michigan legislation that would allow Wayne and Oakland counties to create a history museum authority that could set an operating millage of up to 0.4 mills for up to 20 years.³
