FY 2023-2024 Budget Analysis by the Legislative Policy Division

The Detroit/Wayne County Port Authority (the "Authority") was created by the Port Authority Act of 1978. The legislation enables the Authority to enter into contracts for the acquisition, improvement, enlargement, or extension of port facilities. The mission of the Authority is to plan, develop, and foster economic and recreational growth, through environmental stewardship, in promoting Detroit and southeast Michigan as an import and export freight transportation and distribution hub for the United States, Canada, and the world marketplace.¹

The City of Detroit is providing a \$250,000 general fund subsidy to the Detroit Wayne County Port Authority (DWCPA) from the Non-Departmental budget for FY 2024, per page B35-9.

Issues and Questions

- 1) Please indicate how the \$250,000 subsidy received from the City will affect the DWCPA's operation.
- 2) Please provide an update of the current progress of the DWCPA's Port Forward strategic plan.
- 3) Please provide a brief update on the DWCPA's solicitation of qualifications from interested engineering consultants and firms to provide Engineering services in support of rehabilitation and expansion projects at terminals operating in the Port of Detroit district.
- 4) How much of a subsidy will the DWCPA's receive from Wayne County for FY 2024? How much of a subsidy will the Detroit Port Authority receive from State of Michigan in FY 2024?
- 5) What is revenue from events and docking fees for as of February 28, 2023? What is the revenue budget for events and docking fees for FY 2024? Do you anticipate that event and dock rental revenues will continue to increase in FY 2024?
- 6) According to Visit Detroit, the Detroit/Wayne County Port Authority and Cruise the Great Lakes celebrated a record-breaking 2022 cruise ship season. How many ships do you estimate will dock at the Detroit Port Authority in FY 2024?
- 7) Please describe any new revenue generating activities or programs anticipated for FY 2024.
- 8) Please briefly describe the DWCPA's plan for marketing the Port to potential customers and investors for FY 2024.
- 9) What are your projected performance metrics for the current fiscal year? What are your target metrics for fiscal year 2024?
- 10) According to your 2022 annual report, you've received over \$16 million for investments in port infrastructure. Can you provide details of your infrastructure plan?
- 11) The DWCPA's was awarded \$200,000 to pay for solar panels and \$685,000 for an innovative hydrokinetic energy harvester that will generate electricity from the river. Can you provide details on when the DWCPA will begin these projects?
- 12) One of the DWCPA's strategic initiatives in 2022 was to improve its engagement with communities and increase awareness of it's mission and programs. The DWCPA's established three theme-days (Cruise Ships, Jobs in the Maritime Industry and Cargo Day) which provided information and experience to highlight the work of the DWCPA. Will the DWCPA continue this initiative in FY 2024?
- 13) The DWCPA did not receive approval for the Master Concession Agreement (MCA) Termination. It was requested that the DWCPA focus on developing a detailed plan of post MCA business and operations plans. Can you provide an update concerning the plan?
- 14) Please provide the DWCPA's operating and capital budgets for FY 2023 and FY 2024.
