NOTICE OF PROPOSED SUBSTANTIAL AMENDMENT TO
ANNUAL ACTION PLAN**

Notice is hereby given that the City of Detroit proposes to amend its HUD Annual Action Plan for fiscal year 2022-23, to amend the Homeless Public Service activity, Detroit Health Dept Street Outreach (Code Blue) (Detroit Safe Team) to Detroit Housing Services (Housing & Revitalization Department HRD) Emergency Shelter Operations.

In accordance with Consolidated Plan requirements at 24 CFR Part 91 Subpart B and the City's Citizen Participation Plan, the Housing and Revitalization Department (HRD) has posted the changes to Action Plans through a Substantial Amendment in order to provide opportunity for public comment.

A summary of the proposed changes are as follows:

Line Item to be Reprogrammed (decrease):

Detroit Health Dept Street Outreach (Code Blue) (Detroit Safe Team) (SO) \$ 246,076.39

(HUD Matrix Code 03C) – The Detroit Health Department Outreach Team will assess the housing and human services needs of the families living in occupied foreclosures across the city, as well as assisting precariously housed individuals and families. The Outreach Team will address immediate needs while helping to secure some form of stable and permanent housing in the case of emergency relocation.

Line Item for Funding Addition (increase):

Detroit Housing Services (Housing & Revitalization Department HRD) \$246,076.39

(HUD Matrix Code 03T Emergency Shelter Homeless Programs) - Provision of shelter case management services, specific to residents who are being placed in hotels by Detroit Housing Services. Detroit Housing Services provides in some cases temporary shelter in the form of hotel, motel and short-term transitional housing. For those cases approved for shelter, Detroit Housing services will provide direct case management to these sheltered residents, in the form of documentation support, employment and income support, and other housing-related wraparound support. The ultimate goal is to facilitate relocation into a rental unit from shelter within 120 days. (100 Households/year --> 250 residents (average HH size 2.5)
