## **Re:** Executive Organization Plan (EOP) Amendments

Honorable City Council:

I am pleased to present to you the attached amendments to the Executive Organization Plan (EOP). Pursuant to Section 7-102 of the 2012 Detroit City Charter, any amendments to the EOP are to be submitted to your Honorable Body and made public. After a public hearing, your Honorable Body is required to approve, recommend modification, or reject the plan within sixty (60) business days. Lacking such action, the amendments become effective.

The proposed amendments to the Executive Organization Plan would:

- 1. Transfer Construction and Facilities Maintenance functions from the General Services Department to the Demolition Department. The purpose for this transfer, which includes capital functions such as the building or renovating of City of Detroit structures, is to consolidate those responsibilities with the residential and commercial demolition activities of the City of Detroit. This will provide more streamlined and efficient operation of demolition functions and construction activities; and
- 2. Rename the Demolition Department to the Construction and Demolition Department. The purpose of this renaming is to reflect the consolidation of Construction and Facilities Maintenance with demolition activities; and
- 3. Transfer the animal care functions of Chapter 6, *Animal Care, Control and Regulation*, from the Detroit Health Department to the General Services Department. The purpose for transferring the animal care functions is to consolidate the shelter operation and enforcement functions of Animal Care and Control. This consolidation will provide more streamlined and efficient operation of both functions.

Please find attached the proposed Amendments, Resolution Distributing the EOP Amendments and Notice Thereof as well as the Resolution to Set and Provide Notice of the Public Hearing.

In addition to the proposed EOP Amendments outlined above, please note I have submitted the following proposed changes in the account structure for publication in the Budget Book for your consideration:

- (1) Consistent with the Eighth Amended Plan for the Adjustment of Debts of the City of Detroit (October 22, 2014), *In re City of Detroit, Mich.*, Case No. 13-53846, (Bankr ED Mich, 2013) and in anticipation of the first full legacy pension payment in 2024, shift legacy pension contributions from Non-Departmental to the Debt Service and Legacy Pension department under the Office of the Chief Financial Officer; and
- (2) Shift the Project Clean Slate initiative appropriation from the Law Department to Non-Departmental; and
- (3) Transfer the Community Violence Intervention appropriation and management of the associated grants from the Detroit Police Department to the Detroit Health Department; and
- (4) Transfer of Citywide IT overhead cost centers from Non-Departmental to the Department of Innovation and Technology.

These important internal budget modifications are most appropriately addressed as part of this Honorable Body's ongoing budget review and approval process, and do not rise to the level of structural or functional changes that would warrant inclusion in the City's EOP.

Lastly, please note that pursuant to the authority granted in Section 22-10-3, I am transferring the roles and responsibilities of the Housing and Revitalization Department (HRD) under Chapter 22, *Housing*, Article X, *Right to Counsel in Eviction Proceedings*, from HRD to the Law Department, which is an Independent Department under Chapter 2 of Section 7.5-201 of the 2012 Detroit City Charter. The purpose for this transfer is to organize legal services provided by designated organizations through the Office of Eviction Defense under the City's Law Department, even if that Department is not responsible for funding or providing such services directly. Therefore, no modifications to the current language of Sec. 140, *Housing and Revitalization Department*, are necessary to effectuate this amendment. Please note this transfer is effective January 3, 2023.
