## RESOLUTION TO RECOGNIZE MAY AS NATIONAL NURSES MONTH

- WHEREAS, Registered nurses in the United States constitute our nation's largest health care profession and are an indispensable component of the safety and quality of care of hospitalized and non-hospitalized patients; and
- **WHEREAS,** Nurses serve on the front lines, risking their lives treating the injured and sick during wartime, natural disasters, and public health emergencies, including the COVID-19 pandemic;
- WHEREAS, Detroit's nurses have worked tirelessly throughout the COVID-19 pandemic, enduring immense stress and placing their own lives at risk to come to the aid of those in need; and
- WHEREAS, Because nurses are known to be patient advocates who act to protect the lives of individuals under their care, nurses are well-positioned to provide leadership to eliminate health care disparities that exist in the United States and in Detroit; and
- WHEREAS, Nurses are the cornerstone of the public health infrastructure, promoting healthy lifestyles and educating communities on disease prevention and health promotion; and
- **WHEREAS,** The demand for registered nurses and licensed practical nurses is greater now than ever before due to the aging of the American population, multiple concurrent public health crises, the continuing expansion of life-sustaining technologies, and the exponential growth of home health care services; and
- **WHEREAS,** More qualified registered nurses and licensed practical nurses will be needed in the future to meet the continually growing complex needs of health care consumers in Detroit and across the country; and
- **WHEREAS,** Beginning in 1991, the United States recognized National Nurses Week as May 6, also known as "National Recognition Day for Nurses", through May 12, the birthday of Florence Nightingale, the founder of modern nursing; and
- WHEREAS, In 2020, the American Nurses Association extended National Nurses Week to recognize May as National Nurses Month, partially to recognize the heroic efforts of nurses and their role in responding to the COVID-19 pandemic; and
- WHEREAS, National Nurses Month is a time of year to reflect on the important contributions that nurses make to provide safe, high-quality health care; NOW, THEREFORE BE IT
