AHP's ID Division services include HIV testing, prevention and treatment services at the Detroit Public Health STD Clinic, operated on behalf of the Detroit Health Department (DHD) with funding from the Michigan Department of Health and Human Services (MDHHS). The ID Division training center, MATEC-Michigan, is part of our region's 10 state AIDS Education and Training Center (AETC). They meet monthly over Zoom to discuss patients, share best practices, and determine who may require enhanced services. Over the last year, we have found success in developing trust among providers, following up on patients potentially lost to care, and increasing services for women and infants struggling with medication adherence. Vendor has integrated mental health care into the program, as well.

The majority of pregnant women will be African American (90% or AHP's HIV patients are African American); they are an additional priority because their treatment prevents perinatal transmission. AHP's team provides ongoing coordination starting during pregnancy up to 18 months post-partum to ensure parents and children have full care and prevention services.

AHP has 2 bilingual patient advocates that provides onsite French translation. We use a real-time telephone translation service called Language Line Solutions. Medical assistants connect this portable device to the client's spoken language for use in the privacy of an exam room.





The RFP for ADA Complementary Paratransit Services was issued in 2022. City Council approved People's Express, Inc. [6004732] for 30% of the services for a 5-year term, from Jan. 1,2023 – Dec. 31,2027 at the November 1, 2022 for \$15,865,980.26. OCP re-issued the RFP Feb. 2023 for the remaining 70% of the Services after the City managed Transdev contract 6004731 failed a vote.

Bid Information:

RFP Opened on February, 2023 and Closed on March 17, 2023. 44 Suppliers attended the pre-bid meeting; 14 Proposals received.

Bids were scored based on: Project Management [20 points], Project Team [20 points], Project Fleet [15 points], Demonstrated Past Performance [5 points], Cost [5 points], Detroit Certifications [D-BB & D-HB] for the Vendor [15 points] and for the sub-contractor [if applicable – 20 points]. Maximum total without certifications is 65 points & max total with certifications is 100 points.

The evaluation committee awarded contracts to Big Star Transit; Moe Transportation; People's Express; SW Transport Co. dba Checker Transportation; and Delray United Action Council, all of which currently provide paratransit services to the City. None of them hold any Detroit Business Certifications. The committee also decided to amend the previously approved People's Express contract to reflect the June 30, 2028 end date, instead of issuing a new contract.

All firms accepted the current rate being paid under the emergency paratransit contracts for year 1 with a 3.7% increase for year 2-5.

DDOT Paratransit will collect weekly metrics on Total trips, Total late trips, Total no show trips, Total missed trip, On-time performance, Trips per Hour (TPH).

Assessments of performance will be completed and damages will be deducted from the monthly invoice, including \$50 for each late pickup exceeding 10% each month, \$50 per missed trip, \$100 per document cell phone use occurrence, \$25 per dress coder infraction, \$100 for any infraction uncorrected after 30 days for accident repairs, and \$100 per day for each vehicle operated without scheduled maintenance/inspection and \$200 per day for more than 3 days or 500 miles without scheduled maintenance/inspection.
