- Re-Open Utley Library on Woodward between King + Alger as a LIBRARY


Goal #2

- Tell the full story about the ugly North end Landing project and secretive and non-inclusive planning and how disregarded and unheard the local residents feel

Neighborhood Housing Stabilization + Equitable Development

Goal #1



Allow and encourage a wide variety of housing types.

- I would like to see blighted and razed neighborhoods redeveloped into cultural spaces; themed communities with more diversity. Mass builds with solar not reliant upon commercial DTE energy. Japanese style homes - 50 to 100 blocks instead of piece milled builds. Mass overhaul of sewer systems and removal of large trees that were improperly planted and overtook to housing foundations and sewers. Also, existing new developments were used to disenfranchise existing residents used as corporate housing for incoming workers while current residents were suppressed with unaffordable rent and outdating buildings. Rent control, section 8 reform, new builds in the thousands of buildings. Luxury updates not substandard builds.
- 2 household family. We need an affordable option so that mom and dad can have homes close together for effective co-parenting purposes.
- But scrap North End Landing, shameful process and development by city and DLBA, and let's sit down at planning table with residents who live in that area. But don't force intense density on lower North End residents with the controversial North End Landing very disrespectful to residents who live right their. Build tall buildings next to houses of selected unelected Vanguard CDC "internal cabinet" members who had no concern for real inclusion of impact residents.

Goal #2



Preserve naturally affordable housing.

- Keep neighborhood people here / do not displace long time residents.
- Displacement prevention.
 Partner with community land trust to ensure permanent affordability and community self-determination.
- SCRAP North End Landing

 very disrespectful to the residents nearby
- North End population: at peak: 51,000 10 year ago: 5,400 24% white 2020: 4.800 24% white population can't keep going down and housing prices go up that's crazy.
- SCRAP North End Landing start again with impact residents. Please city don't be so disrespectful of us impact residents. North End Landing is mostly expensive, and salvageable houses got bulldozed for this project So you won't have to keep rebuilding. This keeps people from moving in ASAP.

Parks and Open Space

Goal #1



Expand the tree canopy.

- SCRAP NORTH END LANDING. Don't plan in secret from local residents.
- · Add plants to beautify.
- · Trees are destroying sidewalks.
- Restore the historic large -tree canopy on EVERY street, not just small trees on commercial corridors. Richer neighborhoods with tree canopy are up to 10' cooler and healthier overall. It's a social-justice issue.
- "Pocket Forests" not just rows of trees!
- · Yesss! Shade is where it's at!!
- Westminster off Woodward has little or none!!
- · Why I fell in love w/ Josephine St.
- Yes to more tress need plan to water them, not just plant them
- Removal of trees trees improperly planted which destroyed services and foundations of sidewalks and houses smaller species of trees - fruit trees
- Super uncool of land bank, city, and city council to treat us unequally
- Yes so don't destroy much lots for North End Landing - there lots were denied as side lots to local neighbors

Goal #2



Activate vacant land.

- Yes like the Vanguard Kresge sponsored grant to expand Bennett Playground but then they ignored that and planned North End Landing in a very resident disrespectful way.
- So people stop throwing trash, glass on sidewalks of vacant lots, for more neighborhood meeting places.
- · Outdoor space for events jazz
- Fountains
- Pocket parks or large parks ex: Trumbull+ G. River
- Let nearby neighbors be involved don't secretly plan on the people who live right there.
- Even if folks stewarding the land don't get a discount at least tell us the moment all the holds are released.
- Let people who live nearby have a say - scrap North End Landing - a very local resident disrespectful and secretly planned project.

Goal #3



Protect and standardize community stewarded open spaces.

- Yes better than any grocery. Convenience!
- You didn't give us all a fair chance with the non-inclusively planned North End Landing. Very sad the City of Detroit, except for maybe member at large Waters, and Vanguard CDC are not concerned about sincere and inclusive community engagement of the people who live right there and were purposely excluded from the visioning and planning of a few Vanguard selected unelected NE residents who signed NDA's (non-disclosure agreements) with the City's desired increased density desires, the careful planning of green spaces is essential.

Neighborhood Commercial Areas


Goal #1



Re-establish Oakland Avenue as a thriving commercial corridor.

- Access to funding and commercial real estate allows people to be financially free and have political influence. Prioritizing and limiting commercial ventures and commercial property ownership to residents of the neighborhood allows for cultural diversification and protects the community from monopolies and capitalistic oppression from outside investors with no commitment to the community.

- Build dense housing along largely vacant Oakland, with consultation of local residents instead of making lower NE residents so miserable. Build it there if neighbors are okay and not NEL


Goal #2

Goal #6




Explore the creation of an Oakland corridor community group to act as a local administration of tactical corridor improvements + programming.

Streets for People

Goal #1



Transform existing unsheltered bus stops with the addition of new shelters along primary stops and major intersections.

- Michigan's weather can be BRUTAL!
- Shuttles to specific cultural areas.
- · Re-designed routes.
- Better pay for happier bus drivers. Current drivers are suffering from sciatica and nasty conditions.

Goal #2



Support the increased frequency and modes of public transit along Oakland + Woodward to major employment centers.

- The Q-Line should have been put on a dedicated rail. Largely wasted effort except homeless people ride it in the cold.

Goal #3

- Plan green space and stormwater mitigation first
- · No to North End Landing.



Goal #4



Improve pedestrian visibility, safety, accessibility and sidewalk connections throughout the neighborhood.

- Make Oakland a slow street.
- Consider using the alley east of Oakland as the main pedestrian and biking thoroughfare rather than Oakland Ave. (all the way from East Grand to Highland Park). This could link to the Holbrook spur of the Joe Louis Greenway.
- Figure out a way to stop people from throwing glass bottles, especially on Brush, John R, + Oakland.

Goal #5



Improve bicycling infrastructure in the North End.

North End Landing should not have been planned by a selected, unelected group of North End residents and Vanguard CDC who purposely excluded the would-bemost impacted residents. Vanguard's "Internal Community Cabinet" sat down for 3 years and planned a huge mostly expensive (almost all) mostly rental complex and disregarded the wishes of the vast majority of the would-be-impacted residents to have been included in the beginning. Would you like your block planned in secret? This is not how to build a harmonious or welcoming community. There is plenty of publicly owned land to build density in without being disrespectful and non-inclusive in planning the immediate area of where the impact residents of the North End Landing project is planned.


