RESOLUTION IN SUPPORT OF THE PROPOSED BRITTANY CLARDY ACT FOR MISSING AND MURDERED BLACK WOMEN AND GIRLS

- WHEREAS, On September 19, 2023, US House Representative Ilhan Omar introduced HR 5573, entitled the Brittany Clardy Act for Missing and Murdered Black Women and Girls; and
- WHEREAS, Brittany Clardy, an 18-year-old Black woman from Minnesota, was tragically found murdered in 2013. Her family members immediately reported to law enforcement that Clardy was missing, however officers initially dismissed their concerns and delayed the investigation; and
- **WHEREAS,** According to the National Crime Information Center (NCIC), Black women and girls accounted 20% of all missing persons cases despite being only 7% of the US population¹, and Black women have the highest rate of death from homicide among women;² and
- **WHEREAS,** Despite Black women being overrepresented in the population of missing persons, they are vastly underrepresented in media coverage of missing persons in both the cases that are covered by the media and the length of coverage, especially compared to White women;³ and
- **WHEREAS,** This bias towards a lack of interest in missing persons cases involving Black women also appears to exist in law enforcement, as cases involving Black women stay open four times longer than other cases on average;⁴ and
- **WHEREAS,** In May of 2023, Minnesota took a proactive measure to address these disparities by passing a law that created the first Office of Missing African American Women and Girls; and
- WHEREAS, The Minnesota Office of Missing African American Women and Girls is intended to address the disparities by investigating cold cases, reopening closed cases where Black women or girls were declared to have died under suspicious circumstances, and assisting police agencies and community groups with active cases; and
- **WHEREAS,** The Brittany Clardy Act introduced in the US House of Representatives would create a national Office for Missing Black Women and Girls within the Department of Justice;
- WHEREAS, As a city with a roughly 78% black population, Detroit has an interest in eliminating any racial bias with regard to the treatment of missing persons cases, and to ensure that missing
