These notices shall satisfy two separate but related procedural requirements for activities undertaken by the City of Detroit.

REQUEST FOR RELEASE OF FUNDS

On or about March 15, 2024, the City of Detroit will submit a request to the U.S. Department of Housing and Urban Development (HUD) Detroit Field Office for the release of 1. HOME Funds under Title II of the National Affordable Housing Act of 1990 (HOME), and 2. Community Development Block Grant funds authorized under Title I of the Housing and Community Development Act of 1974 (Public Law 93-383) to undertake a project known as:

For the Purpose Of: Acquisition, rehabilitation of the existing Kingston Apartments building at 8842 2nd Avenue and new construction of 16 duplexes on the remaining parcels for a total of 43 housing units of affordable housing units in the Piety Hill neighborhood. There will be onsite parking included in the envelope of the duplexes and off-street parking for the Kingston Apartments building.

Mitigation Measures/Conditions/Permits: 1. Remedial action must be employed under the guidance of the Michigan EGLE to address onsite contaminants. 2. Hours of construction shall be in accordance with local code to mitigate temporary construction phase noise. 3. Conditions of the Section 106 Conditional No Adverse Effect determination are completed. 4. Noise attenuation measures will be incorporated into the building. 5. Asbestos and Lead materials impacted during renovations will be removed by qualified professionals.

The City of Detroit has determined that the project will have no significant impact on the human environment. RELEASE OF FUNDS

The City of Detroit certifies to HUD that Ms. Julie Schneider, in her capacity as Director of the Housing and Revitalization Department at the City of Detroit consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the City of Detroit to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of fund and the City of Detroit's certification for a period of fifteen (15) days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of Detroit; (b) the City of Detroit has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient has committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to the U.S. Department of Housing and Urban Development – Detroit Field Office, Keith E. Hernandez, Director, Community Planning and Development at DetroitCPD@hud.gov. Potential objectors should contact HUD to verify the actual last day of the objection period.
