The Future of Health development team has consolidated an updated response to a question received from Council President Mary Sheffield's memorandum dated February 8th, 2024.

1) Can Henry Ford Health provide a shuttle that will provide transportation for senior buildings to and from local grocery stores and activities twice per month?

The Developers will work with the Henry Ford Health Community Advisory Committee to develop and address the transportation needs of the community within the impact area. The focus will be on ensuring reliable access to the Future of Health Campus.

Through ongoing Community Engagement with the Advisory Committee, the developers will conduct a needs assessment to identify the specific needs for seniors. Through on-going engagement we will seek to answer the following questions:

- 1. Transportation Preferences:
 - a. What modes of transportation are most preferred by seniors in our community for local errands and are there specific challenges or limitations they face with transportation, and what current opportunities exist today.
- 2. Senior Errand Needs:
 - a. What are the primary errands or activities that seniors find challenging to fulfill independently, and which ones do they consider most crucial for their daily lives?
- 3. Technology Training Needs:
 - a. What is the level of technology literacy among seniors within the impact area, and how comfortable are seniors with using digital tools for tasks such as online shopping, and appointment scheduling.
