OVERVIEW

The Detroit Fire Department (DFD) is committed to operating with full transparency and the utmost respect for the citizens and governing authorities of the City of Detroit. The intent of this report is to satisfy the requirements set forth in ordinance 2021-17, Chapter 17, Article V, section 17-5-455 of the Detroit City Code.

BREAKDOWN

Data Collection:

To date, the DFD owns fourteen (14) Skydio X2E drones that classify as surveillance technology under the current Detroit City Code. During calendar year 2023, all data collected using this technology was recorded directly to a secure digital (SD) Card housed in the drone. This captured video data was, later uploaded to a secure OneDrive for archiving and restricted access for DFD personnel.

The total usage number for DFD surveillance technology:

During calendar year 2023, the DFD deployed Skydio X2E drones Seven (7) times within City of Detroit boundaries.

During calendar year 2023, the DFD shared drone recorded video footage with the individuals / entities listed below:

In April 2023, The DFD entered into a contract with Skydio INC. to purchase fourteen (14) X2E Drones with accessories. DFD acquired these unmanned aerial vehicles (UAV's) with Port Security grant funds totaling **\$296,776.00**. During calendar year 2023, DFD incurred no additional costs related to this technology.

Misuse of the technology during the reporting period:

There were no reports of misuse of DFD drones during calendar year 2023.
