*MEMBER ROBINSON (CHAIR OF THE EDUCATION SUB-COMMITTEE) EXPLAINS FOCUS AND SCOPE OF HIS SUBCOMMITTEE, EXPLAINS THAT HIS SUBCOMMITTEE MAY EXPLORE*

*WHAT OTHER STATES ARE DOING “AND SEE WHAT PARTS OF THOSE WE MIGHT TAKE UNTO OURSELVES, AND WHERE WE NEED TO BE INNOVATIVE IN THE DETROIT MANIFESTATION OF REPARATIONS,” ANNOUNCES FIRST MEETING WILL BE ON FEBRUARY 26<sup>TH</sup>, ANNOUNCES THAT NOTES WILL BE TAKEN AND POSTED, STATES THAT ZOOM WILL BE PUBLICIZED SOON.*

e. Health Sub-Committee

*MEMBER BELLE (CHAIR OF HEALTH SUBCOMMITTEE) ANNOUNCES THAT THE HEALTH SUBCOMMITTEE HAS BEEN MEETING ON THE THIRD TUESDAY, STATES THAT THE HEALTH COMMITTEE BEGAN COLLABORATING WITH THE UNIVERSITY OF MICHIGAN ON THE HARM STUDY, STATES THE HARM STUDY WILL FOCUS ON HOW ENVIRONMENTAL RACISM HARMED RACIALLY SEGREGATED NEIGHBORHOOD NEIGHBORHOODS, RECOMMENDS THAT JANICE HAZEL CHAIR THE COMMITTEE BECAUSE SHE HAS DEVELOPED TRUST WITH OUR COMMUNITY PARTICIPANTS.
