# COUNCIL MEMBER'S CORNER



## Legislative Updates Fiscal Year 2025 Budget Allocations Concerning District 2

Council Member Calloway has achieved significant progress for District 2 and the entire city of Detroit in the FY25 budget (July 1, 2024 - June 30, 2025). Following more than fifty hearings, Council Member Calloway successfully secured funding for the following initiatives:

- Approval of \$2.5 Million for the repair and restoration of the Merrill Fountain at Palmer Park. Initially located near Campus Martius in front of the original opera house, the fountain was gifted to the People of Detroit. In 1925, it was relocated to Palmer Park, where children used to play in the water. Subsequently, the water pipes broke, leading

to the fountain's deterioration. It is time to repair and restore the fountain to its former glory, ensuring that future generations can appreciate this historic landmark.

- Approval of \$2.5 Million for a pilot program focused on lead-based paint encapsulation. This initiative aims to support Mom-and-Pop landlords in meeting rental property registration and certification standards. The objective is to enhance the availability of safe housing units and reduce the incidence of lead poisoning among children.
- Approval to transfer \$2.7 Million from the Detroit Police Department budget to fund a police driver safety program. The aim is to minimize avoidable traffic accidents involving police vehicles. In light of resolving prominent civil cases, the City of Detroit is prioritizing reducing accidents and enhancing traffic safety for officers and the community.
- Approval of \$500,000 for the GOAL LINE program. The after-school program has received much praise from working parents. Initially located at the Northwest Activity Center in District 2, it is scheduled to expand to other areas of the city in the near future.
- Approval of \$40,000 for welcome banners on the historic Avenue of Fashion in support of our local businesses.

On that very next Sunday, she attended and joined and has been a member ever since. According to Sarah's family, she loves to watch television, talk on the phone, and look out the window. Even after reaching the Century Club, Sarah is still very independent, outspoken, and full of life. One of her favorite sayings is, "I will tell you in the front before you stick out behind." In other words, she is straight to the point, and you always know where she's coming from. Sarah continues to live a very long and exemplary life. ## Council Member Calloway's Small Business Spotlight

Human-I-T on Seven Mile opened its doors in June of 2023. Founded in Los Angeles in 2012 by Gabe Middleton and Detroit Native James Jack, Human-I-T started with the goal of closing the digital divide and diverting e-waste from landfills. Since its expansion to Detroit in 2020, Human-I-T has distributed over 18,500 devices, connected 3,500 Detroit households with affordable internet connections, and trained almost 800 individuals with vital digital skills training. Human-I-T recently collaborated with General Motors to provide 70 free devices to selected students and families associated with The Lab Drawer and Detroit Promise. The Lab Drawer offers culturally relevant STEAM experiences to historically marginalized youth, while Detroit Promise ensures tuition-free paths to higher education for eligible Detroit residents. Council Member Whitfield Calloway expressed her enthusiasm about their contribution to District 2 and their ongoing dedication to bridging the digital gap during their June grand opening. This recent device distribution reflects their belief that technology access is a fundamental right, not a privilege.

## Palmer Park Tennis Academy: A Legacy of Excellence and Growth

Palmer Park Tennis Academy (PPTA), led by Lenora King, a.k.a. Coach Lee, has seen great success recently. In 2020, the program was honored as the Community Tennis Association of the Year by the U.S. Tennis Association, a prestigious recognition presented by tennis legend Billie Jean King. This accolade was followed by significant financial support from Dick's Sporting Goods, the Cranbrook Pro Men's Tournament in 2023, and the Kaspers Foundation.

The program's commitment to excellence is evident in its initiatives, such as the High-Performance Day Camp, now in its third year, catering to tournament-level and high-school athletes looking to elevate their tennis skills. The camp includes 20 players and runs five days a week for 3-4 hours a day, with a dedicated fitness trainer session each week. PPTA organized an annual Juneteenth celebration with the SE Michigan Tennis Association/Midwest USTA to introduce tennis to aspiring athletes

and honor African American History in the sport. Additionally, the program hosted wheelchair tennis training and has participated in numerous regional tournaments.

This season, PPTA aims to enhance its offerings. Plans include seminars by Sports Psychologist Dr. Jay Novetsky, nutrition presentations for high-performance athletes, hosting a Midwest Diversity Day in May, and USTA national footwork specialist David Bailey. PPTA also wants to improve its facilities, including installing lighting and renovating the clubhouse.

With a strong focus on player development, community engagement, and continuous improvement, PPTA is geared up for another year of growth and success, showcasing the program's commitment to excellence and inclusivity in tennis.

## Senior Citizen Solid Waste Discount

The application period for the Senior Citizen Solid Waste Discount offered by the City of Detroit is July 1-September 15. Here are the details:

- Homeowners aged 65 and above with a Principle Residence Exemption on file are eligible for a discount.
- The Solid Waste Fee is \$250, with qualifying seniors receiving a \$125 discount.
- Annual reapplication is **not** required as long as ownership and residency are maintained.

Application instructions for the Senior Citizen Solid Waste Discount:

Submit the completed Senior Citizen Application for Solid Waste Discount to the City of Detroit Treasurer's Office between July 1- September 15.

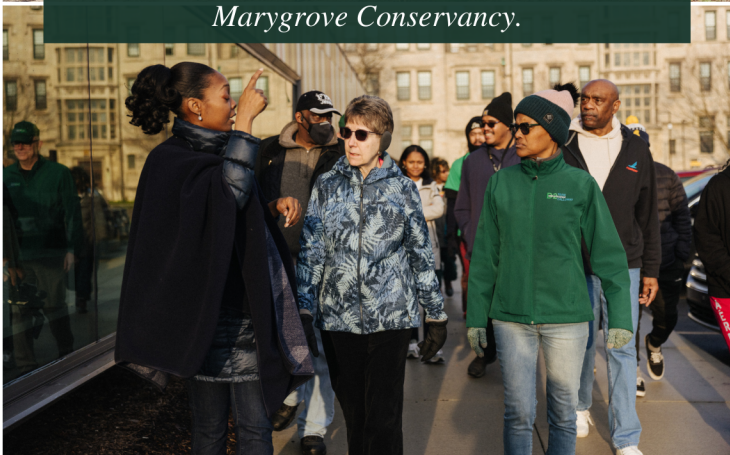

## Rallying for Better Living Conditions in Palmer Park

Last month #TeamCalloway was in Palmer Park peacefully picketing against Arizona-based Urban Communities (aka UC Palmer Park) after receiving multiple complaints from residents living in apartments owned by the company. The picket, which was well attended, drew attention to issues including continued maintenance neglect and inadequate living conditions reported by their tenants, mainly comprised of senior citizens. Urban Communities owns 14 properties in the area, with some buildings having multiple outstanding violations from the city's Building, Safety, Engineering, and Environmental (BSEED) Department. Following the picket, our team was made aware of recent changes that have occurred within Urban Communities, including a new property management company being named through a court order. #TeamCalloway will continue to fight for the tenants in the area, and throughout District 2 regarding inadequate service and living conditions. This change in property management is hopefully the beginning of new changes to come for the tenants in Palmer Park.

## 2024 Palmer Park Art Fair

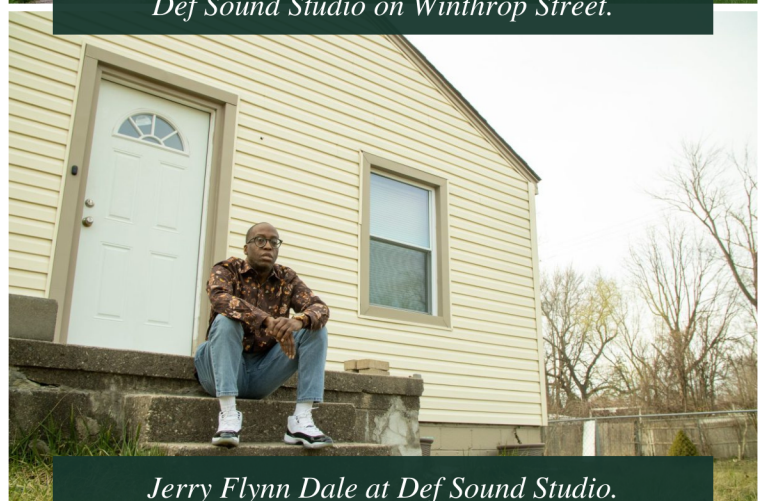

Sound Suite Studios is known for its collaborations with Anita Baker, Luther Vandross, and Parliament Funkadelic.
