DON'T BE A VICTIM COMMON FRAUD SCAMS

A common fraud scam is known as the Impostor scam. This is where a fraudster pretends to be someone you know or trust to try to convince you to send them money. They might even claim they are with the IRS or another government agency. These scams can be communicated in many different ways, including via emails, text messages, phone calls, and social media. They messages may ask you to 'confirm' or 'update' confidential personal information such as bank account numbers. In other cases, the communications might be an offer to help victims of current or prior frauds to recover any losses. Some scams may request that you pay taxes on prize winnings or fill out an insurance claim. Impostor fraudsters may also claim that you have an unpaid debt and threaten you with an arrest or a lawsuit unless you immediately pay what they claim you owe.

Here are some tips to make sure you don't fall victim to the Impostor fraud scam.

- Government agencies do not make unsolicited calls asking for money or sensitive personal information to be provided over the phone.
- Government agencies will never threaten you, or demand that you pay by gift card, wiring money, or digital currency.
- Do not open emails from people you do not know. If you are unsure
 if the email you received is legitimate, contact the sender in a
 different way.
- Even when you think you know the sender, be careful with links and web addresses. Fraudulent website addresses may be nearly identical to that of a legitimate website. Be on the lookout for a slight variation in the spelling or logo.



• You can always visit the company's website that you have typed in to complete the request instead of clicking on a link.

Refunding the Refund

In May 2022, the Baltimore City Office of Inspector General (OIG) received a referral from the City's Department of Finance regarding the issuance of an erroneous \$2,014,571.63 refund to an incorrect company. A City vendor who processes multiple City bill payments improperly processed a payment that was supposed to satisfy the property tax for an unnamed company. The vendor accidentally applied the company's payment of \$1,008,905.89 to a property tax bill for a different company. When the Department of Finance attempted to reverse the payment from the wrong

company to the correct company, the software system for property tax bills duplicated the payment, issuing a check for \$2,014,571.63 to the wrong company. The owner of the company deposited the check into their bank account.

The OIG issued several subpoenas for the company owner's bank information. The OIG's investigation revealed that the owner had spent approximately \$58,000 of the deposited funds on purchases and had an overdrawn balance. The OIG found that the City cannot recover those funds. After the bank placed a hold on the owner's account for the remaining balance, the owner returned \$1.9 million back to the City by wire transfer. The Department of Finance provided information that assisted the OIG in referring this case to the appropriate law enforcement entities to pursue a criminal investigation against the owner. The OIG's report recommended that the Department of Finance examine both the payment vendor's contracts and the software

vendor's contracts with the City's Law Department to determine if any financial loss protection exists. The report also suggested that the Department of Finance coordinate with the software vendor to create better refund processes to prevent future erroneous refund issues. In response to the OIG's recommendations, the Department of Finance reported that they had updated its policies to require a review before refunds of over \$10,000 are issued.
