RE: Request for feasibility and process for recognizing Juneteenth

Council President Mary Sheffield requested that the Legislative Policy Division (LPD) provide an assessment of the feasibility and process for raising the Juneteenth flag on the grounds of a city government building. This report includes:

- historical context of Juneteenth.
- process for raising the flag.
- alternative commemoration methods.
- relevant Supreme Court cases regarding flag policies.
- examples of how other local and state governments commemorate Juneteenth.

Raising the Juneteenth Flag at CAYMC

Upon checking with the Detroit Joint Building Authority, the management of the Coleman A. Young Municipal Center (CAYMC) we learned he process for raising a flag at the CAYMC would and in the past has involved the City Council requesting that the Board of Commissioners of the Joint Wayne County building Authority approve it.¹

Historical Context

Juneteenth: Juneteenth, also known as Freedom Day, Jubilee Day, and Liberation Day, commemorates the end of slavery in the United States. It marks June 19, 1865, when Union General Gordon Granger arrived in Galveston, Texas, and announced the end of the Civil War and the emancipation of enslaved African Americans. Although the Emancipation Proclamation had been signed by President Abraham Lincoln on January 1, 1863, it took over two years for the news to reach Texas.

Juneteenth in Michigan: In Michigan, Juneteenth was officially recognized as a state holiday in 2005, when Governor Jennifer Granholm signed the legislation into law. The recognition of Juneteenth as a federal holiday came much later, on June 17, 2021, when President Joe Biden signed the Juneteenth National Independence Day Act into law.

Feasibility and Process of Raising the Juneteenth Flag

Feasibility

Raising the Juneteenth flag on city government grounds is feasible and aligns with the broader recognition of Juneteenth as a significant holiday. It is a powerful symbol of the city's commitment to acknowledging and celebrating African American history and culture.

Process

The process for raising a flag at the CAYMC would and in the past has involved the City Council requesting that the Board of Commissioners of the Joint Wayne County building Authority approve it.

Alternative Commemorations

If raising the Juneteenth flag is not feasible, the city can explore other ways to commemorate the holiday:

- 1. **Public Events and Celebrations**: Host parades, festivals, and community gatherings featuring local artists, musicians, and speakers. Organize historical reenactments and educational programs about Juneteenth.
- 2. **Official Proclamations**: Issue a city proclamation recognizing Juneteenth and its importance. Encourage local businesses and institutions to observe the holiday.
- 3. **Public Art and Memorials**: Commission murals, statues, or other public art installations celebrating African American history and culture. Establish a Juneteenth memorial site in a public park or plaza.
- 4. Educational Initiatives: Partner with schools and libraries to provide educational resources and programs about Juneteenth. Promote reading lists, film screenings, and discussion groups focused on African American history and civil rights.

Origin of the Pan-African Red Black and Green Flag

The Pan-African flag, (also called the Marcus Garvey, UNIA, Afro-American or Black Liberation flag,) was designed to represent people of the African Diaspora, and, as one scholar put it, to symbolize "black freedom, simple." The banner, with its horizontal red, black and green stripes, was adopted by the Universal Negro Improvement Association (UNIA) at a conference in New York City in 1920.²

Origin of the Juneteenth Flag

The first flag that represented the holiday was created in 1997 by Ben Haith, the founder of the National Juneteenth Celebration Foundation (NJCF). Three years later, artist Lisa Jeanne Graf explained on her website that she "fine tuned" the original version, resulting in the flag we see today. This was the same year that Haith led the holiday's initial flag raising ceremony in Boston's Roxbury Heritage Park, according to the National Juneteenth Observance Foundation (NJOF). Even though the red, white, and blue flag is closely associated with Juneteenth, you'll still see some celebrating with the red, green, and black Pan-African flag, which was created in 1920, after Jamaican activist Marcus Garvey called for a Black liberation flag. Though both the Pan-African and Juneteenth Flags serve as symbols of pride and freedom for Black people, the Juneteenth flag was intentionally created to honor a single holiday, whereas the Pan-African flag represents all of the African diaspora.³
