**NOTICE OF AVAILABILITY AND PUBLIC HEARING ON THE DRAFT
2023 CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION
REPORT (CAPER)**

The CAPER describes the expenditures for projects implemented or completed between July 1, 2023 and June 30, 2024 for the Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), Emergency Solutions Grants (ESG), and Housing Opportunities for Persons With AIDS (HOPWA) programs. The report also discusses housing and community development goal and objective attainment as outlined in the Consolidated Plan strategy and Action Plans. The CAPER is submitted to HUD annually.

The Housing and Revitalization Department will hold a virtual public hearing to receive comments on the Draft 2023 Consolidated Annual Performance and Evaluation Report (CAPER). The CAPER virtual public hearing will be held on Tuesday, September 24, 2024, from 5:00pm – 6:00pm.
