REQUEST FOR RELEASE OF FUNDS

On or about November 1, 2024, and in accordance with 24 CFR 58.71, the City of Detroit will submit a request to the U.S. Department of Housing and Urban Development (HUD) Detroit Field Office for the release of 1. HOME Funds authorized under Title II of the National Affordable Housing Act of 1990 (HOME), and 2. Project Based Vouchers from the Detroit Housing Commission, to undertake a project known as:

Project Title: North Corktown Apartments; 2607 14th Street, Detroit, Michigan.

For the Purpose Of: Acquisition, demolition of the existing warehouse building, and new construction of a residential mix-used building in the North Corktown Neighborhood of Detroit, Michigan. The proposed project includes new construction of a four-story 49 two-bedroom apartments containing energy efficient appliances, commercial space on the first floor, a dog park, an outdoor picnic shelter, and a parking lot.

Mitigation Measures/Conditions/Permits: 1. Remedial action must be employed under the guidance of the Michigan EGLE to address onsite contaminants. 2. Hours of construction shall be in accordance with local code to mitigate temporary construction phase noise. 3. Conditions of the Section 106 Conditional No Adverse Effect determination are completed. 4. Noise attenuation measures will be incorporated into the building.

HUD will accept objections to its release of fund and the City of Detroit's certification for a period of fifteen (15) days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of Detroit; (b) the City of Detroit has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient has committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to the U. S.
