



Community Conversation (Housing Meeting notes continued in this meeting)

- Different Housing Types of ROW houses, garden apts, etc...
- Energy efficient housing.
- Equity essential for all housing decisions and no displacement with new development
- Beautiful, equitable with more homeowners in the neighborhood
- Housing that takes advantage of natural landscaping clean
- Tiny houses where Youth can be involved in the process / landscaping / clean
- Racial Equity and oncome based on those currently living in Brightmoor where affordability is based on Brightmoor residents
- Centralize equity and NO FUTURE housing should be built until Brightmoor Homes issue resolved with NDND
- The 50 Homes or 50K CDBG Grants should be released into People's Hands
- The Community needs more typologies developed in the neighborhood (i.e. Brownstones Senior Housing)

Priority Recommendations

- What are Community Stewards?
 Community Stewards are those who take care of the parks and help and play a role in programming and the overall maintenance of the park
- Existing shelters are hard to reserve digitally. Does the City need to work on this
- We need more safety roping / signage regarding all traffic in the park
- Data related to safety in the parks is needed
- How can we (The Community) get public access to the Rouge River Greenway
- There is too much illegal dumping on Telegraph near the Rouge River
- More Fed money for the Rouge River Clean Up
- We need more pocket parks throughout the neighborhood



Priority Recommendations

- Can we have a splash pad in the parks so kids can play in the water
- Multiple Basketball Courts are needed throughout the parks in the neighborhood
- Better maintenance of existing parks is needed
- New non-motorized greenways are needed in the parks and to connect existing open spaces
- We need to utilize some of the vacant land for drag racing
- Land Between I-96 and Rouge Park owned by Catholic Church South of I 96. That land is under utilized. Parks should coordinate with Catholic church for that land
- The DLBA website does not have updated information on land ownership



Which 2 strategies would you prioritize?




Vacant Land

- Community Partners should start getting plans together for use of vacant land in the neighborhood
- Does the DLBA have an idea or map that identifies how many side lots available.
- Yes they do, and the DON will be coordinating and event with the DLBA with community information on how to buy side lots and neighborhood lots
- · We need better regulations against dumping
- We need a 7 generations sustainable model as it pertains to planting the right trees so they last for generations to come. Plant the right kind of trees for this region
- New housing with different incomes should be developed near the parks and improved open spaces
- Vacant lots should be turned into training grounds for the different types of jobs within the industry of sport.
- Zoning makes it harder to build accessory dwelling units or ADUs on existing occupied private property
- The community groups should start to think about Community land trust




