REQUEST FOR RELEASE OF FUNDS

On or about November 4th, 2024, and in accordance with 24 CFR 58.71, the City of Detroit will submit a request to the U.S. Department of Housing and Urban Development (HUD) Detroit Field Office for the release of 1. HOME Funds authorized under Title II of the National Affordable Housing Act of 1990 (HOME), and 2. Project Based Vouchers from the Inkster Housing Commission, to undertake a project known as:

Project Title: Russell Woods Senior Center; 11421 Dexter Avenue, Detroit, Michigan.

For the Purpose Of: Acquisition and adaptive reuse of an existing apartment building in the Nardin Park Neighborhood of Detroit, Michigan. The proposed project consists of complete rehabilitation of a vacant, 12-story 138-unit apartment building into a 77-unit senior apartment building. The first floor will consist of community areas, including a library, a fitness room, meeting areas. Exterior work includes sidewalk and burb replacement, landscaping, and milling and resurfacing of the existing parking lot.

Mitigation Measures/Conditions/Permits: 1. Remedial action must be employed under the guidance of the Michigan EGLE to address onsite contaminants. 2. Conditions of the Section 106 Conditional No Adverse Effect determination are completed. 3. Hours of construction shall be in accordance with local code to mitigate temporary construction phase noise. 4. Asbestos and lead impacted during renovations will be removed by qualified professionals.
