

#### From the Desk of the Inspector General "A Few Good IGs"

In November, I attended the Association of Inspectors General (AIG) 2024 Training Conference in New Orleans, LA along with a couple of my staff. I first attended this conference with former Inspector General James Heath 10 years ago on behalf of the Office, shortly after the 2012 Charter created the OIG. We learned so much as a newly minted Office of Inspector General. We were new to the work of "IGing", and it was amazing how large and robust this community was then and remains so today. Detroit's OIG has participated nearly every year since, including hosting the conference in 2015.

I know you are thinking what a fun place to attend a conference, but the days were long, beginning at 8:00 a.m. and ending after 5:30 p.m., leaving little time or energy for too much more than rest. Most of our time there was spent learning from, and exchanging ideas with, the over 400 attendees at the event representing various OIG's at the federal, state, military and local level. There were several sessions under the conference's theme of the "Art of Oversight". Each session gave practical or nuanced information on how to improve how we carry out our oversight role.

Some sessions gave practical examples of the real-world challenges Offices of Inspector Generals are facing, including an informative panel of IG's from the City of Baltimore, Baltimore County, the City of Dallas, and the City of Atlanta. Though all the presentations were compelling, the report from Atlanta's Inspector General

Shannon Manigault stood out because it was intense, current, and unresolved. IG Manigault has faced unfair and disturbing actions since releasing a report critical of someone with connections to elected officials in the Atlanta City Government. IG Manigault simply did her job in presenting a thorough and well-reasoned report. Almost immediately following the release of that report, she and her office were subjected to a rushed process that culminated in recommendations to the Atlanta City Council that would strip the office of the very powers that make it an Office of Inspector General.

Please forgive the adaptation of one of my favorite movies, as I am shamelessly appropriating the villain Col. Nathan Jessup's (played by Jack Nicholson) words after proclaiming Lt. Dan Kaffee (played by Tom Cruise) can't handle the truth. He goes on to talk about walls needing to be guarded by men with guns and everyone needing, and wanting, Col. Jessup on that wall. My corny adaption goes like this... Deep down in places you may or may not talk about at parties...you need IG's like Shannon Manigault standing up on walls for honesty, integrity, accountability, and standing against government fraud, abuse, waste, and corruption. These are the words that we use to guide our ways as we do a very difficult job for the citizens we serve.

I believe the citizens of Atlanta appreciate having an OIG, particularly after dealing with the corruption and scandal that comes with its most recent history. #### DONT BE A VICTIM COMMON FRAUD SCAMS

Committed to Honesty and Integrity in City Governmen

**DONT GET TAKEN...** Give me some credit, I won't fall victim to Consumer Fraud Debt and Credit Schemes

Consumer fraud occurs when a person experiences financial or personal loss as a result of deceptive, unfair, or misleading business practices. Scammers typically target those considered to be the most vulnerable or naïve but all consumers, even those that consider themselves savvy, are at risk. A common type of consumer fraud offers to help people with debt and/or to repair their credit. Below are some schemes that everyone should be on the lookout for.

#### **Debt Consolidation Scheme-**

This scam targets consumers with significant debt. The debt relief service falsely promises to negotiate a lower monthly payment that is spread over a longer period with a creditor. The debt relief service then collects the money but fails to forward it to the creditor.

#### **Credit Repair Scheme-**

Scammers use solicitations to offer to repair a consumer's credit. However, this is not possible because valid negative credit information cannot be removed from a credit report for 7 to 10 years.

#### **Credit Card Debt Elimination Scheme-**

People burdened with credit card debt are targeted in this scheme. Debt elimination scams offer to eliminate people's debt for an upfront feet. Some scammers even convince people that it is illegal to collect on credit card debt by citing non-existent statutes. Once someone pays, the scammer disappears.

#### **Credit Analysis Scheme-**

Scammers offer to do a confidential analysis of a consumer's credit history to help them repair their credit. The consumer is required to provide their bank account number to pay an advance fee. The scammer then takes money from the person's bank account and never provides any assistance.

#### credit fraud. ere are some red flags to look out for so you don't fall victim to debt and

- Unsolicited offers: Very few reputable debt settlement companies cold-call potential clients. Upfront fees: Anyone initiating contact offering to take care of your debt for an upfront fee should immediately raise your suspicions. This tactic is prohibited by the Trade Commission.
  - uaranteed promises: If a company makes promises that are too good to be true they probably are. Promised results, such as reducing your debt by a certain percentage, is a big warning sign.
  - se contact with your creditors: If a debt relief company instructs you to cut off all contact with your creditors, it's best to stay away from them.
  - lentions of legal loopholes and government programs: Be wary of companies that advertise little-known legal loopholes or new "government programs" that can get you out of debt. nrollment without reviewing your documents: A legitimate debt settlement company will closely look at your documents to assess your financial situation before enrolling you. A scammer doesn't need to do that
- because the don't plan on actually helping you.

#### The OIG Sheds Light on Nebulous Relationships between Atlanta City officials, Employees and Contractors Prompting Task Force to Limit OIG

In January 2023, the City of Atlanta Office of Inspector General (OIG) received a complaint about a \$20,000 reimbursement request City Council Member Michael Julian Bond made for Hello Fresh food distribution expenses. The payment was directed to a post office box address linked to Council Member Bond's former campaign manager, Bernard Tokarz. The City Council rejected Bond's reimbursement request and ultimately approved donating the funds to a food relief organization instead of reimbursing Council Member Bond. The OIG's investigation focused on Mr. Tokarz and Bond's former chief of staff, and current City employee Vanessa Manley to shed light on nebulous relationships between city officials, employees and vendors. The OIG found that Mr. Tokarz, a registered Georgia lobbyist, did not disclose financial and personal ties with various city employees and officials. In addition, Mr. Tokarz regularly advises Council Member Bond on city matters and serves as the principal agent for multiple businesses with contracts with the City of Atlanta. One of Mr. Tokarz's businesses, Howell Mill Communications LLC, received \$52,303 from the city between July 2021 and August 2023. Over \$42,000 of those payments originated from Council Member Bond's council account. The OIG also discovered that Howell Mill Communications paid over \$13,000 to senior city employees for campaign consulting during the 2021 election season.



City Ethics rules state that officials with even an indirect personal interest in any proposed legislation "shall not vote for or against, discuss, decide, in any way participate in considering the matter or seek to influence the votes or decisions of others on such matter." Council Member Bond did not recuse himself from considering the 2022 Cloverhurst bid despite his relationship with Tokarz and voted to approve the agreement. Cloverhurst was one of two companies awarded the contract.


DDOT Director G. Michael Staley DDOT Assistant Director of Operations **Geo Joy**


