- **RESOLVED** The Detroit City Council hereby recognizes the NAWIC Detroit and its many dedicated volunteers for its steadfast work on behalf and support of women in construction, and proudly recognizes the week of March 2-8, 2025 as "Women in Construction Week"; **NOW BE IT FURTHER**
