- Project Impacts:
 - Lane Closures
 - One Lane Open in Each Direction between April and September
 - Parking Restrictions

MARCH 18, 2025 - JUNE 2026

Monroe from Randolph to I-375

- Project: Monroe Streetscape
- Project Owner: Greektown Neighborhood Partnership | ENG 25-115
- Project Impacts:
 - Full vehicle closure of Monroe between Randolph and St. Antoine
 - Long-Term Intersection Closures at Brush/Beaubien
 - Intersection Closure at St. Antoine late April late May
 - Periodic Intersection Closure at St. Antoine
 - Pedestrian Access Always Maintained
- Access Notes:
 - 400 Monroe Wayne County Pick up/drop off should utilize Lafayette between Brush and Beaubien
 - On-street parking available on Lafayette, Fort, Macomb, Beaubien
 - Greektown People Mover Stop Open (and Free to Use)
 - Greektown Casino Parking Access from I-375 and Macomb

- Project Impacts:
 - Full closure of WB Broadway between Grand River and Gratiot
 - Limited sidewalk access on north side of Broadway
 - Traffic should use SB Gratiot to NB Woodward as alternate route

JANUARY 1, 2025 – DECEMBER 2025

WB E. Jefferson Avenue near M-10

- Project: 2nd Avenue Extension (MDOT Permit)
- Project Owner: Huntington Place
- Project Impacts:
 - Lane Closures on WB E. Jefferson downtown
 - Lane Closures on SB M-10 approaching Larned
 - Exit Closure on NB M-10 at W. Jefferson
 - Exit Closure on SB M-10 at Larned (Intermittent)

JANUARY 13, 2025 – MARCH 31, 2025

Larned from St. Aubin to I-375

- Project Owner: DTE Gas
- Project Impacts:
 - Full closure of EB Larned between St. Antoine and I-375
- Access Notes:
 - Traffic should use NB Beaubien to EB Lafayette to access I-375 and points east as alternate route


