Tax Statement

Sec. 17-2-10. - Tax Statement and Bond Statement

The City Council shall cause to be levied and collected by general tax the amount of the tax statement so approved and may issue any bonds so authorized to be to be issued. All such proceedings shall be completed within one week following the maximum final approval of the budget by the City Council.

Tax statement was included in the proposed budget documents in the previous fiscal years.
