**To All Prospective Applicants:**

Please reference the above request for qualifications (RFQQ) that is open until December 31, 2029. Be advised that from time-to-time scopes of work in RFQQ 185300 may be revised or added to. Currently the City has immediate needs for Construction Engineering and Inspection (CEI) Services. In order to be able to bid on the CEI project, firms must be pre-qualified and approved by the City of Detroit on Supply Schedule #9.

Due to an insufficient quantity of early responses to allow for adequate competition, as well as the need for some projects to begin expeditiously, the deadline to submit qualifications to be eligible for this first round of projects is **12:00 PM (EST), Friday, March 7, 2025**.
