RE: 2025-26 Homeless Solutions Funding review schedule and list of applicants to identify any potential conflict of interest (RESOLUTION FOR CONSIDERATION)

The City Planning Commission (CPC) staff in cooperation with the Housing and Revitalization Department (HRD) are requesting Your Honorable Body approve a schedule of public hearings and deliberative sessions for the 2025-26 Homeless Solutions Funding recommendations.

The Homeless Solutions Funding program consists of two Department of Housing and Urban Development funding sources: 1) Homeless Public Service (HPS) and 2) Emergency Solutions Grants (ESG). Similar to previous years, the Homeless Solutions Funding review and award decisions are done later than the Neighborhood Opportunity Fund (NOF) review in order to combine the HPS with the ESG funding allocations.

The CPC and HRD staff recommend the following schedule for the Planning and Economic Development Standing Committee, expanded:
