**RE:** Update on Landlord Compliance Rates in the City of Detroit

This memorandum is in response to your request for the Buildings, Safety Engineering and Environmental Department (BSEED) to provide an update on the number and percentage of Detroit rental units that are now in compliance with the Rental Compliance Ordinance and have completed the requisite inspections to receive a Certificate of Compliance. We submit the following.

We currently have 11,546 active C of Cs for rental compliance. That translates to 47% of our total Rental Registration number (24,398), and approximately 16% of the total estimated rental universe (~72,000).

At the end of 2021, we had just 5,929 active C of Cs (8%). We have increased each year: 8,450 in 2022 (12%); 8,731 in 2023 (12%); 11,063 in 2024 (15%).
